1st Race: 65. The Mount Joy Plate - Div. II - (About) 1200 metres. Horses rated 15 to 35 (14 Runners).

POLAR EXPRESS (Chandrashekar) jumped awkwardly outwards and inconvenienced ROC GIRL (V.R.Jagadeesh) at the start.

Jockey Chethan Gowda, the rider of SHIVALIC GOLD was reprimanded for shifting out and inconveniencing ACTIVATED (Ryan Marshall) on his outside passing the 1100 Metres.

Jockey Ryan Marshall, the rider of ACTIVATED was fined Rs.3,000/- for not making sufficient effort to improve his position from 1000 Metres till about 500 Metres.

Jockey Anjar Alam, the rider of BLOOM BUDDY was fined Rs.2,000/- for shifting 'in' and causing interference to BLARNEY STONE (Arshad Alam) on his inside approaching 800 Metres.

Jockey K. Raja Rao, the rider of CAPITAL GAIN was reprimanded for shifting out and inconveniencing VALOUR (Irvan Singh) on his outside passing the 600 Metres.

Jockey A.R.Pradeep, the rider of ZEE ZEE TOP reported that his mount was running green throughout the race.

Routine Sample was taken for analysis from the winner b g GOLDEN VISION.

2nd Race: 66. The Topmost Plate - (About) 1400 metres. Horses rated 15 to 35, 5 years old and over (14 Runners).

Jockey R. Vaibhav, the rider of LIGHTNING ATTACK reported that his mount was not galloping fluently throughout the race. The horse was subjected to veterinary examination but no abnormality was reported.

Jockey P. Trevor, the rider of HAFNIUM reported that his mount was not galloping fluently throughout the race. The horse was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner ch h CASEY.

<u>3rd Race: 67. The Kolar Plate - (About) 1200 metres. Horses rated 30</u> to 50, 5 years old and over (14 Runners).

BENEDICTION (V.R.Jagadeesh) jumped awkwardly outwards and inconvenienced PROPINE (Rayan Ahmed.R) at the start.

ISPELLDANGERTOALL (Naveen M.) took a fly jump at the start.

Jockey Naveen M., the rider of ISPELLDANGERTOALL reported that he could not get a clear run between the 250 Metres and 150 Metres due to a closely packed field.

Jockey P. Mani, the rider of BIRCHWOOD was reprimanded for dropping hands before passing the winning post.

Routine Sample was taken for analysis from the winner b m WINGS OF DESIRE.

<u>4th Race: 68. The Narasimharaja Trophy - (About) 2000 metres.</u> <u>Horses rated 60 and above (9 Runners).</u>

ASTRAL FORCE (V.R.Jagadeesh) accidentally brushed the running rails passing the 1200 Metres.

Jockey Suraj Narredu, the rider of ANGELINO was fined Rs.1,000/- for shifting 'in' and causing interference to SPEEDSTER (Arshad Alam) on his inside passing the 200 Metres.

ROYAL CRYSTAL (S. John) sustained cut injury on left hind cannon.

Routine Sample was taken for analysis from the winner b c ROYAL CRYSTAL.

5th Race: 69. The Bangalore St. Leger(Grade II) - (About) 2800 metres. Indian Horses 4 years old and over (Foaled in 2016 or before). (6 Runners).

WELL CONNECTED (P. Trevor) sustained superficial injury on left hind tendon.

Compulsory urine and blood samples were taken for analysis from the following I, II & III placed horses viz:

6th Race: 70. The R.W.I.T.C Cup - (About) 1400 metres. Horses rated 75 and above (7 Runners).

RAFA (Rayan Ahmed R.) stood flat footed and lost few lengths at the start. In view of its behaviour, Trainer Mr. S. Dominic was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey R. Vaibhav, the rider of AUTOMATIC reported that his mount was not galloping fluently in the final 200 Metres. The horse was subjected to veterinary examination but no abnormality was reported.

It was reported after the race that NAAZAAN (Naveen M.) pulled up lame on right fore. Trainer Mr. Sharat Kumar was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b g NORTHERN ALLIANCE.

7th Race: 71. The Bharachukki Plate - (About) 1400 metres. Horses rated 45 to 65, 4 years old and over (14 Runners).

Jockey Surya P., the rider of EXCELLENT SORRENTO was reprimanded for travelling wide between the 600 Metres and 500 Metres for no apparent reason.

Jockey Irvan Singh, the rider of PIPER REGINA was fined Rs.1,000/- for shifting out and causing interference to HARBOUR SUNRISE (Antony Raj S.) on his outside approaching 400 Metres.

Jockey Darshan R.N, the rider of THREE WISHES was fined Rs.2,000/- for shifting out and causing interference to GREY CHANNEL (Arshad Alam) on his outside, PIPER REGINA (Irvan Singh) which was travelling directly behind also had to be checked by its rider passing the 350 Metres.

Jockey P. Trevor, the rider of ROYAL RESOLUTION reported that his mount was not galloping fluently in the final 150 Metres. The horse was subjected to veterinary examination but no abnormality was reported.

An enquiry is being held into the improved performance of POSEIDON, trained by Mr. V. Lokanath and ridden by Jockey V.R.Jagadeesh in the above race as compared to its previous run in Race No. 47 i.e., The Bhagamandala Plate (about) 1600 Metres, Horses rated 45 to 65 run on 3rd December, 2020 when ridden by Jockey Prashant P. Dhebe where it ran unplaced.

Routine Sample was taken for analysis from the winner b r POSEIDON.

8th Race: 72. The Mount Joy Plate - Div. I - (About) 1200 metres. Horses rated 15 to 35 (12 Runners).

Permission was granted to Trainer Mr.Neil Darashah to withdraw AKASI (Nazerul Alam) on veterinary grounds as it was found to be lame on right hind hock. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

CAPABLE (Prashant P.Dhebe) was extremely fractious inside the gates, whereby the rider was injured. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order.

Jockey S. Zervan, the rider of MYSTIC EYE was fined Rs.2,000/- for shifting 'in' and causing interference to the horses on his inside viz; CHISOX (R. Shelar), SIZZLER (Darshan R.N) and GLENARY (P. Trevor) soon after the start.

It was observed that GLENARY (P. Trevor) raced fiercely between the 1100 Metres till about 900 Metres.

Jockey A. Ashhad Asabar, the rider of LOVELY SIERRA was reprimanded for shifting 'in' and inconveniencing GRIFFIN (Anjar Alam) on his inside approaching the final 100 Metres.

Jockey S. John, the rider of FLAMINGO ROAD was reprimanded for riding an indifferent race.

Routine Sample was taken for analysis from the winner b f MYSTIC EYE.

Permission was granted to trainers M/s. S. Dominic and S. Narredu to deputize on behalf of trainers M/s. Neil Darashah and Rajesh Narredu who were unable to attend the races.
