# BANGALORE WINTER MEETING 2020-21 SEVENTEENTH DAY, SATURDAY, 20<sup>TH</sup> FEBRUARY, 2021 RACING INCIDENTS (129-136)

**GOING: Good**

RAILING POSITION: Railing fixed at average width of 4.5 Meters from

1600 Meters to winning post from its original position.

### 1<sup>st</sup> Race: 129. The Raichur Plate - (About) 1400 metres. Horses rated 00 to 20, 5 years old and over (12 Runners).

GAZEBO TALK (K.G. Likith Appu) jumped awkwardly inwards and inconvenienced SPECIAL STONE (S. Saqlain) on its inside at the start.

Jockey K.G. Likith Appu, the rider of GAZEBO TALK was fined Rs.1,000/- for shifting out and causing interference to JAI VIKRAM (Chethan Gowda) on his outside passing the 1000 Metres.

Jockey Mohammed Aliyar, the rider of UNIFIER was fined Rs.1,000/- for shifting 'in' and causing interference to FIERCE FIGHTER (Ikram Ahmed) on his inside approaching 1000 Metres.

Jockey Chethan Gowda, the rider of JAI VIKRAM was reprimanded for shifting 'in' and inconveniencing AWESOME GIRL (Tousif Khan) on his inside in the final 75 Metres of the race.

Jockey K.G. Likith Appu, the rider of GAZEBO TALK reported that he could not ride from the desired position as instructed by the trainer as his mount jumped awkwardly inwards at the start.

GAZEBO TALK (K.G. Likith Appu) sustained superficial clip injury on left achilles.

CHUL BUL RANI (H. M. Akshay) was subjected to veterinary examination but no abnormality was reported.

AWESOME GIRL (Tousif Khan) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g COMMANDPOST.

### 2<sup>nd</sup> Race: 130. The Horanadu Plate - Div. II - (About) 1200 metres. Horses rated 15 to 35 (12 Runners).

ESTELLA (Naveen Kumar. V) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr.Mahmood Khan was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

SPARKLING (S. Saqlain) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.V. Lokanath was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

BARONESS (Angad) jumped awkwardly outwards and inconvenienced PHOENIX SURPRISE (Ankit Yadav) on its outside at the start.

Jockey Shreyas Singh, the rider of STAR HOPPER was reprimanded for shifting 'in' and tightening QUICK SHOTS (Dharshan Antony.B) on his inside passing the 1000 Metres.

Jockey Dharshan Antony.B, the rider of QUICK SHOTS was fined Rs.1,000/- for coming 'in' and causing interference to AEROSPEED (H. M. Akshay) on his inside, whereby ARROGANCE (S. Hussain) which was travelling directly behind had to be checked by its rider passing the 700 Metres.

Jockey S. Saqlain, the rider of SPARKLING was fined Rs.1,000/- for shifting out and taking out LIFEISAMIRACLE (Arvind Kumar. N) on his outside approaching 600 Metres.

BARONESS (Angad) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b c DECORUM.

### 3<sup>rd</sup> Race: 131. The Planetarium Plate - (About) 1200 metres. Horses rated 30 to 50, 5 years old and over (12 Runners).

Jockey Dharshan Antony .B, the rider of MR HUMBLE was fined Rs.3,000/- for not making sufficient effort on his mount during the race.

YERWAZAN (T. S. Jodha) ran detached in the final 200 Metres. The horse was subjected to veterinary examination. On examination, it was found to have pulled up lame on left fore. Trainer Mr. M. Rajendra Singh was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

DARAHASINI (Surya P.) ran detached in the final 200 Metres. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Pradeep Annaiah was informed to ensure better performance of his charge in future.

GYPSY (S.Mubarak) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b m SCHAFENBERG.

### 4<sup>th</sup> Race: 132. The Indian Navy Plate - (About) 1600 metres. Horses rated 45 to 65 (12 Runners).

As Jockey P.S. Chouhan could not arrive to fulfill his riding engagement due to the reasons beyond his control. Permission was granted to trainer Mr. Faraz Arshad to declare Jockey Neeraj Rawal to ride KARADENIZ in place of the declared rider.

SET TO WIN (S. Sunil) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Sharat Kumar was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Angad, the rider of ALEXANDRE DUMAS was fined Rs.3,000/- for coming 'in' and causing interference to EXCELLENT SORRENTO (Naveen Kumar. V), which in turned passed it onto CRACK OF DAWN (P. Trevor), whereby CRACK OF DAWN brushed the rails on his inside passing the 1100 Metres.

It was observed that SET TO WIN (S. Sunil) did not get a clear run between the 250 Metres and 150 Metres.

THE STRENGTH (Arvind Kumar. N) ran detached from the field. Trainer Mr. Sharat Kumar was informed to ensure better performance of his charge in future.

Jockey A. Sandesh, the rider of FIRST IMPRESSION was fined Rs.3,000/- for the excessive use of whip on his mount during the race (1st infringement).

It was reported after the race that EXCELLENT SORRENTO (Naveen Kumar. V) burst its blood vessels. Trainer Mr.Dheeraj.V was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was reported after the race that ALBERETTA (R. Vaibhav) burst its blood vessels. Trainer Mr.Irfan Ghatala was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

CRACK OF DAWN (P. Trevor) was subjected to veterinary examination. On examination, it was found to have sustained superficial clip injury on outside left hind cannon.

Routine Sample was taken for analysis from the winner dk b m HOKKAIDO.

### 5<sup>th</sup> Race: 133. The Stewards Trophy - (About) 1400 metres. Horses rated 75 and above (6 Runners).

NORTHERN ALLIANCE (Arul J.H) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Neil B Devaney was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

SAINT PETERSBURG (Shreyas Singh) jumped awkwardly inwards.

COLONEL HARTY (Arshad Alam) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b m ABIRA.

### 6<sup>th</sup> Race: 134. The Sherlock Bangalore Juvenile Million (Grade III) - (About) 1400 metres. 3 years old only (foaled in 2018) (9 Runners).

Permission was granted to trainer Mr. Pradeep Annaiah to declare Jockey S. Zervan to ride MAGELLAN in place of the declared rider P.S. Chouhan.

It was observed that Jockey P. Trevor, the rider of SCINTILLATING LASS had to steady his mount to avoid striking the front runner AHERNE (Arshad Alam) approaching 300 Metres.

SCRUPLES (Suraj Narredu) was impounded for veterinary examination but no abnormality was reported.

Surprise sample was taken for analysis from dk b f SCRUPLES.

Compulsory urine and blood samples were taken for analysis from the following I,II & III placed horses viz:

b g COOL RIDER I b f PECANWOOD II b c STOCKBRIDGE III

### 7<sup>th</sup> Race: 135. The Kedarnath Plate - (About) 1600 metres. Horses rated 15 to 35 (11 Runners).

Permission was granted to trainer Mr. Pradeep Annaiah to declare Jockey Neeraj Rawal to ride RAINBOW RISING in place of the declared rider P.S. Chouhan.

Jockey V.R.Jagadeesh replaced the indisposed Jockey Y.S. Srinath on NICHE CANNABIS.

MAX MUELLER (Chetan Kalay S.) was extremely fractious, while being loaded, broke the front barrier and dislodged the rider, whereby he was injured. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order.

SKIATHOS (Rayan Ahmed R.) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.S. Dominic was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

AL BURAAQ (Arshad Alam) took a fly jump at the start.

Routine Sample was taken for analysis from the winner b c REDOUBTABLE.

### 8<sup>th</sup> Race: 136. The Horanadu Plate - Div. I - (About) 1200 metres. Horses rated 15 to 35 (12 Runners).

GRIFFIN (Salman Khan) jumped awkwardly outwards and inconvenienced DREAMS AHEAD (Aakash Chavan) on its outside at the start.

Jockey Naveen Kumar. V, the rider of LOVELY SIERRA reported that his mount was hanging out after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Azhar Ali was informed to take appropriate corrective measures before accepting with it again.

SWEET MAGNOLIA (K.G. Likith Appu) was subjected to veterinary examination but no abnormality was reported.

LIGHTNING CHARLIE (Dharshan Antony.B) was subjected to veterinary examination but no abnormality was reported.

GALACTICAL (Arul J.H) was subjected to veterinary examination but no abnormality was reported.

CHAIN OF THOUGHTS (Arvind Kumar. N) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g GRIFFIN.

## ADDITIONAL REPORTS BANGALORE WINTER MEETING 2020-21 TENTH DAY, SATURDAY, 2<sup>ND</sup> JANUARY, 2021

#### (A)

### Race: 77. The New Year Cup (Grade III) - (About) 1400 metres. 4 years old and over at the time of starting.

The Stipendiary Stewards reported Trainer Mr. Darius R. Byramji to the Stewards for contravention of Calendar Notification under the heading "PUNISHMENT TO TRAINERS BY STIPENDIARY STEWARDS /STEWARDS (Under Clause -8)" in respect of his charge MULTIFACETED. In that his charge MULTIFACETED ran in a inconsistent manner and exhibiting reversal of form wherein, it won in Race. 77 i.e., The New Year Cup (Grade – III) - (About) 1400 Metres, 4 Years old and over at the time of starting run on 2nd January, 2021 as compared to its previous runs in Race No. 30 and Race No.6 of the Bangalore Winter Meeting 2020-21 when ridden by Jockey Suraj Narredu it ran unplaced.

The Stewards held an enquiry on 12<sup>th</sup> February, 2021 and examined Trainer Mr. Darius R. Byramji.

After deliberations, the Stewards decided to fine Trainer Mr. Darius R. Byramji a sum of Rs.25,000/-for violating the BTC Calendar Notification under the heading "PUNISHMENT TO TRAINERS BY STIPENDIARY STEWARDS /STEWARDS (Under Clause -8)" in respect of his charge MULTIFACETED.

#### <u>(B)</u>

#### FIFTEENTH DAY, FRIDAY, 5<sup>TH</sup> FEBRUARY, 2021

### Race: 118. The Stayers Trial Stakes - (About) 2400 metres. 4 years old and over at the time of starting.

The Stipendiary Stewards reported Jockey Suraj Narredu, the rider of SALAZAAR, to the Stewards for alleged contravention of Rule No. 159 (a) & (b) of the BTC Rules of Racing in the above race in that:

The Stewards held an enquiry on 19<sup>th</sup> of February, 2021 and examined Jockey Suraj Narredu and Trainer Mr. Irfan Ghatala.

The Stewards after considering the submissions made by Jockey Suraj Narredu and Trainer Mr. Irfan Ghatala, after viewing the CCTV replay of the race, acting on their observations and after detailed deliberations, they decided to:

- (a) Note the explanations tendered by Trainer Mr. Irfan Ghatala;
- (b) Treat Jockey Suraj Narredu as a disqualified person from 5<sup>th</sup> March, 2021 to 30<sup>th</sup> April, 2021. Should he apply for a Jockey's licence for the period 1<sup>st</sup> May, 2021 to 30<sup>th</sup> April, 2022. It shall be considered only after 5<sup>th</sup> July, 2021 and fined him a sum of Rs.50,000/- for contravention of Rule No. 159 (a) & (b) of the BTC Rules of Racing (not permitted to ride work).

#### <u>(c)</u>

The Stewards at their meeting held on 12<sup>th</sup> February, 2021 considered the compliant (e-mail dated 8<sup>th</sup> February, 2021) by Dr. R. Senthil Kumar, Senior Veterinary Officer with regards to Handover and Takeover Form on dk b g LYCURGUS.

The Stewards examined Trainer Mr. Sriram Komandur. After deliberations, they decided to fine Trainer Mr. Sriram Komandur a sum of Rs.5,000/- for his negligence in discharge of his duties as a Trainer. Thereby, contravening Rule No. 114 (b) (i) of the B.T.C. Rules of Racing.

#### (D)

The Stewards at their meeting held on 12<sup>th</sup> February, 2021 considered the compliant (e-mail dated 8<sup>th</sup> February, 2021) by Dr. R. Senthil Kumar, Senior Veterinary Officer with regards to Handover and Takeover Form on dk b g LYCURGUS.

The Stewards examined Trainer Mr. Sharat Kumar. After deliberations, they decided to fine Trainer Mr. Sharat Kumar a sum of Rs.5,000/- for his negligence in discharge of his duties as a Trainer. Thereby, contravening Rule No. 114 (b) (i) of the B.T.C. Rules of Racing.
