RACING INCIDENTS

(155 - 163)

GOING : Good

PENETROMETER READING: 3.9 Cms.

RAILING POSITION: Railing fixed at its original position.

1st Race: 155. The Good-Bye Plate - (About) 1400 metres. Horses rated 00 to 20 (12 Runners).

Jockey Darshan R.N, the rider of SIZZLER reported that he did not get a clear run due to closely packed field between the 200 Metres and 150 Metres.

It was observed that Jockey G Sai Vamshi, the rider of REVAN STAR lost his left rein passing the 150 Metres which he regained within a few strides.

Jockey G Sai Vamshi, the rider of REVAN STAR was fined Rs.3,000/- for the excessive use of whip on his mount during the race (1st infringement).

Routine Sample was taken for analysis from the winner ch m AZEEMKI PRINCESS.

2nd Race: 156. The Champion Jockey Trophy - Div. II - (About) 1200 metres. Horses rated 15 to 35, 4 years old only (12 Runners).

Jockey P. Trevor replaced the indisposed Jockey S. John on OCEAN DUNES.

ORLEANS (Akshay Kumar) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.S.S. Attaollahi was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

SILENT TRIGGAR (Darshan R.N) jumped awkwardly outwards onto PERFECT HALO (Vinod Shinde) at the start.

Jockey R. Vaibhav, the rider of SPARKLING reported that his mount accidentally slipped passing the 500 Metres. The horse was subjected to veterinary examination but no abnormality was reported.

It was reported after the race that PRERANA (D. Patel) burst its blood vessels. Trainer Mr.M. Rajendra Singh was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was reported after the race that SILENT TRIGGAR (Darshan R.N) pulled up lame on right fore. Trainer Mr.Dheeraj.V was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner ch f RULE OF ENGAGEMENT.

3rd Race: 157. The Premium Spirit Plate - (About) 1400 metres. Maiden Horses 3 years old only. (11 Runners).

Trainer Mr. Irfan Ghatala was fined Rs.10,000/- for having accepting his charge IMPERIAL BLUE to run in the above race when it was under treatment. Subsequently, permission was granted him to withdraw it from the above race.

Jockey Y.S. Srinath, the rider of GULFSTREAM PARK was fined Rs.2,000/- for not drawing the declared weight on the scales. Subsequently, permission was granted to trainer Mr. Neil Darashah (to deputizing on behalf of Trainer Mr. S. Padmanabhan) to declare Jockey S. Zervan to ride GULFSTREAM PARK in place of the declared rider.

TWILIGHT FAME (K. Sai Kiran) jumped awkwardly outwards and inconvenienced WAR CHIEFTAIN (Akshay Kumar) and OHANNA (Ryan Marshall) on its outside at the start.

Routine Sample was taken for analysis from the winner b f OWN LEGACY.

4th Race: 158. The Champion Trainer Trophy - (About) 1600 metres. Horses rated 15 to 35, 4 years old only (10 Runners).

Permission was granted to Trainer Mr.S.S. Attaollahi to withdraw ARLETTE (Akshay Kumar) on veterinary grounds as it was found to have urticaria. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey P. Trevor, the rider of ALMANACH reported that his mount was running green in the final 300 Metres.

It was observed that the saddle of RAINBOW RISING had shifted back after entering the straight. After due examination of the equipment, trainer Mr. Pradeep Annaiah was fined Rs. 3,000/- for faulty saddling.

Jockey G Sai Vamshi, the rider of RAINBOW RISING reported that his mount was not galloping fluently in the last 200 Metres. The horse was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b f ROYAL BLOSSOM.

5th Race: 159. The Leading Stud Trophy - (About) 1400 metres. Horses rated 30 to 50 (11 Runners).

MOUNTAIN LION (Y. S. Srinath) dropped the rider on the way to the starting gates. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order. An enquiry is being held into the incident.

GRIFFIN (Salman Khan) jumped awkwardly inwards and inconvenienced SAINTHOOD (Surya P.) at the start.

Jockey Surya P., the rider of SAINTHOOD was reprimanded for shifting 'in' and inconveniencing TWINKLE FEET (Arshad Alam) on his inside passing the 1000 Metres.

Jockey Darshan R.N, the rider of CLASSIC CHARM reported that his mount was hanging 'in' after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr.S. Ganapathy was informed to take appropriate corrective measures before accepting with it again.

Routine Sample was taken for analysis from the winner b g GRIFFIN.

6th Race: 160. The Leading Owner Trophy - (About) 1400 metres. Horses rated 60 and above (9 Runners).

Trainer Mr. Sharat Kumar was fined Rs.5,000/- for not obtaining prior permission for his charge SET TO WIN (P. Sai Kumar) to race without HOOD. Subsequently, permission was granted to him to run his charge without a HOOD.

An enquiry is being held into the relatively improved performance of MALWA, trained by Mr. S.S. Attaollahi and ridden by Jockey Akshay Kumar in the above race as compared to its previous run in Race No. 125 i.e., The G. Krishnappa Memorial Trophy (about) 1200 Metres, Horses rated 60 and above run on 13th February, 2021 where it ran unplaced.

Routine Sample was taken for analysis from the winner b g MALWA.

7th Race: 161. The Governor's Trophy - (About) 1600 metres. 3-year-old horses (foaled in 2018) (5 Runners).

Permission was granted to Trainer Mr.S.S. Attaollahi to withdraw TERESITA on veterinary grounds as it was found to be lame on left fore. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Trainer Mr.Rakesh was fined Rs.5,000/- for discrepancy in shoeing in respect of his charge CHASHNI.

Trainer Mr. R.H.Sequeira was fined Rs.5,000/- for discrepancy in shoeing in respect of his charge SOLOIST.

SILVARIUS (Antony Raj S.) after jumping out slightly swerved towards the left. In view of its behaviour, Trainer Mr.Arjun Mangalorkar was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Routine Sample was taken for analysis from the winner ch f SCINTILLATING LASS.

8th Race: 162. The Champion Jockey Trophy - Div. I - (About) 1200 metres. Horses rated 15 to 35, 4 years old only (11 Runners).

Jockey Akshay Kumar replaced the indisposed Jockey S. John on FLAMINGO ROAD.

BELLI DEEPA (A.R.Pradeep) was examined by the Club's Veterinary Officer and was found to have sustained bleeding cut injury over poll and bruise over right knee. Under the circumstances, it was permitted to be withdrawn on veterinary grounds. Trainer Mr. Pradeep Annaiah was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Ravi R., the rider of JAVA PENINSULA was fined Rs.2,000/- for not exercising sufficient control on his mount, whereby he allowed it to drift out from 900 Metres till about 700 Metres. In the process he inconvenienced CODE OF HONOUR (P. Trevor).

Routine Sample was taken for analysis from the winner b f MYSTIC EYE.

9th Race: 163. The Seabiscuit Salver - (About) 1400 metres. Horses rated 15 to 35, 5 years old and over (Whips not allowed) (12 Runners).

ZHU ZHU ZEST (Chandrashekar) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.V. Lokanath was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

KINGSFIELD (Salman Khan) jumped awkwardly outwards onto SHIVALIK KISS (L. A. Rozario) at the start.

Jockey Arul J.H, the rider of MARCO POLO was fined Rs.1,000/- for shifting out and causing interference to REVERENCE (Dharshan Antony.B) on his outside passing the 350 Metres.

It was reported after the race that SHIVALIK KISS (L. A. Rozario) burst its blood vessels. Trainer Mr.Azhar Ali was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner ch h STRIKING MEMORY.

Permission was granted to trainers M/s. S. Narredu and Neil Darashah to deputize on behalf of trainers M/s. Rajesh Narredu and S. Padmanabhan who were unable to attend the races.

Race: 117. The S.V.Subramaniam Memorial Trophy - (About) 1600 metres. Horses rated 60 and above.

The Stipendiary Stewards reported Jockey P. Trevor, the rider of ALEXANDRE DUMAS for Unsatisfactory Riding [Rule No. 161 (ii) of the BTC Rules of Racing] in the above race. The Stewards held an enquiry on 8th March, 2021, examined Trainer Mr. Narayana Gowda. V and Jockey P. Trevor.

After deliberations, the Stewards decided to:

- (a) Note the explanations tendered by Trainer Mr. Narayana Gowda. V; and
- (b) Fine Jockey P. Trevor a sum of Rs. 20,000/- for Unsatisfactory Riding [Rule No. 161 (ii) of the BTC Rules of Racing] on his mount ALEXANDRE DUMAS.
