**RACING INCIDENTS**  
**(164 - 172)**

**GOING: Good**

**PENETROMETER READING: 3.6 Cms.**

**RAILING POSITION: Railing fixed at its original position.**

**1<sup>st</sup> Race: 164. The Salute Her Plate - (About) 1200 metres. Maiden Horses 3 years old only. (11 Runners).**

DEVILS MAGIC (Arul J.H) was extremely fractious, reared up and flipped over at the starting gates. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order.

Jockey P. Trevor, the rider of MUIRFIELD reported that his mount was changing legs during the race. The horse was subjected to veterinary examination but no abnormality was reported.

Jockey Akshay Kumar, the rider of IMPERIAL BLUE was fined Rs.1,000/- for shifting 'in' and tightening THE OMEGA MAN (D. Patel) on his inside passing the 650 Metres.

Routine Sample was taken for analysis from the winner b g IMPERIAL BLUE.

**2<sup>nd</sup> Race: 165. The World Sparrow Day Plate - Div. II - (About) 1200 metres. Horses rated 00 to 20, 5 years old and over (12 Runners).**

Jockey M. Madhu Babu, the rider of SPECIAL STONE was fined Rs.5,000/- for repeatedly checking his mount between the 950 Metres till about 800 Metres, whereby PHOENIX REACHED (T. S. Jodha) and ULTIMATE POWER (Darshan R.N) had to check their respective mounts and fall back passing the 850 Metres.

SPECIAL STONE (M. Madhu Babu) was subjected to veterinary examination. On examination, it was found to have superficial gum injury.

Trainer Mr. Sharat Kumar was Rs.10,000/- for the inconsistent pattern of running and reversal of form of his charge ALTAIR (K. Sai Kiran) in the above race as compared to its previous run in Race No. 155 i.e., The Good-Bye Plate - (About) 1400 Metres. Horses rated 00 to 20 run on 13th March, 2021, where it ran unplaced.

Routine Sample was taken for analysis from the winner dk b r ALTAIR.

**3<sup>rd</sup> Race: 166. The Divine Light Plate - (About) 1400 metres. Horses rated 15 to 35, 4 years old only (12 Runners).**

Jockey Arvind Kumar. N, the rider of BLAZING GOLD reported that he lost his left rein passing the 300 Metres, which he regained it within a few strides.

ROCK AND DANCE (K. Raja Rao) ran detached from the field. Trainer Mr. S. Dominic was informed to ensure better performance of his charge in future.

Jockey H. M. Akshay, the rider of GOLDEN MEMORY reported that he accidentally lost his whip passing the 250 Metres. An enquiry is being held into the incident.

Jockey P. Sai Kumar, the rider of FLAMING ORANGE was fined Rs.1,000/- for shifting out and taking out GOLDEN MEMORY (H. M. Akshay) on his outside passing the 150 Metres.

Jockey H. M. Akshay, the rider of GOLDEN MEMORY was fined Rs.1,000/- for shifting 'in' and bumping FLAMING ORANGE (P. Sai Kumar) on his inside in the final 50 Metres.

Routine Sample was taken for analysis from the winner b g FOUR WHEEL DRIVE.

**4<sup>th</sup> Race: 167. The Set Aight Plate - Div. II - (About) 1200 metres. Horses rated 15 to 35, 5 years old and over (Whips not allowed) (11 Runners).**

Permission was granted to Trainer Mr. Sharat Kumar to withdraw GOLD GRAY on veterinary grounds as it was found to be trotting lame on right fore tendinitis. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

ESTELLA (Arul J.H) reared up as the gates opened and lost many lengths at the start. In view of its behaviour, Trainer Mr. S. Inayathulla (deputizing on behalf of Trainer Mr. Mahmood Khan) was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

PARADISO (Siddaraju.P) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Imtiaz Khan was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

APOLLO BAY (A. Ashhad Asbar) jumped awkwardly outwards brushing the gates at the start.

Jockey Ankit Yadav, the rider of CHUL BUL RANI was fined Rs.1,000/- for shifting 'in' and causing interference to COMMANDPOST (Angad) on his inside passing the 900 Metres.

Jockey Chethan Gowda, the rider of CAMELEONS IMAGE was fined Rs.3,000/- for the improper practice of hitting the horse with his hands during the race.

Trainer Mr. Neil Darashah was Rs.10,000/- for the inconsistent pattern of running and reversal of form of his charge CAMELEONS IMAGE (Chethan Gowda) in the above race as compared to its previous run in Race No. 154 i.e., The Shivanasamudra Plate – Div. I (About) 1200 Metres. Horses rated 15 to 35, 5 years old and over, run on 6th March, 2021, where it ran unplaced.

Routine Sample was taken for analysis from the winner dk b m CAMELEONS IMAGE.

**5<sup>th</sup> Race: 168. The Star Contender Plate - (About) 1200 metres. Horses rated 30 to 50 (12 Runners).**

Routine Sample was taken for analysis from the winner b f WATCHMYSTARS.

**6<sup>th</sup> Race: 169. The Serjeant At Arms Plate - (About) 1800 metres. Horses rated 45 to 65 (10 Runners).**

It was observed that Jockey Arul J.H, the rider of GREEN CHANNEL accidentally struck the whip of Jockey Y. S. Srinath, the rider of MOUNTAIN LION, whereby Jockey Y.S. Srinath's whip fell off passing the 200 Metres.

Routine Sample was taken for analysis from the winner b m GREEN CHANNEL.

**7<sup>th</sup> Race: 170. The Brigadier Gerard Plate - (About) 1200 metres. Horses rated 60 and above (10 Runners).**

PSYCHIC WARRIOR (H. M. Akshay) reared up at the gates whereby the Jockey was injured. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order.

MANCHESTER (Rayan Ahmed R.) was extremely fractious at the gates and refused to be stalled. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order.

Jockey Angad, the rider of DEPTH CHARGE was fined Rs.5,000/- for coming 'in' and causing severe interference to CUBAN PETE (S. Zervan) on his inside approaching 1000 Metres.

Jockey L. A. Rozario, the rider of SILVER IKON was fined Rs.2,000/- for shifting 'in' and causing interference to DEPTH CHARGE (Angad) on his inside passing the 900 Metres.

It was observed that ALPHA (Nazerul Alam) could not get a clear run between the 200 Metres till about 100 Metres.

Routine Sample was taken for analysis from the winner ch g CUBAN PETE.

**8<sup>th</sup> Race: 171. The Set Aight Plate - Div. I - (About) 1200 metres. Horses rated 15 to 35, 5 years old and over (Whips not allowed) (12 Runners).**

Permission was granted to trainer Mr. Neil B Devaney to substitute Jockey K. Sai Kiran to ride DEFINITIVE in place of the declared rider Jockey A. Ashhad Asbar.

Permission was granted to trainer Mr. S. Dominic to substitute Jockey Arul J.H to ride HABANERO in place of the declared rider Jockey H.M. Akshay.

SUN SPLASH (G Sai Vamshi) jumped awkwardly outwards onto RAW GOLD (Salman Khan) at the start.

Jockey S. John, the rider of STAR AND GARTER was fined Rs.1,000/- for coming 'in' and tightening CELESTIAL HIGHWAY (Nazerul Alam) on his inside approaching 700 Metres.

Routine Sample was taken for analysis from the winner b g DEFINITIVE.

**9<sup>th</sup> Race: 172. The World Sparrow Day Plate - Div. I - (About) 1200 metres. Horses rated 00 to 20, 5 years old and over (11 Runners).**

Permission was granted to trainer Mr. Dheeraj.V to substitute Jockey Arul J.H to ride NOSTRADAMUS in place of the declared rider Jockey H.M. Akshay.

It was observed that the left fore shoe of LIFEISAMIRACLE (Naveen M.) had come off on the way to the saddling enclosure. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order.

BAHURUPAH (S. Saqlain) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Warren Singh was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Routine Sample was taken for analysis from the winner b g NOSTRADAMUS.

**Race: 95. The Chamundi Hill Plate - (About) 1600 metres. Horses rated 15 to 35.**

The Stipendiary Stewards reported Jockey P. Trevor, the rider of REDOUBTABLE for Injudicious Riding [Rule No. 161 (ii) of the BTC Rules of Racing] in the above race. The Stewards held an enquiry on 15<sup>th</sup> March, 2021, examined Trainer Mr. Prasanna Kumar.P and Jockey P. Trevor.

After deliberations, the Stewards decided that:

- (a) Note the explanations tendered by Trainer Mr. Prasanna Kumar.P; and
- (b) Should Jockey P. Trevor apply for a Jockey's licence for the year 2021-22 and if granted a Jockey's Licence, the same shall remain suspended for the first four race days of Bangalore Summer Meeting 2021 and fine him a sum of Rs.25,000/- for Injudicious Riding [Rule No. 161 (ii) of the BTC Rules of Racing] on his mount REDOUBTABLE (permitted to ride work).
- (c) He was informed of his right to appeal.
