#### BANGALORE WINTER MEETING 2021-22 SEVENTEENTH DAY, TUESDAY, 11<sup>TH</sup> JANUARY, 2022

# (Postponed from Saturday, 8<sup>th</sup> January, 2022) RACING INCIDENTS (120 - 126)

**GOING:** Good

PENETROMETER READING: 3.6 Cms.

RAILING POSITION: Railing fixed at average width of 4.5 Meters from

1600 Meters to winning post from its original position.

### 1<sup>st</sup> Race: 120. The Snow Bird Plate - Div. II - (About) 1100 metres. Horses rated 20 to 45 (10 Runners).

SUPER KIND (M. Mark) jumped awkwardly outwards and inconvenienced TWIN FLAME (Rajesh Kumar M) soon after the start.

It was observed that Jockey M. Mark, the rider of SUPER KIND had to steady his mount approaching 1000 Metres due to the crowding of the field.

Jockey V.R.Jagadeesh, the rider of RAVEN ROCK was fined Rs.1,000/- for shifting 'in' and causing interference to CAPRI GIRL (D'nuSingh Deora) on his inside passing the 700 Metres.

Jockey Shamaz Shareef, the rider of FOVEAL VISION was fined Rs.3,000/for not making any effort to improve his position between the 1000 Metres till about the 400 Metres.

Jockey M. Mark, the rider of SUPER KIND was reprimanded for dropping hands before passing the winning post.

An enquiry is being held into the relatively improved performance of AHERNE, trained by Mr. Imtiaz Khan and ridden by Jockey Darshan R.N in the above race as compared to its previous run in Race No.97 i.e., The Invasor Plate (about) 1100 Metres, Maiden horses 3 years old only, run on 18th December, 2021 where it ran unplaced.

Routine Sample was taken for analysis from the winner b g AHERNE.

### 2<sup>nd</sup> Race: 121. The Winged Foot Plate - (About) 1800 metres. Horses rated 00 to 25 (12 Runners).

SKIATHOS (Darshan R.N) planted, lost many lengths and did not raise a fluent gallop till the 1700 Metres. In view of the repeated behaviour, Trainer Mr.S. Dominic was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least two Mock Races.

Jockey P. Trevor, the rider of SECRET OF LIFE was fined Rs.3,000/- for the excessive use of whip on his mount during the race (1st infringement).

An enquiry is being held into the running and riding of SCINTILLA, trained by Mr. S.S. Attaollahi and ridden by Jockey Shreyas Singh. Sin the above race.

NICHE CANNABIS (P. Mani) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner dk b f PRINCESS GLORIA.

## 3<sup>rd</sup> Race: 122. The S.V. Subramaniam Memorial Trophy - (About) 1200 metres. Horses rated 40 to 65, 5 years old and over (10 Runners).

Permission was granted to Trainer Mr.Pradeep Annaiah to withdraw ACEROS (D'nuSingh Deora) on veterinary grounds as it was found to be suffering from fever. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Md.Akram, the rider of STARRY WIND reported that his mount was not galloping fluently at the start and was hanging 'in' after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported.

It was observed that ALBERETTA (L. Alex Rozario) could not get a clear run between the 350 Metres and 300 Metres due to the crowding of the field.

An enquiry is being held into the running and riding of STARRY WIND, Trained by Mr. Mahmood Khan and ridden by Jockey Md.Akram in the above race.

Routine Sample was taken for analysis from the winner ch m RECALL OF YOU.

### 4<sup>th</sup> Race: 123. The New Year Cup (Grade III) - (About) 1400 metres. 4 years old and over at the time of starting. (4 Runners).

It was reported after the race that HUKUM (Y. S. Srinath) burst its blood vessels. Trainer Mr. Faraz Arshad was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Compulsory urine and blood samples were taken for analysis from the following I,II & III placed horses viz:

b m SHESMYSCRIPT II

b m WATCHMYSTARS III

### 5<sup>th</sup> Race: 124. The Bangalore Oaks (Grade II) - (About) 2400 metres. 4-year-old Indian Fillies (foaled in 2018) (9 Runners).

Trainer Mr. Vijay Singh was fined Rs.10,000/- by the Stewards for not declaring his charge AMAZONIA to start after having accepted with it to run in the above race.

As Jockey Prashant P. Dhebe was certified medically unfit to ride. Permission was granted to trainer Mr. P. Shroff to substitute Jockey Akshay Kumar to ride REVOLUTION in place of the declared rider.

It was reported after the race that PECANWOOD (Suraj Narredu) burst its blood vessels. Trainer Mr.Arjun Mangalorkar was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Compulsory urine and blood samples were taken for analysis from the following I, II & III placed horses viz:

#### 6th Race: 125. The Indira Sagar Plate - (About) 1800 metres. Horses rated 20 to 45 (6 Runners).

SECRET SOURCE (S. Hussain) ran detached from the field. The horse was subjected to veterinary examination. On examination, it was found to have sharp molars. Hence, Trainer Mr. S. Narredu was fined Rs.3,000/- for his negligence (1st infringement).

Routine Sample was taken for analysis from the winner b g PRINCE ABIR.

#### 7th Race: 126. The Snow Bird Plate - Div. I - (About) 1100 metres. Horses rated 20 to 45 (10 Runners).

Jockey Kiran Rai P replaced the indisposed Jockey Nazerul Alam on LIVISILLA.

Jockey Y. S. Srinath, the rider of GALACTICAL was fined Rs.1,000/- for shifting 'in' and tightening the horses on his inside viz; MILLBROOK (Antony Raj S.) and SHANAEY (Vishal N Bunde) passing the 1000 Metres.

Jockey Antony Raj S., the rider of MILLBROOK reported that his mount was hanging out from 900 Metres. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Arjun Mangalorkar was informed to take appropriate corrective measures before accepting with it again.

Routine Sample was taken for analysis from the winner dk b h GALACTICAL.

Permission was granted to trainers M/s. Kishan Thomas, S.S. Attaollahi, S. Dominic and S. Narredu to deputize on behalf of trainers M/s. Prasanna Kumar, P. Shroff, Neil Darashah and Rajesh Narredu who were unable to attend the races.
