**(9-16)**

**GOING : GOOD**

**PENETROMETER READING: 4.2 Cms.**

**RAILING POSITION: Railing fixed at average width of 4.0 Meters from 1600 Meters to winning post from its original position.**

**1<sup>st</sup> Race: 9. The Ganga Plate - Div. II - (About) 1600 metres. Horses rated 00 to 25 (11 Runners).**

MASTER OF SUCCESS (A.R.Pradeep) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Azhar Ali was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

CAPITAL GAIN (Nazerul Alam) jumped out awkwardly and inconvenienced AMALFI SUNRISE (Arshad Alam) at the start.

Jockey Arul J.H, the rider of TENARIS reported that his saddle shifted forward passing the 1400 Metres as such he could not offer any assistance in the final 300 Metres. After due examination of the equipment, Trainer Mr. Pradeep Annaiah was fined Rs.3,000/- for faulty saddling of his charge.

Jockey Nazerul Alam, the rider of CAPITAL GAIN was fined Rs.1,000/- for shifting 'in' and bumping CAPABLE (Naveen M.) on his inside passing the 100 Metres.

Jockey Naveen.M, the rider of CAPABLE was fined Rs.2,000/- for not wearing his goggles during the race

TENARIS (Arul J.H) was subjected to veterinary examination but no abnormality was reported.

An enquiry is being held into the running and riding of CAPABLE, trained by Mr. Sharat Kumar and ridden by Jockey Naveen .M in the above race.

Routine Sample was taken for analysis from the winner dk b f AMALFI SUNRISE.

**2<sup>nd</sup> Race: 10. The Jog Falls Plate - Div. III - (About) 1200 metres. Horses rated 20 to 45 (Whips not allowed) (12 Runners).**

PORT OF BEAUTY (A.R.Pradeep) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Azhar Ali was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Routine Sample was taken for analysis from the winner b g GARAMOND.

**3<sup>rd</sup> Race: 11. The Tetrarch Plate - (About) 1200 metres. Maiden Horses 3 years old only. (11 Runners).**

THE INHERITOR (M. Mark) was extremely fractious, reared up inside the stalls and on immediate examination by the Club's Veterinary Officer was found to have abrasion on right hip and right hind cannon. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr.Sharat Kumar was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

SUPER RUFFIAN (A.Ashhad Asbar) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Neil B Devaney was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

BELVEDERE (Nazerul Alam) sustained bleeding cut injury on left hind pastern.

MEGA SUCCESS (Vivek) sustained abrasion on right fore cannon.

Routine Sample was taken for analysis from the winner b g ETOSHA.

**4<sup>th</sup> Race: 12. The Jog Falls Plate - Div. II - (About) 1200 metres. Horses rated 20 to 45 (Whips not allowed) (11 Runners).**

Permission was granted to Trainer Mr. Sriram Komandur to withdraw JOKSHAN (A.Ashhad Asbar) on veterinary grounds as it was found to be lame on right fore due to capped elbow. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Md. Habeeb, the rider of ARTIANA was fined Rs.2,000/- for not wearing his goggles during the race.

It was reported after the race that AMAZONITE (D'nuSingh Deora) burst its blood vessels. Trainer Mr.M. Rajendra Singh was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

PALM READER (P. Mani) sustained clip injury on left hind fetlock.

THE PREACHER (A.R.Pradeep) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b f BALTIMORE.

**5<sup>th</sup> Race: 13. The Vidhana Soudha Trophy - (About) 1400 metres. Maiden Horses 3 years old only. (12 Runners).**

Jockey Yash Narredu, the rider of A STAR IS BORN was fined Rs.1,000/- for shifting 'in' and causing interference to DOUGLAS (Vinod Shinde) on his inside passing the 250 Metres.

Routine Sample was taken for analysis from the winner b c A STAR IS BORN.

**6<sup>th</sup> Race: 14. The Rajyotsava Trophy (Grade III) - (About) 1400 metres. 3 years old and over (6 Runners).**

Compulsory urine and blood samples were taken for analysis from the following I,II & III placed horses viz:

**7<sup>th</sup> Race: 15. The Jog Falls Plate - Div. I - (About) 1200 metres. Horses rated 20 to 45 (Whips not allowed) (12 Runners).**

It was observed that Jockey A.Imran Khan, the rider of DRUSILLA had to steady his mount to avoid striking the front runners, in the process he shifted out and bumped ULTIMATE STRIKER (Md. Habeeb) passing the 700 Metres.

It was observed that DARK VISION (Kiran Rai P) accidentally stumbled passing the 600 Metres.

MICHIGAN MELODY (Vishal N Bunde) sustained bleeding cut injury on right hind pastern.

PERFECT RENDITION (D'nuSingh Deora) sustained clip injury over right hind pastern and fetlock.

It was reported after the race that DARK VISION (Kiran Rai P) pulled up lame on right fore and also sustained bleeding cut injury over right hind pastern. Trainer Mr. Aravind G. was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b m SCHAFENBERG.

**8<sup>th</sup> Race: 16. The Ganga Plate - Div. I - (About) 1600 metres. Horses rated 00 to 25 (9 Runners).**

MARCO POLO was not declare to start in the above race.

Permission was granted to Trainer Mr. Neil Darashah to withdraw MY VISION (Nazerul Alam) on veterinary grounds as it was found to be sore on left fore hoof. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

TOP NEWS (M. Mark) was examined at the saddling enclosure and was found to be trotting lame on left fore. Under the circumstances, it was permitted to be withdrawn on veterinary grounds. Trainer Mr. S. Dominic was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was observed that Cross Nose band of COMMANDPOST (Rajesh Kumar M) came off soon after the start. After due examination of the equipment, Trainer Mr. Narayana Gowda V. was fined Rs.2,000/- for not fastening the cross nose band properly on his charge.

Routine Sample was taken for analysis from the winner b f KENSINGTON COURT.
