**RACING INCIDENTS**  
**(1-8)**

**GOING : Good**

**PENETROMETER READING: 3.8 Cms.**

**RAILING POSITION: Railing fixed at average width of 4.0 Meters from 1600 Meters to winning post from its original position.**

**1<sup>st</sup> Race: 1. The Inauguration Plate - Div. II - (About) 1200 metres. Horses rated 00 to 25, 5 years old and over (11 Runners).**

Trainer Mr. Neil Darashah was fined Rs.10,000/- for having accepting his charge AKASI (K.G. Likith Appu) to run in the above race when it was under treatment. Subsequently, permission was granted him to withdraw it from the above race.

It was observed that Jockey Shreyas Singh S, the rider of ICONIC PRINCESS had to steady his mount approaching 900 Metres to avoid striking the front runner CHUL BUL RANI (D. Patel).

Jockey Rajesh Kumar M, the rider of ELITE AGENT reported that his mount was hanging out after entering the straight. The horse was subjected to veterinary examination. On examination, it was found to have small bit injury on right cheek. However, Trainer Mr. Narayana Gowda V. was informed to take appropriate corrective measures before accepting with it again.

It was observed that PERFECTGOLDENERA (D'nuSingh Deora) had pulled up passing the 150 Metres. On immediate examination by the Club's Veterinary Officer, it was found to be lame on left fore. Trainer Mr. M. Rajendra Singh was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Shamaz Shareef, the rider of GAZEBO TALK was fined Rs.1,000/- for not exercising sufficient control, thereby inconveniencing ICONIC PRINCESS (Shreyas Singh S) passing the 100 Metres.

CHUL BUL RANI (D. Patel) was impounded for veterinary examination but no abnormality was reported.

An enquiry is being held into the running and riding of CHUL BUL RANI, trained by Mr. S. Inayathulla and ridden by Jockey D. Patel in the above race.

An enquiry is being held into the running and riding of LIGHT OF LOVE, trained by Mr. Faraz Arshad and ridden by Jockey A.Imran Khan in the above race.

Surprise sample was taken for analysis from b m CHUL BUL RANI.

Routine Sample was taken for analysis from the winner dk b g GAZEBO TALK.

**2<sup>nd</sup> Race: 2. The Novice Plate - (About) 1100 metres. Maiden Horses 3 years old only. (12 Runners).**

It was observed that DE VILLIERS (P. S. Chouhan) raced fiercely between the 950 Metres till about 600 Metres. The horse was subjected to veterinary examination but no abnormality was reported.

Jockey Antony Raj S., the rider of DOMINA reported that he accidentally lost his whip passing the 100 Meters.

Routine Sample was taken for analysis from the winner b g DE VILLIERS.

**3<sup>rd</sup> Race: 3. The Inauguration Plate - Div. I - (About) 1200 metres. Horses rated 00 to 25, 5 years old and over (12 Runners).**

An enquiry is being held into the running and riding of SUPER GLADIATOR, trained by Mr. Azhar Ali and ridden by Jockey Chethan Kalay S. in the above race.

SUPER GLADIATOR (Chethan Kalay .S) was impounded for veterinary examination. On examination, it was found to have burst its blood vessels (Endoscopy - Grade III). Trainer Mr. Azhar Ali was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Surprise sample was taken for analysis from b g SUPER GLADIATOR.

Routine Sample was taken for analysis from the winner dk b g MARCO POLO.

**4<sup>th</sup> Race: 4. The Vedavati Plate - Div. II - (About) 1400 metres. Horses rated 20 to 45, 4 years old and over (11 Runners).**

Permission was granted to Trainer Mr.Imtiaz Khan to withdraw TWINKLE FEET (Kiran Rai P) on veterinary grounds as it was found to be trotting lame on right fore. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Trainer Mr. Faraz Arshad was fined Rs. 2,000/- for not using Tongue Strap on his charge EXCLUSIVE MANDATE (A.Imran Khan) for which prior approval had been obtained. Subsequently, Tongue Strap was put on before horses left the paddock.

Jockey Arul J.H, the rider of ALMANACH was fined Rs.1,000/- for not maintaining a straight course, thereby inconveniencing CHRISTOPHER WREN (Arshad Alam) and FOUR WHEEL DRIVE (Akshay Kumar) in the final 150 Metres of the race.

Jockey A.Imran Khan, the rider of EXCLUSIVE MANDATE reported that his mount was not galloping fluently after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported.

An enquiry is being held into the running and riding of EXCLUSIVE MANDATE, trained by Mr. Faraz Arshad and ridden by Jockey A.Imran Khan in the above race.

Routine Sample was taken for analysis from the winner b g ALMANACH.

**5<sup>th</sup> Race: 5. The Racing Patrons Cup - (About) 1200 metres. Horses rated 40 to 65, 4 years old and over (12 Runners).**

THE STRENGTH (A.Ashhad Asbar) jumped out awkwardly.

Jockey P. S. Chouhan, the rider of WATCHMYSTARS reported that he clipped the front runner CRACK OF DAWN (Vishal N Bunde) approaching 600 Metres as such he had to check and shift out thereby inconveniencing SOUTHERN RULER (Ashok Kumar A).

Routine Sample was taken for analysis from the winner b f WATCHMYSTARS.

**6<sup>th</sup> Race: 6. The Royal Calcutta Turf Club Cup - (About) 1400 metres. 3-year-old horses (foaled in 2018) (6 Runners).**

It was reported after the race that PECANWOOD (Antony Raj S.) burst its blood vessels. Trainer Mr. Arjun Mangalorkar was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b f MOON'S BLESSING.

**7<sup>th</sup> Race: 7. The Dudhsagar Falls Plate - (About) 1600 metres. Horses rated 20 to 45 (11 Runners).**

JOKSHAN was not declare to start in the above race.

Jockey Chethan Kalay S., the rider of BROOKLYN SUPREME was fined Rs.1,000/- for shifting 'in' and tightening TURKOMAN (Vinod Shinde) and ANTIBES (S. John) on his inside passing the 1500 Metres.

Jockey S. John, the rider of ANTIBES reported that he had to steady his mount to avoid striking the front runner QUEEN REGNANT (Kiran Rai P) approaching 700 Metres.

Jockey Kiran Rai P, the rider of QUEEN REGNANT was fined Rs.1,000/- for shifting out and taking out TURKOMAN (Vinod Shinde) on his outside passing the 250 Metres.

Jockey Vishal N Bunde, the rider of AMAZING BLAZE reported that his saddle shifted back in the final 200 Metres. After due examination of the equipment, Trainer Mr. S. Padmanabhan was fined Rs.3,000/- for faulty saddling of his charge.

An enquiry is being held into the running and riding of MISTLETOE, trained by Mr. Prasanna Kumar and ridden by Jockey D'nu Singh Deora in the above race.

Routine Sample was taken for analysis from the winner b c STOCKBRIDGE.

**8<sup>th</sup> Race: 8. The Vedavati Plate - Div. I - (About) 1400 metres. Horses rated 20 to 45, 4 years old and over (11 Runners).**

JOKSHAN was not declare to start in the above race.

Routine Sample was taken for analysis from the winner dk b f ALLABOUTHER.
