GOING : Soft

PENETROMETER READING: 5.6 Cms.

RAILING POSITION: Railing fixed at average width of 6.0 Meters from 1600 Meters to winning post from its original position.

1st Race: 59. The World Children's Day Plate - Div. III - (About) 1400 metres. Horses rated 00 to 25 (10 Runners).

Permission was granted to Trainer Mr. Azhar Ali to withdraw PERFECT HALO (Ahsan Qureshi) on veterinary grounds as it was found to be trotting lame on right fore. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey S. Saqlain, the rider of PRINCESS JASMINE was fined Rs.1,000/- for shifting out and taking out the horses on his outside viz; CAPABLE (Naveen M.) and SOUTHERN POWER (Ikram Ahmed) in the final 100 Metres of the race.

Jockey Vivek, the rider of RAW GOLD was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

Routine Sample was taken for analysis from the winner b f PRINCESS JASMINE.

2nd Race: 60. The Youre So Beautiful Plate - Div. II - (About) 1200 metres. Horses rated 20 to 45 (12 Runners).

TALL GIRL (Rayan Ahmed R.) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. S. Dominic was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

FLAMINGO ROAD (Arul J.H) was squeezed between SECRETSUPERSTAR (Chethan Kalay S.) and DAWN RISING (Ryan Marshall) soon after the start.

Jockey Vivek, the rider of MEGA SUCCESS reported that he accidentally lost his whip passing the 200 Meters.

GULFSTREAM PARK (A. Sandesh) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner dk b c THE SOVEREIGN ORB.

3rd Race: 61. The World Children's Day Plate - Div. II - (About) 1400 metres. Horses rated 00 to 25 (11 Runners).

ZHU ZHU ZEST (Darshan R.N) reared up, fell and was struck inside the starting gates and was kicked on the right flank by adjacent horse. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr. V. Lokanath was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

TENARIS (Arul J.H) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner ch f WINMYLOVE.

4th Race: 62. The Youre So Beautiful Plate - Div. I - (About) 1200 metres. Horses rated 20 to 45 (11 Runners).

Trainer Mr. S. Dominic was fined Rs.2,000/- for not obtaining prior permission for using Tongue Strap on his charge ANNE BOLEYN (D'nuSingh Deora). Subsequently, Tongue Strap was removed before the horse left the paddock.

QUEEN OF SANDS (A.R.Pradeep) reared up and hit the withers on the rear gates and was stuck inside for a considerable period of time. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr. Kishan Thomas was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

KALYAN (Siddaraju.P) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Neil B Devaney was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Arul J.H, the rider of RULE OF ENGAGEMENT was fined Rs.1,000/- for shifting out and taking out POWERFUL LADY (S. John) on his outside passing the 350 Metres.

An enquiry is being held into the running and riding of REALIA, trained by Mr. Azhar Ali and ridden by Jockey Chethan Kalay .S in the above race.

Routine Sample was taken for analysis from the winner dk b g THREE ACES.

5th Race: 63. The Siachen Plate - (About) 1400 metres. Horses rated 20 to 45 (10 Runners).

Permission was granted to Trainer Mr.S. Padmanabhan to withdraw DOUGLAS (A. Sandesh) on veterinary grounds as it was found to be lame on right fore. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

ICELANDIC (Akshay Kumar) reared up, fell inside the gates and hit the withers and was stuck inside the stalls. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr. Arjun Mangalorkar (deputizing on behalf of Trainer Mr. S.S. Attaollahi) was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Rajesh Kumar M, the rider of TWILIGHT FAME was fined Rs.2,000/- for not maintaining a straight course approaching 1200 Meters, in the process he shifted 'in' and caused interference to the horses viz; MARK ONE (Ryan Marshall) and THE KING N I (Surya P.).

It was observed that FREDERICO (Shamaz Shareef) shied away towards the left, whereby the rider was totally unbalanced and was dislodged from his mount passing the 350 Metres and the horse ran rider less thereafter. In view of its behaviour, Trainer Mr. Irfan Ghatala was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey C. S. Jodha, the rider of OWN LEGACY reported that his mount had a very soft mouth. The horse was subjected to veterinary examination. On examination, it was found to have bit sore on both side oral mucosa. However, Trainer Mr. S. Ganapathy was informed to take appropriate corrective measures before accepting with it again.

An enquiry is being held into the running and riding of MOVING AHEAD, trained by Mr. Kishan Thomas and ridden by Jockey S.K.Paswan in the above race.

Routine Sample was taken for analysis from the winner b f LIMITED SOURCE.

6th Race: 64. The Sea Biscuit Trophy - (About) 1200 metres. Maiden Horses 3 years old only. (12 Runners).

Jockey M. Mark replaced the indisposed Jockey Shamaz Shareef on THE INTRUDER.

ELITE CROWN (Kiran Rai P) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Aravind G. was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey P. Mani, the rider of THE OMEGA MAN was fined Rs.1,000/- for shifting 'in' and causing interference to BUL BULE HIND (Arvind Kumar. N) approaching 1000 Metres.

THE INTRUDER (M. Mark) ran detached from the field. Trainer Mr. Warren Singh was informed to ensure better performance of his charge in future.

Routine Sample was taken for analysis from the winner ch f TERESITA.

7th Race: 65. The Bangalore Turf Club Trophy (Grade III) - (About) 1200 metres. 3 years old and over. (6 Runners).

Compulsory urine and blood samples were taken for analysis from the following I,II & III placed horses viz:

ch c GOLDEN OAKS II

dk b h MAURITANIA III

8th Race: 66. The Southern Bay Plate - (About) 1100 metres. Horses rated 20 to 45, 5 years old and over, to be ridden by Indian Jockeys Claiming allowance (Whips not allowed) (12 Runners).

Jockey S. Saqlain, the rider of STAR AND GARTER was fined Rs.2,000/- for not maintaining a straight course before passing red marker post, whereby he shifted out and caused interference to the horses viz; SONGKRAN (Tousif Khan), LAND OF LIBERTY (Angad) and RECZAI (Vishal N Bunde).

Jockey Arul J.H, the rider of ACEROS was fined Rs.2,000/- for coming 'in' and tightening STAR AND GARTER (S. Saqlain) on his inside passing the 900 Metres.

Routine Sample was taken for analysis from the winner b m RECZAI.

9th Race: 67. The World Children's Day Plate - Div. I - (About) 1400 metres. Horses rated 00 to 25 (10 Runners).

Permission was granted to Trainer Mr. Irfan Ghatala to withdraw SPEED SEVEN (P. S. Chouhan) on veterinary grounds as it was found to be lame on right hind. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Permission was granted to Trainer Mr.S. Inayathulla to withdraw HIGHLAND ROCK (Vivek) on veterinary grounds as it was found to have urticaria. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

ANOTHER RAINBOW (D'nuSingh Deora) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. M. Rajendra Singh was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

FLAMBOYANT GIRL (M. Mark) after jumping out did not raise a fluent gallop for the first 100 Metres. In view of its behaviour, Trainer Mr.S. Dominic was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Routine Sample was taken for analysis from the winner dk b c BLACK COFFEE.

Permission was granted to trainer Mr. Arjun Mangalorkar to deputize on behalf of trainer Mr. S.S. Attaollahi who was unable to attend the races.
