RACING INCIDENTS

(112 - 119)

GOING : Good

PENETROMETER READING: 3.4 Cms.

RAILING POSITION : Railing fixed at average width of 3.0 Meters from 1600 Meters to winning post from its original position.

1st Race: 112. The Chambal Plate - Div. II - (About) 1200 metres. Horses rated 00 to 25, 5 years old and over, to be ridden by Indian Jockeys claiming allowance (Whips not allowed) (10 Runners).

LIGHTNING ATTACK (S. Hussain) reared up and fell inside the gate, stuck between the adjacent horses and was kicked by them. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr.V. Lokanath was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

JAN ZIZKA (L. Alex Rozario) croup stuck over the rear gates (spraining the back) for considerable period of time. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr. S. Padmanabhan was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

ELITE AGENT (Angad) after jumping out slightly swerved towards the left and lost few lengths at the start. In view of its behaviour, Trainer Mr. Narayana Gowda V. was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

BAHURUPAH (Siddaraju.P) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Warren Singh was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

AWESOME GIRL (K.G. Likith Appu) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. S. Dominic was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Vishal N Bunde, the rider of LADY NECTAR reported that his mount was hanging 'in' after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr.M. Rajendra Singh was informed to take appropriate corrective measures before accepting with it again.

Jockey Nazar Alam, the rider of AEROSPEED was fined Rs.3,000/- for shifting out and causing interference to ELITE AGENT (Angad), which in turn passed it onto BAHURUPAH (Siddaraju. P) on his outside in the final 150 Metres.

An enquiry is being held into the running and riding of AEROSPEED, trained by Mr. S. Inayathulla and ridden by Jockey Nazar Alam in the above race.

Routine Sample was taken for analysis from the winner b g NOSTRADAMUS.

2nd Race: 113. The Kodagu Plate - Div. II - (About) 1400 metres. Horses rated 20 to 45, 4 years old and over (11 Runners).

LUCKY CHANCE (Darshan R.N) bolted and ran rider less from weighing scale to inner sand track and on outer sand track till mile marker twice for a considerable distance. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr. S. Dominic was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

HITOMI SAKUMA (Rajesh Kumar M) planted and did not take any practical part in the race. In view of its behaviour, Trainer Mr.Narayana Gowda V. was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least two Mock Races.

KINGS SPEECH (S. A. Gray) after jumping out did not raise a fluent gallop. In view of its behaviour, Trainer Mr. S. Padmanabhan was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Antony Raj S., the rider of SILVERITA reported that his mount was lugging out under pressure during the final stages of race. The horse was subjected to veterinary examination but no abnormality was reported.

An enquiry is being held into the running and riding of AIR BLAST, trained by Mr. Neil B. Devaney (deputizing on behalf of Trainer Mr.Arjun Mangalorkar) and ridden by Jockey S. Saqlain in the above race.

THE STRENGTH (Naveen M.) was subjected to veterinary examination but no abnormality was reported.

AIR BLAST (S. Saqlain) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b c OMBUDSMAN.

3rd Race: 114. The Sardar Sarovar Plate - Div. II - (About) 1200 metres. Horses rated 20 to 45 (11 Runners).

PURPLE LEGEND (Md. Habeeb) jumped awkwardly outwards and inconvenienced THE SENSE (Vinod Shinde) at the start.

Jockey V.R.Jagadeesh, the rider of TOWER QUEST was fined Rs.2,000/- for shifting 'in' and cutting across the field, thereby causing interference to the horses on his inside viz; MARK ONE (Prashant P.Dhebe), COMPLIANCE (Shamaz Shareef) and MEGA SUCCESS (Vivek) passing the 900 Metres.

Jockey Darshan R.N, the rider of UNIQUE STYLE reported that his mount was hanging 'in' throughout the race. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. V. Lokanath was informed to take appropriate corrective measures before accepting with it again.

It was reported after the race that TOWER QUEST (V.R.Jagadeesh) burst its blood vessels. Trainer Mr.Darius R. Byramji was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

COMPLIANCE (Shamaz Shareef) sustained bleeding cut injury on both nostrils.

Routine Sample was taken for analysis from the winner b f SHIVALIK MIRROR.

4th Race: 115. The Kodagu Plate - Div. I - (About) 1400 metres. Horses rated 20 to 45, 4 years old and over (12 Runners).

Routine Sample was taken for analysis from the winner b f DRUSILLA.

5th Race: 116. The Big Brown Plate - (About) 1800 metres. Maiden Horses 3 years old only. (6 Runners)

Permission was granted to Trainer Mr.Rajesh Narredu to withdraw LOVE (Suraj Narredu) on veterinary grounds as it was found to have abrasion and cellulites on right fore fetlock. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Neeraj Rawal, the rider of FAITH OF SUCCESS was fined Rs.1,000/- for shifting 'in' and causing interference to LINKIN PARK (V.R.Jagadeesh) on his inside passing the 300 Metres.

It was reported after the race that MUIRFIELD (Antony Raj S.) burst its blood vessels. Trainer Mr. Neil B. Devaney (is deputizing on behalf of trainer Mr.Arjun Mangalorkar) was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b f FAITH OF SUCCESS.

6th Race: 117. The Altenburg Trophy - (About) 1400 metres. Horses rated 40 to 65 (7 Runners).

LAGOPUS (Surya P.) kicked the starting gates and pulled up lame on left hind. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr.Pradeep Annaiah was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey V.R.Jagadeesh, the rider of WHIZZO reported that his mount was hanging out after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr.Azhar Ali was informed to take appropriate corrective measures before accepting with it again.

KNIGHT IN HOOVES (Suraj Narredu) sustained bleeding gum injury.

Routine Sample was taken for analysis from the winner b g KNIGHT IN HOOVES.

7th Race: 118. The Sardar Sarovar Plate - Div. I - (About) 1200 metres. Horses rated 20 to 45 (11 Runners).

BABA VOSS (Harish B.) reared up as the gates opened, totally unbalancing the rider and was dislodged from his mount, thereafter ran rider less.

Jockey Shamaz Shareef, the rider of CAESARS PALACE was reprimanded for shifting 'in' and inconveniencing ULTIMATE SPEED (V.R.Jagadeesh) on his inside passing the 200 Metres.

Routine Sample was taken for analysis from the winner b g DE VILLIERS.

8th Race: 119. The Chambal Plate - Div. I - (About) 1200 metres. Horses rated 00 to 25, 5 years old and over, to be ridden by Indian Jockeys claiming allowance (Whips not allowed) (12 Runners).

Jockey K.G. Likith Appu, the rider of AKASI was fined Rs.1,000/- for shifting 'in' and causing interference to the horses on his inside viz; COMMANDPOST (Angad) and SMILE AROUND (Chandrashekar) approaching 1000 Metres.

Jockey S. Saqlain, the rider of ULTIMATE STRIKER reported that he lost his left rein momentarily passing the 150 Metres, which he regained within few strides.

Routine Sample was taken for analysis from the winner b g OZARK.

Permission was granted to trainer Mr. Neil B. Devaney to deputize on behalf of trainer Mr. Arjun Mangalorkar who was unable to attend the races.
