RAILING POSITION: Railing fixed at average width of 8.0 Meters from 1600 Meters to winning post from its original position.

1st Race: 74. The Sutlej Plate - Div. II - (About) 1400 metres. Horses rated 00 to 25(Whips not allowed) (9 Runners).

ALTAMONTE (Salman Khan) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. S. Inayathulla was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey P. Mani, the rider of FLORENCIA was fined Rs.3,000/- for shifting 'in' and causing interference to SCINTILLA (IndraJeet Singh), whereby COMMANDPOST (Rajesh Kumar M) and OROGENESIS (Chandrashekar. M) which were travelling directly behind also had to be checked by respective riders passing the 900 Metres.

ALTAMONTE (Salman Khan) sustained superficial injury on right hind chestnut.

Routine Sample was taken for analysis from the winner b g SOUTHERN POWER.

2nd Race: 75. The Sharavati Plate - (About) 1600 metres. Horses rated 20 to 45, 5 years old and over (9 Runners).

Jockey Ranjeet Singh, the rider of LEGENDARY PRINCESS was reprimanded for shifting out and inconveniencing SAINTHOOD (P. Sai Kumar) on his outside passing the 700 Metres.

Jockey Ranjeet Singh, the rider of LEGENDARY PRINCESS was fined Rs.1,000/- for allowing his mount to drift out under the use of whip in the final 100 Metres of the race.

An enquiry is being held into the running and riding of MARCO POLO, trained by Mr. Pradeep Annaiah and ridden by Jockey Arul J.H in the above race.

STAR AND GARTER (Antony Raj S.) was impounded for veterinary examination. On examination, it was found to have burst its blood vessels (Endoscopy - Grade IV). Trainer Mr.Arjun Mangalorkar was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Surprise sample was taken for analysis from b m STAR AND GARTER.

Routine Sample was taken for analysis from the winner b h TRENSETTER.

3rd Race: 76. The Linganamakki Plate - Div. II - (About) 1400 metres. Horses rated 20 to 45 (5 Runners).

Permission was granted to Trainer Mr. Prithviraj B. to withdraw KARANVEER on veterinary grounds as it was found to be bleeding from both nostrils. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Permission was granted to Trainer Mr. S. Narredu to withdraw SECRET SOURCE (Rayan Ahmed R.) on veterinary grounds as it was found to be trotting lame on right fore. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

THE INHERITOR (Naveen M.) hit the outer railing of inner sand track and dropped the rider galloped around 2000 Metres on the inner sand track. On immediate examination by the Club's Veterinary Officer it was found to have abrasion over right knee and bleeding cut injury over right fore pastern. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr.Sharat Kumar was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey A.Imran Khan, the rider of MORGANITE was fined Rs.3,000/- for the excessive use of whip on his mount during the race (1st infringement).

Routine Sample was taken for analysis from the winner b g MORGANITE.

4th Race: 77. The R.W.I.T.C Cup - (About) 1100 metres. Maiden Horses 3 years old only. (9 Runners).

Trainer Mr. Azhar Ali was fined Rs.5,000/- as he failed to obtaining prior permission before the acceptance for the use of Tongue Strap on his charge PERFECT JUSTICE (D. Patel) to run in the above race. Subsequently, permission was granted to him to run his charge with a Tongue Strap before the race day.

Permission was granted to Trainer Mr. Prasanna Kumar to withdraw OSWALD (D'nuSingh Deora) on veterinary grounds as it was found to be lame on left hind. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Darshan R.N, the rider of PROMISE KEPT was fined Rs.1,000/- for shifting 'in and causing interference to PERFECT JUSTICE (D. Patel) on his inside passing the 800 Metres.

Jockey Arvind Kumar. N, the rider of IMMACULATE was fined Rs.1,000/- for shifting 'in' and bumping SODASHI (Rayan Ahmed R.) on his inside passing the 300 Metres.

Jockey P. Mani, the rider of CHIRAAG was reprimanded for riding an indifferent race.

Routine Sample was taken for analysis from the winner dk b f PROMISE KEPT.

5th Race: 78. The Classic Story Trophy - (About) 1200 metres. Horses rated 40 to 65 (8 Runners).

Jockey Arul J.H, the rider of HARMONIA was fined Rs.2,000/- for coming 'in' and tightening the horses on his inside viz; AACHEN (Salman Khan) and PERFECT RENDITION (D'nuSingh Deora) approaching 900 Metres.

Jockey Salman Khan, the rider of AACHEN was fined Rs.1,000/- for shifting 'in' and causing interference to HARMONIA (Arul J.H) on his inside passing the 400 Metres.

Jockey Arvind Kumar. N, the rider of THE RESPONSE was fined Rs.1,000/-for shifting 'in' and causing interference to SCHAFENBERG (Shreyas Singh S) on his inside passing the 300 Metres.

Routine Sample was taken for analysis from the winner b m HARMONIA.

6th Race: 79. The Linganamakki Plate - Div. I - (About) 1400 metres. Horses rated 20 to 45 (7 Runners).

Jockey Chethan Kalay S replaced the indisposed Jockey A.R. Pradeep on FICTIONEER.

Jockey Chethan Kalay .S injured his right leg while his mount FICTIONEER was being loaded into the starting gates. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order.

Jockey Surya P., the rider of LAGOPUS was reprimanded for shifting 'in' and inconveniencing JOHNNIE BLACK (Aakash Chavan) on his inside at the start.

Jockey N. S. Parmar, the rider of DE VILLIERS reported that his mount was hanging out from 600 Metres. The horse was subjected to veterinary examination. On examination, it was found to have bit sore on left buccal commissure. However, Trainer Mr.S.S. Attaollahi was informed to take appropriate corrective measures before accepting with it again.

JOHNNIE BLACK (Aakash Chavan) ran detached from the field. The horse was subjected to veterinary examination. On examination, it was found to be lame on left hind. Trainer Mr. Darius R. Byramji was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

LIVISILLA (K.G. Likith Appu) sustained superficial cut injury on right fore fetlock.

Routine Sample was taken for analysis from the winner dk b g OBSIDIAN.

7th Race: 80. The Sutlej Plate - Div. I - (About) 1400 metres. Horses rated 00 to 25(Whips not allowed) (10 Runners).

HAFNIUM (Chandrashekar. M) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Kishan Thomas was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Chandrashekar.M, the rider of HAFNIUM was fined Rs. 2,000/- for not making sufficient effort to improve his position from the 1300 Metres till about 400 Metres.

Jockey Yash Narredu, the rider of IMPECCABLE was fined Rs.1,000/- for shifting 'in' and tightening BUL BULE HIND (Arvind Kumar. N) on his inside approaching 900 Metres.

Jockey Vishal N Bunde, the rider of CODE OF HONOUR was fined Rs.2,000/for the improper practice of hitting the horse with his hands passing the 100 Metres in a no whip race.

CRIMSON HEART (Ajeet Kumar) sustained superficial injury on right hind cannon.

GAZEBO TALK (Siddaraju.P) sustained bleeding clip injury over right hind over bulb.

HAFNIUM (Chandrashekar) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner dk b g EXTRAORDINARY.

Permission was granted to trainers M/s. S. Dominic and Azhar Ali to deputize on behalf of trainers M/s. Neil Darashah and Irfan Ghatala who were unable to attend the races.

BANGALORE WINTER MEETING 2021-22 FIRST DAY, TUESDAY, 2ND NOVEMBER, 2021 (Postponed from Sunday, 31st October, 2021)

Race: 1. The Inauguration Plate Div- II - (About) 1200 metres. Horses rated 00 to 25, 5 Years old and over.

(A)

An enquiry was held on 2nd December, 2021 by the Stipendiary Stewards for the above race with respect to Jockey D. Patel pertaining to his riding on his mount CHUL BUL RANI, "In that he did not make sufficient effort in riding out his mount in the final 150 Metres of the race".

Jockey D. Patel was interviewed by the Stipendiary Stewards. The Stipendiary Stewards after considering the submissions made by Jockey D. Patel and Trainer Mr. S. Inayathulla and after viewing the CCTV decided to charge Jockey D. Patel for Incompetent Riding.

The Stipendiary Stewards thereafter suspended the Jockey's Licence granted to Jockey D. Patel with effect from **10**th **December, 2021 to 31**st **December, 2021** (both days inclusive) as he had pleaded guilty of the charge under Rule No. 161 (ii) of the BTC Rules of Racing for Incompetent Riding on his mount CHUL BUL RANI (he was permitted to ride work) and was informed of his right to appeal.

Trainer Mr. Faraz Arshad and Jockey A. Imran Khan were questioned regarding the running and riding of LIGHT OF LOVE. After due enquiry, their explanations were noted for future reference.

Race: 4. The Vedavati Plate - Div. II - (About) 1400 metres. Horses rated 20 to 45, 4 years old and over.

Trainer Mr. Faraz Arshad and Jockey A. Imran Khan were questioned regarding the running and riding of EXCLUSIVE MANDATE. After due enquiry, their explanations were noted for future reference.

SECOND DAY, MONDAY, 1st NOVEMBER, 2021

Race: 9. The Ganga Plate - Div. II - (About) 1600 metres. Horses rated 00 to 25

Trainer Mr. Sharat Kumar and Jockey Naveen. M were questioned regarding the running and riding of CAPABLE. After due enquiry, Jockey Naveen. M was fined Rs.5,000/- for not making sufficient effort on his mount during the race and Trainer Mr. Sharat Kumar was fined Rs.5,000/- for the unsatisfactory explanations tendered by him during the enquiry for the above race.

NINTH DAY, FRIDAY, 26TH NOVEMBER, 2021

Race: 63. The Siachen Plate - (About) 1400 metres. Horses rated 20 to 45.

Trainer Mr. Kishan Thomas and Jockey S.K. Paswan were questioned regarding the running and riding of MOVING AHEAD. After due enquiry, as Jockey S.K. Paswan had dislocated his right shoulder in the final 150 Metres of the race and the supporting medical records were produced during the enquiry at this instance a grave benefit of doubt was given to him. However, while noting their explanations Jockey S.K. Paswan was advised to ride to the satisfaction of Stipendiary Stewards in atleast two Mock Races after he resumes his riding activities and before he accepts to ride in races.
