RACING INCIDENTS
(167-173)

GOING : Good

PENETROMETER READING: 3.5 Cms.

RAILING POSITION : Railing fixed at average width of 7.0 Meters from 1600 Meters to winning post from its original position.

1st Race: 167. The Mahi Plate - Div. III - (About) 1200 metres. Horses rated 00 to 25 (11 Runners).

BARONESS (K. Sai Kiran) was examined at the starting gate by the Club's Veterinary Officer and was observed to have diarrhoea. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr.Narayana Gowda V. was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

SPEAKING OF SKIES (Arshad Alam) planted, after jumping out swerved towards the left, went onto the sand track and did not take any practical part in the race. In view of its behaviour, Trainer Mr.Imtiaz Khan was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

ALTAMONTE (Vivek) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.S. Inayathulla was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Md. Habeeb, the rider of ULTIMATE STRIKER was fined Rs.3,000/- for not making sufficient effort on his mount during the race.

Routine Sample was taken for analysis from the winner b g SIR JERSEY.

2nd Race: 168. The Bhima Plate - (About) 1400 metres. Horses rated 20 to 45, 5 years old and over (9 Runners).

ALLABOUTHER (S. John) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Prasanna Kumar (deputizing on behalf of Trainer Mr. Arjun Mangalorkar) was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

COMMANDPOST (Rajesh Kumar M) took a fly jump.

Jockey Vinod Shinde, the rider of SECRET SOURCE was fined Rs.1,000/- for coming 'in' and causing interference to ALLABOUTHER (S. John) on his inside passing the 500 Metres.

SECRET SOURCE (Vinod Shinde) ran detached from the field from about 400 Metres. The horse was subjected to veterinary examination. On examination, it was found to have sustained superficial injury on right hind fetlock. However, Trainer Mr.S. Narredu was informed to ensure better performance of his charge in future.

SKYFIRE (Surya. P) was subjected to veterinary examination but no abnormality was reported.

Trainer Mr. Azhar Ali was questioned regarding the relatively improved performance of his charge CANDLELIGHTQUEEN (Arshad Alam) as compared to its previous run in Race No. 162 i.e., The Kadamba Falls Plate – Div. II, (about) 1400 Metres, Horses rated 20 to 45, 5 years old and over run on 3rd February, 2022 wherein it ran unplaced. After due enquiry, Trainer Mr. Azhar Ali was fined Rs.5,000/- for the unsatisfactory explanations tendered by him during the enquiry for the above race.

Routine Sample was taken for analysis from the winner ch m CANDLELIGHTQUEEN.

3rd Race: 169. The Mahi Plate - Div. II - (About) 1200 metres. Horses rated 00 to 25 (12 Runners).

Jockey Shreyas Singh S, the rider of RED LUCIFER was fined Rs.1,000/- for shifting 'in' and causing interference to QUIET STYLE (Salman Khan) on his inside passing the 1000 Metres.

Jockey Md. Habeeb, the rider of SO YOU'RE HERE was reprimanded for shifting 'in' and inconveniencing CHAIN OF THOUGHTS (M. Mark) on his inside approaching 900 Metres.

Jockey Shreyas Singh S, the rider of RED LUCIFER was fined Rs.3,000/- for not improving his position from 700 Metres till about 350 Metres.

Jockey Darshan R.N, the rider of LIGHTNING CHARLIE reported that he lost his right rein passing the 200 Metres, which he regained within a few strides. Simultaneously he also accidentally lost his whip at the same juncture.

CRIMSON HEART (S. Saqlain) was subjected to veterinary examination but no abnormality was reported.

RED LUCIFER (Shreyas Singh S) was subjected to veterinary examination but no abnormality was reported.

It was reported after the race that CRIMSON HEART (S. Saqlain) burst its blood vessels (on endoscopy – Grade- III at 6:55 P.M.). Trainer Mr. Sharat Kumar was informed to produce a fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner ch r CHISOX.

4th Race: 170. The Valley of Flowers Plate - Div. II - (About) 1400 metres. Horses rated 20 to 45 (9 Runners).

TOP DANCER (S. John) took a fly jump.

It was observed that Jockey V.R.Jagadeesh, the rider of KNOTTY PRINCESS had to steady his mount approaching 1200 Metres due to crowding of the field.

STRIKING MELODY (Darshan R.N) sustained superficial clip injury on left hind pastern and outer bulb.

Routine Sample was taken for analysis from the winner b f TOP DANCER.

5th Race: 171. The Shivamogga Plate - (About) 1200 metres. Horses rated 40 to 65, 5 years old and over (8 Runners).

Jockey P Trevor, the rider of GALACTICAL was fined Rs.1,000/- for shifting 'in' and causing interference to WINGS OF DESIRE (Arshad Alam) on his inside before passing the red marker post.

It was reported after the race that AACHEN (Salman Khan) burst its blood vessels. Trainer Mr. Irfan Ghatala was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b g GOLDEN VISION.

6th Race: 172. The Valley of Flowers Plate - Div. I - (About) 1400 metres. Horses rated 20 to 45 (10 Runners).

Jockey Ajeet Kumar, the rider of OSIRIS reported that he accidentally lost his whip passing the 200 Metres.

It was observed that PERFECT EMPRESS (Surya P) could not get clear run between the 250 Metres and 150 Metres.

Routine Sample was taken for analysis from the winner b g PEYO.

7th Race: 173. The Mahi Plate - Div. I - (About) 1200 metres. Horses rated 00 to 25 (12 Runners).

ELITE CROWN (L. Alex Rozario) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Aravind .G was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey S Hussain, the rider of HOOFED WONDER reported that his mount was erratic throughout the race. The horse was subjected to veterinary examination but no abnormality was reported. In view of its repeated behaviour, Trainer Mr. Rajesh Narredu was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Surya P, the rider of APOLLO LIGHT was fined Rs.1,000/- for shifting 'in' and causing interference to HOOFED WONDER (S. Hussain) on his inside soon after the start.

Jockey Siddaraju P, the rider of BUL BULE HIND was reprimanded for shifting 'in' and inconveniencing CHANDRA KANTA (Salman Khan) on his inside soon after the start.

Jockey Anjar Alam , the rider of FREDERICO was reprimanded for shifting 'out' and inconveniencing DON'S DEN (S Saqlain) on his outside passing the 900 Metres.

Jockey V R Jagadeesh, the rider of DEVILS MAGIC was fined Rs.1,000/- for shifting out and taking out FREDERICO (Anjar Alam) on his outside approaching 750 Metres.

Jockey Ahsan Qureshi, the rider of HANDSOME MOVER was fined Rs.2,000/- for not making sufficient effort on his mount in the final 250 Metres.

HANDSOME MOVER (Ahsan Qureshi) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner dk b r DEVILS MAGIC.

Permission was granted to trainers M/s. V. Lokanath, Dheeraj.V, Faraz Arshad and Prasanna Kumar to deputize on behalf of trainers M/s. B. Prithviraj, S. Dominic, K. Pradeep Annaiah and Arjun Managalorkar who were unable to attend the races.

An enquiry was held into the relatively improved performance of AHERNE, trained by Mr. Imtiaz Khan and ridden by Jockey Darshan R.N in the above race as compared to its previous run in Race No.97 i.e., The Invasor Plate (about) 1100 Metres, Maiden horses 3 years old only, run on 18th December, 2021 where it ran unplaced. After due enquiry, Trainer Mr. Imtiaz Khan explanations were noted for future reference.
