RACING INCIDENTS

(174 - 179)

GOING : Good

PENETROMETER READING: 3.6 Cms.

RAILING POSITION : Railing fixed at average width of 9.5 Meters from 1600 Meters to winning post from its original position.

1st Race: 174. The Koyna Plate - Div. II - (About) 1400 metres. Horses rated 00 to 25 (10 Runners).

Permission was granted to Trainer Mr.Narayana Gowda V. to withdraw COMMANDPOST (K. Sai Kiran) on veterinary grounds as it was found to be suffering from fever. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey A.Ashhad Asbar, the rider of WAR TRAIL was fined Rs.1,000/- for shifting out and causing interference to SODASHI (Suraj Narredu) on his outside passing the 400 Metres.

Jockey Arvind Kumar. N, the rider of STUNNING BEAUTY was fined Rs.1,000/- for shifting out and taking out the horses on his outside viz; WAR TRAIL (A.Ashhad Asbar) and SODASHI (Suraj Narredu) approaching 200 Metres.

Jockey M. Mark, the rider of CAPITAL GAIN was fined Rs.1,000/- for shifting out and taking out SODASHI (Suraj Narredu) in the final 100 Metres.

An enquiry is being held into the running and riding of CAPITAL GAIN trained by Mr. S. Dominic and ridden by Jockey M. Mark in the above race.

SODASHI (Suraj Narredu) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g JE NE SAIS QUOI.

2nd Race: 175. The Gaganachukki Plate - Div. II - (About) 1200 metres. Horses rated 20 to 45 (12 Runners).

Jockey A.Imran Khan, the rider of MITSURO was fined Rs.1,000/- for shifting out and taking out PLANETARY JOY (S. Saqlain) on his outside passing the 800 Metres.

Jockey A.Ashhad Asbar, the rider of THE KING N I reported that his mount was galloping fiercely between the 800 Meters to 600 Metres.

Jockey Ajeet Kumar, the rider of EXTRAORDINARY was fined Rs.5,000/- for repeatedly checking his mount at the start and approaching 700 Metres for no apparent reason.

Jockey S. Saqlain, the rider of PLANETARY JOY was fined Rs.1,000/- for shifting 'in' and tightening THE KING N I (A.Ashhad Asbar) on his inside approaching 400 Metres.

Jockey K. Sai Kiran, the rider of TWILIGHT FAME reported that his mount was not galloping fluently in the straight. The horse was impounded for veterinary examination. On examination, it was found to have epiglottic entrapment, abrasion on right gaskin behind and superficial clip injury on inside right gaskin. Trainer Mr. Narayana Gowda V. was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again. [Looking into poor performance of TWILIGHT FAME in the above race]

Surprise sample was taken for analysis from gr r TWILIGHT FAME.

Routine Sample was taken for analysis from the winner dk b g THE INHERITOR.

3rd Race: 176. The Hampi Plate - (About) 1600 metres. Horses rated 20 to 45 (8 Runners).

MY VISION (Nazerul Alam) walked out of the gates and lost many lengths at the start. In view of its behaviour, Trainer Mr. Neil Darashah was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Routine Sample was taken for analysis from the winner ch g AFERPI.

4th Race: 177. The Sarb-Kla Plate - (About) 1100 metres. Maiden Horses 3 years old only. (8 Runners).

Jockey Tauseef Ahmed, the rider of SHEER BLISS was fined Rs.3,000/- for shifting 'in' and causing interference to PHILOSOPHY (S. A. Gray), which in turn passed it onto ASHWA MAGADHEERA (Suraj Narredu) on his inside passing the 950 Metres.

Jockey Ranjeet Singh, the rider of BANKSY reported that his mount was hanging 'in' in the straight. Trainer Mr. S. Padmanabhan was informed to take appropriate corrective measures before accepting with it again.

An enquiry is being held into the running and riding of PHILOSOPHY trained by Mr.S. Padmanabhan and ridden by Jockey S.A. Gray in the above race.

Routine Sample was taken for analysis from the winner dk b f QUEEN SPIRIT.

5th Race: 178. The Gaganachukki Plate - Div. I - (About) 1200 metres. Horses rated 20 to 45 (11 Runners).

Jockey Surya P., the rider of LAUTERBRUNNEN reported that his mount stumbled at the start.

DEFINING POWER (D'nuSingh Deora) sustained superficial clip injury on right hind cannon.

Routine Sample was taken for analysis from the winner b m AZTEC QUEEN.

6th Race: 179. The Koyna Plate - Div. I - (About) 1400 metres. Horses rated 00 to 25 (9 Runners).

Permission was granted to Trainer Mr. Sharat Kumar to withdraw FLAMING ORANGE (Ajeet Kumar) on veterinary grounds as it was found to be suffering from colic. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

SKY PRINCESS (A.Ashhad Asbar) walked out of the gates and lost many lengths at the start. In view of its behaviour, Trainer Mr. Azhar Ali was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

DAWN RISING (P. Trevor) jumped out awkwardly and inconvenienced STAR DOMINATION (Naveen M.) at the start.

Jockey Salman Khan, the rider of ACTIVATED was fined Rs.1,000/- for shifting 'in' and causing interference to the horses on his inside viz; FLOWER OF PARADISE (S. Saqlain) and STAR DOMINATION (Naveen M.) passing the 1250 Metres.

Jockey P. Trevor, the rider of DAWN RISING was fined Rs,1,000/- for shifting out and taking out SKY PRINCESS (A.Ashhad Asbar) on his outside approaching 350 Metres.

Routine Sample was taken for analysis from the winner ch f MEASURE OF TIME.
