RACING INCIDENTS
(180-185)

GOING : Good

PENETROMETER READING: 3.3 Cms.

RAILING POSITION : Railing fixed at average width of 9.5 Meters from 1600 Meters to winning post from its original position.

1st Race: 180. The Mahadayi Plate - (About) 1400 metres. Horses rated 20 to 45, 5 years old and over (12 Runners).

FLYING BOLT (Surya P.) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr.Dheeraj.V was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

PERFECT RENDITION (Shamaz Shareef) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Prasanna Kumar was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

It was observed that OZARK (Arvind Kumar. N) was forced to travel wide from the start till about 800 Metres.

It was reported after the race that PERFECT RENDITION (Shamaz Shareef) burst its blood vessels. Trainer Mr.Prasanna Kumar was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

COPPER SUNRISE (D'nuSingh Deora) sustained superficial clip injury on left hind outer bulb.

Routine Sample was taken for analysis from the winner dk b g TWINKLE FEET.

2nd Race: 181. The Ellora Caves Plate - (About) 1600 metres. Horses rated 00 to 25, 5 years old and over (11 Runners).

BLUE FIRE (A.Imran Khan) ran detached from the field from 500 Metres. In view of its repeated poor performance, Trainer Mr. Rajesh Narredu was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least two Mock Races.

Jockey M. Mark, the rider of MESSALA reported that his mount was changing its legs during the race. The horse was subjected to veterinary examination. On examination, it was found to be trotting lame on right fore. Trainer Mr. Darius R. Byramji was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was reported after the race that SIZZLER (Bhawani Singh) pulled up lame on right hind, sustained superficial clip injury over left hind tendon and deep clip injury on right hind tendon and was pulled up by its rider approaching 500 Metres and did not complete the course. Trainer Mr.S. Ganapathy was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was reported after the race that GOLDEN MEMORY (Vishal N Bunde) was observed bleeding from right nostril (on Endoscopy found to have sustained injury over nose bridge). Trainer Mr.V. Lokanath was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

BLUE FIRE (A.Imran Khan) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g ECO FRIENDLY.

3rd Race: 182. The Trombay Plate - (About) 1200 metres. Maiden Horses 3 years old only. (5 Runners).

Permission was granted to Trainer Mr. S. Inayathulla to withdraw BESUGE (S. Hussain) on veterinary grounds as it was found to have right hind cannon cellulitis. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

ROMANTIC HEART (Rajesh Kumar M) reared up, totally unbalancing the rider and dislodged him from his mount in the paddock and the Jockey was injured. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order.

SLEIPNIR (D'nuSingh Deora) continuously reared up at the starting gates whereby the left fore shoe had come off. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order.

Routine Sample was taken for analysis from the winner b c ASHWA YUDHVIR.

4th Race: 183. The Kitty Bank Trophy - (About) 1400 metres. Horses rated 40 to 65, 5 years old and over (9 Runners).

Jockey IndraJeet Singh, the rider of SCHAFENBERG was fined Rs.1,000/- for shifting 'in' and tightening GREEN CHANNEL (S. John) on his inside approaching 100 Metres.

Jockey A.Ashhad Asbar, the rider of PELUCHE and Jockey D'nuSingh Deora, the rider of LUCKY CHANCE were cautioned for pulling up their mounts soon after the winning post.

Routine Sample was taken for analysis from the winner b g LUCKY CHANCE.

5th Race: 184. The Kallathigiri Falls Plate - (About) 1400 metres. Horses rated 20 to 45 (8 Runners).

An enquiry is being held into the running and riding of AHERNE trained by Mr.Imtiaz Khan and ridden by Jockey A.Ashhad Asbar in the above race.

WINDSTORM (Yash Narredu) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b f ANALECT.

6th Race: 185. The Hooghly Plate - (About) 1200 metres. Horses rated 00 to 25 (11 Runners).

Jockey Rajesh Kumar .M was certified fit after his fall in the paddock in third race of the day and was permitted to ride in the above race.

PRINCESS AURA (Arvind Kumar. N) was examined at the starting gate by the Club's Veterinary Officer and was found to be trotting lame on left fore. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr.Kishan Thomas was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Shamaz Shareef, the rider of FORCE ASSAULT reported that his mount was changing its legs under the use of whip whereby he was unbalanced and brushed the rails passing the 300 Metres.

Jockey S. John, the rider of BEAUTIFUL OBLIVIAN was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

Jockey A.Ashhad Asbar, the rider of KNOTTY CITY was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

Routine Sample was taken for analysis from the winner b f BEAUTIFUL OBLIVIAN.

Permission was granted to trainer Mr. Prasanna Kumar to deputize on behalf of trainer Mr. Kishan Thomas who was unable to attend the races.
