# BANGALORE WINTER MEETING 2021-22 TWENTYFIFTH DAY, FRIDAY, 25<sup>TH</sup> FEBRUARY, 2022 RACING INCIDENTS (186-194)

**GOING: Good** 

PENETROMETER READING: 3.4 Cms.

RAILING POSITION: Railing fixed at average width of 5.5 Meters from 1600 Meters to winning post from its original position.

1<sup>st</sup> Race: 186. The Subarnarekha Plate - (About) 1200 metres. Horses rated 00 to 25 (11 Runners).

Permission was granted to Trainer Mr. Sharat Kumar to withdraw LIFEISAMIRACLE (P. Sai Kumar) on veterinary grounds as it was found to be suffering from colic. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Naveen M replaced the indisposed Jockey A. Imran khan on LADY SUPREMOS.

LIMITED EDITION (Anjar Alam) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr.Irfan Ghatala was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

BENTAYGA (L. Alex Rozario) was slowly away, lost many lengths, swerved towards the right, brushed the running rails passing the 1100 Metres and ran detached thereafter. In view of its behaviour, Trainer Mr.Pradeep Annaiah was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

TOWER QUEST (S. Saqlain) ran detached from the field. The horse was subjected to veterinary examination. On examination, it was found to have pulled up lame on right hind and bleeding from both nostrils. Trainer Mr. Darius R. Byramji was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was reported after the race that BIMARAN CASKET (Md.Akram) burst its blood vessels. Trainer Mr.Neil B Devaney was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Trainer Mr. Sharat Kumar was fined Rs.20,000/- for the inconsistent pattern of running and reversal of form of his charge STUNNING BEAUTY (Arvind Kumar. N) as compared to its previous run in Race No. 174 i.e., The Koyna Plate – Div. II (about) 1400 Metres, Horses rated 00 to 25 run on  $18^{th}$  February, 2022 wherein it ran  $4^{th}$ .

BENTAYGA (L. Alex Rozario) sustained superficial injury on left fore fetlock.

Routine Sample was taken for analysis from the winner ch m STUNNING BEAUTY.

### 2<sup>nd</sup> Race: 187. The Souparnika Plate - (About) 1400 metres. Horses rated 20 to 45, 5 years old and over (10 Runners).

Permission was granted to Trainer Mr. Neil B Devaney to withdraw DEFINITIVE (S. Saqlain) on veterinary grounds as it was found to have sustained deep cut injury on right hock. He was informed to produce a

Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey A. Ashhad Asbar replaced the indisposed Jockey A. Imran khan on CANDLELIGHTQUEEN.

KIMERA (Vishal N Bunde) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr.Mahmood Khan was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey S. A. Gray, the rider of SILVERITA was fined Rs.10,000/- for not exercising sufficient control over his mount in the final 200 Metres of the race, whereby he allowed his mount to drift out inconveniencing DREAM CHASER( D'nuSingh Deora).

FLAMING ORANGE (P. Sai Kumar) sustained superficial clip injury on left hind fetlock.

Jockey D'nuSingh Deora, the rider of DREAM CHASER placed 2nd by the judge objected against Jockey S. A. Gray, the rider of SILVERITA placed 1st for "In the last 250 Metres the winner drifted out, took my ground, bumped me in the last 75 Metres, which cost me a certain race". The Stewards held an enquiry immediately after the race and interviewed the Jockeys concerned. After deliberations, they decided to uphold the objection and revise the order of placings as under:

DREAM CHASER I

SILVERITA II

CAESARS PALACE III

CANDLELIGHTQUEEN IV

Routine Sample was taken for analysis from the winner dk b h DREAM CHASER.

### 3<sup>rd</sup> Race: 188. The Hiranyakeshi Plate - (About) 1200 metres. Horses rated 20 to 45, 5 years old and over (10 Runners).

ANNE BOLEYN (D'nuSingh Deora) was examined at the saddling yard and found to be trotting lame on right fore. Under the circumstances, it was permitted to be withdrawn on veterinary grounds. Trainer Mr. S. Dominic was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

DALLAS DRIFTER (A.Ashhad Asbar) stumbled at the start.

Jockey Vinod Shinde, the rider of IMPECCABLE was fined Rs. 3,000/- for shifting 'in' and tightening the horses on his inside viz; DALLAS DRIFTER (A.Ashhad Asbar) and OCEAN DUNES (S. Saqlain), whereby DONNA BELLA (Ahsan Qureshi) which was travelling directly behind had to be checked by its rider passing the 1000 Metres.

It was observed that IMPECCABLE (Vinod Shinde) did not get a clear run in the final 50 Metres of the race due to a closely packed field.

SONGKRAN (Tousif Khan) ran detached from the field. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. S. Dominic was informed to ensure better performance of his charge in future.

Routine Sample was taken for analysis from the winner dk b m DONNA BELLA.

### 4<sup>th</sup> Race: 189. The Uttara Kannada Plate - (About) 1600 metres. Horses rated 40 to 65, 5 years old and over (8 Runners).

Routine Sample was taken for analysis from the winner dk b m CARACAS.

### 5<sup>th</sup> Race: 190. The Forever Elegance Trophy - (About) 1200 metres. Horses rated 40 to 65 (9 Runners).

As Jockey Surya. P was medically unfit to ride after his ride in the 3<sup>rd</sup> race. Permission was granted to trainer Mr. Pradeep Annaiah to substitute Jockey IndraJeet Singh to ride HARMONIA in place of the declared rider.

THE RESPONSE (Ajeet Kumar) jumped awkwardly outwards and inconvenienced DEL MAR (Harish. B) soon after the start.

DEL MAR (Harish B.) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g DE VILLIERS.

### 6<sup>th</sup> Race: 191. The Bangalore Juvenile Million(Grade III) - (About) 1400 metres. 3 years old only (foaled in 2019). (6 Runners).

Jockey Neeraj Rawal, the rider of WILD EMPEROR reported that his mount was lugging 'in' under pressure during the race. The horse was subjected to veterinary examination. On examination, it was found to have sharp molars and sustained superficial injury on left hind coronet. Hence Tr.Faraz Arshad was fined Rs.3,000/- for his negligence(1st infringement).

It was observed that FORSETI (Darshan R.N) raced fiercely between the 1100 Metres till about 700 Metres.

Jockey P. Trevor, the rider of PLACE VENDOME reported that his whip got entangled in his rein between the 175 Metres till about 125 Metres. As the incident was accidental no action was taken beyond noting his explanations.

Compulsory urine and blood samples were taken for analysis from the following I,II & III placed horses viz:

### 7<sup>th</sup> Race: 192. The Charminar Plate - (About) 1800 metres. Horses rated 20 to 45 (7 Runners).

Permission was granted to Trainer Mr. Prasanna Kumar to withdraw TACTICAL COMMAND (S. John) on veterinary grounds as it was found to be walking lame on right hind. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

TYTO ALBA (Rajesh Kumar M) threw its head up in the air and did not raise a fluent gallop till 1600 Metres. In view of its behaviour, Trainer Mr.Narayana Gowda .V was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Vinod Shinde, the rider of GULFSTREAM PARK reported that his mount stumbled soon after the start and passing the 1600 Metres.

Jockey P. Trevor, the rider of AFERPI reported that his mount was hanging 'in' in the final 200 Metres of the race. The horse was subjected to veterinary examination but no abnormality was reported.

Jockey Shamaz Shareef, the rider of SUPER RUFFIAN reported that his mount was lugging 'in' under pressure in the final 200 Metres of the race. The horse was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b f MUIRFIELD.

### 8<sup>th</sup> Race: 193. The Manikyadhara Falls Plate - (About) 1200 metres. Horses rated 20 to 45 (11 Runners).

Trainer Mr.S. Dominic was fined Rs.10,000/- by the Stewards for not declaring his charge SONGKRAN to start after having accepted with it to run in the above race.

Jockey Salman Khan, the rider of MEGA SUCCESS was fined Rs.2,000/- for shifting 'in' and causing interference to MASHA (Nazerul Alam) on his inside passing the 900 Metres.

Routine Sample was taken for analysis from the winner ch m SECRETSUPERSTAR.

### 9<sup>th</sup> Race: 194. The Subansiri Plate - (About) 1200 metres. Horses rated 00 to 25, 5 years old and over (12 Runners).

Jockey D'nuSingh Deora replaced the indisposed Jockey A. Imran Khan on TOP NEWS.

FOVEAL VISION (Harish B.) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Prasanna Kumar was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

TOP NEWS (D'nuSingh Deora) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. S. Dominic was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Nazerul Alam, the rider of CHUL BUL RANI was fined Rs.3,000/- for cutting across the field and tightening the horses on his inside viz; ESTELLA (Abhay Singh), PERFECT HALO (S. Saqlain) and BELDONA (C.Umesh) before passing the red marker post.

SYMPHONY OF SEAS (P. Mani) ran detached from the field. The horse was subjected to veterinary examination. On examination, it was found to be lame on left fore. Trainer Mr. Warren Singh was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

An enquiry is being held into the running and riding of BELDONA, trained by Mr.Kishan Thomas and ridden by Jockey C.Umesh in the above race.

BELDONA (C.Umesh) was impounded for veterinary examination but no abnormality was reported.

Surprise sample was taken for analysis from b m BELDONA.

Routine Sample was taken for analysis from the winner b m CHUL BUL RANI.

## ADDITIONAL REPORTS BANGALORE WINTER MEETING 2021-22 NINTH DAY , FRIDAY , 26<sup>TH</sup> NOVEMBER, 2021

Race: 60. The Youre So Beautiful Plate - Div. II - (About) 1200 metres. Horses rated 20 to 45.

#### **(A)**

The Stipendiary Stewards reported Trainer Mr. Kishan Thomas to the Stewards on 24<sup>th</sup> February, 2022 for Unsatisfactory running of his charge SECRETSUPERSTAR, (thereby violating – alleged breach of rules) Rule No. 202 (xvi) of the BTC Rules of Racing Racing read with BTC Calendar Notification under the heading "PUNISHMENT TO TRAINERS BY STIPENDIARY STEWARDS / STEWARDS (Unsatisfactory Running of charge under Clause -10)".

The Stewards considering the Charge Sheet No.776 issued to Trainer Mr. Kishan Thomas, after viewing the CCTV replay, submissions made by Trainer Mr. Kishan Thomas and After deliberations, they decided to:

- (a) Suspend the trainer's Licence granted to him with effect from 14<sup>th</sup> March, 2022 to 19<sup>th</sup> March, 2022 (both days inclusive) and fine him a sum of Rs.50,000/-for Unsatisfactory Running of his charge SECRETSUPERSTAR, for violating alleged breach of rules i.e., Rule No. 202 (XVI) of the BTC Rules of Racing read with BTC Calendar Notification under the heading "PUNISHMENT TO TRAINERS BY STIPENDIARY STEWARDS / STEWARDS (Unsatisfactory Running of charge under Clause -10)".
- (b) He was informed of his right to appeal.

#### <u>(B)</u>

The Stipendiary Stewards reported Jockey Chethan Kalay.S to the Stewards on 24<sup>th</sup> February, 2022 for Unsatisfactory Riding [Rule No. 161 (ii) of the BTC Rules of Racing] on his mount SECRETSUPERSTAR in the above race.

The Stewards after considering the Charge Sheet No.775 issued to Jockey Chethan Kalay.S, after viewing the CCTV replay of the race, submissions made by Jockey Chethan Kalay.S and after deliberations, they decided to:

- (a) Suspend the Jockey's Licence granted to him with effect from 19<sup>th</sup> March, 2022 to 26<sup>th</sup> March, 2022 (both days inclusive) and fine him a sum of Rs.25,000/- and further resolved that should he apply for the grant of "A" Jockeys licence under B.T.C Rules of Racing for the forthcoming Season 2022-23, the same will be granted subject to the condition that his licence will be suspended for the first five (5) race days of the Bangalore Summer Meeting 2022 (the dates will be notified at a later date) for Unsatisfactory Riding [Rule No. 161 (ii) of the BTC Rules of Racing] on his mount SECRETSUPERSTAR (Permitted to ride work).
  - (b) He was informed of his right to appeal.

#### **ELEVENTH DAY, SATURDAY, 4<sup>TH</sup> DECEMBER, 2021**

### Race: 75. The Sharavati Plate - (About) 1600 metres. Horses rated 20 to 45, 5 years old and over.

The Stipendiary Stewards reported Jockey Arul J.H. to the Stewards on 24<sup>th</sup> February, 2022 for Unsatisfactory Riding [Rule No. 161 (ii) of the BTC Rules of Racing] on his mount MARCO POLO.

The Stewards after considering the Charge Sheet No.780 issued to Jockey Arul J.H., after viewing the CCTV replay of the above race, submissions made by Trainer Mr. Pradeep Annaiah & Jockey Arul. J.H. and after deliberations, they decided to:

- (a) Fine Jockey Arul J.H a sum of Rs.5,000/- for Unsatisfactory riding [Rule No. 161 (ii)] on your mount MARCO POLO of BTC Rules of Racing.
- (a) Fine Trainer Mr. Pradeep Annaiah a sum of Rs.5,000/- for Unsatisfactory explanations tendered by him during the enquiry in respect of his charge MARCO POLO.

#### FIFTEENTH DAY, THURSDAY, 30<sup>TH</sup> DECEMBER, 2021

## Race: 112. The Chambal Plate - Div. II - (About) 1200 metres. Horses rated 00 to 25, 5 years old and over, to be ridden by Indian Jockeys claiming allowance (Whips not allowed).

The Stipendiary Stewards reported Jockey Nazar Alam to the Stewards on 24<sup>th</sup> February, 2022 for Contravention of Rule No. 159 (a) & (b) of the B.T.C. Rules of Racing on his mount AEROSPEED.

The Stewards after considering the Charge Sheet No.781 issued to Jockey Nazar Alam and viewing the CCTV replay of the race, submissions made by Jockey Nazar Alam and after deliberations, they decided to change the charges levied against Jockey Nazar Alam by the Stipendiary Stewards for Contravention of Rule No. 159 (b) of the B.T.C Rules of Racing to Unsatisfactory Riding 161 (ii) of the B.T.C. Rules of Racing and thereafter decided as under:-

- (a) Suspend the Jockey's Licence granted to him with effect from 14<sup>th</sup> March, 2022 to 26<sup>th</sup> March, 2022 (both days inclusive) and further resolved that should he apply for the grant of "B" Jockeys licence under B.T.C Rules of Racing for the forthcoming Season 2022-23, the same will be granted subject to the condition that his licence will be suspended for the first four (4) race days of the Bangalore Summer Meeting 2022 (the dates will be notified at a later date) for Unsatisfactory Riding [Rule No. 161 (ii) of the BTC Rules of Racing] on his mount AEROSPEED (Permitted to ride work).
- (b) He was informed of his right to appeal.

### Race: 113. The Kodagu Plate - Div. II - (About) 1400 metres. Horses rated 20 to 45, 4 years old and over.

The Stipendiary Stewards reported Jockey S. Saqlain to the Stewards on 24<sup>th</sup> February, 2022 for Contravention of Rule No. 159 (a) & (b) of the B.T.C. Rules of Racing on his mount AIR BLAST.

The Stewards after considering the Charge Sheet No.784 issued to Jockey S. Saqlain and viewing the CCTV replay of the race, submissions made by Trainer Mr. Sulaiman S. Attaollhi (Spokesperson for Jockey S. Saqlain), Trainer Mr. Arjun Mangalorkar and deputizing Trainer Mr. Neil B. Devaney and after deliberations, they decided to change the charges levied against Jockey S. Saqlain by the Stipendiary Stewards for Contravention of Rule No. 159 (a) & (b) of the B.T.C Rules of Racing to Unsatisfactory Riding 161 (ii) of the B.T.C. Rules of Racing and thereafter decided as under:-

- (a) Suspend the Jockey's Licence granted to him with effect from **14**<sup>th</sup> **March, 2022 to 26**<sup>th</sup> **March, 2022** (both days inclusive for Unsatisfactory Riding [Rule No. 161 (ii) of the BTC Rules of Racing] on his mount AIR BLAST (Permitted to ride work).
- (b) Note the explanations tendered by Trainer Mr. Arjun Mangalorkar and deputizing Trainer Mr. Neil B. Devaney.
- (c) He was informed of his right to appeal.

#### SEVENTEENTH DAY, TUESDAY, 11<sup>TH</sup> JANUARY, 2022

### Race: 122. The S.V. Subramaniam Memorial Trophy - (About) 1200 metres. Horses rated 40 to 65, 5 years old and over.

An enquiry was held on 26<sup>th</sup> February, 2022 by the Stipendiary Steward for the above race with respect to Jockey Md. Akram on his mount STARRY WIND. In that "He failed to make sufficient effort in riding out his mount in the above race more so in the final 250 Metres when his horse was hanging out he used his whip in the right and allowed his mount to drift out".

Jockey Md. Akram was interviewed by the Stipendiary Steward. The Stipendiary Steward after considering the submissions made by Jockey Md. Akram and after viewing the CCTV decided to charge Jockey Md. Akram for Incompetent Riding.

The Stipendiary Steward thereafter suspended the Jockey's Licence granted to Jockey Md. Akram on **11**<sup>th</sup> **March, 2022** as he had pleaded guilty of the charge under Rule No. 161 (ii) of the BTC Rules of Racing for Incompetent Riding on his mount STARRY WIND (he was permitted to ride work) and was informed of his right to appeal.

#### TWENTIETH DAY, WEDNESDAY, 26<sup>TH</sup> JANUARY, 2022

### Race: 153. The Totalizator Cup - Div. I - (About) 1200 metres. Horses rated 20 to 45.

The Stipendiary Stewards reported Jockey S.A. Gray to the Stewards on 25<sup>th</sup> February, 2022 for Contravention of Rule No. 159 (a) & (b) of the B.T.C. Rules of Racing on his mount DOUGLAS.

The Stewards after considering the Charge Sheet No.782 issued to Jockey S.A. Gray, after viewing the CCTV replay of the race and submissions made by Jockey S.A. Gray and Trainer Mr S. Padmanabhan decided to limit the charges from 159 (a) & (b) to contravention of Rule No. 159 (b) of the B.T.C. Rules of Racing.

After deliberations, they have decided to:

- (a) Suspend the Jockey's License granted to him with effect from 8th March, 2022 to 7th April, 2022 (both days inclusive) and fine him a sum of Rs 25,000/- for contravention of Rule 159 (b) of the BTC Rules of Racing on his mount DOUGLAS (He is permitted to ride work).
- (b) Note the explanations tendered by Trainer Mr. S. Padmanabhan.
- (c) He was informed of his right to appeal.
