TWENTYFIRST DAY , THURSDAY , 3rd FEBRUARY, 2022

RACING INCIDENTS

(159 - 166)

GOING : Good

PENETROMETER READING: 4.0 Cms.

RAILING POSITION : Railing fixed at average width of 9.0 Meters from 1600 Meters to winning post from its original position.

1st Race: 159. The Indravati Plate - Div. II - (About) 1400 metres. Horses rated 00 to 25, 6 years old and over (11 Runners).

Trainer Mr. Neil Darashah was fined Rs.1,000/- for failing to produce the declared colors at the scales in respect of his charge AKASI (Ahsan Qureshi). Subsequently, All Black emergency colors were permitted to be used.

IRON FIST (Surya P.) planted, lost many lengths at the start and ran detached thereafter. In view of its behaviour, Trainer Mr.Pradeep Annaiah was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey K. Sai Kiran, the rider of ELITE AGENT was fined Rs.2,000/- for shifting 'in' and causing interference to HE'S THE ONE (Darshan R.N) on his inside approaching 200 Metres.

Jockey Ahsan Qureshi, the rider of AKASI was reprimanded for riding an indifferent race.

Jockey Naveen Kumar. V, the rider of PALM READER was reprimanded for dropping hands before passing the winning post.

Jockey Ajeet Kumar, the rider of SMILE AROUND was reprimanded for dropping hands before passing the winning post.

IRON FIST (Surya P.) was subjected to veterinary examination. On examination, it was found to be lame on right fore. Trainer Mr. Pradeep Annaiah was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

HE'S THE ONE (Darshan R.N) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner dk b g ELITE AGENT.

2nd Race: 160. The Splendid Role Plate - (About) 1100 metres. Maiden Horses 3 years old only. (7 Runners).

FORTY NINER (M. Mark) dropped the rider at the starting gates, bolted anticlockwise, galloped on outer sand track and was apprehended in the paddock. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order.

ROMANTIC HEART (K. Sai Kiran) jumped awkwardly outwards and inconvenienced SPIRIT (Prashant P.Dhebe) soon after the start.

Jockey Prashant P.Dhebe, the rider of SPIRIT was fined Rs.2,000/- for not wearing goggles during the race.

Routine Sample was taken for analysis from the winner ch c RAVISHING FORM.

3rd Race: 161. The Indravati Plate - Div. I - (About) 1400 metres. Horses rated 00 to 25, 6 years old and over (11 Runners).

Jockey K. Sai Kiran, the rider of COMMANDPOST was fined Rs.1,000/- for dropping hands in the final 200 Metres for no apparent reason.

PROUDWISH (Surya P.) ran detached from the field. Trainer Mr. Pradeep Annaiah was informed to ensure better performance of his charge in future.

Jockey Naveen Kumar. V, the rider of BIRCHWOOD was fined Rs.5,000/- for not making sufficient effort on his mount during the race.

Routine Sample was taken for analysis from the winner b m LIFEISAMIRACLE.

4th Race: 162. The Kadambi Falls Plate - Div. II - (About) 1400 metres. Horses rated 20 to 45, 5 years old and over (12 Runners).

KIMETTO (K. Sai Kiran) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr.Narayana Gowda V. was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

It was observed that MY ONE AND ONLY (Tauseef Ahmed) was inclined to run between the 700 Metres to 600 Metres.

Jockey Ajeet Kumar, the rider of GOLD GRAY was fined Rs. 1,000/- for shifting 'in' and causing interference to OZARK (D'nusingh Deora), whereby NOSTRADAMUS (M. Mark) which was travelling directly behind had to be check by its rider approaching 1000 Metres.

Routine Sample was taken for analysis from the winner gr h LORD FRANKEL.

5th Race: 163. The Hassan Plate - (About) 2000 metres. Horses rated 40 to 65 (3 Runners).

At request of Trainer Mr. Imtiaz Khan, PELUCHE (Antony Raj S.) was examined at the saddling enclosure and found to be trotting lame on right fore. Under the circumstances, it was permitted to be withdrawn on veterinary grounds. Trainer was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner dk b m ANTIBES.

6th Race: 164. The Stayers Trial Stakes - (About) 2400 metres. 4 years old and over at the time of starting. (5 Runners).

Jockey S. John, the rider of SALAZAAR was fined Rs.10,000/- for shifting 'in' and causing interference to the horses viz; TOWERING PRESENCE (Akshay Kumar) and SPEEDSTER (Suraj Narredu) on his inside approaching 600 Metres and for further shifting 'in' and causing severe interference to SPEEDSTER (Suraj Narredu) and BISATE (P. Trevor) passing 500 Metres.

Jockey P. Trevor, the rider of BISATE reported that his mount was making a roaring noise and was choking in the final 250 Metres. The horse was subjected to veterinary examination. On immediate examination, it was found to have ILH Paralysis Grade - IV (On Endoscopy). Trainer Mr. Laxman Singh was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was reported after the race that SALAZAAR (S. John) pulled up lame on right fore. Trainer Mr. Irfan Ghatala was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner gr m SPEEDSTER.

7th Race: 165. The Raichur Plate - (About) 1200 metres. Horses rated 40 to 65 (8 Runners).

Jockey Akshay Kumar was fined Rs.2000/- for not drawing the declared weight on the scales. Subsequently, permission was granted to Trainer Mr. S.S. Attaollahi to declare Jockey D'nuSingh Deora to ride KATANA in place of the declared rider.

SET TO WIN (Vishal N Bunde) was slowly away, lost many lengths and ran detached till about 200 Metres. In view of its repeated behaviour, Trainer Mr. Sharat Kumar was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Routine Sample was taken for analysis from the winner b g KNIGHT IN HOOVES.

8th Race: 166. The Kadambi Falls Plate - Div. I - (About) 1400 metres. Horses rated 20 to 45, 5 years old and over (12 Runners).

Jockey Kiran Rai P, the rider of AZTEC QUEEN was reprimanded for shifting 'in' and inconveniencing EXTRAORDINARY (K. Sai Kiran) on his inside soon after the start.

It was observed that EXTRAORDINARY (K. Sai Kiran) was inclined to run out between the 900 Metres to 800 Metres.

Jockey P. Trevor, the rider of IN A BREEZE reported that his mount was hanging 'in' after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Irfan Ghatala was informed to take appropriate corrective measures before accepting with it again.

Jockey Md. Habeeb, the rider of STRIKING MEMORY reported that he accidentally lost his whip passing the 200 Meters.

Jockey Kiran Rai P, the rider of AZTEC QUEEN was fined Rs.1,000/- for shifting out and causing interference to TWINKLE FEET (Arshad Alam), which in turn passed it onto SHINING ROCK (Surya P.) on his outside approaching 100 Metres.

Jockey Naveen Kumar. V, the rider of GYPSY was reprimanded for travelling wide rounding the final bend for no apparent reason.

Jockey K. Sai Kiran, the rider of EXTRAORDINARY was reprimanded for travelling wide rounding the final bend for no apparent reason.

VENUS BAY (V.R. Jagadeesh) ran detached from the field till about the final 100 Metres. Trainer Mr. Azhar Ali was informed to ensure better performance of his charge in future.

Routine Sample was taken for analysis from the winner b g SMITHSONIAN.

Permission was granted to trainers Mr. S. Narredu and Kishan Thomas to deputize on behalf of trainers Mr. Rajesh Narredu and Prasanna Kumar who were unable to attend the races.

NINTH DAY , FRIDAY , 26TH NOVEMBER, 2021

Race: 62. The Youre So Beautiful Plate - Div. I - (About) 1200 metres. Horses rated 20 to 45.

(A)

The Stipendiary Stewards reported Trainer Mr. Azhar Ali to the Stewards on 2nd February, 2022 for Unsatisfactory Running of his charge REALIA, (thereby violating – alleged breach of B.T.C rule) Rule No. 202 (XVI) of the BTC Rules of Racing read with BTC Calendar Notification under the heading “PUNISHMENT TO TRAINERS BY STIPENDIARY STEWARDS / STEWARDS (Unsatisfactory Running of charge under Clause -10)”.

The Stewards considering the Charge Sheet No.696 issued to Trainer Mr. Azhar Ali and examined him.

After deliberations, they decided to:

- (a) Fine him a sum of Rs.50,000/- for Unsatisfactory Running of his charge REALIA, for violating – alleged breach of rules i.e., Rule No. 202 (XVI) of the BTC Rules of Racing read with BTC Calendar Notification under the heading “PUNISHMENT TO TRAINERS BY STIPENDIARY STEWARDS / STEWARDS (Unsatisfactory Running of charge under Clause -10)”.
- (b) He was informed of his right to appeal.

(B)

The Stipendiary Stewards reported Jockey Chethan Kalay.S to the Stewards on 2nd February, 2022 for Unsatisfactory Riding on his mount REALIA.

The Stewards after considering the Charge Sheet No. 697 issued to Jockey Chethan Kalay. S and after viewing the CCTV replay of the above race and after deliberations, they decided to:

- (a) Suspend the Jockey's Licence granted to him with effect from **12th February, 2022 to 18th March, 2022** (both days inclusive) and fine him a sum of Rs.25,000/- for Unsatisfactory Riding [Rule No. 161 (ii) of the BTC Rules of Racing] on his mount REALIA (Permitted to ride work).
- (b) He was informed of his right to appeal.

TENTH DAY , FRIDAY , 3RD DECEMBER, 2021

Race: 69. The Mahanadi Plate - (About) 1600 metres. Horses rated 00 to 25, 4 years old and over.

The Stipendiary Stewards reported Jockey Arshad Alam to the Stewards on 3rd February, 2022 for Unsatisfactory Riding [Rule No. 161 (ii) of the BTC Rules of Racing] on his mount AMALFI SUNRISE in the above race.

The Stewards after considering the Charge Sheet No. 698 issued to Jockey Arshad Alam and viewing the CCTV replay of the race & after deliberations, they decided to:

- (a) Suspend the Jockey's Licence granted to him with effect from **13th February, 2022 to 26th February, 2022** (both days inclusive) for Unsatisfactory Riding [Rule No. 161 (ii) of the BTC Rules of Racing] on his mount AMALFI SUNRISE (Permitted to ride work).
- (b) He was informed of his right to appeal.

THIRTEENTH DAY , SATURDAY , 18TH DECEMBER, 2021

Race: 101. The Karnataka Police Trophy - (About) 1600 metres. Horses rated 60 to 85.

The Stipendiary Stewards reported Jockey Antony Raj.S to the Stewards on 3rd February, 2022 for Dangerous riding on his mount ELECTRA. In that he shifted "in" unnecessarily and caused severe interference to POSEIDON (S. Saqlain) who got squeezed between the railing and his mount, thereby dislodging the rider Jockey S. Saqlain approaching 1400 Meters.

The Stewards after considering the Charge Sheet No.699 issued to Jockey Antony Raj. S and viewing the CCTV replay of the race & after deliberations, they decided to:

- (a) Suspend the Jockey's Licence granted to him with effect from **13th February, 2022 to 26th February, 2022** (both days inclusive) and fine him a sum of Rs.20,000/- for Dangerous Riding [Rule No. 161 (i) of the BTC Rules of Racing] on his mount ELECTRA (Permitted to ride work).
- (b) He was informed of his right to appeal.

FIRST EXTRA DAY , SATURDAY , 11TH DECEMBER, 2021

Race: 89. The Dare To Dream Plate - (About) 1600 metres. Horses rated 00 to 25, 4 years old and over.

The Stipendiary Stewards reported Jockey Darshan R.N to the Stewards on 3rd February, 2022 for Unsatisfactory Riding [Rule No. 161 (ii) of the BTC Rules of Racing] on his mount CINCO DE MAYO in the above race.

The Stewards after considering the Charge Sheet No.774 issued to Jockey Darshan R.N and viewing the CCTV replay of the race and after deliberations, they decided to:

- (a) Suspend the Jockey's Licence granted to him with effect from **13th February, 2022 to 19th February, 2022** (both days inclusive) for Unsatisfactory Riding [Rule No. 161 (ii) of the BTC Rules of Racing] on his mount CINCO DE MAYO (Permitted to ride work).
- (b) He was informed of his right to appeal.

TWELFTH DAY , FRIDAY , 10TH DECEMBER, 2021

Race: 88. The Krishna Plate - Div. I - (About) 1200 metres. Horses rated 00 to 25, to be ridden by Indian Jockeys Claiming Allowance.

The Stipendiary Stewards reported Jockey L. Alex Rozario to the Stewards on 2nd February, 2022 for Contravention of Rule No. 159 (b) of the B.T.C. Rules of Racing on his mount THE INHERITOR.

The Stewards after considering the Charge Sheet No.778 issued to Jockey L. Alex Rozario and viewing the CCTV replay of the race and after deliberations, they decided to change the charges levied against Jockey L. Alex Rozario by the Stipendiary Stewards for Contravention of Rule No. 159 (b) of the B.T.C. Rules of Racing to Unsatisfactory Riding 161 (ii) of the B.T.C. Rules of Racing and thereafter decided as under:-

- (a) Suspend the Jockey's Licence granted to him with effect from **12th February, 2022 to 19th February, 2022** (both days inclusive) for Unsatisfactory Riding [Rule No. 161 (ii) of the BTC Rules of Racing] on his mount THE INHERITOR (Permitted to ride work).
- (b) He was informed of his right to appeal.

THIRTEENTH DAY , SATURDAY , 18TH DECEMBER, 2021

**Race: 96. The Wind Stream Plate - Div. II - (About) 1400 metres.
Horses rated 00 to 25, 5 years old and over.**

An enquiry was held into the running and riding of FLORENCIA, trained Mr. S. Inayathulla and ridden by Jockey Salman Khan in the above race. After due enquiry, their explanations were noted for future reference.

**Race: 103. The Wind Stream Plate - Div. I - (About) 1400 metres.
Horses rated 00 to 25, 5 years old and over.**

An enquiry was held into the running and riding of SMILE AROUND, trained by Mr. Sharat Kumar and ridden by Jockey P. Sai Kumar in the above race. After due enquiry, at this instance a grave benefit of doubt was given to Jockey P. Sai Kumar. However, he was severely cautioned as to the future riding.
