RAILING POSITION: Railing fixed at average width of 4.0 Meters from 1600 Meters to winning post from its original position.

1st Race: 195. The Damodar Plate - (About) 1400 metres. Horses rated 00 to 25 (Whips not allowed) (10 Runners).

FLOWER OF PARADISE (Vishal N Bunde) was kicked by another horse on the way to the starting gates as such it was examined by the Club's Veterinary Officer and was found to have sustained bleeding cut injury on right forearm. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr.V. Lokanath was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

KIMETTO (K. Sai Kiran) was examined at the starting gate by the Club's Veterinary Officer and was found to be trotting lame on left hind. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr.Narayana Gowda .V was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

KARACHI (Antony Raj S.) reared up as the gates opened and lost many lengths at the start. An enquiry is being held into the incident.

SPEAKING OF SKIES (Ikram Ahmed) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Imtiaz Khan was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

PRINCESS AURA (Arvind Kumar. N) after jumping out did not raise a fluent gallop for the first 200 Metres and ran detached from the field. In view of its behaviour, Trainer Mr.Kishan Thomas was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

AIR DISPLAY (Salman Khan) jumped awkwardly outwards.

RHAPSODY IN GREEN (Nazerul Alam) jumped awkwardly inwards.

Jockey K.G. Likith Appu, the rider of FREDERICO was fined Rs.1,000/- for shifting 'in' and causing interference to SPEAKING OF SKIES (Ikram Ahmed) on his inside approaching 900 Metres, whereby SPEAKING OF SKIES (Ikram Ahmed) stumbled.

Jockey K.G. Likith Appu, the rider of FREDERICO was reprimanded for shifting out and inconveniencing RHAPSODY IN GREEN (Nazerul Alam) on his outside passing the 700 Metres.

It was observed that SPEAKING OF SKIES (Ikram Ahmed) accidentally brushed the running rails passing the 500 Metres.

Jockey Ikram Ahmed, the rider of SPEAKING OF SKIES reported that his goggle snapped and came off approaching 400 Metres.

It was reported after the race that KARACHI (Antony Raj S.) burst its blood vessels. Trainer Mrs. Parvati Byramji was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was reported after the race that FREDERICO (K.G. Likith Appu) burst its blood vessels. Trainer Mr.Irfan Ghatala was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner dk b g MITSURO.

2nd Race: 196. The Sabarmati Plate - Div. II - (About) 1200 metres. Horses rated 00 to 25, 6 years old and over (9 Runners).

Permission was granted to Trainer Mr.M. Rajendra Singh to withdraw BLACK WHIZZ (Suraj Narredu) on veterinary grounds as it was found to have abrasion of left fore fetlock, knee, shoulder and left hock. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Harish B replaced the indisposed Jockey Surya.P on GLORIOUS DAYS.

GAZEBO TALK (Ahsan Qureshi) bolted on the way to the starting gates, dislodged the rider and since the horse had galloped for a considerable distance. It was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr. Neil B Devaney was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

BLAZING ENGINE (Arvind Kumar. N) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Kishan Thomas was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Routine Sample was taken for analysis from the winner b g ULTIMATE STRIKER.

3rd Race: 197. The Gomos Plate - (About) 1400 metres. Maiden Horses 3 years old only. (10 Runners).

Jockey Suraj Narredu, the rider of ALL ATTRACTION reported that his mount was running green throughout the race.

Jockey Akshay Kumar, the rider of TRIUMPHANT was reprimanded for shifting out and inconveniencing MOUNT ETNA (Arshad Alam) on his outside passing the 1000 Metres.

It was observed that Jockey M. Mark, the rider of SUNWAY LAGOON had to ride in check between the 1000 Metres to 900 Metres due to a closely packed field.

CYRENIUS (S. A. Gray) sustained superficial clip injury on left hind cannon and abrasion on left hind fetlock.

Routine Sample was taken for analysis from the winner dk b c CYRENIUS.

4th Race: 198. The Shivaganga Falls Plate - Div. II - (About) 1200 metres. Horses rated 20 to 45 (12 Runners).

REALIA (K. Sai Kiran) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr.Azhar Ali was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

CAPRI GIRL (D'nuSingh Deora) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Prasanna Kumar was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Darshan R.N, the rider of REGAL MELODY reported that his mount was not galloping fluently after entering the straight and ran detached. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Prithviraj B. was informed to ensure better performance of his charge in future.

Jockey Antony Raj S., the rider of OCEAN DUNES reported that he accidently lost his whip passing the 200 Meters.

It was reported after the race that MATERA (Suraj Narredu) burst its blood vessels. Trainer Mrs.Parvati Byramji was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

An enquiry is being held into the inconsistent pattern of running and reversal of form of OCEAN DUNES, trained by Mr. Arjun Mangalorkar and ridden by Jockey Antony Raj S. in the above race as compared to its previous run in Race No. 188 i.e., The Hiranyakeshi Plate, (about) 1200 Metres Horses rated 20 to 45, 5 years old and over run on 25/2/2022 wherein it ran unplaced.

Routine Sample was taken for analysis from the winner b g OCEAN DUNES.

5th Race: 199. The Topmost Plate - (About) 1200 metres. Horses 3 years old only. (8 Runners).

It was observed that ROYAL GLORY (Ranjeet Singh) was inclined to run out between the 800 Metres to 700 Metres.

Jockey S. Hussain, the rider of BESUGE reported that he had to steady his mount approaching 700 Metres.

It was observed that OOH LA LA (D. Patel) was inclined to run out between the 800 Metres to 700 Metres.

Trainer Mr. S. Padmanabhan and Jockey S.A. Gray were questioned regarding running and riding of FORTUNATUS. Jockey stated that:

- (a) He was instructed to ride from a handy position;
- (b) Get a cover and pull out and do his best in the straight;
- (c) He rode as per instructions but his mount was lugging out under pressure in the final 200 Metres, he also made an effort to change his whip hand and tried to keep it on an even keel, but it could only finish 3rd.

The Trainer while corroborating the statements of the Jockey add that he felt that his horse needs a longer distance. Their explanations were noted for future reference. FORTUNATUS(S. A. Gray) was impounded for veterinary examination but no abnormality was reported.

Surprise sample was taken for analysis from b c FORTUNATUS.

Routine Sample was taken for analysis from the winner b g YUKAN.

6th Race: 200. The Bellary Plate - (About) 1400 metres. Horses rated 40 to 65, 5 years old and over (9 Runners).

Jockey Salman Khan, the rider of STARRY WIND reported that his mount was hanging out from the 800 Metres. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr.Mahmood Khan was informed to take appropriate corrective measures before accepting with it again.

Routine Sample was taken for analysis from the winner b m AZTEC QUEEN.

7th Race: 201. The Parfait Amour Trophy - (About) 1800 metres. Horses rated 40 to 65, 5 years old and over (5 Runners).

MOHICAN (Nazerul Alam) ran detached from the field. The horse was subjected to veterinary examination. On examination, it was found to be lame on right fore. Trainer Mr. Neil Darashah was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b g JACK RYAN.

8th Race: 202. The Shivaganga Falls Plate - Div. I - (About) 1200 metres. Horses rated 20 to 45 (12 Runners).

Jockey Arvind Kumar. N replaced the indisposed Jockey Surya. P on LAUTERBRUNNEN.

GUN POINT (Vivek) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Kishan Thomas was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Antony Raj S., the rider of PROMISE KEPT was fined Rs.3,000/- for shifting 'in' and causing interference to STONE HOUSE (Kiran Rai P) on his inside approaching 1000 Metres.

It was observed that Jockey Siddaraju. P, the rider of OSIRIS had to steady his mount between the 1000 Metres and 900 Metres due to a closely packed field.

Jockey K. Sai Kiran, the rider of THE STRENGTH was fined Rs.3,000/- for shifting 'in' and causing interference to STONE HOUSE (Kiran Rai P) approaching 900 Metres.

Jockey Rajesh Kumar M, the rider of MYSTICAL MERKABAH reported that his mount was hanging out from 800 Metres till about 500 Metres. The horse was subjected to veterinary examination but no abnormality was reported. Trainer Mr.Narayana Gowda V. was informed to take appropriate corrective measures before accepting with it again.

Routine Sample was taken for analysis from the winner b g TACTICAL COMMAND.

9th Race: 203. The Balmuri Falls Plate - (About) 1600 metres. Horses rated 00 to 25 (12 Runners).

SUPER RUFFIAN (Antony Raj S.) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr.Neil B Devaney was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

HANDSOME ROCKY (Rajesh Kumar. M) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Narayana Gowda.V was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Ahsan Qureshi, the rider of JE NE SAIS QUOI was fined Rs. 1,000/for coming 'in' and causing interference to HANDSOME MOVER (Tauseef Ahmed) on his inside at the start.

Jockey D. Gnaneshwar, the rider of ENRICHMENT was fined Rs.2,000/- for shifting out and causing interference to EXALTED DREAM (M. Prabhakaran), which in turn passed it onto FUN AND LAUGHTER (S. John) on his outside before passing the red marker post.

Jockey Ahsan Qureshi, the rider of JE NE SAIS QUOI was fined Rs.1,000/-for shifting 'in' and causing interference to FOR OLD TIMES (Darshan R.N.) on his inside passing the 1500 Metres.

Jockey M. Mark, the rider of SHUBANKAR was severely reprimanded for slowing the pace approaching 1400 Metres.

Jockey IndraJeet Singh, the rider of ICONIC PRINCESS reported that his saddle shifted forward approaching 1400 Metres as such he could not offer much assistance till about 350 Metres. After due examination of the equipment, Trainer Mr.Arjun Mangalorkar (deputizing on behalf of Trainer Mr. S.S. Attaollahi) was fined Rs.3,000/- for faulty saddling of his charge.

Jockey Darshan R. N., the rider of FOR OLD TIMES was fined Rs.1,000/- for coming 'in' and causing interference to FUN AND LAUGHTER (S. John), which in turn passed it onto ICONIC PRINCESS (Indrajeet Singh) on his inside approaching 200 Metres.

SHUBANKAR (M. Mark) sustained superficial injury on right fore fetlock.

Routine Sample was taken for analysis from the winner b g JE NE SAIS QUOI.

10th Race: 204. The Sabarmati Plate - Div. I - (About) 1200 metres. Horses rated 00 to 25, 6 years old and over (10 Runners).

BRAMASTRAM (L. Alex Rozario) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. M. Rajendra Singh was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Darshan R.N, the rider of ULTIMATE SPEED was fined Rs.1,000/- for shifting out and causing interference to the horses on his outside viz; CELESTIAL HIGHWAY (Vivek) and AMAZING LUCK (Siddaraju.P) at the start.

Jockey G.Y. Rajesh Babu, the rider of SHE'S INNOCENT was reprimanded for travelling wide between the 600 Metres to 500 Metres for no apparent reason.

Jockey Darshan R.N, the rider of ULTIMATE SPEED reported that his mount was hanging out throughout the race. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. V. Lokanath was informed to take appropriate corrective measures before accepting with it again.

Jockey K. Sai Kiran, the rider of GOLD GRAY was fined Rs.1,000/- for coming 'in' and causing interference to HABANERO (Antony Raj S.) on his inside in the final 75 Metres of the race.

Jockey Nazerul Alam, the rider of BIRCHWOOD was fined Rs.2,000/- for exulting before passing the winning post.

ARECA ANGEL (Rajesh Kumar M) sustained clip injury on right hock.

Urine and Blood sample were taken for analysis from the winner b g BIRCHWOOD.

Permission was granted to trainer Mr. Arjun Mangalorkar to deputize on behalf of trainer Mr. S.S. Attaollahi who was unable to attend the

ADDITIONAL REPORTS BANGALORE WINTER MEETING 2021-22 EIGHTEENTH DAY, TUESDAY, 18TH JANUARY, 2022

Race: 142. The Nagarjuna Sagar Plate - Div. I - (About) 1400 metres. **Horses rated 00 to 25.**

The Stipendiary Stewards reported Jockey Naveen. M to the Stewards on 11th March, 2022 for Contravention of Rule No. 159 (a) & (b) of the B.T.C. Rules of Racing on his mount THE INHERITOR.

The Stewards after considering the Charge Sheet No.783 issued to Jockey Naveen. M, after viewing the CCTV replay of the race in question, submissions made by Spokesperson Mr. P.S. Chouhan for Jockey Naveen. M and Trainer Mr. Sharat Kumar decided to limit the charges from 159 (a) & (b) to only contravention of Rule No. 159 (b) of the B.T.C. Rules of Racing.

After further deliberations, they decided to:

- (a) Suspend the Jockey's License granted to Jockey Naveen. M with effect from 20th March, 2022 to 30th April, 2022 (both days inclusive) and fine him a sum of Rs 10,000/- and further resolved that should he apply for the grant of "A" Jockeys licence under B.T.C Rules of Racing for the forthcoming Season 2022-23, the same will be granted subject to the condition that his licence shall remain suspended from 1st May, 2022 to 19th June, 2022 for contravention of Rule 159 (b) of the BTC Rules of Racing on his mount THE INHERITOR (He is permitted to ride work).
- (b) Note the explanations tendered by Trainer Mr. Sharat Kumar.
- (c) He was informed of his right to appeal.
