**RACING INCIDENTS**

**(205 - 210)**

**GOING : Good**

**PENETROMETER READING: 3.8 Cms.**

**RAILING POSITION: Railing fixed at average width of 3.0 Meters from 1600 Meters to winning post from its original position.**

**1<sup>st</sup> Race: 205. The Brahmani Plate - Div. II - (About) 1400 metres. Horses rated 00 to 25 (9 Runners).**

Trainer Mr. Neil Darashah was fined Rs.10,000/- for having accepted his charge RHAPSODY IN GREEN (Antony Raj S.) to run in the above race when it was under treatment. Subsequently, permission was granted to him to withdraw it from the above race.

Jockey K. Sai Kiran, the rider of FLAMING ORANGE was fined Rs.2,000/- for coming 'in' and causing interference to ZEHNASEEB (G Sai Vamshi), which in turn passed it onto ICONIC PRINCESS (IndraJeet Singh) on his inside approaching 200 Metres.

It was reported after the race that FLAMING ORANGE (K. Sai Kiran) burst its blood vessels. Trainer Mr. Sharat Kumar was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

ALTAMONTE (Darshan R.N) sustained bleeding cut injury on right nasal septum.

Routine Sample was taken for analysis from the winner b g SUPER GLADIATOR.

**2<sup>nd</sup> Race: 206. The Kumudavathi Plate - (About) 1200 metres. Horses rated 20 to 45, 6 years old and over (12 Runners).**

ELITE AGENT (Rajesh Kumar M) jumped out awkwardly and lost few lengths at the start. In view of its behaviour, Trainer Mr.Narayana Gowda.V was informed not accept with it again until its behavior improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Darshan R.N, the rider of PASTICHE was reprimanded for coming 'in' and tightening DR LOGAN (Anjar Alam) on his inside passing the 600 Metres.

Jockey Surya P., the rider of SKYFIRE reported that his whip got entangled in the reins for a few strides passing the 300 Metres.

SKYFIRE (Surya P.) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner dk b g BENEDICTION.

**3<sup>rd</sup> Race: 207. The Chitravathi Plate - (About) 1400 metres. Horses rated 20 to 45, 5 years old and over (11 Runners).**

CAESARS PALACE was not declared to start for the above race.

Jockey Arvind Kumar. N replaced the indisposed Jockey Kiran Naidu on QUEEN OF SANDS.

CLASSIC CHARM (Kiran Rai P) jumped awkwardly inwards.

Jockey Suraj Narredu, the rider of SEE MY HEELS was fined Rs.1,000/- for shifting 'in' and causing interference to COPPER SUNRISE (D'nuSingh Deora) on his inside passing the 350 Metres.

Jockey Darshan R.N, the rider of SENSATIONAL GREY was reprimanded for shifting out and inconveniencing COPPER SUNRISE (D'nuSingh Deora) on his outside passing the 350 Metres.

Jockey Kiran Rai P, the rider of CLASSIC CHARM reported that he accidentally lost his whip passing the 150 Meters.

Routine Sample was taken for analysis from the winner b m SEE MY HEELS.

**4<sup>th</sup> Race: 208. The Amathos Trophy - (About) 1600 metres. Horses rated 40 to 65 (8 Runners).**

SET TO WIN (Darshan R.N) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Sharat Kumar was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

SOUTHERN DYNASTY (Bhawani Singh) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.S. Ganapathy was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

It was observed that ETOSHA (S. Zervan) was lugging 'in' under pressure in the final 200 Metres of the race.

RULING GODDESS (Akshay Kumar) was subjected to veterinary examination but no abnormality was reported.

ALMANACH (P. Trevor) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g ETOSHA.

**5<sup>th</sup> Race: 209. The Hornadu Plate - (About) 1400 metres. Horses rated 20 to 45 (6 Runners).**

KENSINGTON COURT and BELVEDERE were not declared to start for the above race.

Jockey D'nuSingh Deora, the rider of SCRIBBLING HOPPER was reprimanded for shifting 'in' and inconveniencing MASHA (Vishal N Bunde) on his inside passing the 1000 Metres.

Jockey Vishal N Bunde, the rider of MASHA reported that his mount was hanging out after entering the straight. Trainer Mr.Faraz Arshad was informed to take appropriate corrective measures before accepting with it again.

Routine Sample was taken for analysis from the winner dk b r SCRIBBLING HOPPER.

**6<sup>th</sup> Race: 210. The Brahmani Plate - Div. I - (About) 1400 metres. Horses rated 00 to 25 (8 Runners).**

AIRCRAFT and RUDRAM were not declared to start for the above race.

Jockey Antony Raj S., the rider of DIVINE RAY reported that his mount was running green throughout the race.

It was reported after the race that LIFEISAMIRACLE (K. Sai Kiran) pulled up lame on right fore. Trainer Mr.Sharat Kumar was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

DIVINE MASCULINE (Rajesh Kumar M) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner dk b g AUGUSTO.
