RAILING POSITION: Railing fixed at average width of 3.0 Meters from 1600 Meters to winning post from its original position.

1st Race: 211. The Hindon Plate - Div. II - (About) 1100 metres. Horses rated 00 to 25 (12 Runners).

Jockey P. Sai Kumar replaced the indisposed Jockey K. Sai Kiran on SMILE AROUND.

COMMANDPOST (Rajesh Kumar M) was slowly away and lost many lengths at the start. In view of its behaviour, Trainer Mr.Narayana Gowda .V was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Tousif Khan, the rider of SANTORINI SECRET reported that his mount was keen passing the 800 Metres whereby his mount struck the front runner LIGHTNING CHARLIE (Vishal N Bunde) and SMILE AROUND (P. Sai Kumar) which was travelling directly behind had to be steadied by its rider.

Jockey S. Hussain, the rider of LADY SUPREMOS was fined Rs.1,000/- for coming 'in' and causing interference to SHE'S SUPERB (Arvind Kumar. N) on his inside approaching 400 Metres.

Jockey Vishal N Bunde, the rider of LIGHTNING CHARLIE reported that his mount was running green after entering the straight. The horse was subjected to veterinary examination. On examination, it was found to have abrasion on left Achilles.

Jockey Tousif Khan, the rider of SANTORINI SECRET was severely reprimanded for not fastening his chin strap.

SANTORINI SECRET (Tousif Khan) sustained superficial injury on right hind tendon and fetlock.

Routine Sample was taken for analysis from the winner b g STRIKING POINT.

2nd Race: 212. The Yagachi Plate - (About) 1600 metres. Horses rated 20 to 45, 5 years old and over (8 Runners).

Jockey P. Sai Kumar replaced the indisposed Jockey K. Sai Kiran on ECO FRIENDLY.

TYTO ALBA (Rajesh Kumar M) reared up as the gates opened and lost many lengths. In view of its behaviour, Trainer Mr.Narayana Gowda V. was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

TENALI (D'nuSingh Deora) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Prasanna Kumar was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Antony Raj S., the rider of IN A BREEZE reported that his mount was hanging 'in' after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported.

It was reported after the race that CANDLELIGHTQUEEN (Anjar Alam) burst its blood vessels. Trainer Mr. Azhar Ali was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was reported after the race that TENALI (D'nuSingh Deora) had apparently lost its right hind shoe during the race.

It was reported after the race that LIVISILLA (Suraj Narredu) had apparently lost its left hind shoe during the race and also sustained deep clip injury on left hind fetlock.

Routine Sample was taken for analysis from the winner b m LIVISILLA.

3rd Race: 213. The Catherine Falls Plate - (About) 1400 metres. Horses rated 20 to 45 (7 Runners).

SCRIBBLING HOPPER, REMONTOIR and RUDRAM were not declared to start for the above race.

BUL BULE HIND (Siddaraju.P) ran detached from the field. Trainer Mr. Sharat Kumar was informed to ensure better performance of his charge in future.

It was reported after the race that AUGUSTINA (K.G. Likith Appu) pulled up lame on right fore. Trainer Mr.Neil Darashah was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b f KENSINGTON COURT.

4th Race: 214. The S. Rangarajan Memorial Cup - (About) 1200 metres. Maiden Horses 3 years old only. (10 Runners).

It was observed that MY SOLITAIRE (Shamaz Shareef) stumbled passing the 900 Metres, whereby his mount drifted out and inconvenienced VICTORIA PUNCH (C.Umesh).

MY SOLITAIRE (Shamaz Shareef) abrasion on left hind pastern.

Routine Sample was taken for analysis from the winner b f AMRELI.

5th Race: 215. The Sirimane Falls Plate - (About) 1200 metres. Horses rated 20 to 45 (10 Runners).

Jockey P. Sai Kumar replaced the indisposed Jockey K. Sai Kiran on JOKSHAN.

Jockey Antony Raj S., the rider of OCEAN DUNES was fined Rs.1,000/- for coming 'in' and bumping JOKSHAN (P. Sai Kumar), which in turn passed it onto OSIRIS (Siddaraju.P) on his inside soon after the start.

It was observed that MILLBROOK (S. John) was inclined to run out between the 700 Metres to 500 Metres.

Jockey S. John, the rider of MILLBROOK was fined Rs.3,000/- for the improper use of whip on his mount during the race.

Jockey Akshay Kumar, the rider of THOUSAND WORDS was fined Rs.2,000/-for not maintaining a straight course in the final 150 Metres.

MILLBROOK (S. John) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g THOUSAND WORDS.

6th Race: 216. The Hindon Plate - Div. I - (About) 1100 metres. Horses rated 00 to 25 (11 Runners).

RED LUCIFER (Salman Khan) bolted on the way to the saddling enclosure, galloped for considerable distance and found to have sustained bleeding cut injury on left fore medial bulb. Under the circumstances, it was permitted to be withdrawn on veterinary grounds. Trainer Mr.Irfan Ghatala was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

GUNMASTER (Chethan Gowda) ran detached from the field. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr.Warren Singh was informed to ensure better performance of his charge in future.

It was observed that Jockey Md.Akram, the rider of TURKOMAN had to steady his mount passing the 500 Metres due to closely packed field.

Routine Sample was taken for analysis from the winner dk b f DOMINA.

Permission was granted to trainer Mr. Prasanna Kumar. P to deputize on behalf of trainer Mr. Arjun Mangalorkar who was unable to attend the races.

Race: 63. The Siachen Plate - (About) 1400 metres. Horses rated 20 to 45.

Trainer Mr. S. Inayathulla and Jockey D. Patel were questioned regarding the running and riding of GYPSY in the above race. After due enquiry, Trainer and Jockey were fined Rs.5,000/- each respectively for the unsatisfactory explanations tendered by them during the enquiry for the above race.

THIRTEENTH DAY, SATURDAY, 18TH DECEMBER, 2021

Race: 98. The Field Marshal Plate - (About) 1200 metres. Horses rated 20 to 45, 4 years old and over (Whips not allowed).

Trainer Mr. Pradeep Annaiah and Jockey Arul J.H. were questioned regarding the running and riding of RULE OF ENGAGEMENT. After due enquiry, their explanations were noted for future reference.

<u>EIGHTEENTH DAY, TUESDAY, 18TH JANUARY, 2022</u> (Postponed from Saturday, 15th January, 2022)

Race: 136. The Arkavati Plate - (About) 1600 metres. Horses rated 20 to 45, 5 years old and over.

An enquiry was held into the withdrawal of SECRET SOURCE trained by Mr. S. Narredu. Trainer Mr. S. Narredu along with the syce and Jamedar of SECRET SOURCE were examined by the Stipendiary Stewards. After due enquiry, the Stipendiary Stewards fined Trainer Mr. S. Narredu Rs.10,000/for negligence in discharge of his duties as a trainer thereby Contravening Rule No. 114 (b) (i) of the BTC Rules of Racing for the above race in respect of his charge SECRET SOURCE.

Race: 141. The Sriharikota Plate - (About) 1400 metres. Horses rated 20 to 45.

An enquiry was held into the pattern of running of ANALECT, trained by Mr. Prasanna Kumar and ridden by Jockey Antony Raj .S in the above race as compared to its previous run in Race No. 84 i.e, The Seattle Slew Plate (about) 1200 Metres, Maiden Horses 3 years old only run on 10th December, 2021 wherein it ran 4th. After due enquiry, it was decided to note the explanations tendered by Trainer Mr. Prasanna Kumar.

TWENTIETH DAY, WEDNESDAY, 26TH JANUARY, 2022

Race: 151. The Totalizator Cup - Div. III - (About) 1200 metres. Horses rated 20 to 45.

Trainer Mr. Narayana Gowda.V and Jockey Rajesh Kumar. M were questioned regarding the running and riding of MYSTICAL MERKABAH in the above race. After due enquiry, their explanations were noted for future reference.

ORDER OF THE BOARD OF APPEAL BANGALORE WINTER MEETING 2021-22 TWENTIETH DAY, WEDNESDAY, 26TH JANUARY, 2022

Race: 153. The Totalizator Cup - Div. I - (About) 1200 metres. Horses rated 20 to 45.

The Board of Appeal of Bangalore Turf Club Ltd., at its meeting held on 15^{th} March, 2022 considered the Appeal dated 1^{st} March, 2022 addressed by Jockey S. A. Gray against the decisions of the Stewards at their meeting held on 25^{th} February, 2022.

The Board considered the evidence produced by the Stipendiary Stewards, the Veterinary Officer and Jockey S. A. Gray.

After repeated viewing of the video recording of the race, detailed deliberation, using their wisdom and experience. The Board members arrived at a unanimous decision and held Jockey S. A. Gray "guilty as charged" in this matter.

Thereafter, the Board decided as under:

- (i) Reject the appeal filed by Jockey S. A. Gray.
- (ii) The revised period of suspension of his Jockey's Licence is from 16th March, 2022 to 14th April, 2022 (Both days inclusive) and fine him a sum of Rs.25,000/- for Contravention of Rule No. 159 (b) of the BTC Rules of Racing on his mount DOUGLAS (He was permitted to ride work during his suspension).
- (iii) To forfeit Rs.11,800/- (Inclusive GST) paid by Jockey S. A. Gray towards the Appeal fee.
