PENETROMETER READING: 4.1 Cms.

RAILING POSITION: Railing fixed at its original position.

1st Race: 30. The Sir Charles Todhunter Memorial Trophy - Div. II - (About) 1100 metres. Horses rated 20 to 45 (11 Runners).

GOLDEN RING (Khurshad Alam) reared up, broke the front barriers, bolted and ran rider less. On immediate examination, it was found to have sustained deep cut injury on the muzzle. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr. S. Narredu (deputizing on behalf of Trainer Mr. Rajesh Narredu) was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

EMPRESS BELLA (Naveen Kumar. V) dropped the rider on the way to the starting gates, ran anticlockwise and galloped for almost 1800 Metres. On immediate examination by the Club's Veterinary Officer, it was found to be exhausted. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr. Mahmood Khan was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

THE KING N I (K.G. Likith Appu) took a fly jump.

Jockey K. Sai Kiran, the rider of THE REPUBLIC POWER was fined Rs.3,000/- for not making sufficient effort on his mount during the race.

Jockey K.G. Likith Appu, the rider of THE KING N I reported that he accidentally lost his whip passing the 100 Meters.

THE KING N I (K.G. Likith Appu) sustained superficial injury on right hind pastern.

Routine Sample was taken for analysis from the winner b f ISNT SHE BEAUTIFUL.

2nd Race: 31. The Sutej Plate - (About) 1800 metres. Horses rated 00 to 25 (6 Runners).

As Jockey Vivek was certified medically unfit to ride. Permission was granted to trainer Mr. Warren Singh to substitute Jockey A.R.Pradeep to ride SAND CASTLES in place of the declared rider.

Jockey M. Prabhakaran, the rider of LOVE reported that his mount was hanging 'in' after entering the straight. The horse was subjected to veterinary examination. On examination, it was found to have sharp molars. Hence, Trainer Mr. S. Narredu (deputizing on behalf of Trainer Mr. Rajesh Narredu) was informed that Trainer Mr. Rajesh Narredu was fined Rs.3,000/- for his negligence.

Routine Sample was taken for analysis from the winner b c TURKOMAN.

3rd Race: 32. The Sir Charles Todhunter Memorial Trophy - Div. I - (About) 1100 metres. Horses rated 20 to 45 (12 Runners).

THE GOLDEN DREAM (Naveen Kumar. V) dropped the rider on the way to the starting gates, bolted, ran rider less and galloped for almost 2000 Metres. On immediate examination by the Club's Veterinary Officer, it was found to be exhausted. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr. Sharat Kumar was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

FORTY NINER (Tousif Khan) jumped awkwardly outwards and inconvenienced STAR ADMIRAL (L. Alex Rozario) soon after the start.

It was observed that APPSARA (K.G. Likith Appu) accidentally brushed the running rails passing the 1000 Metres.

It was observed that SCARLET IBIS (A.R.Pradeep) was running green throughout the race. The horse was subjected to veterinary examination but no abnormality was reported.

FORTY NINER (Tousif Khan) sustained superficial cut injury on right fore cannon and fetlock.

THE GREY GERANIUM (Chandrashekar M) was subjected to veterinary examination but no abnormality was reported.

An enquiry was held on 18/12/2022 by the Stipendiary Steward for the above race with respect to the riding of Jockey Chandrashekar .M, the rider of THE GREY GERANIUM in the above race "Wherein he allowed his mount to travel wide from 800 Metres till about 500 Metres for no apparent reason and for not infusing adequate vigour in riding out his mount in the final 400 Metres."

Jockey Chandrashekar .M was interviewed by the Stipendiary Steward. The Stipendiary Steward after considering the submissions made by Jockey Chandrashekar .M and after viewing the CCTV decided to charge Jockey Chandrashekar .M for Incompetent Riding.

The Stipendiary Steward thereafter suspended the Jockey's Licence granted to Chandrashekar .M with effect from **28-12-2022 to 31-12-2022 (Both days inclusive)** for Incompetent Riding under Rule No. 161 (ii) of the BTC Rules of Racing on his mount THE GREY GERANIUM (he is permitted to ride work) and was informed of his right to appeal.

Routine Sample was taken for analysis from the winner b g THE RESPONSE.

4th Race: 33. The D.M.Shivaswamy Memorial Trophy - (About) 1600 metres. Horses rated 40 to 65 (7 Runners).

Permission was granted to Trainer Mr. Arjun Mangalorkar to withdraw ANGEL BLISS (Antony Raj S.) on veterinary grounds as it was found to be lame on left hind and suffering from fever. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

As Jockey S. John was certified medically unfit to ride. Permission was granted to trainer Mr. Arjun Mangalorkar to substitute Jockey Antony Raj S to ride SILVARIUS in place of the declared rider.

Jockey Y. S. Srinath, the rider of DOUGLAS was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

Jockey P. Trevor, the rider of PRAGUE was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

PRAGUE (P. Trevor) sustained superficial injury on tongue.

Routine Sample was taken for analysis from the winner b g DOUGLAS.

5th Race: 34. The Wolf 777 Bangalore 2000 Guineas (Grade II) - (About) 1600 metres. 3-year-old Indian Horses (foaled in 2019) (8 Runners).

Jockey A. Sandesh, the rider of FORTUNATUS was reprimanded for shifting out and inconveniencing LAST WISH (P. S. Chouhan) on his outside approaching 1200 Metres.

Jockey Darshan R.N, the rider of DISRUPTOR reported that he did not get a clear run due to a closely packed field approaching the 350 Metres.

Compulsory urine and blood samples were taken for analysis from the following I,II & III placed horses viz:

6th Race: 35. The Kitty Bank Plate - (About) 1200 metres. Horses rated 40 to 65, 4 years old and over (10 Runners).

IN A BREEZE (L. Alex Rozario) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr.Irfan Ghatala was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Nazerul Alam, the rider of SOUTHERN RULER was reprimanded for travelling wide rounding the final bend for no apparent reason.

Routine Sample was taken for analysis from the winner b g DEL MAR.

7th Race: 36. The December Plate - (About) 1400 metres. Horses rated 20 to 45 (9 Runners).

As Jockey Vivek was certified medically unfit to ride. Permission was granted to trainer Mr. S. Inayathulla to substitute Jockey A.R.Pradeep to ride AKASI in place of the declared rider.

URBAN BORBON (Nazerul Alam) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Prasanna Kumar was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey A.R.Pradeep, the rider of AKASI reported that his mount was hanging out throughout the race. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. S. Inayathulla was informed to take appropriate corrective measures before accepting with it again.

Routine Sample was taken for analysis from the winner ch c SPLENDIDO.

Permission was granted to trainers M/s. S. Narredu and Neil B. Devaney to deputize on behalf of trainers M/s. Rajesh Narredu and Darius R. Byramji who were unable to attend the races.

ORDER OF THE STEWARDS

BANGALORE SUMMER MEETING 2022

FIRST EXTRA DAY, THURSDAY , 11TH AUGUST, 2022

Race: 166. The Winslow Stakes - Div. II - (About) 1200 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible) (Outstation horses eligible).

Detection of prohibited substances in the urine sample of ch f MY SOLITAIRE.

The Stewards of the Bangalore Turf Club Ltd. at their meeting held on Saturday, 17th December, 2022 considered the detailed report submitted by the Stipendiary Steward & the relevant matter connected thereto and Charge Sheet No. 806 dated 16/11/2022 pertaining to the positive finding of [4- METHYLAMINOANTIPYRINE and KETOPROFEN – (Class IV) (prohibited substances) in the urine sample taken from ch f MY SOLITAIRE winner of Race No.166 of the Bangalore Summer Meeting 2022 i.e. The Winslow Stakes - Div. II - (About) 1200 metres. Maiden Horses 3 years old only, run on Thursday, 11th August, 2022. The horse trained by Mr. Prasanna Kumar and owned by M/s. Sans Craintes Stud Farm (p) Ltd.

The Stewards examined trainer Mr. Prasanna Kumar noted the oral submissions made by him during the enquiry as regards this matter and concluded as under:

- (a) Noted that he had partially pleaded guilty of alleged breach of Rule Nos. 19, 23 and 25 with regards to Medication Calendar Notification under the heading "Medication and Treatment of Horses Training and Racing and Anti- Doping Control of Medication Rules" and Rule No. 202 (x) (b) of the B.T.C Rules of Racing as charged by Stipendiary Steward.
- (b) To fine him a sum of Rs. 40,000/- (1st infringement) for the positive finding of [4- METHYLAMINOANTIPYRINE and KETOPROFEN – (Class IV) (prohibited substances) in the urine sample taken from ch f MY SOLITAIRE as contained in BTC Calendar Notification under the heading "Medication and treatment of horses in Training and Racing and Anti-Doping Control of Medication Rules".
- (c) Thereafter, the Stewards decided to fine trainer Mr. Prasanna Kumar a total sum of Rs. 1,00,000/- for contravening Rule Nos. 19, 23 and 25 of the Medication Calendar Notification under the heading "**Medication and Treatment of Horses Training and Racing and Anti- Doping Control of Medication Rules**".

Rule Nos. 19, 23 & 25 reading as follows:-

RULE No. 19

"A trainer must record in his log book (hand written) any medication or treatment administered to any horse in the trainer's care by midnight on the day on which the administration was given.

(1) For the purpose of this Rule, each record of administration must include the following information:-

- (a) the name of the horse;
- (b) the date and time of administration of the treatment or medication;
- (c) the name of the treatment or medication administered (brand name or active constituent);
- (d) the route of administration including by injection, stomach tube, paste, topical application or inhalation;
- (e) the amount of medication given (if applicable);
- (f) the duration of treatment (if applicable);
- (g) the name and signature of the person/s administering and/or authorizing the administration of the treatment or medication.

(2) For the purposes of this rule "treatment" includes:-

- (a) shockwave therapy;

- (b) acupuncture (including laser treatment);
- (c) chiropractic treatment;
- (d) the use of any electrical stimulation device (including transcutaneous electrical nerve stimulation (TENS));
- (e) magnetic field therapy;
- (f) ultrasound;
- (g) any form of oxygen therapy, including hyperbaric oxygen therapy;
- (h) the taking of a blood sample.

(3) For the purposes of this Rule "medication" includes:-

- (a) all Controlled Drugs administered by an approved veterinarian;
- (b) all Prescription Animal Remedies;
- (c) all Prescription Only Medicines, prescribed and/or dispensed by an Approved Veterinarian for off-label use;
- (d) all injectable medicines (intravenous, intramuscular, subcutaneous, intra-articular) not already referred to above;
- (e) all Pharmacist Only medicines;
- (f) all veterinary and other medicines containing other scheduled and unscheduled prohibited substances;
- (h) all herbal/ayurvedic preparations;
- (i) all homeopathic medicines.

(4) Any person who breaches this Rule is guilty of an offence and may be penalized.

RULE No. 23

The Trainer shall always be responsible and accountable at all times for:-

- (a) The management, administration, supervision, security and control of horses and of stable employees under his / her charge;
- (b) The feeding, feed supplements, treatment, stable routine, management, protection and security of the horses in his / her stable;
- (c) For ensuring that only Veterinarians approved by the Stewards inject or otherwise treat horses in his / her care;
- (d) For ensuring that no person is employed as a stable employee in connection with any horse in his / her care unless such person holds a license from the appropriate Authority.

RULE No. 25

- 1) A person must not have in his or her possession or on his or her premises any medication, substance or preparation which has not been registered, labelled, prescribed, dispensed or obtained.
- 2) The Stewards may confiscate any medication, substance or preparation referred to in sub-rule (1), and use it as evidence in any inquiry, hearing or other proceeding under the Rules;
- 3) Any person who breaches this Rule is guilty of an offence and may be penalized."

- (d) To suspend the trainer's licence granted to trainer Mr. Prasanna Kumar **w.e.f 2/1/2023 to 30/1/2023 (Both days inclusive)** for infringement of Rule No. 202 (x) (b) of the B.T.C Rules of Racing.

"Any person who uses or has in his possession, any electric or electronic apparatus or any improper contrivance capable of affecting the performance of a horse in a race or training gallop".

- (e) He was informed of his right to appeal.
