RACING INCIDENTS
(37 - 46)

GOING : Good

PENETROMETER READING: 4.2 Cms.

RAILING POSITION: Railing fixed at average width of 7.0 Meters from 1600 Meters to winning post from its original position.

1st Race: 37. The Yamuna Plate - Div. II - (About) 1200 metres. Horses rated 00 to 25 (Whips not allowed) (11 Runners).

DAWN RISING (Vivek.G) after jumping out swerved towards the left, went onto the sand track till about 1000 Metres. In view of its behaviour, Trainer Mr. Mahmood Khan was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

JAI VIKRAM (Syed Imran) reared up as the gates opened, dislodging its rider and ran rider less thereafter. In view of its behaviour, Trainer Mr. Azhar Ali was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

OSIBISA (Siddaraju.P) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Sharat Kumar was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey K.G. Likith Appu, the rider of PRAIA DO CASSINO was fined Rs.1,000/- for shifting out and causing interference to RED LUCIFER (Antony Raj S.) on his outside passing the 800 Metres.

It was observed that WAR TRAIL (B. L. Paswan) was inconvenienced by the rider less horse JAI VIKRAM passing the 200 Metres.

Routine Sample was taken for analysis from the winner ch f SPIRIT DANCER.

2nd Race: 38. The Kisan Divas Plate - Div. III - (About) 1400 metres. Horses rated 20 to 45 (11 Runners).

EMPRESS BELLA (Chandrashekar M) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Mahmood Khan was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

It was observed that EMPRESS BELLA (Chandrashekar M) was inclined to run out between the 1000 Metres till about 500 Metres and ran detached thereafter. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Mahmood Khan was informed to take appropriate corrective measures before accepting with it again and also to ensure better performance of his charge in future.

Jockey R.Ajinkya, the rider of SINGHSAAB was fined Rs.1,000/- for shifting out and causing interference to OASIS CLASS (Nazerul Alam), which in turn passed it onto AFERPI (Kiran Rai P) on his outside passing the 1000 Metres.

Jockey B. L. Paswan, the rider of THE BEGINNING was fined Rs.1,000/- for shifting out and causing interference to OASIS CLASS (Nazerul Alam), which in turn passed it onto AFERPI (Kiran Rai P) on his outside passing the 450 Metres.

Jockey R.Ajinkya, the rider of SINGHSAAB reported that he momentarily lost his left rein passing the 150 Metres, which he regained within a few strides.

Jockey P. Trevor, the rider of LISTEN TO ME reported that his mount totally stopped galloping in the final 100 Metres. The horse was subjected to veterinary examination. On examination, it was found to have burst its blood vessels (On endoscopy Grade - III). Trainer Mr. S.S. Attaollahi was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey S. Zervan, the rider of GEORGE EVEREST was reprimanded for dropping hands before passing the winning post.

Surprise sample was taken for analysis from b g LISTEN TO ME.

Routine Sample was taken for analysis from the winner b g GALLOPING AHEAD.

3rd Race: 39. The Krishna Plate - Div. II - (About) 1400 metres. Horses rated 20 to 45, 5 years old and over (9 Runners).

Jockey Chethan Kalay S., the rider of REALIA was fined Rs.2,000/- for not making sufficient effort to improve his position from 800 Metres till about 500 Metres for no apparent reason.

It was observed that JOHN CONNOR (Nazerul Alam) pulled up lame passing the 400 Metres whereby the rider was dislodged. On immediate examination, it was found to have sustained complete open fracture on left hind mid cannon. Hence, it was euthanized.

It was observed that REALIA (Chethan Kalay S.) shied away from the lame horse JOHN CONNOR approaching 400 Metres.

STUNNING BEAUTY (K. Sai Kiran) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g GOLDEN TIME.

4th Race: 40. The Kisan Divas Plate - Div. II - (About) 1400 metres. Horses rated 20 to 45 (12 Runners).

HIGH OPINION (B. Nayak) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Warren Singh was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Vivek.G, the rider of KING OF WAR reported that he accidentally lost his whip passing the 250 Meters.

Routine Sample was taken for analysis from the winner ch g KING OF WAR.

5th Race: 41. The Abbey Falls Plate - (About) 1200 metres. Maiden Horses 2 years old only (6 Runners).

Permission was granted to Trainer Mr. Prasanna Kumar to withdraw VIVALDO (Akshay Kumar) on veterinary grounds as it was found to be lame on right hind. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

JULIO (P. Trevor) jumped awkwardly outwards.

Jockey Vinod Shinde, the rider of FEARLESS JOEY was fined Rs.1,000/- for not maintaining a straight course, thereby causing interference to TRUE FAITH (S. Zervan), which in turn passed it onto CRYSTAL SNOW (Darshan R.N) on his inside approaching 200 Metres.

Jockey Vinod Shinde, the rider of FEARLESS JOEY was reprimanded for shifting out and inconveniencing JULIO (P. Trevor) on his outside approaching 150 Metres.

Routine Sample was taken for analysis from the winner b c CZAR.

6th Race: 42. The Krishna Plate - Div. I - (About) 1400 metres. Horses rated 20 to 45, 5 years old and over (9 Runners).

Jockey Kiran Rai P, the rider of TYTO ALBA was reprimanded for shifting 'in' and inconveniencing KATANA (Y. S. Srinath), which in turn passed it onto SEE MY HEELS (M. Prabhakaran) on his inside soon after the start.

Jockey Kiran Rai P, the rider of TYTO ALBA reported that his mount was not galloping fluently from the start and ran detached thereafter. In view of its behaviour, Trainer Mr. Narayana Gowda V. was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least two Mock Races.

Jockey Chandrashekar M, the rider of OSIRIS was reprimanded for dropping hands in the final 100 Metres.

TYTO ALBA (Kiran Rai P) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b f FOUR WHEEL DRIVE.

7th Race: 43. The Y.S.Surender Memorial Trophy - (About) 1200 metres. Horses rated 40 to 65 (10 Runners).

THE INHERITOR (K. Sai Kiran) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Sharat Kumar was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

GENERAL PATTON (Nazerul Alam) accidentally stumbled soon after jumping out of the starting gates.

Jockey K. Sai Kiran, the rider of THE INHERITOR was reprimanded for shifting 'in' and inconveniencing MILLBROOK (Antony Raj S.) on his inside approaching 350 Metres.

ETERNAL PRINCESS (Vinod Shinde) was subjected to veterinary examination but no abnormality was reported.

COOL RIDER (Y. S. Srinath) was subjected to veterinary examination but no abnormality was reported.

(A)

An enquiry was held on 24/12/2022 by the Stipendiary Steward for the above race with respect to the riding of Jockey Vinod Shinde, the rider of ETERNAL PRINCESS "wherein he shifted 'in' sharply and caused severe interference to MILLBROOK (Antony Raj S.), whereby he clipped the front runner ETERNAL PRINCESS and had to shift out, thereby causing severe interference to the horses on his outside viz; COOL RIDER (Y. S.

Srinath), LAUTERBRUNNEN (Kiran Rai P) and GENERAL PATTON (Nazerul Alam) which had to be checked by their respective rider's approaching 900 Metres."

Jockey Vinod Shinde was interviewed by the Stipendiary Steward. The Stipendiary Steward after considering the submissions made by Jockey Vinod Shinde and after viewing the CCTV decided to charge Jockey Vinod Shinde for Careless Riding.

The Stipendiary Steward thereafter suspended the Jockey's Licence granted to Vinod Shinde with effect from **5-1-2023 to 25-1-2023 (Both days inclusive)** as he had pleaded guilty for Careless Riding under Rule No. 161 (i) of the BTC Rules of Racing on his mount ETERNAL PRINCESS (he is permitted to ride work) and was informed of his right to appeal.

(B)

An enquiry was held on 24/12/2022 by the Stipendiary Steward for the above race with respect to the riding of Jockey Siddaraju.P, the rider of CAPABLE "wherein from 900 Metres he has not made any effort to improve his position till about 650 Metres, he bumped on the saddle twice passing the 500 Metres for no apparent reason and thereafter, he did not infuse adequate vigour in riding out his mount in the final 350 Metres".

Jockey Siddaraju.P was interviewed by the Stipendiary Steward. The Stipendiary Steward after considering the submissions made by Jockey Siddaraju.P and after viewing the CCTV decided to charge Jockey Siddaraju.P for Incompetent Riding.

The Stipendiary Steward thereafter suspended the Jockey's Licence granted to Siddaraju.P with effect from **5-1-2023 to 26-1-2023 (Both days inclusive)** as he had pleaded guilty for Incompetent Riding under Rule No. 161 (ii) of the BTC Rules of Racing on his mount CAPABLE (he is permitted to ride work) and was informed of his right to appeal.

Routine Sample was taken for analysis from the winner b f COOL RIDER.

8th Race: 44. The Ashoka Chakra Cup - (About) 1800 metres. 3 years old and over (5 Runners).

EVALDO (Akshay Kumar) sustained superficial clip injury on left hind tendon.

Routine Sample was taken for analysis from the winner b g EVALDO.

9th Race: 45. The Kisan Divas Plate - Div. I - (About) 1400 metres. Horses rated 20 to 45 (11 Runners).

RECREATOR (Salman Khan) jumped awkwardly outwards.

Jockey R.Ajinkya, the rider of BALOR was fined Rs.1,000/- for shifting out and taking out KLOCKNER (Y. S. Srinath), which in turn passed it onto JE NE SAIS QUOI (Shreyas Singh S) on his outside approaching 800 Metres.

Jockey A. Imran Khan, the rider of RHAPSODY IN GREEN reported that he could not get a clear view between the 1000 Metres till about 600 Metres due to the severe kick back of the track.

Jockey P. Trevor, the rider of SOCIABLE reported that he could not get a clear view between the 1000 Metres till about 600 Metres due to the severe kick back of the track.

Jockey Antony Raj S., the rider of NIKOLINA reported that he could not get a clear view between the 1000 Metres till about 600 Metres due to the severe kick back of the track.

Jockey K. Sai Kiran, the rider of THE GOLDEN DREAM was reprimanded for travelling wide rounding the final bend for no apparent reason and for dropping hands in the final 100 Metres.

BALOR (R. Ajinkya) sustained gum injury.

Routine Sample was taken for analysis from the winner b g BALOR.

10th Race: 46. The Yamuna Plate - Div. I - (About) 1200 metres. Horses rated 00 to 25 (Whips not allowed) (11 Runners).

Jockey Salman Khan replaced the indisposed Jockey V.R. Jagadeesh on APOLLO LIGHT.

AIR DISPLAY (K.G. Likith Appu) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.S. Inayathulla was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

ELITE AGENT (Kiran Rai P) sustained gum injury.

EMERALDO (R. Vaibhav) was subjected to veterinary examination but no abnormality was reported.

An enquiry is being held into the running and riding of SKY PRINCESS, trained by Mr.Azhar Ali and ridden by Jockey Chethan Kalay S in the above race.

Routine Sample was taken for analysis from the winner b m ACTIVATED.
