

**BANGALORE WINTER MEETING 2022-23**  
**SECOND DAY, SATURDAY , 3<sup>RD</sup> DECEMBER, 2022**  
**RACING INCIDENTS**  
**(8 -15)**

**GOING : Good**

**PENETROMETER READING: 3.8 Cms.**

**RAILING POSITION: Railing fixed at average width of 4.0 Meters from 1600 Meters to winning post from its original position.**

**1<sup>st</sup> Race: 8. The Godavari Plate - (About) 1400 metres. Horses rated 00 to 25 (12 Runners).**

As Jockey Rajesh Kumar. M was certified medically unfit to ride. Permission was granted to trainer Mr. Narayana Gowda V. to substitute Jockey Shamaz Shareef to ride ARECA ANGEL in place of the declared rider.

Jockey Siddaraju.P, the rider of MEMORABLE TIME was reprimanded for shifting 'in' and inconveniencing MAX MUELLER (Prashant P.Dhebe), which in turn passed it onto REGAL FORCE (Arshad Alam) passing the 1000 Metres.

It was reported after the race that FREDERICO (K.G. Likith Appu) burst its blood vessels. Trainer Mr.Mahmood Khan was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

ARECA ANGEL (Shamaz Shareef) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g MEGA SUCCESS.

**2<sup>nd</sup> Race: 9. The Udupi Plate - Div. II - (About) 1200 metres. Horses rated 20 to 45, 4 years old and over (11 Runners).**

GUNMASTER (A.R.Pradeep) was extremely fractious, refused to remain in the Stalls. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order.

Trainer Mr. Pradeep Annaiah and Jockey V.R.Jagadeesh were questioned regarding the running and riding of MR HUMBLE in the above race. The trainer stated that his instruction to the Jockey was go to front, do his best in the straight. The Jockey while corroborating the statement of the trainer added that his mount stopped galloping completely in the final 150 Metres. Their explanations were noted for future reference. The horse was subjected to veterinary examination. On examination, it was found to have sustained superficial injury on right hock inside.

Routine Sample was taken for analysis from the winner b g FLYING QUEST.

**3<sup>rd</sup> Race: 10. The Beginners Plate - (About) 1200 metres. Maiden Horses 2 years old only. (7 Runners).**

Jockey Nazerul Alam, the rider of KNOTTY CHARMER was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

Jockey Nazerul Alam, the rider of KNOTTY CHARMER was fined Rs.2,000/- for exulting before passing the winning post.

Routine Sample was taken for analysis from the winner b c KNOTTY CHARMER.

**4<sup>th</sup> Race: 11. The World Conservation Day Plate - Div. II - (About) 1400 metres. Horses rated 20 to 45 (11 Runners).**

PRINCESS AURA (Surya P.) planted, swerved towards the left, did not raise a fluent gallop for the first 150 Metres and ran detached thereafter. In view of its behaviour, Trainer Mr.Kishan Thomas was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

It was reported after the race that REMONTOIR (Salman Khan) burst its blood vessels. Trainer Mr.Imtiaz Khan was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

An enquiry was held on 4<sup>th</sup> December, 2022 by the Stipendiary Steward for the above race into the interference caused by Jockey Ahsan Qureshi, the rider of NIKOLINA in that he shifted 'in' and caused severe interference to the horses on his inside viz; LISTEN TO ME (Neeraj Rawal), RORITO (Tousif Khan) and SOLID POWER (V.R.Jagadeesh) approaching 1200 Metres.

Jockey Ahsan Qureshi was interviewed by the Stipendiary Steward. The Stipendiary Steward after considering the submissions made by Jockey Ahsan Qureshi and after viewing the CCTV replay decided to charge Jockey Ahsan Qureshi for Careless Riding.

The Stipendiary Steward thereafter suspended the Jockey's Licence granted to Ahsan Qureshi with effect from **14-12-2022 to 23-12-2022 (both days inclusive)** as he had pleaded guilty of the charge under Rule No. 161 (i) of the BTC Rules of Racing for Careless Riding on his mount NIKOLINA (he was permitted to ride work) and was informed of his right to appeal.

SOLID POWER (V.R.Jagadeesh) sustained superficial injury on both hind cannon.

NIKOLINA (Ahsan Qureshi) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b (mtg) f SILVER CANYON.

**5<sup>th</sup> Race: 12. The Alydar Plate - (About) 1400 metres. Horses rated 40 to 65, 4 years old and over (9 Runners).**

MEMORITER (Surya P.) jumped awkwardly inwards and inconvenienced ETOSHA (S. Zervan), which in turn passed it onto ONLY YOU (Md.Akram) on its inside at the start.

Jockey K.G. Likith Appu, the rider of MOON'S BLESSING reported that his saddle shifted forward passing the 1200 Metres. After due examination of the equipment, Trainer Mr. S.S. Attaollahi was fined Rs.3,000/- for faulty saddling.

Jockey Vinod Shinde, the rider of MILLBROOK was fined Rs.1,000/- for shifting 'in' and causing interference to SCRIBBLING HOPPER (Nazerul Alam) and MEMORITER (Surya P.) on his inside approaching 1200 Metres.

Jockey Vinod Shinde, the rider of MILLBROOK reported that he lost his whip passing the 300 Metres. As Jockey S. Zervan, the rider of ETOSHA accidentally struck his whip.

SCRIBBLING HOPPER (Nazerul Alam) sustained bleeding gum injury.

Routine Sample was taken for analysis from the winner b f MOON'S BLESSING.

**6<sup>th</sup> Race: 13. The Madras Race Club Cup - (About) 1200 metres. Horses rated 60 to 85 (9 Runners).**

As Jockey Rajesh Kumar. M was certified medically unfit to ride. Permission was granted to trainer Mr. Narayana Gowda V. to substitute Jockey Shamaz Shareef to ride COLONEL HARTY in the place of the declared rider.

Jockey R.Ajinkya, the rider of UNYIELDING reported that his whip got entangled momentarily in the reins passing the 150 Metres.

Routine Sample was taken for analysis from the winner b g DE VILLIERS.

**7<sup>th</sup> Race: 14. The World Conservation Day Plate - Div. I - (About) 1400 metres. Horses rated 20 to 45 (10 Runners).**

MAYBACH (Rayan Ahmed R.) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.S. Dominic was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Rayan Ahmed R., the rider of MAYBACH was reprimanded for riding an indifferent race. He was further informed in presence of Trainer Mr. S. Dominic that that the repetition of similar manner of riding will entail him being reported to Stewards for disciplinary action.

Jockey Adarsh G., the rider of GOLDEN TIME was reprimanded for riding an indifferent race. He was further informed in presence of Trainer Mr. V. Lokanath that that the repetition of similar manner of riding will entail him being reported to Stewards for disciplinary action.

It was reported after the race that HARMONIA (Mohammed Aliyar) burst its blood vessels. Trainer Mr. Faraz Arshad was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner ch c PINNACLE POINT.

**8<sup>th</sup> Race: 15. The Udupi Plate - Div. I - (About) 1200 metres. Horses rated 20 to 45, 4 years old and over (11 Runners).**

THREE ACES (V.R.Jagadeesh) planted and did not take any practical part in the race. In view of its behaviour, Trainer Mr.V. Lokanath was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

STUNNING BEAUTY (Naveen Kumar. V) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Sharat Kumar was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Tousif Khan, the rider of MEASURE OF TIME reported that he brushed the right side of the gates while jumping out, whereby he lost his right stirrup which he regained within a few strides.

ACEROS (Adarsh G.) ran detached in the final 150 Metres. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. V. Lokanath was informed to ensure better performance of his charge in future.

Routine Sample was taken for analysis from the winner b g COOL RIDER.
