RACING INCIDENTS
(47 – 54)

GOING : Good

PENETROMETER READING: 4.0 Cms.

RAILING POSITION: Railing fixed at average width of 8.5 Meters from 1600 Meters to winning post from its original position.

1st Race: 47. The Tapti Plate - Div. II - (About) 1400 metres. Horses rated 00 to 25, 5 years old and over (9 Runners).

Jockey B. Nayak, the rider of STAR CITIZEN was fined Rs.1,000/- for shifting 'in' and causing interference to ARTIANA (Vinod Shinde), which in turn passed it onto COUNTRY'S JEWEL (Darshan R.N) on his inside soon after the start.

Jockey A.R.Pradeep, the rider of MASTER OF SUCCESS was fined Rs.2,000/- for travelling wide between the 900 Metres till about 500 Metres for no apparent reason.

Jockey K.G. Likith Appu, the rider of KONICHIWA was reprimanded for shifting out and inconveniencing REGAL FORCE (Imran Chisty) on his outside passing the 500 Metres.

Jockey Chethan Kalay S., the rider of SHE'S INNOCENT was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

It was reported after the race that STAR CITIZEN (B. Nayak) burst its blood vessels and sustained superficial cut injury on left gaskin region. Trainer Mr.Warren Singh was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

ARTIANA (Vinod Shinde) sustained superficial clip injury on right fore cannon.

MASTER OF SUCCESS (A.R.Pradeep) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner dk b/br g KONICHIWA.

2nd Race: 48. The Ganga Plate - (About) 1600 metres. Horses rated 00 to 25 (8 Runners).

SPEED SEVEN (L. Alex Rozario) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Irfan Ghatala was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Imran Chisty, the rider of LUMINARY STAR reported that his mount stopped galloping from 400 Metres. The horse was subjected to veterinary examination. On examination, it was found to have burst its blood vessels. Trainer Mr. S. Ganapathy was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Ahsan Qureshi, the rider of SOUTHERNARISTOCRAT was fined Rs.2,000/- for the improper use of whip on his mount during the race.

Routine Sample was taken for analysis from the winner dk b g BABA VOSS.

3rd Race: 49. The Vindication Plate - (About) 1400 metres. Maiden Horses 2 years old only. (6 Runners).

FONDNESS OF YOU (Suraj Narredu) after jumping out, shied inwards from DOUBLE SCOTCH (P. S. Chouhan) towards the rails.

Jockey P. S. Chouhan, the rider of DOUBLE SCOTCH was reprimanded for dropping hands before passing the winning post.

Routine Sample was taken for analysis from the winner gr f ANZAC PIPERNAL.

4th Race: 50. The Harangi Plate - (About) 2000 metres. Horses rated 20 to 45 (7 Runners).

Jockey Neeraj Rawal, the rider of BANKSY was reprimanded for taking an unduly long lead during the race.

BRUCE ALMIGHTY (Rayan Ahmed R.) sustained superficial injury on left hind fetlock.

RULE OF LAW (Imran Chisty) sustained superficial injuries on left hind pastern and right hind fetlock.

Routine Sample was taken for analysis from the winner b g STORMY OCEAN.

5th Race: 51. The Phar Lap Plate - (About) 1400 metres. Horses rated 40 to 65, 5 years old and over (9 Runners).

Jockey L. Alex Rozario, the rider of ELUSIVE GIRL reported that his saddle shifted back after entering the straight. After due examination of the equipment, Trainer Mr. Azhar Ali was fined Rs.3,000/- for faulty saddling of his charge.

It was observed that SOUTHERN POWER (Akshay Kumar) was lugging 'in' under pressure during the final stages of the race.

Jockey Y. S. Srinath, the rider of GREEN CHANNEL was reprimanded for shifting 'in' and inconveniencing GOLDEN TIME (Vivek.G) on his inside passing the 250 Metres.

Jockey Vivek.G, the rider of GOLDEN TIME was fined Rs.1,000/- for coming 'in' and causing interference to SILVER DEW (Darshan R.N), which in turn passed it onto BENEDICTION (V.R.Jagadeesh) on his inside passing the 200 Metres.

It was reported after the race that BENEDICTION (V.R.Jagadeesh) pulled up lame on left fore. Trainer Mr. M. Rajendra Singh was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

SILVER DEW (Darshan R.N) sustained superficial bleeding clip injury on left gaskin.

Routine Sample was taken for analysis from the winner b m GREEN CHANNEL.

6th Race: 52. The Karnataka Police Trophy - (About) 1200 metres. Horses rated 60 to 85 (8 Runners).

HUKUM (B. Nayak) ran detached from the 300 Metres. The horse was subjected to veterinary examination. On examination, it was found to have burst its blood vessels. Trainer Mr. Faraz Arshad was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b c STAR GLORY.

7th Race: 53. The Kali Plate - (About) 1600 metres. Horses rated 20 to 45, 5 years old and over (8 Runners).

LYCURGUS (Siddaraju.P) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Sharat Kumar was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Darshan R.N, the rider of PELUCHE was fined Rs.10,000/- for shifting out and causing severe interference to QUEEN REGNANT (A.Imran Khan), whereby the rider had to momentarily check & shift out passing the final 100 Metre and LYCURGUS (Siddaraju.P) which was travelling directly behind also had to be checked by its rider.

Routine Sample was taken for analysis from the winner b g PELUCHE.

8th Race: 54. The Tapti Plate - Div. I - (About) 1400 metres. Horses rated 00 to 25, 5 years old and over (9 Runners).

THUNDERSTRUCK (K. Sai Kiran) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr.Sharat Kumar was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

RORITO (A.Imran Khan) was impounded for veterinary examination but no abnormality was reported.

PRAIA DO CASSINO (Siddaraju.P) was subjected to veterinary examination but no abnormality was reported.

Surprise sample was taken for analysis from b m RORITO.

Routine Sample was taken for analysis from the winner dk b g SINGHSAAB.
