EIGHTH DAY, SATURDAY, 31st DECEMBER, 2022
RACING INCIDENTS
(55 - 62)

GOING : Good

PENETROMETER READING: 3.5 Cms.

RAILING POSITION: Railing fixed at average width of 8.5 Meters from 1600 Meters to winning post from its original position.

1st Race: 55. The Vani Vilasa Sagara Trophy - Div. III - (About) 1200 metres. Horses rated 20 to 45 (9 Runners).

Trainer Mr. S.S. Attaollahi was fined Rs. 5,000/- for not obtaining prior permission for his charge SOFIYA (P. Trevor) to race with Tongue Strap. Subsequently, permission was granted to him to run his charge SOFIYA with a Tongue Strap.

Trainer Mr. S. Ganapathy was fined Rs.5,000/- for discrepancy in shoeing in respect of his charge QUICK WITTED (1st infringement).

Jockey K. Sai Kiran, the rider of THE REPUBLIC POWER was fined Rs.2,000/- for travelling wide from 1000 Metres till about 600 Metres for no apparent reason.

It was observed that Jockey IndraJeet Singh, the rider of LIMITED EDITION had to steady his mount to avoid striking the front runner FIREFINCH (Salman Khan) approaching 800 Metres.

Jockey S.Mubarak, the rider of FLAMINGO ROAD was reprimanded for travelling wide between 600 Metres till about 400 Metres.

Jockey K. Sai Kiran, the rider of THE REPUBLIC POWER reported that his mount was hanging 'in' in the final 300 Metres. The horse was subjected to veterinary examination but no abnormality was reported. Trainer Mr. Sharat Kumar was informed to take appropriate corrective measures before accepting with it again.

Jockey Mohammed Aliyar, the rider of QUICK WITTED reported that he accidentally lost his whip passing the 200 Meters.

MAROON (Shamaz Shareef) sustained superficial injury on right hind pastern.

FLAMINGO ROAD (S.Mubarak) sustained superficial injury on right hind pastern.

Routine Sample was taken for analysis from the winner b f SOFIYA.

2nd Race: 56. The Ghostzapper Plate - Div. II - (About) 1200 metres. Horses rated 20 to 45, 4 years old and over (9 Runners).

AIR BLAST (A.Imran Khan) jumped awkwardly outwards.

PRINCESS AURA (Shamaz Shareef) threw its head up while jumping out of the starting gates.

ALTAIR (Siddaraju.P) sustained superficial clip injury on right hind tendon.

Routine Sample was taken for analysis from the winner b g THE OMEGA MAN.

3rd Race: 57. The Ice Breaker Plate - (About) 1200 metres. Horses 2 years old only. (9 Runners).

NORTHERN QUEST (V.R.Jagadeesh) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b c KNOTTY CHARMER.

4th Race: 58. The Vani Vilasa Sagara Trophy - Div. II - (About) 1200 metres. Horses rated 20 to 45 (8 Runners).

Permission was granted to Trainer Mr.V. Lokanath to withdraw BREEZE BLUSTER (Vivek.G) on veterinary grounds as it was found to be lame on left fore and swelling in pastern. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

THEWHISPERQUIETLY (Siddaraju.P) was subjected to veterinary examination but no abnormality was reported.

An enquiry was held on 31st December, 2022 by the Stipendiary Steward for the above race into the interference caused by Jockey Siddaraju.P, the rider of THEWHISPERQUIETLY in that:

- "a) He failed to improve his position from 1000 Metres and he had not made any visible efforts, as he lacked vigour and enterprise in his riding till about 400 Metres;
- b) Thereafter, when he started urging his mount it responded very well to his urging and covered a lot of ground in the final 300 Metres;
- c) Had he made the same effort from the start of the race his mount would have finished much closer to the field."

Jockey Siddaraju.P was interviewed by the Stipendiary Steward. The Stipendiary Steward after considering the submissions made by Jockey Siddaraju.P and after viewing the CCTV replay decided to charge Jockey Siddaraju.P for unsatisfactory Riding.

The Stipendiary Steward thereafter suspended the Jockey's Licence granted to Siddaraju.P with effect from **3-2-2023 to 4-3-2023 (both days inclusive)** as he had pleaded guilty of the charge under Rule No. 161 (i) of the BTC Rules of Racing for Unsatisfactory Riding on his mount THEWHISPERQUIETLY (he was permitted to ride work) and was informed of his right to appeal.

Routine Sample was taken for analysis from the winner b f MONTELENA.

5th Race: 59. The Vani Vilasa Sagara Trophy - Div. I - (About) 1200 metres. Horses rated 20 to 45 (9 Runners).

SHEER BLISS (K.G. Likith Appu) jumped awkwardly outwards.

Jockey Darshan R.N, the rider of MACE was reprimanded for shifting out and inconveniencing THE GREY GERANIUM (Siddaraju.P) on his outside passing the 1000 Metres.

Jockey L. Alex Rozario, the rider of TRIPITAKA was fined Rs.1,000/- for shifting 'in' and causing interference to CONTADOR (Akshay Kumar) on his inside passing the 250 Metres.

It was observed that CONTADOR (Akshay Kumar) could not get a clear run between the 200 Metres and 150 Metres.

Jockey L. Alex Rozario, the rider of TRIPITAKA reported that he lost his whip approaching 200 Metres.

Jockey Akshay Kumar, the rider of CONTADOR was fined Rs.3,000/- for dropping hands in the final 100 Metres.

Jockey Darshan R.N, the rider of MACE reported that his mount was running green throughout the race.

Jockey A.Imran Khan, the rider of ENGLISH BAY was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

ALASKAN JEWEL (B. L. Paswan) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g ENGLISH BAY.

6th Race: 60. The New Year Eve Cup (Grade III) - (About) 1400 metres. 3 years old and over (6 Runners).

Compulsory urine and blood samples were taken for analysis from the following I,II & III placed horses viz:

b m FOREST FLAME I

dk b g ALL ATTRACTIVE II

b g IMPERIAL BLUE III

7th Race: 61. The Native Chieftain Plate - (About) 2000 metres. Horses rated 40 to 65 (5 Runners).

Jockey P. Trevor, the rider of TIGNANELLO was fined Rs.2,000/- for shifting 'in' and causing interference to SOUTHERN DYNASTY (Imran Chisty) on his inside passing the 200 Metres.

Jockey Darshan R.N, the rider of DISRUPTOR was reprimanded for taking an unduly long lead during the race.

Routine Sample was taken for analysis from the winner b g TIGNANELLO.

8th Race: 62. The Ghostzapper Plate - Div. I - (About) 1200 metres. Horses rated 20 to 45, 4 years old and over (8 Runners).

Jockey IndraJeet Singh, the rider of SUPER RUFFIAN was fined Rs.2,000/-for shifting 'in' and bumping SUPER KIND (P. Trevor), which in turn passed it onto on his inside viz; DOMINA (K.G. Likith Appu) and LAUTERBRUNNEN (L. Alex Rozario) soon after the start.

It was observed that the whip of Jockey IndraJeet Singh, the rider of SUPER RUFFIAN was entangled in the reins momentarily passing the 200 Metres.

Routine Sample was taken for analysis from the winner b g JOKSHAN.

Race: 40. The Kisan Divas Plate - Div. II - (About) 1400 metres. Horses rated 20 to 45.

Jockey K. Sai Kiran, the rider of THE STRIKINGLY was fined Rs.5,000/- for the excessive use of whip on his mount during the race (2nd infringement).

Race: 46. The Yamuna Plate - Div. I - (About) 1200 metres. Horses rated 00 to 25.

(A)

The Stipendiary Stewards reported Jockey Chethan Kalay.S to the Stewards for Contravention of Rule No. 161 (ii) of the B.T.C. Rules of Racing on his mount SKY PRINCESS.

The Stewards held an enquiry on 31st December, 2022 and examined Jockey Chethan Kalay.S and Trainer Mr. Azhar Ali.

The Stewards considered the following:

- (a) Charge sheet issued to Jockey Chethan Kalay.S by the Stipendiary Steward;
- (b) The Submissions made by Jockey Chethan Kalay.S and Trainer Mr. Azhar Ali during the enquiry;
- (c) Stewards viewed the various angles of the race with specific reference to the riding of Jockey Chethan Kalay.S;
- (d) The Stewards noted that Jockey Chethan Kalay.S had pleaded guilty of alleged breach of Contravening Rule No. 161 (ii) of the BTC Rules of Racing as charged by the Stipendiary Steward;

The Stewards, thereafter using their wisdom and experience, arrived at a unanimous decision that Jockey Chethan Kalay.S was "**Guilty**" as charged in the matter.

In the light of above, the Stewards decided as under:

- (a) To suspend the Jockey's Licence granted to Chethan Kalay.S with effect from **10-1-2023 to 5-3-2023 (Both days inclusive)** for Unsatisfactory Riding [Rule No. 161 (ii) of the BTC Rules of Racing] on his mount SKY PRINCESS (he is permitted to ride work).
- (b) He was informed of his right to appeal to the Board of Appeal.

(B)

The Stipendiary Stewards reported Trainer Mr. Azhar Ali to the Stewards for Contravening Rule No. 114 (b) (i) of the B.T.C. Rules of Racing in respect of his charge SKY PRINCESS.

The Stewards held an enquiry on 31st December, 2022 and examined Trainer Mr. Azhar Ali and Jockey Chethan Kalay.S.

The Stewards considered the following:

- (a) Charge sheet issued to Trainer Mr. Azhar Ali by the Stipendiary Steward;
- (b) The Submissions made by Trainer Mr. Azhar Ali during the enquiry;
- (c) Stewards viewed the various angles of the race with specific reference to the riding of Jockey Chethan Kalay.S;
- (d) The Stewards noted that Trainer Mr. Azhar Ali had pleaded guilty of alleged breach for Contravening Rule No. 114 (b) (i) under BTC Rules of Racing as charged by the Stipendiary Steward;
- (e) The Stewards were not satisfied with the explanations tendered by Trainer Mr. Azhar Ali during the enquiry with specific reference to unsatisfactory running of his charge SKY PRINCESS.

The Stewards, thereafter using their wisdom and experience, arrived at a unanimous decision that Trainer Mr. Azhar Ali was "**Guilty**" as charged in the matter.

In the light of above, the Stewards decided as under:

- (a) To suspend the trainer's licence granted to Mr. Azhar Ali with effect from **10-1-2023 to 8-2-2023 (Both days inclusive)** for Contravening Rule No. 114 (b) (i) of the BTC Rules of Racing read with Calendar Notification under the heading "PUNISHMENT TO TRAINERS BY STIPENDIARY STEARDS / STEWARDS" – (Unsatisfactory Running) in respect of his charge SKY PRINCESS.
- (b) He was informed of his right to appeal to the Board of Appeal.
