**(107 - 115)**

**GOING : Good**

**PENETROMETER READING: 3.8 Cms.**

**RAILING POSITION: Railing fixed at average width of 7.5 Meters from 1600 Meters to winning post from its original position.**

**1<sup>st</sup> Race: 107. The Mahi Plate - Div. II - (About) 1200 metres. Horses rated 00 to 25 (10 Runners).**

Permission was granted to Trainer Mr. Sharat Kumar to withdraw WAR TRAIL (K.G. Likith Appu) on veterinary grounds as it was found to be lame on right fore. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

ULTIMATE CHOICE (Vinod Shinde) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. V. Lokanath was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey L. Alex Rozario, the rider of CASH OUT was fined Rs.1,000/- for shifting 'in' and tightening STAR CITIZEN (Nazerul Alam) on his inside passing the 300 Metres.

Jockey Rayan Ahmed R., the rider of COMEONSON reported that he accidentally lost his whip passing the 300 Meters.

Jockey Arshad Alam, the rider of PHOENIX SURPRISE was reprimanded for shifting out and taking out STAR CITIZEN (Nazerul Alam) on his outside passing the 300 Metres.

SOUTHERN CHROME (Mohammed Aliyar) ran detached from the field. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Aravind G. was informed to ensure better performance of his charge in future.

ULTIMATE CHOICE (Vinod Shinde) was subjected to veterinary examination but no abnormality was reported.

ANNE BOLEYN (A.Imran Khan) was subjected to veterinary examination but no abnormality was reported.

Urine and Blood Sample were taken for analysis from the winner b m CASH OUT.

**2<sup>nd</sup> Race: 108. The Bhima Plate - (About) 1600 metres. Horses rated 20 to 45, 5 years old and over (11 Runners).**

RHAPSODY IN GREEN (K.G. Likith Appu) brushed the right side of the gates while jumping out, whereby the rider was totally unbalanced and was dislodged from his mount soon after the start.

Jockey P. Mani, the rider of ECO FRIENDLY was fined Rs.5,000/- for not making sufficient effort on his mount during the race.

It was reported after the race that MUIRFIELD (S. John) burst its blood vessels. Trainer Mr.Arjun Mangalorkar was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

RHAPSODY IN GREEN (K.G. Likith Appu) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner dk b g LYCURGUS.

**3<sup>rd</sup> Race: 109. The Kabini Plate - Div. III - (About) 1200 metres. Horses rated 20 to 45 (10 Runners).**

MASTEROFTHESKIES (Koshi Kumar) broke the front barrier and ran rider less, clockwise and anti clock wise and completed about one round of the course. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order.

CHIRAAG (Mohammed Aliyar) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr.Mahmood Khan was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least two Mock Races.

ACTIVATED (Y. S. Srinath) stumbled soon after jumping out of the starting gates.

PRINCESS JASMINE (Salman Khan) after jumping out of the starting gates lept in the air.

It was observed that FLYING BRAVE (IndraJeet Singh) lost its hind footing passing the 900 Metres.

Jockey Angad, the rider of TWILIGHT FAME was reprimanded for shifting 'in' and inconveniencing CHIRAAG (Mohammed Aliyar) on his inside passing the 400 Metres.

Jockey IndraJeet Singh, the rider of FLYING BRAVE was fined Rs.5,000/- for not making sufficient effort on his mount during the race.

Jockey Darshan R.N, the rider of SPIRIT DANCER was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

It was reported after the race that HABANERO (Tousif Khan) pulled up lame on right fore. Trainer Mr.S. Dominic was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

FLYING BRAVE (IndraJeet Singh) sustained superficial injury on right hind fetlock.

SPIRIT DANCER (Darshan R.N) sustained superficial injury on left fore cannon.

EMPRESS BELLA (P. Mani) sustained superficial injury on right fore pastern.

Routine Sample was taken for analysis from the winner ch m SPIRIT DANCER.

**4<sup>th</sup> Race: 110. The Chambal Plate - (About) 1200 metres. Maiden Horses 3 years old only. (12 Runners).**

TREASURE CHEST (Y. S. Srinath) jumped awkwardly outwards onto SPIRIT OF THE ROSE (R.Ajinkya) soon after the start.

Jockey Imran Chisty, the rider of GOLDEN PEAKS was reprimanded for shifting out and inconveniencing SERAI (Mohammed Aliyar) on his outside passing the 1000 Metres.

DIAMOND HOOVES (Vinod Shinde) ran detached from the field. Trainer Mr. V. Lokanath was informed to ensure better performance of his charge in future.

Routine Sample was taken for analysis from the winner b g ELPENOR.

**5<sup>th</sup> Race: 111. The Kabini Plate - Div. II - (About) 1200 metres. Horses rated 20 to 45 (11 Runners).**

MASTER OF COURAGE (Salman Khan) took a fly jump.

It was observed that FLAMINGO ROAD (S. Saqlain) accidentally stumbled passing the 400 Metres.

Jockey L. Alex Rozario, the rider of SOCIABLE was fined Rs.3,000/- for shifting out and causing interference to FLAMINGO ROAD (S. Saqlain) on his outside passing the 350 Metres.

It was reported after the race that ONE SO WONDERFUL (Vinod Shinde) pulled up lame on left hind and sustained bleeding cut injury on left hind coronet. Trainer Mr.V. Lokanath was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

STUNNING BEAUTY (Y. S. Srinath) was subjected to veterinary examination but no abnormality was reported.

Surprise sample (Urine and blood) were taken for analysis from dk b m FLAMINGO ROAD.

Routine Sample was taken for analysis from the winner b g ARCHWAY.

**6<sup>th</sup> Race: 112. The K.N.Chennabasappa Memorial Trophy - (About) 1400 metres. Horses rated 40 to 65 (10 Runners).**

GALLOPING AHEAD (S. Saqlain) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr.S. S. Attaollahi was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

THE INHERITOR (Vivek.G) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner gr h SHUBANKAR.

**7<sup>th</sup> Race: 113. The Sprinters Trial Stakes (Grade III) - (About) 1200 metres. 4 years old and over. (7 Runners).**

Permission was granted to Trainer Mr. Imtiaz Sait to withdraw ENDEAVOUR on veterinary grounds as it was found to be lame on right fore. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Akshay Kumar, the rider of AZTEC QUEEN was fined Rs.3,000/- for shifting 'in' and causing interference to KNOTTY DANCER (S. John) on his inside in the final 100 Metres of the race.

Jockey P. Trevor, the rider of AGNOSTIC was reprimanded for shifting 'in' and inconveniencing GOLDEN OAKS (A. Sandesh) on his inside in the final 50 Metres of the race.

Compulsory urine and blood samples were taken for analysis from the following I, II & III placed horses viz:

b g AGNOSTIC I

b m AZTEC QUEEN II

b g KNOTTY DANCER III

**8<sup>th</sup> Race: 114. The Kabini Plate - Div. I - (About) 1200 metres. Horses rated 20 to 45 (11 Runners).**

DIVINE BLESSINGS (IndraJeet Singh) took a fly jump.

Jockey S. John, the rider of STARS ABOVE was fined Rs.3,000/- for shifting out and causing interference to the horses on his outside viz; SUPER KIND (L. Alex Rozario) and THE OMEGA MAN (Naveen Kumar. V) on his outside soon after the start.

Jockey Y. S. Srinath, the rider of THE REPUBLIC POWER was reprimanded for shifting 'in' and inconveniencing DIVINE BLESSINGS (IndraJeet Singh) on his inside at the start.

Jockey Y. S. Srinath, the rider of THE REPUBLIC POWER was fined Rs.2,000/- for shifting 'in' and causing interference to THE OMEGA MAN (Naveen Kumar. V), which in turn passed it onto SUPER KIND (L. Alex Rozario) on his inside approaching 1100 Metres.

Jockey IndraJeet Singh, the rider of DIVINE BLESSINGS reported that his saddle shifted forward passing the 1000 Metres, as such he could not offer much assistance to his mount thereafter. After due examination of the equipment, Trainer Mr. Neil B Devaney was fined Rs.3,000/- for faulty saddling of his charge.

Jockey Darshan R.N, the rider of STAR ADMIRAL reported that his reins accidentally got stuck in his neck at about 350 Metres as such he could not offer full assistance to his mount thereafter.

ACEROS (Salman Khan) ran detached from the field. Trainer Mr. V. Lokanath was informed to ensure better performance of his charge in future.

Routine Sample was taken for analysis from the winner b g THE REPUBLIC POWER.

**9<sup>th</sup> Race: 115. The Mahi Plate - Div. I - (About) 1200 metres. Horses rated 00 to 25 (10 Runners).**

Permission was granted to Trainer Mr.Neil B Devaney to withdraw LUCKY AGAIN (IndraJeet Singh) on veterinary grounds as it was found to be lame on left fore. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Rayan Ahmed R replaced the indisposed Jockey Arshad Alam on FIRST ROYALIST.

Jockey L. Alex Rozario, the rider of COUNTRY'S JEWEL was fined Rs.1,000/- for shifting out and causing interference to THE BEGINNING (Tousif Khan) on his outside at the start.

Jockey Rayan Ahmed R., the rider of FIRST ROYALIST reported that his mount was not galloping fluently from 600 Metres. The horse was subjected to veterinary examination but no abnormality was reported.

Jockey R.Ajinkya, the rider of ANTILOPE was fined Rs.3,000/- for not sufficiently persevering with his mount in the final 300 Metres.

Routine Sample was taken for analysis from the winner b m SACRED CREATOR.

**ADDITIONAL REPORT**  
**ORDER OF THE STEWARDS**  
**BANGALORE WINTER MEETING 2022-23**  
**NINTH DAY, SATURDAY, 7<sup>th</sup> January, 2023**

**Race: 63. The Indira Sagar Plate - Div. II - (About) 1100 metres.**  
**Horses rated 20 to 45, 6 years old and over.**

The Stipendiary Stewards reported Jockey Chandrashekar. M to the Stewards for Contravention of Rule No. 159 (b) of the B.T.C. Rules of Racing on his mount SMILE AROUND.

The Stewards held an enquiry on 9<sup>th</sup> February, 2023 and examined Jockey Chandrashekar. M and Trainer Mr. Sharat Kumar.

**The Stewards considered the following:**

- The Minutes of the Preliminary enquiry conducted by the enquiry officers;
  - Charge sheet issued to Jockey Chadrashakar. M by the Stipendiary Stewards;
  - The Submissions made by Jockey Chadrashakar. M, and Trainer Mr. Sharat Kumar during the enquiry by the Stewards;
  - Stewards viewed various angles of the race with specific reference to the riding by Jockey Chadrashakar. M in the above race;
  - The Stewards noted that Jockey Chadrashakar. M had not pleaded guilty of alleged breach of Contravening Rule No. 159 (b) of the BTC Rules of Racing as charged by the Stipendiary Stewards.
- (a) The Stewards also noted that Jockey Chadrashakar. M was already suspended by the Stipendiary Stewards from **10-2-2023 to 5-3-2023 (Both days inclusive)** for Unsatisfactory Riding [Rule No. 161 (ii) of the B.T.C. Rules of Racing] on his mount CHIRAAG in Race No. 90 of the BWM 2022 - 23.

Thereafter in their collective wisdom, they unanimously decided that Jockey Chandrashekar. M was "**Guilty**" as charged in the matter.

**In light of the above, the Stewards decided as under:**

- To withdraw the Jockey's Licence granted to **Chandrashekar. M** and treat him as a disqualified person with effect from **6-3-2023 to 30-6-2023 (Both days inclusive)** for Contravening Rule No. 159 (b) of the BTC Rules of Racing on his mount SMILE AROUND (he is not permitted to ride work).
- Fined Trainer Mr. Sharat Kumar a sum of Rs.50,000/- for general negligence in the discharge of his duties as a trainer and more particularly as to the selection of riders for his charges in between runs and for the unsatisfactory explanations tendered by him during the Stewards enquiry.

They were informed of their right to Appeal to the Board of Appeal.
