# BANGALORE WINTER MEETING 2022-23 NINTEENTH DAY, SATURDAY, 11<sup>TH</sup> MARCH, 2023 RACING INCIDENTS (146 -153)

**GOING: Good** 

PENETROMETER READING: 3.6 Cms.

RAILING POSITION: Railing fixed at average width of 5.75 Meters from 1600 Meters to winning post from its original position.

### 1<sup>st</sup> Race: 146. The Count Fleet Plate - Div. II - (About) 1400 metres. Horses rated 00 to 25, 5 years old and over (8 Runners).

Permission was granted to Trainer Mr. Mahmood Khan to withdraw DAWN RISING (L. Alex Rozario) on veterinary grounds as it was found to have sustained injury on right hind medial cannon. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Kirtish Bhagat, the rider of MARCO POLO reported that he accidently lost his whip passing the 300 Meters.

ELITE AGENT (Kiran Rai P) was subjected to veterinary examination but no abnormality was reported

Routine Sample was taken for analysis from the winner b m WAR TRAIL.

# 2<sup>nd</sup> Race: 147. The Classic Story Trophy - Div. II - (About) 1200 metres. Horses rated 20 to 45 (9 Runners).

Jockey Rayan Ahmed R., the rider of EL ALAMEIN was reprimanded for shifting 'in' and inconveniencing MASTER OF COURAGE (Vivek) on his inside approaching 1100 Metres.

It was observed that EL ALAMEIN (Rayan Ahmed R.) was inclined to run out from the 800 Metres. The horse was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g AGERA.

# 3<sup>rd</sup> Race: 148. The Frankel Stakes - (About) 1600 metres. Horses rated 20 to 45, 5 years old and over (8 Runners).

ARMORY (Kiran Rai P) after jumping out did not raise a fluent gallop till the 1400 Metres. In view of its behaviour, Trainer Mr.Narayana Gowda V. was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least two Mock Races.

It was observed that SPEAKING OF STARS (Salman Khan) accidentally stumbled passing the 1300 Metres.

It was reported after the race that HOPE ISLAND (S. John) burst its blood vessels. Trainer Mr.Arjun Mangalorkar was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was reported after the race that KATANA (Y. S. Srinath) burst its blood vessels. Trainer Mr. Warren Singh was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b m QUEEN REGNANT.

# 4<sup>th</sup> Race: 149. The Octogonal Stakes - (About) 1400 metres. Horses rated 60 to 85 (8 Runners).

Jockey P. Trevor, the rider of DE VILLIERS was fined Rs.2,000/- for not coming in proper attire to the weighing room to fulfill his riding engagement for the day's races.

Jockey Suraj Narredu, the rider of SHAMROCK was fined Rs.2,000/- for not coming in proper attire to the weighing room to fulfill his riding engagement for the day's races.

PEYO (Khurshad Alam) was slowly away and lost many lengths at the start. In view of its behaviour, Trainer Mr. S. Narredu was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Suraj Narredu, the rider of SHAMROCK reported that his mount was hanging 'in' throughout the race. The horse was subjected to veterinary examination. On examination, it was found to have sustained injury on left buccal commissure.

Jockey L. Alex Rozario, the rider of DOUGLAS was reprimanded for shifting 'in' and inconveniencing DE VILLIERS (P. Trevor) on his inside passing the 300 Metres.

KNIGHT IN HOOVES (M. Prabhakaran) sustained superficial injury on right fore cannon.

Routine Sample was taken for analysis from the winner b c SHAMROCK.

### 5<sup>th</sup> Race: 150. The Classic Story Trophy - Div. I - (About) 1200 metres. Horses rated 20 to 45 (8 Runners).

Trainer Mr. Faraz Arshad was fined Rs. 10,000/- for having accepting his charge BELVEDERE (B. Nayak) to run in the above race when it was under treatment. Subsequently, permission was granted him to withdraw it from the above race.

Permission was granted to Trainer Mr. Sharat Kumar to withdraw OXYTOCIN on veterinary grounds as it was found to have sustained injury on nasal bridge and left base of ear. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Kiran Naidu, the rider of APPSARA was fined Rs.2,000/- for not coming in proper attire to the weighing room to fulfill his riding engagement for day's races.

ROYAL GRANT (Kiran Rai P) after jumping out swerved towards the right, dislodging its rider and did not take any practical part in the race. In view of its behaviour, Trainer Mr.Narayana Gowda V. was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Kiran Naidu, the rider of APPSARA was fined Rs.3,000/- for dropping hands in the final 150 Metres for no apparent reason.

Jockey Darshan R.N, the rider of STAR ADMIRAL was fined Rs.5,000/- for the excessive use of the whip on his mount during the race (2nd infringement).

It was reported after the race that STARS ABOVE (S. John) burst its blood vessels. Trainer Mr.Arjun Mangalorkar was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

SOCIABLE (L. Alex Rozario) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b m CASH OUT.

### 6<sup>th</sup> Race: 151. The Maj. C. Newton-Davis Memorial Trophy - (About) 1400 metres. Horses 3 years old only. (6 Runners).

Jockey Suraj Narredu, the rider of MAGNUS reported that he could not get clear view from start till about 700 Metres, as such he could not offer full assistance to his mount due to severe kick back of the track.

Routine Sample was taken for analysis from the winner b f AUSPICIOUS QUEEN.

# 7<sup>th</sup> Race: 152. The Mount Joy Plate - (About) 1600 metres. Horses rated 40 to 65, 5 years old and over (8 Runners).

SPECTACULAR (Neeraj Rawal) jumped awkwardly outwards and inconvenienced PELUCHE (L. Alex Rozario) soon after the start.

Jockey P. Trevor, the rider of AUGUSTO reported that his mount was not striding out well during the race. The horse was subjected to veterinary examination but no abnormality was reported.

LYCURGUS (Y. S. Srinath) sustained superficial clip injury on right hind fetlock.

Routine Sample was taken for analysis from the winner b m SEE MY HEELS.

### 8<sup>th</sup> Race: 153. The Count Fleet Plate - Div. I - (About) 1400 metres. Horses rated 00 to 25, 5 years old and over (8 Runners).

EMERALDO (L. Alex Rozario) jumped awkwardly outwards.

THE INTRUDER (B. Nayak) jumped awkwardly inwards.

Jockey Kiran Rai P, the rider of BARONESS was fined Rs.2,000/- for not maintaining a straight course, thereby inconveniencing the horses on his inside viz; KONICHIWA (P. Trevor) and BENIGNITY (Rayan Ahmed R.) approaching 1200 Metres.

Routine Sample was taken for analysis from the winner b m BARONESS.
