GOING : Good

PENETROMETER READING: 4.0 Cms.

RAILING POSITION: Railing fixed at its original position.

1st Race: 168. The Champion Jockey Trophy - Div. III - (About) 1400 metres. Horses rated 20 to 45 (11 Runners).

TOP DANCER (K.G. Likith Appu) jumped awkwardly outwards.

Jockey L. Alex Rozario, the rider of EMPIRE OF DREAMS was fined Rs.3,000/- for shifting 'in' and causing interference to the horses on his inside viz; RECREATOR (Vinod Shinde), MAYBACH (Tousif Khan) and SHE'S INNOCENT (Arvind Kumar. N) soon after the start.

Jockey S. Zervan, the rider of PHOENIX SURPRISE reported that he lost his left stirrup soon after jumping out of the starting gates, which he regained passing the 1300 Metres.

Jockey P. Trevor, the rider of MACRON reported that his mount was lugging 'in' under pressure in the final 100 Metres of the race. The horse was subjected to veterinary examination but no abnormality was reported.

RECREATOR (Vinod Shinde) sustained superficial cut injury on left hind pastern.

Routine Sample was taken for analysis from the winner b m TOP DANCER.

2nd Race: 169. The Gangavalli Plate - (About) 1600 metres. Horses rated 20 to 45 (12 Runners).

CASTANEDA (K.G. Likith Appu) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Arjun Mangalorkar was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey K.G. Likith Appu, the rider of CASTANEDA reported that his mount was not galloping fluently throughout the race. The horse was subjected to veterinary examination. On examination, it was found to be lame on left fore. Trainer Mr. Arjun Mangalorkar was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

RULE OF LAW (V.R.Jagadeesh) ran detached from 200 Metres. Trainer Mr. S. Ganapathy was informed to ensure better performance of his charge in future.

Routine Sample was taken for analysis from the winner b g THUNDERSTRUCK.

3rd Race: 170. The Champion Jockey Trophy - Div. II - (About) 1400 metres. Horses rated 20 to 45 (8 Runners).

SPEAKING OF STARS (Vivek) was examined at the starting gate by the Club's Veterinary Officer and was found to be trotting lame on left fore. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr.S. Inayathulla was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

MY SOLITAIRE (Salman Khan) was extremely fractious inside the starting gates and injured the rider. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order.

OPUS ONE (L. Alex Rozario) jumped awkwardly inwards and inconvenienced FOI (Y. S. Srinath) soon after the start.

Routine Sample was taken for analysis from the winner b g ACCUMULATE.

4th Race: 171. The Champion Jockey Trophy - Div. I - (About) 1400 metres. Horses rated 20 to 45 (10 Runners).

MUSTERION (Y. S. Srinath) was slowly away and lost many lengths at the start. In view of its behaviour, Trainer Mr. Aravind G. was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Akshay Kumar, the rider of AGERA was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

At the request of Trainer Mr. S.S. Attaollahi, endoscopy was performed on IMPIANA and no abnormality was found.

MUSTERION (Y. S. Srinath) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner ch g KING OF WAR.

5th Race: 172. The Champion Trainer Trophy - (About) 1200 metres. Horses rated 40 to 65, 5 years old and over (12 Runners).

STRIKING MEMORY (Dharshan Antony.B) stumbled soon after jumping out of the starting gates.

Jockey Kiran Rai P, the rider of LAUTERBRUNNEN was reprimanded for shifting out and inconveniencing CLASSIC CHARM (Darshan R.N) on his outside passing the 1000 Metres.

Jockey L. Alex Rozario, the rider of STARRY WIND reported that his mount was hanging out after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported. Trainer Mr.Mahmood Khan was informed to take appropriate corrective measures before accepting with it again.

Jockey Y. S. Srinath, the rider of THE INHERITOR reported that he did not get a clear run between the 1000 Metres and 900 Metres due to a closely packed field.

Routine Sample was taken for analysis from the winner dk b r SCRIBBLING HOPPER.

6th Race: 173. The Leading Owner Trophy - (About) 1400 metres. Horses rated 60 to 85 (9 Runners).

Jockey V.R.Jagadeesh, the rider of ELUSIVE GIRL was fined Rs.1,000/- for shifting 'in' and causing interference to the horses on his inside viz; DE VILLIERS (Akshay Kumar), AUTOMATIC (L. Alex Rozario) and PRINCE ABIR (Abhay Singh) soon after the start.

Jockey P. Trevor, the rider of MOON'S BLESSING reported that he could not get a clear run in the final 75 Metres due to a closely packed field.

Routine Sample was taken for analysis from the winner b g DE VILLIERS.

7th Race: 174. The Governor's Trophy - (About) 1600 metres. 3-year-old horses(foaled in 2020) (6 Runners).

TIGER SHARK (S. Zervan) after jumping out slightly swerved towards the left. In view of its behaviour, Trainer Mr.Neil Darashah was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Routine Sample was taken for analysis from the winner b f AUSPICIOUS QUEEN.

8th Race: 175. The Leading Stud Trophy - (About) 1100 metres. Horses rated 40 to 65 (10 Runners).

Jockey Dharshan Antony.B, the rider of ANAKIN reported that he accidentally lost his whip passing the 100 Metres.

Routine Sample was taken for analysis from the winner b c SIEGE COURAGEOUS.

9th Race: 176. The Good-bye Plate - (About) 1400 metres. Horses rated 00 to 25, 5 years old and over (10 Runners).

Permission was granted to Trainer Mr. Sriram Komandur to withdraw PARADISE BECKONS (Salman Khan) on veterinary grounds as it was found to have abscess on tongue. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

THE INTRUDER (A.R.Pradeep) was examined at the starting gate by the Club's Veterinary Officer and was found to be trotting lame on left hind. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr.Warren Singh was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Neeraj Rawal replaced the indisposed Jockey Y.S. Srinath on LIGHTNING FLAME.

Jockey Rayan Ahmed R., the rider of SEKHMET reported that his mount suddenly slowed down from 1300 Metres and ran detached thereafter. The horse was subjected to veterinary examination but no abnormality was reported. However, In view of its behaviour, Trainer Mr. Kishan Thomas was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey L. Alex Rozario, the rider of ULTIMATE CHANCE reported that his mount was hanging out from 600 Metres. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. S. Dominic was informed to take appropriate corrective measures before accepting with it again.

Jockey Dharshan Antony.B, the rider of DAWN RISING reported that he accidentally lost his whip passing the 100 Metres.

Routine Sample was taken for analysis from the winner b m MEMORABLE TIME.

Permission was granted to trainer Mr. Kishan Thomas to deputize on behalf of trainer Mr. Prasanna Kumar who was unable to attend the races.

ORDER OF THE STEWARDS

Stable inspections carried out on 4/12/2022

(A)

Reference to the Charge Sheet No. 813, dated: 8/3/2023 issued to Trainer Mr. Mahmood Khan by the Stipendiary Steward pertaining to Blistering of his charge b f BESUGE and the matters arising there from, the Stewards of the Bangalore Turf Club Ltd., at their meetings held on 18/03/2023 and 20/03/2023 considered the following:

1. The Charge Sheet No.813, dt.08/03/2023 issued to Trainer Mr. Mahmood Khan with relevant Annexures attached thereto.
2. The video of the horse b f BESUGE clearly displaying the blistering done to Trainer Mr. Mahmood Khan's charge.
3. The written submission made by Trainer Mr. Mahmood Khan on 18/03/2023 before the Stewards.
4. The submission made by him during the enquiry held by the Stewards on 18/03/2023 and 20/03/2023.
5. The opinion of the enquiry officers on this issue.

- **After considering all of the above, the Stewards have concluded that Trainer Mr. Mahmood Khan under whose charge b f BESUGE had been blistered was guilty of violating the BTC Racing Calendar Notification reading as under:**

"Blistering of horses is prohibited in the interest of the welfare of the horse"

Thus, violation of Rule Nos.202 (i) (a) (b) (c) & (d) of BTC Rules of Racing for his dishonest, corrupt, fraudulent, improper practice and dishonourable action in connection with reference to his charge b f BESUGE reading as follows:

202 : *The Stewards and/or the Stewards of the Club shall fine and/or punish and/or warn off and/or exclude and/or eject and/or disqualify and/or suspend or withdraw Licences, for any reason or reasons, from any race course or place where these Rules are in force, any of the following persons viz.:*

- (i) *Any person who in their opinion has been guilty of any*
- (a) *dishonest, corrupt,*
 - (b) *fraudulent, or*
 - (c) ***improper practice or***
 - (d) *dishonourable action*

- **Trainer Mr.Mahmood Khan is guilty of Rule No.202 (x) (b) of BTC Rules of Racing in connection with the possession of the following viz.,:**

- i. Ultrasound machine
- ii. Infrared Light
- iii. Homeopathy medicines

The Rule No.202 (x) (b) reading as follows :-

202 (x) (b) : *Any person who uses or has in his possession, any electric or electronic apparatus or any other apparatus or any improper contrivance capable of affecting the performance of a horse in a race or training gallop.*

- **Trainer Mr.Mahmood Khan is guilty in terms of Rule No.114 (a) (b) (i) of B.T.C Rules of Racing in that as a trainer of b f BESUGE he was not bothered to take his charge b f BESUGE to the veterinary hospital of BTC for treatment. Further, he has stated that he did not visit the stables, which is total neglect in the performance of his duties as a licensed professional. The said act of Trainer attracts the Rule No.114(a) (b) (i) of BTC Rules of Racing produced below :**

114 (a) *Any person training a horse in contravention of this rule may be warned off the course and shall then be subject to all the disabilities specified under the Rules.*

(b) *In addition to or in lieu of any other penalties or punishments as may be laid down under these Rules of Racing, a Trainer may be fined, suspended or disqualified by the Stewards:-*

(i) *If his conduct or negligence or neglect in the performance of his duties as a licenced professional has led or could have led to a breach of the Rules of Racing;*

- **Trainer Mr.Mahmood Khan is guilty of committing various acts of omission in terms of Medication rules under the provisions of BTC Medication Rules reading as follows :-**

Rule No. 2 of Medication Rules :-

Any person who takes part in any matter or race meeting coming within the Rules of Racing agrees to be bound by and comply with them.

Rule No. 13 (d), (g) of Medication Rules :-

Any person committing a breach of any of the practices mentioned below will be guilty of an offence under these Rules and shall be liable to penalty under these Rules.

(d) *Practices that are fraudulent, potentially fraudulent or may have adverse consequences for the integrity of the industry;*

(g) *Any practice which jeopardizes the health and welfare of the horse and the integrity of the industry;*

- **By not maintaining the Medication Log Book the trainer is attracted by the following Rules :-**

Rule No. 19 of Medication Rules :-

A trainer must record in his log book (hand written) any medication or treatment administered to any horse in the Trainer's care by midnight on the day on which the administration was given.

(1) *For the purpose of this Rule, each record of administration must include the following information :-*

(a) *the name of the horse ;*

- (b) *the date and time of administration of the treatment or medication;*
- (c) *the name of the treatment or medication administered (brand name or active constituent);*
- (d) *the route of administration including by injection, stomach tube, paste, topical application or inhalation;*
- (e) *the amount of medication given (if applicable);*
- (f) *the duration of treatment (if applicable);*
- (g) *the name and signature of the person/s administering and/or authorizing the administration of the treatment or medication.*

(3) *Any person who breaches this Rule is guilty of an offence and may be penalized.*

Rule No. 20 of Medication Rules :-

All records required to be kept in accordance with this Rule must be retained by the Trainer for at least 2 years.

➤ **The trainer is always responsible and accountable at all times regarding stable management. By his negligence he has violated Rule No.23 of the BTC Medication Rules reading as follows :-**

Rule No. 23 of Medication Rules :-

The Trainer shall always be responsible and accountable at all times for :-

- (a) *The management, administration, supervision, security and control of horses and of stable employees under his/her charge;*
- (b) *The feeding, feed supplements, treatment, stable routine, management, protection and security of the horses in his/her stable;*
- (c) *For ensuring that only Veterinarians approved by the Stewards inject or otherwise treat horses in his/her care;*
- (d) *For ensuring that no person is employed as a stable employee in connection with any horse in his/her care unless such person holds a licence from the appropriate Authority.*

Therefore, the Stewards unanimously decided as follows: -

- a) To treat Trainer Mr. Mahmood Khan as a disqualified person under the BTC Rules of Racing from **01/04/2023 to 31/03/2024 (Both days inclusive)** for violation of the above said BTC Rules of Racing, BTC Medication Rules and Racing Calendar Notification.
- b) He was informed of his right to appeal before the BTC Board of Appeal within the frame work of BTC Rules of Racing.

(B)

Reference to the Charge Sheet No.814, dated: 08/03/2023 issued to Mr.Babul, working as Jamedar under Trainer Mr. Mahmood Khan by the Stipendiary Steward pertaining to Blistering of the horse b f BESUGE and the matters arising there from, the Stewards of the Bangalore Turf Club Ltd., at their meetings held on 18/03/2023 and 20/03/2023 considered the following:

1. The Charge Sheet No.814, dt.08/03/2023 issued to Mr. Babul with relevant Annexures attached thereto.
2. The video replay of the horse b f BESUGE clearly displaying the blistering done on the horse.

3. The submission made by him during the enquiry held by the Stewards on 18/03/2023 and 20/03/2023.

4. The opinion of the enquiry officers on this issue.

- **After considering all of the above, the Stewards have concluded that he has violated the Racing Calendar Notification in that he has been a party to the blistering of the horse b f BESUGE in his stable. The relevant Racing Calendar Notification is produced below :-**

BLISTERING:-

Blistering of horses is prohibited in the interest of the welfare of the horse.

- **He is guilty of violating Rule No.202 (i) (a) (b) (c) & (d) of BTC Rules of Racing by virtue of his actions. The provisions of the BTC Rules of Racing are reproduced below:**

202 : *The Stewards and/or the Stewards of the Club shall fine and/or punish and/or warn off and/or exclude and/or eject and/or disqualify and/or suspend or withdraw Licences, for any reason or reasons, from any race course or place where these Rules are in force, any of the following persons viz.:*

(i) *Any person who in their opinion has been guilty of any*

(a) dishonest, corrupt,

(b) fraudulent, or

(c) improper practice or

(d) dishonourable action

- **He is guilty of tendering misleading evidence with reference to the enquiry officers regarding blistering of horse by applying locally made oil on the leg of b f BESUGE thereby violating the BTC Medication Rules reading as follows:**

Rule No.2 of Medication Rules :-

Any person who takes part in any matter or race meeting coming within the Rules of Racing agrees to be bound by and comply with them.

Rule No. 13 (d), (g) of Medication Rules :-

Any person committing a breach of any of the practices mentioned below will be guilty of an offence under these Rules and shall be liable to penalty under these Rules.

(d) *Practices that are fraudulent, potentially fraudulent or may have adverse consequences for the integrity of the industry;*

(g) *Any practice which jeopardizes the health and welfare of the horse and the integrity of the industry;*

Therefore, the Stewards unanimously decided as follows: -

- a) To treat Mr.Babul as a disqualified person under the BTC Rules of Racing from **01/04/2023 to 31/03/2024 (Both days inclusive)** for violation of the BTC Rules of Racing and the racing Calendar Notification.

b) He was informed of his right to appeal before the BTC Board of Appeal within the frame work of BTC Rules of Racing.

(C)

Reference to the Charge Sheet No.815, dated:08/03/2023 issued to Mr.Pemma Reddy, working as Assistant to Trainer to Trainer Mr. Mahmood Khan by the Stipendiary Steward pertaining to Blistering of the horse b f BESUGE and the matters arising there from the Stewards of the Bangalore Turf Club Ltd., at their meetings held on 18/03/2023 and 20/03/2023 considered the following :

1. The Charge Sheet No.815, dt.08/03/2023 issued to Mr.Pemma Reddy with relevant Annexures attached thereto.
2. The video replay of the horse b f BESUGE clearly displaying the blistering done on the horse.
3. The submission made by him during the enquiry held by the Stewards on 18/03/2023 and 20/03/2023.
4. The opinion of the enquiry officers on this issue.

➤ **After considering all of the above, the Stewards have concluded that he is guilty of breaching Rule No.202 (i) (a)(b) (c) & (d) of BTC Rules of Racing by virtue of his conduct as an Assistant to Trainer Mr. Mahmood Khan.**

The relevant rules reading as follows:

202 : *The Stewards and/or the Stewards of the Club shall fine and/or punish and/or warn off and/or exclude and/or eject and/or disqualify and/or suspend or withdraw Licences, for any reason or reasons, from any race course or place where these Rules are in force, any of the following persons viz.:*

(i) *Any person who in their opinion has been guilty of any*

(a) dishonest, corrupt,

(b) fraudulent, or

(c) improper practice or

(d) dishonourable action

➤ **He is also guilty of violating Rule No.202 (vi) & (vii) in tendering false and misleading evidence (having known the facts and not reporting to the authorities) during enquiry by the enquiry officers pertaining to the blistering of b f BESUGE and application of some locally made oil on the leg of the b f BESUGE. Thereby violating Rule No.202 (vi) & (vii) of BTC Rules of Racing are reading as follows :**

202 (vi) *Any owner, nominator, trainer, jockey, lessee, apprentice, stable hand, bookmaker or bookmakers assistant or any person who either wilfully refuses to attend and give evidence at an enquiry when requested by the Stewards/Stewards of the Club/Stipendiary Stewards to do so, or knowingly gives evidence which is false or misleading in any particular.*

(vii) *any person who gives at any enquiry or appeal any evidence which in their opinion is false or misleading in any manner.*

Therefore, the Stewards unanimously decided as follows: -

- a) To treat Mr.Pemma Reddy as a disqualified person under the BTC Rules of Racing from **01/04/2023 to 30/09/2023 (Both days inclusive)** for violation of the BTC Rules of Racing and the racing Calendar Notification.
- b) He was informed of his right to appeal before the BTC Board of Appeal within the frame work of BTC Rules of Racing.

Reference to the Charge Sheet No. 816, dated: 8/3/2023 issued to Mr.Sudhir, working as a temporary Syce under Trainer Mr.Mahmood Khan by the Stipendiary Steward pertaining to Blistering of the horse B F BESUGE under his care and the matters arising there from the Stewards of the Bangalore Turf Club Ltd., at their meetings held on 18/03/2023 and 20/03/2023 considered the following:

1. The Charge Sheet No.816, dt.08/03/2023 issued to Mr.Sudhir with relevant Annexures attached thereto.
2. The video replay of the horse B F BESUGE clearly displaying the blistering done on the horse.
3. The submission made by him during the enquiry held by the Stewards on 18/03/2023 and 20/03/2023.
4. The opinion of the enquiry officers on this issue.

- **After considering all the above the Stewards have concluded that he has violated the Racing Calendar Notification in that he has been a party to the blistering of the horse B F BESUGE in his stable. The relevant Racing Calendar Notification is produced below :-**

BLISTERING:-

Blistering of horses is prohibited in the interest of the welfare of the horse.

- **He is guilty of violating Rule No. Rule No.202 (i) (a) (b) (c) & (d) of BTC Rules of Racing by virtue of his actions. The provisions of the BTC Rules of Racing are reproduced below:**

202 : *The Stewards and/or the Stewards of the Club shall fine and/or punish and/or warn off and/or exclude and/or eject and/or disqualify and/or suspend or withdraw Licences, for any reason or reasons, from any race course or place where these Rules are in force, any of the following persons viz.:*

- (i) *Any person who in their opinion has been guilty of any*
 - (a) *dishonest, corrupt,*
 - (b) *fraudulent, or*
 - (c) ***improper practice or***
 - (d) *dishonourable action*

- **He is guilty of tendering false and misleading evidence before the enquiry officers pertaining to blistering of the horse b f BESUGE thereby violating the Rule No.202 (vi) & (vii) of BTC Rules of Racing reading as follows:**

202 (vi) Any owner, nominator, trainer, jockey, lessee, apprentice, stable hand, bookmaker or bookmakers assistant or any person who either wilfully refuses to attend and give evidence at an enquiry when requested by the Stewards/Stewards of the Club/Stipendiary Stewards to do so, or knowingly gives evidence which is false or misleading in any particular.

(vii) any person who gives at any enquiry or appeal any evidence which in their opinion is false or misleading in any manner.

Therefore, the Stewards unanimously decided as follows: -

- a) To treat Mr.Sudhir as a disqualified person under the BTC Rules of Racing from **01/04/2023 to 30/09/2023 (Both days inclusive)** for violation of the BTC Rules of Racing and the racing Calendar Notification.
- b) He was informed of his right to appeal before the BTC Board of Appeal within the frame work of BTC Rules of Racing.
