

**BANGALORE WINTER MEETING 2023-24**  
**FOURTEENTH DAY, FRIDAY, 19<sup>TH</sup> JANUARY, 2024**

**RACING INCIDENTS**

**(91 - 97)**

**GOING : Good**

**PENETROMETER READING: 3.6 Cms.**

**RAILING POSITION: Railing fixed at average width of 7.25 Meters from 1600 Meters to winning post from its original position.**

**1<sup>st</sup> Race: 91. The Ted Fordyce Plate - (About) 1100 metres. Maiden Horses 3 years old only (9 Runners).**

DAYS DATE (L. Alex Rozario) ducked out from the gates after being loaded, ran rider less and completed one round of the course. On immediate examination, it was found to have sustained cut injury on left fore pastern. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order.

Jockey Tousif Khan, the rider of NOBLE PURSUIT was fined Rs.1,000/- for shifting 'in' and caused interference to AHEAD OF THE CURVE (Suraj Narredu) on his inside approaching 1000 Metres.

Jockey A.R.Pradeep, the rider of MEHRA was fined Rs.1,000/- for shifting 'in' and caused interference to NOBLE PURSUIT (Tousif Khan) whereby it stumbled approaching 600 Metres.

Jockeys Suraj Narredu (AHEAD OF THE CURVE), P. Trevor (NYX) and S. Saqlain (SHEROUK) reported that the track was shifty and kick back was appalling during the running of the above race.

Routine Sample was taken for analysis from the winner b c JERSEY KING.

**2<sup>nd</sup> Race: 92. The Arkavati Plate - Div. II - (About) 1600 metres. Horses rated 20 to 45, 5 years old and over (8 Runners).**

Jockey Darshan R.N, the rider of PELUCHE reported that his mount was not striding out well in the final 200 Metres. The horse was subjected to veterinary examination. On examination, it was found to be lame on left hind. Trainer Mr. Imtiaz Khan was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

CHINKY PINKY (A.R.Pradeep) ran detached from the field. Trainer Mr. Darius R. Byramji was informed to ensure better performance of his charge in future.

Jockey Surya P., the rider of THEWHISPERQUIETLY was fined Rs.5,000/- for the excessive use of whip on his mount during the race (2nd infringement).

Jockeys Darshan R.N (PELUCHE) and A.R.Pradeep (CHINKY PINKY) reported that the track was shifty and kick back was appalling during the running of the above race.

It was observed that Jockey Surya P., the rider of THEWHISPERQUIETLY lost balance in the final 75 Metres of the race, whereby he also lost his whip as the incident was accidental no action was taken beyond noting incident.

Routine Sample was taken for analysis from the winner b g THEWHISPERQUIETLY.

**3<sup>rd</sup> Race: 93. The Arkavati Plate - Div. I - (About) 1600 metres. Horses rated 20 to 45, 5 years old and over (8 Runners).**

Routine Sample was taken for analysis from the winner b g ARDAKAN.

**4<sup>th</sup> Race: 94. The Dancing Fountain Stakes - (About) 1200 metres. Horses rated 40 to 65, 5 years old and over (12 Runners).**

Jockey Angad, the rider of LAUTERBRUNNEN was reprimanded for shifting 'in' and tightening TRIPITAKA (Suraj Narredu) on his inside approaching 900 Metres.

Jockey Antony Raj S., the rider of MILLBROOK was reprimanded for shifting out and inconveniencing CLASSIC CHARM (Imran Chisty) on his outside approaching 800 Metres.

Jockey Antony Raj S., the rider of MILLBROOK was fined Rs.1,000/- for shifting out and taking out ANAKIN (Vivek) on his outside passing the 600 Metres.

Jockey V.R.Jagadeesh, the rider of MYSTIC EYE reported that his mount stopped galloping after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported.

Jockey L. Alex Rozario, the rider of SILVER TOKEN was fined Rs.2,000/- for not wearing the goggles during the race.

Jockey Y. S. Srinath, the rider of SOLO PRINCE was reprimanded for dropping hands before passing the winning post.

Routine Sample was taken for analysis from the winner dk b g AUGUSTO.

**5<sup>th</sup> Race: 95. The K.N.Chennabasappa Memorial Trophy - (About) 1400 metres. Horses rated 40 to 65 (7 Runners).**

Trainer Mr. Neil B Devaney was fined Rs.5,000/- for not obtaining prior permission with regards to his charge MAZAL TOV to race without Basket Bit. Subsequently, permission was granted to him to run his charge without Basket Bit.

As Jockey Ram Nandan Manjhi was certified medically unfit to ride. Permission was granted to trainer Mr. Aravind G. to declare Jockey L. Alex Rozario to ride SERAI in place of the declared rider.

MARZGOVEL (F. Norton) dropped the rider on the way to the starting gates, ran rider less, completed the course and was exhausted. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order.

Jockey Y. S. Srinath, the rider of MAZAL TOV was fined Rs.2,000/- for shifting 'in' and tightening RICARDO (Antony Raj S.), which in turn passed it onto IMPIANA (V.R.Jagadeesh) along the rails approaching 200 Metres.

At the behest of the Stipendiary Stewards, the stewards held an enquiry immediately after the race and enquired into the fall of Jockey Vivek. G, the rider of IN THY LIGHT (the interference caused by Jockey Antony Raj.S, the rider of RICARDO) at the start of the race and approaching 1200 Metres. The Stewards examined Jockey Antony Raj.S (RICARDO), V.R. Jagadeesh (IMPIANA) and Shamaz Shareef (MAROON). After detailed deliberations, they decided to disqualify RICARDO which had placed 3<sup>rd</sup> in the above race and the revised order of placings are as under:-

An enquiry is being held into the manner of riding by Jockey Antony Raj.S, the rider of RICARDO, wherein he was not alert at the start and shifted 'in' & caused severe interference to MAROON (Shamaz Shareef), which in turn passed it onto IN THY LIGHT (Vivek. G), further he shifted 'in' and caused interference to IN THY LIGHT (Vivek. G) approaching 1200 Metres, whereby IN THY LIGHT struck the front runner RICARDO (Antony Raj.S), whereby Jockey Vivek. G was totally unbalanced and was unseated from his mount IN THY LIGHT which ran rider less thereafter.

It was reported after the race that RICARDO (Antony Raj S.) pulled up lame on right fore and sustained superficial injury on right fore bulb. Trainer Mr.Arjun Mangalorkar was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was reported after the race that IN THY LIGHT (Vivek.G) pulled up lame on left hind. Trainer Mr.Prasanna Kumar was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

STELLANTIS (P. Trevor) sustained superficial injury on right gaskin.

Routine Sample was taken for analysis from the winner b c STELLANTIS.

**6<sup>th</sup> Race: 96. The Narasimharaja Trophy - (About) 1600 metres. Horses rated 60 to 85 (9 Runners).**

Jockey L. Alex Rozario replaced the indisposed Jockey Vivek. G on TOP DANCER.

FEARLESS JOEY (Salman Khan) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. S. Narredu was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Angad, the rider of AUSPICIOUS QUEEN placed 4th by the judge objected against Jockey S. Saqlain, the rider of SHABELLE placed 1st for "In the last 25 Metres, the winner came and bumped me, when my horse was full of running whereby I had to stop riding which cost me a certain race". The Stewards held an enquiry immediately after the race and interviewed the Jockeys concerned. After deliberations, they decided to uphold the objection and revise the order of placings as under:-

An enquiry is being held into the manner of riding by Jockey S. Saqlain, the rider of SHABELLE in the above race wherein he shifted 'in' in the final 75 Metres of the race, whereby AUSPICIOUS QUEEN (Angad) had to be checked by its rider.

Routine Sample was taken for analysis from the winner b m PINK JASMINE.

**7<sup>th</sup> Race: 97. The Chunchanakatte Falls Plate - (About) 1200 metres. Horses rated 20 to 45, 4 years old only (10 Runners).**

Permission was granted to Trainer Mr. Neil B Devaney to withdraw MY WISH on veterinary grounds as it was found to be lame on left fore. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey S. Saqlain replaced the indisposed Jockey Vivek. G on RAINBOW DREAMER.

At the starting gates BLACKSTONE (Rayan Ahmed R.) was sweating, showing signs of discomfort and trying to lie down. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr. M. Rajendra Singh was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey S. Saqlain, the rider of RAINBOW DREAMER reported that his mount was hanging 'in' after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Prasanna Kumar was informed to take appropriate corrective measures before accepting with it again.

It was observed that RAINBOW DREAMER (S. Saqlain) accidentally stumbled approaching 900 Metres.

Jockey S. Saqlain, the rider of RAINBOW DREAMER was fined Rs.1,000/- for shifting out and taking out SIR TRISTAN (Antony Raj S.) on his outside approaching 850 Metres.

Jockey Ashok Kumar A, the rider of ASAGIRI was reprimanded for riding an indifferent race.

Routine Sample was taken for analysis from the winner ch g BOLD ACT.
