FIFTEENTH DAY, THURSDAY, 25TH JANUARY, 2024

RACING INCIDENTS

(98 - 105)

GOING : Good

PENETROMETER READING: 3.2 Cms.

RAILING POSITION: Railing fixed at average width of 4.25 Meters from 1600 Meters to winning post from its original position.

1st Race: 98. The Gateway of India Plate - Div. II - (About) 1400 metres. Horses rated 20 to 45 (9 Runners).

As Jockey Y.S. Srinath was certified medically unfit to ride. Permission was granted to trainer Mr. S. Dominic to declare Jockey Imran Chisty to ride TREASURE CHEST in place of the declared rider.

PALOMINO (Vivek.G) took a fly jump.

SEA JACK (B. Nayak) after jumping out shifted out violently and inconvenienced PALOMINO (Vivek.G) approaching 1300 Metres and thereafter it was running out throughout the race. In view of its repeated unruly behaviour, Trainer Mr. Pradeep Annaiah was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least two Mock Races. SEA JACK was subjected to veterinary examination but no abnormality was reported.

It was observed that Jockey Harish B., the rider of EVERYONE GODFATHER had to steady his mount to avoid striking the front runner TREASURE CHEST (Imran Chisty) approaching 700 Metres.

Jockey Harish B., the rider of EVERYONE GODFATHER was fined Rs.1,000/- for shifting out and taking out SEA JACK (B. Nayak) on his outside approaching 600 Metres.

Jockey Surya P., the rider of ELIZABETH REGINA was fined Rs.1,000/- for shifting out and taking out SUNLIT PATH (P. Trevor) on his outside passing the 150 Metres.

Jockey Antony Raj S., the rider of BLUE GOD reported that his mount shied away from the advertisement hoarding in the final 100 Metres.

It was reported after the race that EL ALAMEIN (A.R.Pradeep) burst its blood vessels Trainer Mr.Faraz Arshad was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

EVERYONE GODFATHER (Harish B.) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner dk b c BLUE GOD.

2nd Race: 99. The Saddle Up Cup - Div. II - (About) 1200 metres. Horses rated 00 to 25 (Whips not allowed) (8 Runners).

CRIMSON STAR (Vivek) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. S. Inayathulla was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey M. Prabhakaran, the rider of AIR BLAST shifted 'in' very sharply passing the 700 Metres, thereby causing severe interference to DAWN RISING (Imran Chisty) on his inside who almost had a fall from his mount. Further Jockey Imran Chisty, the rider of DAWN RISING had to change course and took out the horses on his outside viz; BELLISSIMO (Naveen M.) and PERFECT HALO (Rajesh Kumar M) approaching 600 Metres. *An enquiry is being held into the incident.*

Routine Sample was taken for analysis from the winner b m SACRED CREATOR.

3rd Race: 100. The Stewards Gold Cup - (About) 1200 metres. Horses rated 40 to 65, 5 years old and over (11 Runners).

Permission was granted to Trainer Mr.Imtiaz Khan to withdraw DISRUPTOR (Inayat) on veterinary grounds as it was found to be trotting lame on right fore. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

As Jockey Y.S. Srinath was certified medically unfit to ride. Permission was granted to trainer Mr. S. Dominic to declare Jockey P. Trevor to ride MAPLE LEAF in place of the declared rider.

CHUL BUL RANI (Darshan R.N) accidentally stumbled soon after the start.

Jockey Suraj Narredu, the rider of EXCELLENT RAY reported that he accidentally struck the front runner MAPLE LEAF (P. Trevor), whereby he shifted out and took out the horses on his outside viz; LAUTERBRUNNEN (Rajesh Kumar M) and JOKSHAN (Vivek.G). At this point of time, the horses travelling behind viz; CLASSIC CHARM (Imran Chisty), OSIRIS (Afsar Khan), CHUL BUL RANI (Darshan R.N), SOUTHERN FORCE (S. Saqlain) and THE GREY GERANIUM (Surya P.) all had to be checked by their respective riders approaching 750 Metres. Jockey Suraj Narredu pulled up his mount and dismounted at 700 Metres. As the incident was accidental no action was taken beyond noting the incident.

EXCELLENT RAY was subjected to veterinary examination and it was found to be lame on left fore. Subsequently, it was euthanized at 6.30 PM on 25.01.24 as the horse sustained irreparable fracture of Left scapula.

Routine Sample was taken for analysis from the winner dk b h MAPLE LEAF.

4th Race: 101. The Srikantadatta Narasimharaja Wadiyar Memorial Trophy - (About) 1400 metres. Horses rated 80 and above (5 Runners).

Jockey Salman Khan, the rider of PEYO was fined Rs.1,000/- for shifting 'in' and causing interference to DUN IT AGAIN (Koshi Kumar) on his inside passing the 1000 Metres.

SALENTO (Antony Raj S.) was subjected to veterinary examination. On examination, it was found to be lame on right fore. Trainer Mr. Arjun Mangalorkar was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b m MOON'S BLESSING.

5th Race: 102. The G. Nityanand Memorial Bangalore Winter Million - (About) 1200 metres. 3-year-old horses (foaled in 2021) (7 Runners).

Jockey Shamaz Shareef, the rider of FLIGHT ON reported that that his mount grabbed its bit towards the right at the start. The horse was subjected to veterinary examination but no abnormality was reported.

Jockey Vivek.G, the rider of SCARLETTE LADY was reprimanded for shifting 'in' and inconveniencing FLIGHT ON (Shamaz Shareef) on his inside passing the 1000 Metres.

Jockey Shamaz Shareef, the rider of FLIGHT ON was fined Rs.1,000/- for shifting out and taking out FINLEY (F. Norton) on his outside passing the 850 Metres.

Jockey F. Norton, the rider of FINLEY reported that he accidentally lost his whip in the final 80 Metres.

Routine Sample was taken for analysis from the winner dk b c KNOTTY LEGEND.

6th Race: 103. The Bangalore Race Course 161st Year Commemoration Trophy - (About) 1600 metres. 4 years old and over at the time of starting. (4 Runners).

SANTORINO (L. Alex Rozario) sustained superficial injury on right hind pastern.

Routine Sample was taken for analysis from the winner b h SHAMROCK.

7th Race: 104. The Winfair 247 Sports Gaming Plate - (About) 1200 metres. Horses rated 20 to 45, 5 years old and over (12 Runners).

Trainer Mr. Warren Singh was fined Rs.5,000/- for discrepancy in shoeing in respect of his charge KALLU SAKKARE (A.R.Pradeep) (1st infringement).

Jockey Salman Khan, the rider of BENZEMA reported that his mount was inclined to run out between the 900 Metres to 700 Metres.

Jockey Chethan Kalay S., the rider of MAROON was fined Rs.5,000/- for the excessive and improper use of whip on his mount during the race (2nd infringement), whereby he shifted out and inconvenienced THE STRIKINGLY (Naveen M.) passing the 150 Metres.

Jockey Naveen M., the rider of THE STRIKINGLY was fined Rs.5,000/- for the excessive use of whip on his mount during the race (2nd infringement).

It was reported after the race that INDIAN BLUES (Vivek.G) burst its blood vessels. Trainer Mr. Prasanna Kumar was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

CHISOX (Siddaraju.P) sustained superficial injury on left hind cannon.

Routine Sample was taken for analysis from the winner b m KALLU SAKKARE.

8th Race: 105. The Gateway of India Plate - Div. I - (About) 1400 metres. Horses rated 20 to 45 (9 Runners).

STEP TO DESTINY (Vivek) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. V. Lokanath was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Routine Sample was taken for analysis from the winner ch f WONDER WOMAN.

Permission was granted to trainer Mr. S. Narredu to deputize on behalf of trainer Mr. Rajesh Narredu was unable to attend the races.
