RAILING POSITION: Railing fixed at average width of 4.0 Meters from

1600 Meters to winning post from its original position.

1st Race: 31. The Becket Plate - (About) 1100 metres. Maiden Horses 2 years old only (7 Runners).

Jockey Vivek.G, the rider of MAGICAL BAY was fined Rs.1,000/- for shifting 'in' and tightening MAKOTO (Antony Raj S.) on his inside passing the 1000 Metres.

It was observed that MAGICAL BAY (Vivek.G) drifted out under pressure in the final 200 Metres. Trainer Mr. Prasanna Kumar was informed to take appropriate corrective measures before accepting with it again.

Routine Sample was taken for analysis from the winner dk b f MAGICAL BAY.

2nd Race: 32. The Muthyalamaduvu Plate - Div. II - (About) 1200 metres. Horses rated 20 to 45 (11 Runners).

CRISTALDO (Chethan Kalay S.) took a fly jump.

QUICK WITTED (V.R.Jagadeesh) took a fly jump.

Jockey Vivek, the rider of SAMACHAR was reprimanded for not maintaining a proper course before passing the red marker post.

Jockey Arshad Alam, the rider of BLEUE DALI reported that he accidently lost his whip approaching 400 Meters.

QUICK WITTED (V.R.Jagadeesh) ran detached from the field. Trainer Mr. S. Ganapathy was informed to ensure better performance of his charge in future.

An enquiry is being held into the running and riding of BLEUE DALI, as Trainer Mr. Azhar Ali has lodged an oral complaint with regard to the riding of Jockey Arshad Alam in the above race.

Routine Sample was taken for analysis from the winner b g NEVER GIVE IN.

3rd Race: 33. The Mahanadi Plate - (About) 1600 metres. Horses rated 20 to 45 (9 Runners).

It was observed that INVINCIBLE (S. Saqlain) raced fiercely between the 1500 Metres to 1200 Metres.

Jockey Akshay Kumar, the rider of MOMENTOUS reported that his mount accidentally stumbled approaching 1300 Metres.

Jockey L. Alex Rozario, the rider of SUNLIT PATH was fined Rs.2,000/- for repeatedly changing course between the 400 Metres to 200 Metres for no apparent reason.

Jockey Neeraj Rawal, the rider of GRANPAR was fined Rs.1,000/- for coming 'in' and causing interference to SUPER SAPPHIRE (Salman Khan) on his inside approaching the final 100 Metres.

INVINCIBLE (S. Saqlain) was subjected to veterinary examination. On examination, it ws found to have burst its blood vessels. Trainer Mr. Darius R. Byramji was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

SASSY (P. Trevor) sustained bleeding injury on gums.

Routine Sample was taken for analysis from the winner b f SASSY.

4th Race: 34. The Glass House Trophy - (About) 1200 metres. Horses rated 40 to 65, 5 years old and over (10 Runners).

OSIRIS (A.Ramu) jumped awkwardly outwards and inconvenienced ANAKIN (Vivek.G) at the start.

Jockey Antony Raj S., the rider of MILLBROOK was fined Rs.3,000/- for not being alert at the start and allowing his mount to shift 'in' and causing interference to KNIGHT IN HOOVES (Suraj Narredu), which in turn passed it onto ANAKIN (Vivek.G).

It was observed that KNIGHT IN HOOVES (Suraj Narredu) stumbled few strides after the start.

Jockey Angad, the rider of LAUTERBRUNNEN reported that he accidently lost his whip approaching 300 Meters.

DEVILS MAGIC (Y. S. Srinath) sustained bleeding cut injury on right hind cannon.

ANAKIN (Vivek.G) sustained bleeding cut injury on right fore cannon.

KNIGHT IN HOOVES (Suraj Narredu) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g SOLO PRINCE.

5th Race: 35. The Kempegowda Cup - (About) 1400 metres. Horses rated 60 to 85 (7 Runners).

PEYO (Vinod Shinde) sustained bleeding cut injury on right fore cannon.

Routine Sample was taken for analysis from the winner b c KNOTTY CHARMER.

6th Race: 36. The Kaveri Plate - (About) 1600 metres. Horses rated 20 to 45, 4 years old and over (9 Runners).

ULTIMATE RULER (Arshad Alam) ran detached from the field. Trainer Mr. S. Dominic was informed to ensure better performance of his charge in future.

CASTANEDA (S. John) was impounded for veterinary examination but no abnormality was reported.

Surprise sample was taken for analysis from ch c CASTANEDA.

Routine Sample was taken for analysis from the winner b m ARMORY.

7th Race: 37. The Muthyalamaduvu Plate - Div. I - (About) 1200 metres. Horses rated 20 to 45 (12 Runners).

GOLDEN STARLET (Rajesh Kumar M) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr.Narayana Gowda V. was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

DIVO (S. Saglain) knuckled soon after the start.

It was observed that BLUES BALLAD (A.Ramu) raced fiercely between 1000 Metres till about 700 Metres.

It was reported after the race that the right fore shoe of DYNAMIC FORCE (Akshay Kumar) had apparently splayed during the race.

Jockey Y. S. Srinath, the rider of ART GALLERY placed 2nd by the judge objected against Jockey P. Trevor, the rider of PROPHECY placed 1st for "In the last 150 Metres the winner has come across my line and bumped me and further to that in the last 100 Metres, the winner cut across me whereby my horse was completely unbalanced which cost me a certain race". The Stewards held an enquiry immediately after the race and interviewed the Jockeys concerned. After deliberations, they decided to uphold the objection and revise the order of placings as under:-

DYNAMIC FORCE III
CROSSWATER IV
OMBUDSMAN V

PROPHECY (P. Trevor) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g ART GALLERY.
