RACING INCIDENTS
(60- 66)

GOING : Good

PENETROMETER READING: 3.6 Cms.

RAILING POSITION: Railing fixed at average width of 5.0 Meters from 1600 Meters to winning post from its original position.

1st Race: 60. The Sharavati Plate - (About) 1600 metres. Horses rated 20 to 45, 5 years old and over (10 Runners).

It was reported after the race that SOUTHERN DYNASTY (Darshan R.N) pulled up lame on right fore. Trainer Mr. S. Ganapathy was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b g JE NE SAIS QUOI.

2nd Race: 61. The Gokak Falls Plate - (About) 2000 metres. Horses rated 20 to 45 (11 Runners).

REGAL ARISTOCRACY (Neeraj Rawal) turned its head towards the right soon after the start was given whereby it planted and lost many lengths. In view of its behaviour, Trainer Mr.Imtiaz Khan was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

It was observed that WALVIS BAY (Vivek.G) accidentally stumbled approaching 1800 Metres.

Jockey Imran Chisty, the rider of SAIGON reported that he accidentally stuck the front runner WALVIS BAY (Vivek.G) passing the 1800 Metres.

Jockey Shreyas Singh S, the rider of SUPER MARVELLA reported that his mount accidentally lost its hind leg footing passing the 1500 Metres.

Jockey Antony Raj S., the rider of EBOTSE reported that his saddle shifted forward at about 1400 Metres as such he could not offer any assistance to his mount thereafter. After due examination of the equipment, Trainer Mr.Arjun Mangalorkar was fined Rs.3,000/- for faulty saddling of his charge.

Jockey P. Trevor, the rider of WONDER WOMAN reported that the track was shifty especially from 900 Metres till about 500 Metres.

Jockey Imran Chisty, the rider of SAIGON reported that the track was shifty especially from 900 Metres till about 500 Metres.

Jockey Vivek.G, the rider of WALVIS BAY reported that the track was shifty especially from 900 Metres till about 500 Metres.

Jockey Hindu Singh, the rider of SUNLIT PATH was fined Rs.1,000/- for shifting 'in' and causing interference to WALVIS BAY (Vivek.G) on his inside approaching 300 Metres.

SUPER MARVELLA (Shreyas Singh S) sustained superficial clip injury on left hind tendon.

WALVIS BAY (Vivek.G) sustained superficial injury on tongue tip.

Routine Sample was taken for analysis from the winner b g SAIGON.

3rd Race: 62. The Devarayanadurga Stakes - (About) 1400 metres. Horses rated 20 to 45 (12 Runners).

SAMACHAR (V.R.Jagadeesh) planted, lost many lengths at the start and ran detached thereafter. In view of its behaviour, Trainer Mr.S. Inayathulla was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

TANKINIKA (L. Alex Rozario) jumped out awkwardly, totally unbalancing the rider, whereby he was dislodged from his mount and the horse ran rider less thereafter.

Jockey Surya P., the rider of ELIZABETH REGINA reported that his mount was hanging out from 600 Metres. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr.Prithviraj B. was informed to take appropriate corrective measures before accepting with it again.

Routine Sample was taken for analysis from the winner b c GRIZZLY.

4th Race: 63. The Kolar Plate - (About) 1400 metres. Horses rated 60 to 85 (12 Runners).

FEARLESS JOEY (Ashok Kumar A) walked out of the gates and lost few lengths at the start. In view of its behaviour, Trainer Mr. S. Narredu was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

It was observed that KING OF WAR (S. Hussain) accidentally stumbled soon after the start.

Jockey Antony Raj S., the rider of DOUGLAS was fined Rs.3,000/- for shifting out and causing interference to RAVISHING FORM (Imran Chisty) on his outside, whereby RAVISHING FORM (Imran Chisty) stumbled approaching 800 Metres.

Jockey S. Hussain, the rider of KING OF WAR reported that he could not get a clear view between the 800 Metres to 500 Metres due to kick back of the track.

Routine Sample was taken for analysis from the winner b c VIVALDO.

5th Race: 64. The Frankel Trophy - (About) 1100 metres. Maiden Horses 2 years old only (10 Runners).

Permission was granted to Trainer Mr. Warren Singh to withdraw GOLDEN STRIDE on veterinary grounds as it was found to be lame on right fore. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

GISMO (Vivek) jumped awkwardly outwards onto ALPHA LEGEND (Vivek.G) soon after the start.

Routine Sample was taken for analysis from the winner dk b c KNOTTY LEGEND.

6th Race: 65. The J.B.Mallaradhya Memorial Trophy - (About) 2000 metres. Horses rated 40 to 65 (6 Runners).

As Jockey S. John was certified medically unfit to ride. Permission was granted to trainer Mr. Imtiaz Khan to declare Jockey Antony Raj S to ride SPLENDIDO in place of the declared rider.

CASTANEDA (S. Saqlain) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Arjun Mangalorkar was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Vivek.G, the rider of ALL ATTRACTION was fined Rs.1,000/- for shifting 'in' and causing interference to CASTANEDA (S. Saqlain) on his inside approaching 1800 Metres.

Routine Sample was taken for analysis from the winner ch c SPLENDIDO.

7th Race: 66. The Chitradurga Plate - (About) 1400 metres. Horses rated 40 to 65, 5 years old and over (10 Runners).

HIGH OPINION (Hindu Singh) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Pradeep Annaiah was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

SMITHSONIAN (Darshan R.N) jumped awkwardly outwards onto TURKOMAN (Shamaz Shareef) soon after the start.

Trainer Mr. S. Ganapathy was fined Rs.2,000/- failing to fastening the side cheek piece properly on his charge CLASSIC CHARM (Imran Chisty) in the above race.

Routine Sample was taken for analysis from the winner ch m SPECTACULAR.

Permission was granted to trainer Mr. S. Narredu to deputize on behalf of trainer Mr. Rajesh Narredu was unable to attend the races.
