# BANGALORE WINTER MEETING 2023-24 EIGHTEENTH DAY, SATURDAY, 10<sup>TH</sup> FEBRUARY, 2024 RACING INCIDENTS

(121 - 128)

**GOING:** Good

PENETROMETER READING: 3.0 Cms.

RAILING POSITION: Railing fixed at average width of 6.25 Meters from 1600 Meters to winning post from its original position.

#### 1<sup>st</sup> Race: 121. The Bidar Plate - (About) 1800 metres. Horses rated 40 to 65, 5 years old and over (5 Runners).

It was observed that GOLDEN TIME (Siddaraju.P) accidentally brushed the rails passing the 600 Metres.

NIKOLINA (S. John) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner ch g AQUAMATIC.

#### 2<sup>nd</sup> Race: 122. The Topmost Plate - (About) 1400 metres. Maiden Horses 3 years old only (12 Runners).

ART OF ROMANCE (Darshan R.N) took a fly jump.

It was observed that HYDER (Dharshan Antony.B) raced fiercely from the start till about 1000 Metres.

MONTERIO (Vivek.G) was subjected to veterinary examination. On examination, it was found to have sustained superficial clip injury on left hind cannon.

Routine Sample was taken for analysis from the winner dk b c REDEFINED.

#### 3<sup>rd</sup> Race: 123. The Winslow Stakes - Div. II - (About) 1200 metres. Horses rated 20 to 45, 5 years old and over (9 Runners).

It was observed that SLICE OF HEAVEN (Surya P.) got squeezed between PRINCESS JASMINE (Vivek.G) and ICE STORM (Rajesh Kumar M) soon after the start.

Jockey Rajesh Kumar M, the rider of ICE STORM was reprimanded for travelling wide between the 700 Metres to 500 Metres for no apparent reason.

It was reported after the race that PRINCESS JASMINE (Vivek.G) pulled up lame on right fore. Trainer Mr.V. Lokanath was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Surprise sample was taken for analysis from b m CAPRI GIRL.

Routine Sample was taken for analysis from the winner b m BORN DANCER.

#### 4<sup>th</sup> Race: 124. The Hampi Plate - (About) 1400 metres. Horses rated 60 to 85 (8 Runners).

KING OF WAR (S. Hussain) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.V. Lokanath was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

INYOUWEBELIEVE (Arvind Kumar. N) planted and did not take any practical part in the race. In view of its behaviour, Trainer Mr. Pradeep Annaiah was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least two Mock Races.

Jockey F. Norton, the rider of STELLANTIS was fined Rs.5,000/- for shifting 'in' and causing interference to PEYO (S. John), whereby KING OF WAR (S. Hussain) which was travelling directly behind had to be checked by its rider approaching 500 Metres.

Jockey F. Norton, the rider of STELLANTIS reported that his mount was hanging 'in' after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr.S.S. Attaollahi was informed to take appropriate corrective measures before accepting with it again.

PEYO (S. John) sustained punctured wound on right hind cannon.

Routine Sample was taken for analysis from the winner b g IRISH COFFEE.

#### 5<sup>th</sup> Race: 125. The H.B.Gundappa Gowda Memorial Trophy - (About) 1200 metres. Horses rated 40 to 65 (12 Runners).

Jockey F. Norton, the rider of MARZGOVEL reported that he did not get a clear run between the 450 Metres to 400 Metres.

Jockey Siddaraju.P, the rider of STAR CONCEPT was fined Rs.1,000/- for shifting 'in' and causing interference to THE PERFECT CHOICE (A.R.Pradeep) on his inside passing the 200 Metres.

Jockey Vivek.G, the rider of PNEUMA reported that his mount stopped galloping in the final 150 Metres. The horse was subjected to veterinary examination but no abnormality was reported.

Jockey S. Hussain, the rider of RICARDO was fined Rs.3,000/- for not maintaining a proper course in the final 150 Metres, whereby he allowed his mount to drift out and took out the horses on his outside viz; PROPHECY (L. Alex Rozario) and MARZGOVEL (F. Norton).

An enquiry was held by the Stipendiary Steward into the interference caused by Jockey Tousif Khan, the rider of FOUR WHEEL DRIVE in the above race. In that he shifted 'in' and caused severe interference to ROMAN SPIRIT (Y. S. Srinath) who had to check his mount and shift out, thereby causing interference to MARZGOVEL (F. Norton), which in turn passed it onto CLASSIC CHARM (Darshan R.N) approaching 800 Metres.

Jockey Tousif Khan was interviewed by the Stipendiary Steward. The Stipendiary Steward after considering the submissions made by Jockey Tousif Khan and after viewing the CCTV replay decided to charge Jockey Tousif Khan for Careless Riding.

The Stipendiary Steward thereafter suspended the Jockey's Licence granted to Tousif Khan with effect from **21/2/2024 to 16/3/2024 (Both days inclusive)** as had he pleaded guilty to the charge under Rule No. 161 (i) of the BTC Rules of Racing for Careless Riding on his mount FOUR WHEEL DRIVE (he was permitted to ride work) and was informed of his right to appeal.

An enquiry is being held into the running and riding of THE PERFECT CHOICE, trained by Mr.Warren Singh and ridden by Jockey A.R.Pradeep in the above race.

Routine Sample was taken for analysis from the winner b c CZAR.

## 6<sup>th</sup> Race: 126. The Aga Aly Asker Sprinters' Trial Stakes - (About) 1200 metres. 4 years old and over at the time of starting. (6 Runners).

Routine Sample was taken for analysis from the winner b h SIEGE COURAGEOUS.

### 7<sup>th</sup> Race: 127. The Bhadra Plate - (About) 1400 metres. Horses rated 20 to 45, 5 years old and over (Whips not allowed) (9 Runners).

As Jockey Salman was certified medically unfit to ride. Permission was granted to trainer Mr.Faraz Arshad to declare Jockey S. Hussain to ride THE OMEGA MAN in place of the declared rider.

SINGHSAAB (Inayat) took a fly jump.

Jockey Ravi R., the rider of THE ATHABASCA was fined Rs.1,000/- for shifting out and taking out MY SOLITAIRE (Arvind Kumar. N) on his outside approaching 800 Metres.

Jockey Inayat, the rider of SINGHSAAB was reprimanded for shifting 'in' and inconveniencing WAR TRAIL (A.R.Pradeep) on his inside passing the 300 Metres.

THE ATHABASCA (Ravi R.) sustained superficial injury on right hind pastern.

Trainer Mr. Imtiaz Khan was fined Rs.10,000/- for the inconsistent pattern of running and reversal of form of REMONTOIR (Siddaraju.P) in the above race as compared to its previous run in Race No. 104 i.e., The Winfair247 Sports Gaming Plate - (About) 1200 metres. Horses rated 20 to 45, 5 years old and over run on 25th January, 2024 wherein it unplaced.

Routine Sample was taken for analysis from the winner b g REMONTOIR.

#### 8<sup>th</sup> Race: 128. The Winslow Stakes - Div. I - (About) 1200 metres. Horses rated 20 to 45, 5 years old and over (7 Runners).

GOLDEN GALLERY (Vivek.G) was examined at the starting gate by the Club's Veterinary Officer and was found to be trotting lame on right fore. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr. V. Lokanath was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

SACRED CREATOR (Rajesh Kumar M) was examined at the starting gate by the Club's Veterinary Officer and was found to be trotting lame on left fore. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr. Narayana Gowda V.was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Darshan R.N, the rider of STAR ADMIRAL was fined Rs.5,000/- for coming 'in' and causing interference to the horses on his inside viz; LADY INVICTUS (Inayat) and CHISOX (Siddaraju.P) approaching 950 Metres.

Jockey Inayat, the rider of LADY INVICTUS reported that he accidently lost his whip passing the 300 Meters.

Jockey Darshan R.N, the rider of STAR ADMIRAL reported that his mount was chocking in the final 250 Metres. The horse was subjected to veterinary examination. On examination, it was found to have burst its blood vessels (on Endoscopy - Grade IV). Trainer Mr. Aravind G. was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner ch m OXYTOCIN.
