RACING INCIDENTS

(129 - 135)

GOING : Good

PENETROMETER READING: 3.2 Cms.

RAILING POSITION: Railing fixed at its original position.

1st Race: 129. The Sabarmati Plate - (About) 1200 metres. Horses rated 00 to 25, 6 years old and over (12 Runners).

DAWN RISING (Vivek.G) slipped from its hind while jumping out of the starting gates.

Jockey S. John, the rider of JERSEY LEGEND reported that his mount was not galloping fluently in the final 200 Metres as such he had to stop riding. The horse was subjected to veterinary examination. On examination, it was found to have burst its blood vessels. Trainer Mr. Neil B Devaney was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

DALLAS DRIFTER (Koshi Kumar) sustained superficial injury on left hind tendon.

AMAZING LUCK (Rayan Ahmed R.) sustained superficial clip injury on right hock.

DAWN RISING (Vivek.G) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner ch m SPIRIT DANCER.

2nd Race: 130. The Shivaganga Falls Plate - Div. II - (About) 1200 metres. Horses rated 20 to 45 (9 Runners).

CROISSANTINO (B. Nayak) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Pradeep Annaiah was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey S. Hussain, the rider of DOUBLE VISION was fined Rs.1,000/- for shifting 'in' and causing interference to THE LADY EMPORIO (A.R.Pradeep) on his inside approaching 450 Metres.

SUNWAY LAGOON (P. Sai Kumar) sustained injury on nasal bridge.

Routine Sample was taken for analysis from the winner dk b g EBOTSE.

3rd Race: 131. The Ghataprabha Plate - (About) 1600 metres. Horses rated 20 to 45, 6 years old and over (9 Runners).

It was observed that APOLLO LIGHT (Koshi Kumar) accidentally brushed rails approaching 1000 Metres.

Jockey P. Sai Kumar, the rider of ECO FRIENDLY was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

Routine Sample was taken for analysis from the winner b g MY VISION.

4th Race: 132. The Shivaganga Falls Plate - Div. I - (About) 1200 metres. Horses rated 20 to 45 (10 Runners).

Jockey A.R.Pradeep, the rider of HIGH SPEED DIVE was fined Rs.1,000/- for shifting out and taking out SPRINGSTEEN (L. Alex Rozario), which in turn passed it

onto TIGERKING (S. Hussain) and BENZEMA (Rayan Ahmed R.) soon after the start.

Jockey V.R.Jagadeesh, the rider of THE WELCOME reported that his mount was hanging out after entering the straight. The horse was subjected to veterinary examination. On examination, the Club's Veterinary Officer reported that it was found to have sharp molars. Hence Trainer Mr. Warren Singh was fined Rs.3,000/- for his negligence(1st infringement).

PRINCESS GOLD (Shreyas Singh S) ran detached from the field. The horse was subjected to veterinary examination. On examination, the Club's Veterinary Officer reported that it was found to have sharp molars. Hence Trainer Mr. V. Lokanath was fined Rs.3,000/- for his negligence (1st infringement).

Surprise sample was taken for analysis from b g HIGH SPEED DIVE.

Routine Sample was taken for analysis from the winner b c KNOTTY CHALLENGER.

5th Race: 133. The R. R. Byramji Memorial Million - (About) 1200 metres. Maiden Horses 3 years old only. (13 Runners).

Permission was granted to Trainer Mr. Aravind G. to withdraw JOON on veterinary grounds as it was found to be suffering from colic. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

N R I ACE (Arshad Alam) reared up and fell to its right before loading into the starting gates. On immediate examination by the Club's Veterinary Officer it found to be walking lame on right fore. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr. Md Sajid Qureshi was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Shreyas Singh S, the rider of CARAT LOVE reported that his mount was running green during the race.

Jockey V.R.Jagadeesh, the rider of SIENNA PRINCESS was reprimanded for shifting out and inconveniencing ASHWA VEDHA (Ashok Kumar A) on his outside passing the 250 Metres.

CARAT LOVE (Shreyas Singh S) ran detached from the field. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Prithviraj .B was informed to ensure better performance of his charge in future.

Routine Sample was taken for analysis from the winner b r LOCKHEED.

6th Race: 134. The Roach Lifescapes Bangalore Juvenile Million(Grade III) - (About) 1400 metres. 3 years old only (foaled in 2021). (4 Runners).

PRICELESS PRINCE (Ashok Kumar A) was extremely fractious inside the starting gates and injured its rider. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order.

At the request of Trainer Mr. S.S. Attaollahi, endoscopy was performed on VAFADAR and no abnormality was found.

Compulsory urine and blood samples were taken for analysis from the following I, II & III placed horses viz:

7th Race: 135. The Bellary Plate - (About) 1400 metres. Horses rated 40 to 65, 6 years old and over (10 Runners).

ARMORY (Rajesh Kumar M) reared up and fell down on the way to the starting gates. On immediate examination by the Club's Veterinary Officer and was found to be sustained injury on right hock and cannon. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr. Narayana Gowda V. was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey A.R.Pradeep, the rider of MILLBROOK reported that his mount was hanging out after entering the straight. The horse was subjected to veterinary examination. On examination, it was found to have sharp molars. Hence, Trainer Mr. S. Inayathulla was fined Rs.3,000/- for his negligence (1st offence).

Jockey Vivek.G, the rider of SOUTHERNARISTOCRAT reported that his mount was not galloping fluently in the final 400 Metres. The horse was subjected to veterinary examination but no abnormality was reported.

Jockey Shamaz Shareef, the rider of AUGUSTO reported that he noticed his mount was bleeding during the race as such he eased his mount from the 600 metres for the safety of the horse and rider. On immediate examination by the Club's Veterinary Officer it was reported to have sustained bleeding cut injury on right upper eye lid. Trainer Mr. Neil B Devaney was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b g AHERNE.

Permission was granted to trainer Mr. S. Narredu to deputize on behalf of trainer Mr. Rajesh Narredu was unable to attend the races.
