**RACING INCIDENTS**  
**(114 - 120)**

**GOING : Good**

**PENETROMETER READING: 3.4 Cms.**

**RAILING POSITION: Railing fixed at average width of 2.25 Meters from 1600 Meters to winning post from its original position.**

**1<sup>st</sup> Race: 114. The Vani Vilasa Sagara Plate - (About) 1400 metres. Horses rated 00 to 25 (12 Runners).**

Jockey Angad, the rider of BURNING ARROW was reprimanded for travelling wide rounding the final bend for no apparent reason.

Jockey Shreyas Singh S, the rider of INFINITE SPIRIT reported that his mount was hanging out after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. V. Lokanath was informed to take appropriate corrective measures before accepting with it again.

Jockey Afsar Khan, the rider of ECO FRIENDLY was fined Rs.1,000/- for coming 'in' and causing interference to INFINITE SPIRIT (Shreyas Singh S) in the final 100 Metres.

Jockey C.Umesh, the rider of MARCO POLO was fined Rs.1,000/- for shifting out and causing interference to DOUBLE VISION (IndraJeet Singh) in the final 100 Metres.

Jockey Chethan Kalay S., the rider of MY VISIONARY was fined Rs.3,000/- for not making sufficient effort on his mount during the race.

Jockey Arshad Alam, the rider of STAR CITIZEN was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

It was reported after the race that MAYBACH (Inayat) pulled up lame on right fore. Trainer Mr.S. Dominic was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Surprise sample was taken for analysis from b g ECO FRIENDLY.

Routine Sample was taken for analysis from the winner dk b f GREELEY.

**2<sup>nd</sup> Race: 115. The Kadambi Falls Plate - Div. II - (About) 1400 metres. Horses rated 20 to 45, 5 years old and over (8 Runners).**

MEGA SUCCESS (V.R.Jagadeesh) was fractious inside the starting gates and the bit had snapped. Under the circumstances, it was permitted to be withdrawn before coming under Starter's order.

SINGHSAAB (C.Umesh) reared up as the gates opened.

Jockey A.R.Pradeep, the rider of RING MASTER reported that his mount was not grabbing its bit till about 300 Metres despite his best efforts. The horse was subjected to veterinary examination. On examination, it was found to be lame on left fore. Trainer Mr. Warren Singh was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey A.Ramu, the rider of WAY OF LIFE was fined Rs.5,000/- for shifting out and causing interference to SOLID POWER (S. Saqlain) on his outside approaching 300 Metres.

It was reported after the race that SOLID POWER (S. Saqlain) pulled up lame on left fore. Trainer Mr. M. Rajendra Singh was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b g RAFFLES.

**3<sup>rd</sup> Race: 116. The February Stakes - (About) 1100 metres. Horses rated 20 to 45 (12 Runners).**

SUN FLARE (Imran Chisty) took a fly jump.

Jockey Koshi Kumar, the rider of FAST RESPONSE was fined Rs.10,000/- for coming 'in' and causing interference to HONEY CAKE (V.R.Jagadeesh), which in turn passed it onto IMMORTAL BEAUTY (Siddaraju.P) before passing the red marker post and for again shifting 'in' and causing interference to the horses on his inside viz; VAYU (Vivek.G), PHOENIX SURPRISE (Inayat) and IMMORTAL BEAUTY (Siddaraju.P) approaching 900 Metres.

Jockey A.Ramu, the rider of CONTRACTOR was fined Rs.10,000/- for shifting 'in' and causing interference to VAYU (Vivek.G), which in turn passed it onto TROPICAL MIST (Rayan Ahmed R.) along the rails, whereby Jockey Rayan Ahmed R., the rider of TROPICAL MIST was totally unbalanced and was dislodged from his mount passing the 800 Metres, thereafter TROPICAL MIST ran rider less.

It was reported after the race that FAST RESPONSE (Koshi Kumar) pulled up lame on left fore. Trainer Mr. S. Dominic was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

IMMORTAL BEAUTY (Siddaraju.P) was impounded for veterinary examination. On examination, it was found to be lame on left hind. Trainer Mr. S. Narredu was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Surprise sample was taken for analysis from b f IMMORTAL BEAUTY.

Routine Sample was taken for analysis from the winner b h ADJUSTMENT.

**4<sup>th</sup> Race: 117. The Dr. T. Thimmaiah Memorial Cup - (About) 2000 metres. Horses rated 40 to 65, 5 years old and over (4 Runners).**

ARMORY (Angad) reared up as the gates opened and lost few lengths at the start. In view of its behaviour, Trainer Mr. Narayana Gowda V. was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Darshan R.N, the rider of STELLAR GOLD was fined Rs.5,000/- for the excessive use of the whip on his mount during the race (2nd infringement).

Jockey Imran Chisty, the rider of BRUCE ALMIGHTY reported that his instructions were to ride from 1<sup>st</sup> /2<sup>nd</sup> position but even after urging his mount could not take a forward position and he added that his mount lugging out in the final 150 Metres. The horse was subjected to veterinary examination. On examination the Club's Veterinary Officer reported that it was found to have sharp molars. Hence Trainer Mr. Faraz Arshad was fined Rs.3,000/- for his negligence(1st infringement).

Routine Sample was taken for analysis from the winner b m STELLAR GOLD.

**5<sup>th</sup> Race: 118. The Stayers' Trial Stakes - (About) 2400 metres. 4 years old and over at the time of starting. (4 Runners).6<sup>th</sup> Race: 119. The C. V. Prasad Rao Million - (About) 1200 metres. Horses 3 years old only (12 Runners).**

Routine Sample was taken for analysis from the winner ch m LA REINA.

**6<sup>th</sup> Race: 119. The C. V. Prasad Rao Million - (About) 1200 metres. Horses 3 years old only (10 Runners).**

Permission was granted to Trainer Mr. Prithviraj.B to withdraw WINDCLEAVER (C.Umesh) on veterinary grounds as it was found to be trotting lame on right hind. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

REDEFINED (Vivek.G) bolted on the way to the starting gates, covered almost 3600 Metres of track and was exhausted. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr. Prasanna Kumar was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Arshad Alam, the rider of BOWEN was fined Rs.1,000/- for shifting 'in' and causing interference to SILICON STAR (A.Ramu), which in turn passed it onto GOLDEN STRIDE (Surya P.) at the start.

Jockey Shreyas Singh S, the rider of AMAZING RULER was fined Rs.3,000/- for not making sufficient effort to improve his position on his mount till about 400 Metres.

Routine Sample was taken for analysis from the winner dk b f EXCELLENT LASS.

**7<sup>th</sup> Race: 120. The Kadambi Falls Plate - Div. I - (About) 1400 metres. Horses rated 20 to 45, 5 years old and over (9 Runners).**

CASH OUT (Surya. P) sustained superficial injury on right hind inner bulb.

Surprise sample was taken for analysis from b g OSIRIS.

Routine Sample was taken for analysis from the winner dk b m KLIMT.

**SIXTH DAY, FRIDAY, 1<sup>ST</sup> DECEMBER, 2023**

**Race: 32. The Muthyalamaduvu Plate - Div. II - (About) 1200 metres. Horses rated 20 to 45.**

The Stipendiary Stewards reported Jockey Arshad Alam to the Stewards for Contravention of Rule No. 161 (i) of the B.T.C Rules of Racing on his mount BLEUE DALI in the above race.

The Stewards held an enquiry on 29/1/2024 and examined Trainer Mr. Azhar Ali and Jockey Arshad Alam.

**The Stewards considered the following:**

- (a) The Minutes of the preliminary enquiry conducted by the enquiry officers;
- (b) Charge sheet issued to Jockey Arshad Alam by the Stipendiary Steward;
- (c) The Submissions made by Trainer Mr. Azhar Ali and Jockey Arshad Alam during the enquiry;
- (d) Stewards viewed various angles of the race with specific reference to the loss of whip by Jockey Arshad Alam;

The Stewards after considering all of the above decided to give a grave benefit of doubt to Jockey Arshad Alam on his mount BLEUE DALI at this instance, wherein he lost his whip approaching 400 Metres in the above race.

**ELEVENTH DAY, SATURDAY, 30<sup>th</sup> DECEMBER, 2023**

**Race: 71. The Shanti Falls Plate - Div. II - (About) 1200 metres. Horses rated 20 to 45 (12 Runners).**

The Stipendiary Stewards reported Jockey A.Ramu to the Stewards for Contravention of Rule No.159 (a) & (b) of the B.T.C Rules of Racing on his mount HIGH SPEED DIVE in the above race.

The Stewards held an enquiry on 29/1/2024 and examined Trainer Mr. Sriram Komandur and Jockey A. Ramu.

**The Stewards considered the following:**

- The Minutes of the Preliminary enquiry conducted by the enquiry officers;
- Charge sheet issued to Jockey A. Ramu by the Stipendiary Steward;
- The Submissions made by Trainer Mr. Sriram Komandur and Jockey A. Ramu during the enquiry;
- Stewards viewed various angles of the race with specific reference to riding his riding by Jockey A. Ramu;
- The Stewards noted that Jockey A. Ramu had not pleaded guilty to the alleged breach of Contravening Rule No. 159 (a) & (b) of the BTC Rules of Racing as charged by the Stipendiary Steward.

Thereafter in their collective wisdom, they unanimously decided that Jockey A. Ramu was "**Guilty**" as charged in the matter.

**In light of the above, the Stewards decided as under:**

- (a) To withdraw the Jockey's Licence granted to A. Ramu and treat him as a disqualified person with effect from **10/2/2024 to 9/8/2024 (Both days inclusive)** for Contravening Rule No. 159 (a) & (b) of the BTC Rules

of Racing on his mount HIGH SPEED DIVE (He is not permitted to ride work).

(b) Noted the explanations tendered by Trainer Mr. Sriram Komandur.

(c) He was informed of his right to appeal to the Board of Appeal.

**FOURTEENTH DAY, FRIDAY, 19<sup>TH</sup> JANUARY, 2024**

**(A)**

**Race: 95. The K.N.Chennabasappa Memorial Trophy - (About) 1400 metres. Horses rated 40 to 65.**

The Stipendiary Stewards reported Jockey Antony Raj.S to the Stewards for Foul Riding thereby Contravening Rule No. 161 (i) of the B.T.C Rules of Racing on his mount RICARDO in the above race.

The Stewards held an enquiry on 29/1/2024 and examined Mr. P. Arun Kumar (Spokesperson) and Jockey Antony Raj.S himself.

**The Stewards considered the following:**

- (a) Charge sheet issued to Jockey Antony Raj.S by the Stipendiary Steward;
- (b) The Submissions made by Spokesperson Mr. P. Arun Kumar and Jockey Antony Raj.S himself during the enquiry;
- (c) Stewards viewed various angles of the race with specific reference to the interference caused by Jockey Antony Raj.S;

After deliberations, they decided to change the charges levied against Jockey Antony Raj.S by the Stipendiary Stewards for Foul Riding to Dangerous Riding Contravening Rule No. 161 (i) of the B.T.C. Rules of Racing and thereafter decided as under:-

- To suspend the Jockey's Licence granted to Antony Raj.S w.e.f **10/2/2024 to 24/2/2024** [Both days inclusive] and fine him a sum of **Rs.25,000/-** for Dangerous Riding [Rule No. 161 (i) of the B.T.C Rules of Racing] on his mount RICARDO in the above race (He is permitted to ride work).
- He was informed of his right to appeal.

**(B)**

**Race: 96. The Narasimharaja Trophy - (About) 1600 metres. Horses rated 60 to 85.**

The Stipendiary Stewards reported Jockey S. Saqlain to the Stewards for Foul Riding thereby Contravening Rule No. 161 (i) of the B.T.C Rules of Racing on his mount SHABELLE in the above race.

The Stewards held an enquiry on 29/1/2024 and examined Jockey S. Saqlain.

**The Stewards considered the following:**

- a) Charge sheet issued to Jockey S. Saqlain by the Stipendiary Steward;
- b) The Submissions made by Jockey S. Saqlain during the enquiry;
- c) Stewards viewed various angles of the race with specific reference to the interference caused by Jockey S. Saqlain.

After deliberations, they decided to change the charges levied against Jockey S. Saqlain by the Stipendiary Stewards for Foul Riding to Dangerous Riding Contravening Rule No. 161 (i) of the B.T.C. Rules of Racing and thereafter decided as under:-

- To suspend the Jockey's Licence granted to S.Saqlain w.e.f **10/2/2024 to 24/2/2024** [Both days inclusive] and fine him a sum of **Rs.25,000/-** for Dangerous Riding [Rule No. 161 (i) of the B.T.C Rules of Racing] on his mount SHABELLE in the above race (He is permitted to ride work).
- He was informed of his right to appeal.

**FIFTEENTH DAY, THURSDAY, 25<sup>TH</sup> JANUARY, 2024**

**Race: 99. The Saddle Up Cup - Div. II - (About) 1200 metres. Horses rated 00 to 25 (Whips not allowed).**

The Stipendiary Stewards reported Jockey M. Prabhakaran to the Stewards for Dangerous Riding thereby Contravening Rule No. 161 (i) of the B.T.C Rules of Racing on his mount AIR BLAST in the above race.

The Stewards held an enquiry on 29/1/2024 and examined Jockey M. Prabhakaran.

**The Stewards considered the following:**

- a) Charge sheet issued to Jockey M. Prabhakaran by the Stipendiary Steward;
- b) The Submissions made by Jockey M. Prabhakaran during the enquiry;
- c) Stewards viewed various angles of the race with specific reference to the interference caused by Jockey M. Prabhakaran;

**In light of the above, the Stewards decided as under:**

- To suspend the Jockey's Licence granted to M. Prabhakaran w.e.f **10/2/2024 to 9/3/2024** [Both days inclusive] for Dangerous Riding [Rule No. 161 (i) of the B.T.C Rules of Racing] on his mount AIR BLAST in the above race (He is permitted to ride work).
- He was informed of his right to appeal.
