RACING INCIDENTS

(136 -144)

GOING : Good

PENETROMETER READING: 3.2cms.

RAILING POSITION: Railing fixed at average width of 7.75 Meters from 1600 Meters to winning post from its original position.

1st Race: 136. The Raichur Plate - (About) 1600 metres. Horses rated 00 to 25 (9 Runners).

Jockey Surya P., the rider of ELIZABETH REGINA was fined Rs.1,000/- for shifting out and causing interference to the horses on his outside viz; ECO FRIENDLY (Vivek) and MARCO POLO (Imran Chisty) before passing the red marker post.

Jockey Imran Chisty, the rider of MARCO POLO was fined Rs.1,000/- for shifting 'in' and causing interference to ECO FRIENDLY (Vivek) on his inside passing the 400 Metres.

Jockey Vivek, the rider of ECO FRIENDLY was fined Rs.2,000/- for shifting out and causing interference to the horses on his outside viz; RECREATOR (S. Hussain) and PETTES LOVE (Naveen M.) passing the 300 Metres.

Jockey Surya P., the rider of ELIZABETH REGINA was fined Rs.2,000/- for shifting out and bumped PETTES LOVE (Naveen M.) in the final 100 Metres.

TANKINIKA (Shamaz Shareef) ran detached from the field. The horse was subjected to veterinary examination. On examination it was found to have Sharp molars. Trainer Mr. Irfan Ghatala was fined Rs.3,000/- for his negligence (1st infringement).

Jockey P. Sai Kumar, the rider of SEA DIAMOND was fined Rs.5,000/- for the excessive use of the whip on his mount during the race (2nd infringement).

MY VISIONARY (Arvind Kumar. N) was subjected to veterinary examination but no abnormality was reported.

Trainer Mr. Pradeep Annaiah was questioned regarding the relative performance of his charge SEA DIAMOND (P. Sai Kumar) the winner of the above race as compared to its previous run in Race No. 110. The Saddle Up Cup - Div. I - (About) 1200 metres. Horses rated 00 to 25 (Whips not allowed) run on 26th January, 2024 wherein it ran unplaced. The trainer stated that:

- a) This horse has been failure for him in its career;
- b) He ran over the different distances to observe its potentiality;
- c) Today he ran into over a 1600 Metres as the season was also coming to a conclusion with few days left;
- d) In Race No.110, it ran in no whip race;
- e) Today with the relatively better Jockey with the aid of whip is just about won the race;
- f) Never the less he didn't fancy it much to win the race but he was surprised that his charge won on the race.

His explanations were noted for future reference.

Routine Sample was taken for analysis from the winner b f SEA DIAMOND.

2nd Race: 137. The Maj. C. Newton-Davis Memorial Trophy - Div. II - (About) 1200 metres. Maiden Horses 3 years old only (9 Runners).

DARING FALCON (Surya P.) was slowly away.

JOYFUL SPIRIT (Naveen M.) ran detached from the field. Trainer Mr. M. Rajendra Singh was informed to ensure better performance of his charge in future.

DARING FALCON (Surya P.) ran detached from the field. Trainer Mr. Warren Singh was informed to ensure better performance of his charge in future.

It was reported after the race that RISE AND REIGN (Siddaraju.P) pulled up lame on left fore. Trainer Mr. S. Narredu (deputizing for Trainer Mr. Rajesh Narredu) was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b f INSPIRE.

3rd Race: 138. The Mussoorie Stakes - (About) 1200 metres. Horses rated 40 to 65, 5 years old and over (11 Runners).

CLASSIC CHARM (Darshan R.N) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.S. Ganapathy was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Arvind Kumar. N, the rider of MACRON was fined Rs.1,000/- for shifting 'in' and causing interference to LAUTERBRUNNEN (Rajesh Kumar M) on his inside passing the 400 Metres.

Jockey A.R.Pradeep, the rider of KALLU SAKKARE placed 2nd by the judge objected against Jockey Arvind Kumar. N, the rider of MACRON placed 1st for "In the last 100 Metres my horse was travelling well whereby the winner shifted out as such I stopped riding which cost me a certain race". The Stewards held an enquiry immediately after the race and interviewed the Jockeys concerned. After deliberations, they decided to overrule the objection.

An enquiry is being held into the running and riding of KALLU SAKKARE, trained by Mr. Warren Singh and ridden by Jockey A.R. Pradeep in the above race.

An enquiry is being held into the manner of riding of Jockey Arvind Kumar. N, the rider of MACRON especially in the final 100 Metres of the race.

Routine Sample was taken for analysis from the winner b g MACRON.

4th Race: 139. The Red Fort Plate - Div. II - (About) 1400 metres. Horses rated 20 to 45 (9 Runners).

Jockey V.R.Jagadeesh replaced the indisposed Jockey Vivek on SAMACHAR.

Jockey Surya P., the rider of CONTRACTOR was fined Rs.2,000/- for shifting 'in' and causing interference to SAMACHAR (V.R.Jagadeesh), whereby it stumbled passing the 1200 Metres.

SEVENTH SAMURAI (S. John) sustained superficial clip injury on left hind fetlock.

SUNLIT PATH (Shamaz Shareef) was subjected to veterinary examination but no abnormality was reported.

An enquiry is being held into the running and riding of SUNLIT PATH, trained by Mr. Irfan Ghatala and ridden by Jockey Shamaz Shareef in the above race.

Routine Sample was taken for analysis from the winner dk b/br g TREASURE CHEST.

5th Race: 140. The Mahadayi Plate - Div. II - (About) 1200 metres. Horses rated 20 to 45, 5 years old and over (10 Runners).

Jockey Shamaz Shareef replaced the indisposed Jockey Vivek on DOMINA.

Jockey Shamaz Shareef, the rider of DOMINA reported that his mount was hanging out in the final 250 Metres. The horse was subjected to veterinary examination but no abnormality was reported.

Jockey Siddaraju.P, the rider of TWINKLE FEET was reprimanded for allowing his mount to drift out under the use of whip in the final 100 Metres.

OOH LA LA (Rayan Ahmed R.) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b r BREEZE BLUSTER.

6th Race: 141. The Maj. C. Newton-Davis Memorial Trophy - Div. I - (About) 1200 metres. Maiden Horses 3 years old only (6 Runners).

JORDANO (L. Alex Rozario) bolted before arrival to the paddock, ran helter skelter crashed against the inner sand track railing and fell. On immediate examination by the Club's Veterinary Officer it was found to have sustained multiple injuries on head, left shoulder, fore arm and died due to shock.

STAR HONOUR (Darshan R.N) was examined at the starting gate by the Club's Veterinary Officer and was found to be trotting lame on left hind. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr. S. Narredu was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was observed that Jockey Imran Chisty, the rider of MAGNETIC momentarily got unbalanced while jumping out of the starting gates.

PURANJAYA (V.R.Jagadeesh) sustained superficial injury on right hind cannon.

MAGNETIC (Imran Chisty) was impounded for veterinary examination but no abnormality was reported.

Surprise sample was taken for analysis from b f MAGNETIC.

Routine Sample was taken for analysis from the winner ch f DEL AVIZ.

7th Race: 142. The P.V.Shetty Memorial Cup - (About) 1200 metres. Horses rated 60 to 85 (7 Runners).

ALDGATE (S. John) was slight slowly away at the start.

It was observed that MAPLE LEAF (Siddaraju.P) jumped awkwardly, whereby the rider lost the left stirrup and lost control over his mount and he shifted out and caused interference to ALDGATE (S. John) on his outside approaching 1100 Metres. Again he shifted out and caused interference to the horses viz; ENGLISH BAY (Surya P.) and ALDGATE (S. John) on his outside passing the 1000 Metres. As a result of which Jockey Siddaraju.P got unbalanced on his saddle and he regained the left stirrup rounding the final bend.

ENGLISH BAY (Surya P.) sustained superficial injury on right hind fetlock and pastern.

Routine Sample was taken for analysis from the winner b m SOFIYA.

8th Race: 143. The Red Fort Plate - Div. I - (About) 1400 metres. Horses rated 20 to 45 (9 Runners).

Jockey V.R.Jagadeesh, the rider of NEVADA GOLD was fined Rs.5,000/- for the excessive use of the whip on his mount during the race (2nd infringement).

Jockey L. Alex Rozario, the rider of GREELEY was reprimanded for travelling wide rounding the final bend for no apparent reason.

Routine Sample was taken for analysis from the winner b f IRISH ROCKSTAR.

9th Race: 144. The Mahadayi Plate - Div. I - (About) 1200 metres. Horses rated 20 to 45, 5 years old and over (10 Runners).

Jockey Shreyas Singh S replaced the indisposed Jockey Vivek on STEP TO DESTINY.

STEP TO DESTINY (Shreyas Singh S) was slowly away and lost considerable ground at the start. In view of its repeated behaviour, Trainer Mr. V. Lokanath was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

PERIDOT (L. Alex Rozario) planted, lost many lengths, did not raise a fluent gallop for the first 100 Metres and ran detached thereafter. In view of its behaviour, Trainer Mr. Irfan Ghatala was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Shreyas Singh S, the rider of STEP TO DESTINY was reprimanded for shifting 'in' and inconveniencing MEASURE OF TIME (Salman Khan) on his inside approaching 900 Metres.

SHEER BLISS (Chandrashekar M) gradually dropped back and ran detached from the field in the final 300 Metres. Trainer Mr. S. Narredu was informed to ensure better performance of his charge in future.

Routine Sample was taken for analysis from the winner b m BORN DANCER.

Permission was granted to trainers M/s. Pradeep Annaiah, Kishan Thomas, Parvati Byramji and S. Narredu to deputize on behalf of trainers M/s. Faraz Arshad, Prasanna Kumar, Darius R. Byramji and Rajesh Narredu who were unable to attend the races.
