RACING INCIDENTS
(160 - 167)

GOING : Good.

PENETROMETER READING: 2.9 Cms.

RAILING POSITION: Railing fixed at its original position.

1st Race: 160. The Trombay Stakes - Div. II - (About) 1400 metres. Maiden Horses 3 years old only. (9 Runners).

It was observed that FORCE OF NATURE (Darshan R.N) was inclined to run out between the 800 Metres and 700 Metres.

HYDER (V.R.Jagadeesh) ran detached from the field. Trainer Mr. Prithviraj B. was informed to ensure better performance of his charge in future.

It was reported after the race that ROYAL WHISPER (Shreyas Singh S) was found to have serous discharge from left nostril. However, endoscopy was performed and no abnormality was found.

Routine Sample was taken for analysis from the winner ch c PROMISEOFTHEFUTURE.

2nd Race: 161. The Champion Jockey Trophy - Div. II - (About) 1400 metres. Horses rated 20 to 45, 5 years old and over (9 Runners).

INDIAN BLUES (Vivek.G) jumped awkwardly inwards onto OMBUDSMAN (Darshan R.N) on its inside soon after the start.

Jockey Arvind Kumar. N, the rider of LADY GODIVA was fined Rs.2,000/- for coming 'in' and causing interference to SAND CASTLES (P. Sai Kumar), which in turn passed in onto OMBUDSMAN (Darshan R.N) on his inside passing the 1300 Metres.

Jockey Rayan Ahmed R., the rider of EL ALAMEIN was fined Rs.2,000/- for coming 'in' and causing interference to LADY GODIVA (Arvind Kumar. N) on his inside approaching 1100 Metres.

INDIAN BLUES (Vivek.G) ran detached from the field. Trainer Mr. Narayana Gowda V. was informed to ensure better performance of his charge in future.

PERIDOT (L. Alex Rozario) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g ECO FRIENDLY.

3rd Race: 162. The Trombay Stakes - Div. I - (About) 1400 metres. Maiden Horses 3 years old only. (8 Runners).

Jockey Antony Raj S., the rider of FELISA was fined Rs.2,000/- for suddenly changing course and causing interference to the horses on his outside viz; BOWEN (Salman Khan) and GALLON OF MY LOVE (Naveen M.) passing the 1200 Metres.

It was observed that BOWEN (Salman Khan) accidentally stumbled passing the 1300 Metres.

Jockey Antony Raj S., the rider of FELISA reported that his mount was running green throughout the race.

ALPHA LEGEND (A.R.Pradeep) sustained clip injury on right hock and right hind tendon.

Routine Sample was taken for analysis from the winner b c AMAZING RULER.

4th Race: 163. The Leading Stud Cup - (About) 1600 metres. Horses rated 20 to 45, 5 years old and over (8 Runners).

RING MASTER (L. Alex Rozario) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Warren Singh was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

It was reported after the race that WAR TRAIL (Vinod Shinde) pulled up lame on left fore. Trainer Mr. M. Rajendra Singh was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b g THEWHISPERQUIETLY.

5th Race: 164. The Champion Trainer Trophy - (About) 1400 metres. Horses rated 40 to 65, 5 years old and over (10 Runners).

Trainer Mr.Prithviraj B. was fined Rs.10,000/- for having accepted his charge ALL ATTRACTION (Dharshan Antony.B) to run in the above race when the owner was under [B.T.F. BAN]. Subsequently, permission was granted to him to withdraw the horse from the above race.

Trainer Mr.Warren Singh was fined Rs.25,000/- for his negligence in discharge of his duties pertaining to his charge THE PERFECT CHOICE (A.R.Pradeep) after having declared it to start. Subsequently, it was permitted to be withdrawn from the above race.

ARMORY (Angad) jumped out awkwardly and did not raise a fluent gallop for the first 100 Metres. In view of its behaviour, Trainer Mr.Narayana Gowda V. was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

It was reported after the race that MEMORABLE TIME (Shreyas Singh S) was found to have serous discharge from left nostril. However, endoscopy was performed and no abnormality was found.

Jockey P. Sai Kumar, the rider of SEKHMET reported that his mount was not galloping fluently during the race. The horse was subjected to veterinary examination but no abnormality was reported.

Jockey Imran Chisty, the rider of ARMSTRONG was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

Routine Sample was taken for analysis from the winner b g ARMSTRONG.

6th Race: 165. The Governor's Trophy - (About) 1600 metres. 3-year-old horses(foaled in 2021). (4 Runners).

MESCALITO (Darshan R.N) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Azhar Ali (deputizing for Trainer Mr. S.S.

Attaollahi) was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Routine Sample was taken for analysis from the winner b c PERICLES.

7th Race: 166. The Leading Owner Cup - (About) 1400 metres. Horses rated 00 to 25 (Whips not allowed) (12 Runners).

Jockey Imran Chisty, the rider of DAWN RISING reported that his mount was hanging out from 800 Metres. The horse was subjected to veterinary examination. Trainer Mr.Faraz Arshad was informed to take appropriate corrective measures before accepting with it again.

SUNLIT PATH (L. Alex Rozario) ran detached from the field. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Irfan Ghatala was informed to ensure better performance of his charge in future.

It was reported after the race that ICE STORM (Rajesh Kumar M) burst its blood vessels. Trainer Mr.Narayana Gowda V. was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

It was reported after the race that CHANDRA KANTA (B. Nayak) was found to have serous discharge from left nostril. However, endoscopy was performed and no abnormality was found.

Routine Sample was taken for analysis from the winner b m DAWN RISING.

8th Race: 167. The Champion Jockey Trophy - Div. I - (About) 1400 metres. Horses rated 20 to 45, 5 years old and over (9 Runners).

Jockey P. Trevor replaced the indisposed Jockey Y.S. Srinath on RAFFLES.

Jockey Antony Raj S., the rider of LEX LUTHOR was fined Rs.5,000/- for the excessive use of the whip on his mount during the race (2nd infringement).

ABLE ONE (P. S. Chouhan) was impounded for veterinary examination. On examination, it was found to be lame on left fore. Trainer Mr. Azhar Ali was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

THE GREY GERANIUM (Darshan R.N) was subjected to veterinary examination but no abnormality was reported.

Surprise sample was taken for analysis from b g ABLE ONE.

Routine Sample was taken for analysis from the winner ch g LEX LUTHOR.

Permission was granted to trainers M/s. Azhar Ali and Kishan Thomas to deputize on behalf of trainers M/s. S.S. Attaollahi and Prasanna Kumar who were unable to attend the races.
