**THIRTEENTH DAY , FRIDAY , 10<sup>TH</sup> JANUARY 2025**

**RACING INCIDENTS**

**(91-97)**

**Going: Good**

**PENETROMETER READING: 3.2 Cms.**

**RAILING POSITION: Railing fixed at an average width of 4.5 meters from 1600 meters to the winning post from its original position.**

**1<sup>st</sup> Race: 91. The Gokak Falls Plate - (About) 2000 metres. Horses rated 20 to 45 (4 Runners).**

MYSTICAL AIR (Akshay Kumar) took a fly jump.

Routine Sample was taken for analysis from the winner ch g VYASA.

**2<sup>nd</sup> Race: 92. The Planetarium Plate - (About) 1600 metres. Horses rated 00 to 25 (8 Runners).**

QUEVEGA (Rajesh Kumar M) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Narayana Gowda V. was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Angad, the rider of BURNING ARROW was fined Rs.2,000/- for shifting out and causing interference to JOYFUL SPIRIT (A.Ramu), which in turn passed it onto DOUBLE SCOTCH (V.R.Jagadeesh) on his outside before passing the red marker post.

Jockey Rayan Ahmed R., the rider of SUPERHERO was fined Rs.1,000/- for shifting 'in' and causing interference to DOUBLE SCOTCH (V.R.Jagadeesh) on his inside approaching 1400 Metres.

Jockey A.Ramu, the rider of JOYFUL SPIRIT was reprimanded for allowing his mount to drift out under the use of whip in the final 250 Metres.

It was reported after the race that QUEVEGA (Rajesh Kumar M) burst its blood vessels (returned bleeding from both nostrils). Trainer Mr. Narayana Gowda V. was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner ch g BURNING ARROW.

**3<sup>rd</sup> Race: 93. The Sharavati Plate - Div. II - (About) 1200 metres. Horses rated 20 to 45, 5 years old and over (Whips not allowed) (8 Runners).**

TRIPPLE V (Pavan) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. K. Purshotham was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Vivek, the rider of INFINITE SPIRIT was fined Rs 1,000/- for coming "in" and causing interference to DOMINA (V.R.Jagadeesh), whereby DOMINA (V.R.Jagadeesh) stumbled passing the 1000 meters.

An enquiry was held on 11<sup>th</sup> January, 2025 by the Stipendiary Steward into the interference caused by Jockey R. Robert, the rider of RUNNING BOLT in the above race. "In that he did not exercise sufficient control over his mount, he allowed his mount to shift out causing interference to ICE STORM (Rajesh Kumar M), which in turn passed it onto TRIPPLE V (Pavan) passing the 1100 Metres, he further shifted out and repeatedly took out ICE STORM (Rajesh Kumar M) between 1100 meters and 1000 meters, thereafter he again shifted out causing interference to FIREFINCH (A.R. Pradeep) passing the 850 Metres."

Jockey R. Robert was interviewed by the Stipendiary Stewards. The Stipendiary Stewards after considering the submissions made by Jockey R. Robert and after viewing the CCTV decided to charge Jockey R. Robert for Careless Riding.

The Stipendiary Stewards thereafter suspended the Jockey's Licence granted to Jockey R. Robert **for two (2) race days of BWM 2024-25 i.e., 25/01/2025, & 26/01/2025** as he had pleaded guilty of the charge under Rule No. 161 (i) of the BTC Rules of Racing for Careless Riding on his mount RUNNING BOLT (he was permitted to ride work) and was informed of his right to appeal.

Jockey Koshi Kumar, the rider of MULTISIDED was fined Rs. 1000/- for shifting out and taking out DOMINA (V.R.Jagadeesh) on his outside approaching 800 meters.

Routine Sample was taken for analysis from the winner dk b g SPRINGSTEEN.

**4<sup>th</sup> Race: 94. The Frankel Trophy - (About) 1100 metres. Maiden Horses 3 years old only. (9 Runners).**

It was observed that jockey Rajesh Kumar M, the rider of RANSOMWARE was using an unserviceable whip. Subsequently, the same was permitted to be changed at the starting gates.

MAGNETAR (A. Sandesh) was slightly slowly away.

MIRACLE STAR (Mukesh Kumar (Hyd)) was slightly slowly away.

It was observed that HAZEL (Akshay Kumar) was running green after entering the straight.

It was observed that jockey P. Trevor, the rider of KHAZANA had to steady his mount, as his mount shied inwards from EL REY (Vinod Shinde) passing the 250 meters.

Routine Sample was taken for analysis from the winner b g MAGNETAR.

**5<sup>th</sup> Race: 95. The J.B.Mallaradhya Memorial Trophy - (About) 1200 metres. Horses rated 40 to 65 (10 Runners).**

LA MCQUEEN (Aleemuddin) accidentally brushed the running rails passing the 1000 meters.

Jockey Angad, the rider of IL VOLO was reprimanded for travelling wide from 1000 Metres till 600 Metres for no apparent reason.

Jockey Arvind Kumar. N, the rider of POWER OF BEAUTY was fined Rs.2000/- for coming "in" and causing interference to LA MCQUEEN (Aleemuddin) on his inside approaching 700 meters.

Jockey L. Alex Rozario, the rider of ART GALLERY was reprimanded for shifting "in" and inconveniencing HAND OF GOD (Shariq Mohd) on his inside in the final 100 meters.

It was reported after the race that HAND OF GOD (Shariq Mohd) pulled up lame on left fore. Trainer Mr. Joseph B. Awale was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

IL VOLO (Angad) sustained abrasion on right hock.

POWER OF BEAUTY (Arvind Kumar. N) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner ch f DEL AVIZ.

**6<sup>th</sup> Race: 96. The Chitradurga Plate - (About) 1400 metres. Horses rated 40 to 65, 5 years old and over (8 Runners).**

Jockey Hemant Chandragiri, the rider of DYNAMIC FORCE was fined Rs.2000/- for his negligence in weighing "in" 900 gms excess in relation to weighing out.

ARMORY (Rajesh Kumar M) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Narayana Gowda V. was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Mukesh Kumar (Hyd), the rider of SUNDANCE KID reported that his mount was hanging out throughout the race. The horse was subjected to veterinary examination. On examination it was found to have bit sore on both oral commissure. Trainer Mr.K. Purshotham was informed to take remedial measures before accepting with it again.

Routine Sample was taken for analysis from the winner b m AUSPICIOUS QUEEN.

**7<sup>th</sup> Race: 97. The Sharavati Plate - Div. I - (About) 1200 metres. Horses rated 20 to 45, 5 years old and over (Whips not allowed) (8 Runners).**

ISABELLE (Pavan) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Irfan Ghatala was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Vivek, the rider of BAASHHA was fined Rs.10,000/- for riding in an injudicious manner.

Routine Sample was taken for analysis from the winner b m ISABELLE.

**BANGALORE WINTER MEETING 2024-2025**

**SECOND DAY, SATURDAY, 9<sup>TH</sup> NOVEMBER 2024**

**Race: 10. The Mount Joy Plate - (About) 1200 metres. Horses rated 00 to 25 (Whips not allowed).**

An enquiry was held by the Stipendiary Stewards regarding the running and riding of CHIRAAAG, trained by Mr. Faraz Arshad and ridden by Jockey Afsar in the above race. After due enquiry, their explanations were noted for future reference.

**EIGHTH DAY, FRIDAY, 13<sup>RD</sup> DECEMBER 2024**

**Race: 53. The Tungabhadra Plate - (About) 1200 metres. Horses rated 20 to 45, 5 years old and over (Whips not allowed).**

An enquiry was held by the Stipendiary Stewards regarding the running and riding of THE GOLDEN DREAM, trained by Mr. Warren Singh and ridden by Jockey A.R. Pradeep in the above race. After due enquiry, their explanations were noted for future reference.

## **ELEVENTH DAY, SATURDAY, 28<sup>TH</sup> DECEMBER 2024**

### **Race: 78. The D. M. Shivaswamy Memorial Trophy - (About) 1600 metres. Horses rated 40 to 65, 4 years old and over.**

Trainer Mr. Narayana Gowda. V and Jockey Mukesh Kumar were examined by the Stewards on 10/01/2025 with regard to running and riding of AUSPICIOUS QUEEN.

The trainer stated that:

His instruction to Jockey Mukesh Kumar were to take a good jump to ride from 2<sup>nd</sup>/3<sup>rd</sup>/4<sup>th</sup> position don't give too much lead to the front runners, pull out in the straight and do his best.

The Jockey while corroborating with the statements of the trainer stated that he had no room to shift out and make his move on the outside between the 600 Metres to 400 Metres.

However, as he progressed in the race he saw a gap along the rail approaching 300 Metres and made his move but that gap also closed and he had to ride in check for about 75 Metres, thereafter he rode out his mount but could only obtain 4<sup>th</sup> place.

The Stewards after deliberations and while noting their explanations decided to severely caution both the trainer and jockey as to the future running of Trainer Mr. Narayana Gowda. V charges and to give a benefit of doubt to the Jockey at this instance.

## **TWELFTH DAY , SATURDAY , 4<sup>TH</sup> JANUARY 2025**

### **Race: 89. The Sardar Sarovar Plate - Div. II - (About) 1100 metres. Horses rated 20 to 45.**

The Stewards at their meeting held on 10/01/2025 considered the report submitted by the enquiry officers wherein Trainer Mr. Warren Singh was questioned with regard to the improved performance of his charge ADITYA.

In that the trainer stated:

- a) His charge when it ran in previous start in Race No. 57 of the BWM 2024-25, the penetrometer reading was 4.8 cms (soft going) and when it won in the above race the penetrometer reading was at 3.0 cms the going made a lot of difference.
- b) The sire win legend generally does not relish the soft going;
- c) The pattern of running of his charge was consistent & it was always ridden from the forward position;
- d) The horse was running in a very poor company and he had given it sufficient time from its previous start;
- e) He was surprised with the manner of victory of his charge & had only fancied it to place in the above race.

The Stewards while noting his explanations severely cautioned him as to the future running of his charges.

**(A)**

**Race: 90. The Sardar Sarovar Plate - Div. I - (About) 1100 metres.  
Horses rated 20 to 45**

The Stewards at their meeting held on 10/01/2025 considered the report submitted by the enquiry officers pertaining to the running and riding of DIVINE PROTECTOR, trained by Mr. Warren Singh and ridden by Jockey Angad in the above race.

In that the trainer stated:

- a) He had instructed the Jockey to ride from 2<sup>nd</sup>/3<sup>rd</sup>/4<sup>th</sup> position and do his best in the straight;
- b) After jumping out the rider was in a handy 2<sup>nd</sup> position, but his charge grabbed its bit on the left side and veered out violently despite the best efforts of the Jockey to keep it on an even course;
- c) He had fancied this horse to win as it had finished a good 4<sup>th</sup> in its previous start;
- d) He also added that the horse had bleed as per the report of the Club's Veterinary Officer this could be the reason for the poor performance.
- e) The Jockey while corroborating the statements of the trainer added that his mount was changing its legs continuously in the last 350 Metres.

The Stewards, while noting the explanations of the enquiry officers severely cautioned Jockey Angad to exercise sufficient control over his mount while riding in future.

**(B)**

The Stewards at their meeting held on 10/01/2025 considered the report submitted by the enquiry officers wherein Trainer Mr. M. Rajendra Singh was questioned with regard to the improved performance of his charge TRUE PUNCH.

In that the trainer stated:

- a) He had instructed Apprentice Jockey Hemant Chandragiri to go the front and do his best but as the pace was fast, he could not obtain a forward position in its previous start;
- b) When it raced in Race No. 57 the going was soft and penetrometer reading was 4.8 Cms and when it won in the above race the penetrometer reading was at 3.0 Cms;
- c) He ran his charge after considerable gap & had applied for a pair of Blinkers which also helped his charge to perform better.
- d) He had only fancied his charge to place in the above race.

His explanations were noted for future reference.
