

**BANGALORE WINTER MEETING 2024-2025**  
**FOURTEENTH DAY, SATURDAY, 18<sup>TH</sup> JANUARY 2025**

**RACING INCIDENTS**

**(98-106)**

**Going: Good**

**PENETROMETER READING: 3.3 Cms.**

**RAILING POSITION: Railing fixed at an average width of 5.5 meters from 1600 meters to the winning post from its original position.**

**1<sup>st</sup> Race: 98. The Alaknanda Plate - (About) 1400 metres. Horses rated 00 to 25, 6 years old and over (8 Runners).**

Jockey Angad, the rider of SACRED CREATOR was fined Rs. 3,000/- for not improving his position from 1200 meters till about 600 meters for no apparent reason.

It was observed that SAND CASTLES (Darshan R.N) accidentally stumbled passing the 200 meters, thereby the rider was dislodged from his mount, thereafter the horse ran riderless. On immediate examination by the club's veterinary officer, it was found to be lame on right fore. Subsequently, it was euthanized at 8:20 a.m. on 19/01/2025 as the mare was suffering from Right fore lateral sesamoid (basal) comminuted fracture with rupture of suspensory apparatus.

Jockey A.R.Pradeep, the rider of CAPRI GIRL was fined Rs.5,000/- for the excessive use of the whip on his mount during the race (2nd infringement).

Routine Sample was taken for analysis from the winner b m LADY INVICTUS.

**2<sup>nd</sup> Race: 99. The Trombay Plate - (About) 1600 metres. Horses rated 20 to 45 (8 Runners).**

SEA BLUSH (Vivek) planted and lost many lengths at the start. In view of its repeated behaviour, Trainer Mr. Umar Shariff. S was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **at least two Mock Races.**

An enquiry was held by the Stipendiary Steward into the excessive use of whip by Jockey P. Trevor on his mount MICHIKO (3rd infringement) in the above race, thereby Contravening the B.T.C Calendar Notification under the heading "USE OF WHIP".

"In that:(a) He used the whip in excess in the above race i.e., Race No. 99 of Bangalore Winter Meeting 2024-25, on his mount MICHIKO, this being the (3<sup>rd</sup> offence) during the season; (b) He used the whip in excess in Race No.11 of Bangalore Winter Meeting 2024-25, on his mount IRON KING (1<sup>st</sup> offence); (c) He used the whip in excess in Race No.81 of Bangalore Winter Meeting 2024-25, on his mount TREASURE CHEST (2<sup>nd</sup> offence).

The Stipendiary Steward after considering the submissions made by Jockey P. Trevor and after viewing the CCTV replay of the races decided as follows:

- (a) To suspend the Jockey's licence granted to Jockey P. Trevor **for two (2) race days of BWM 2024-25 i.e.,31/01/2025 and 07/02/2025** for Contravention of B.T.C Calendar Notification under the heading "USE OF WHIP" (He is permitted to ride work).

(b) He was informed of his right to appeal.

Routine Sample was taken for analysis from the winner b c DESERT KINGDOM.

**3<sup>rd</sup> Race: 100. The Indravati Stakes - Div. II - (About) 1400 metres. Horses rated 20 to 45 (9 Runners).**

EQUALIZER (Tauseef Ahmed) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. G. Y. Rajesh Babu was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey A. Prakash, the rider of SOUTHERNARISTOCRAT reported that there was kick back of the earth between 1200 meters till about 900 meters.

Jockey A. Prakash, the rider of SOUTHERNARISTOCRAT was reprimanded for shifting "in" and inconveniencing EQUALIZER (Tauseef Ahmed) on his inside passing the 1200 meters.

Jockey P. Trevor, the rider of KNOTTY SCOTTY reported that his mount was grabbing its bit throughout the race. The horse was subjected to veterinary examination. On examination by the club's veterinary officer, it was found to have bit injury on left oral commissure and sustained abrasions on right hind. Trainer Mr. Prasanna Kumar was informed to take remedial measures before accepting with it again.

Jockey A. AshhadAsbar, the rider of SUPERCHARGE reported that his mount was hanging "in" after entering the straight. Trainer Mr. Joseph B Awale (deputizing for Trainer Mr. Warren Singh) was informed to take appropriate corrective measures before accepting with it again.

Jockey Suhas. K, the rider of FEELING GOOD was reprimanded for travelling wide rounding the final bend for no apparent reason.

Jockey Rajesh Kumar M, the rider of DAIKI was reprimanded for riding an indifferent race.

Jockey A. AshhadAsbar, the rider of SUPERCHARGE reported that he momentarily lost his right rein passing the 200 meters, which he regained within a few strides.

Routine Sample was taken for analysis from the winner b f HABIBTI.

**4<sup>th</sup> Race: 101. The Abbey Falls Plate - Div. II - (About) 1200 metres. Horses rated 20 to 45, 6 years old and over (10 Runners).**

Permission was granted to Trainer Mr. Joseph B. Awale to withdraw THE STRIKINGLY (Y. S. Srinath) on veterinary grounds as it was found to have sustained injury on right fore cannon and cellulitis. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

NAIROBI (Faiz) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. M. Eshwer was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

SUPER KIND (A.R.Pradeep) jumped awkwardly outwards onto DUFY (Kiran Rai P) at the start.

Jockey V.R.Jagadeesh, the rider of INFINITE SPIRIT was fined Rs. 5,000/- for shifting out and taking out the horses on his outside viz; DUFY (Kiran Rai P) and NAIROBI (Faiz) between the 350 meters and 250 meters.

SPIRIT DANCER (Rayan Ahmed R.) sustained abrasion on right gaskin.

An enquiry is being held into the running and riding of DUFY, trained by Mr. G. Y. Rajesh Babu and ridden by Jockey Kiran Rai P in the above race.

Surprise sample was taken for analysis from ch g DUFY.

Routine Sample was taken for analysis from the winner b m ALTAMONTE.

**5<sup>th</sup> Race: 102. The Indravati Stakes - Div. I - (About) 1400 metres. Horses rated 20 to 45 (8 Runners).**

Jockey G. Praveen, the rider of ABLE ONE was fined Rs. 3,000/- for not improving his position from 1200 meters till about 600 meters for no apparent reason.

Jockey Akshay Kumar, the rider of LIVE THE DREAM reported that his mount was hanging "in" after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Prasanna Kumar was informed to take appropriate corrective measures before accepting with it again.

Routine Sample was taken for analysis from the winner b f LIVE THE DREAM.

**6<sup>th</sup> Race: 103. The S. M. Ramakrishna Rao Memorial Cup - (About) 1200 metres. Maiden Horses 3 years old only. (8 Runners).**

Jockey A.Ramu replaced the indisposed Jockey Darshan R N on VIBRANT QUEEN.

Jockey A.Ramu the rider of VIBRANT QUEEN reported that his mount was hanging 'in' after entering the straight. The horse was subjected to veterinary examination. On examination, it was found to have bit injury on both oral commissure. Trainer Mr. Pradeep Annaiah was informed to take remedial measures.

It was observed that ZIVA (L. Alex Rozario) could not get a clear run between 300 meters and 250 meters.

Routine Sample was taken for analysis from the winner b c CIRCLE OF DREAMS.

**7<sup>th</sup> Race: 104. The R.W.I.T.C. Trophy - (About) 1400 metres. Horses rated 80 and above (6 Runners).**

Jockey A. Sandesh, the rider of ARALINA reported that the breast plate had snapped soon after the start. As the incident was accidental no action was taken beyond noting the incident.

ALDGATE (Aleemuddin) was squeezed between FORSETI (Shreyas Singh S) and THE PROTECTOR (Y. S. Srinath) passing the 1300 Metres.

Routine Sample was taken for analysis from the winner b g KALAMITSI.

**8<sup>th</sup> Race: 105. The Vijayanagar Plate - (About) 1200 metres. Horses rated 40 to 65, 6 years old and over (8 Runners).**

Jockey L. Alex Rozario, the rider of SOLO PRINCE was fined Rs.1,000/- for shifting "in" and causing interference to OWN LEGACY (Shreyas Singh S) on his inside passing the 1100 meters.

Jockey L. Alex Rozario, the rider of SOLO PRINCE was fined Rs.2,000/- for coming "in" and causing interference to SOUTHERN FORCE (Y. S. Srinath) on his inside passing the 1000 meters.

Jockey Koshi Kumar, the rider of MAPLE LEAF was fined Rs.2,000/- for shifting out and causing interference to OWN LEGACY (Shreyas Singh S), whereby OWN LEGACY (Shreyas Singh S) stumbled passing the 200 meters.

Routine Sample was taken for analysis from the winner b g METZINGER.

**9<sup>th</sup> Race: 106. The Abbey Falls Plate - Div. I - (About) 1200 metres. Horses rated 20 to 45, 6 years old and over (11 Runners).**

Jockey A.Ramu replaced the indisposed jockey Darshan R N on AGERA.

PERIDOT (Pavan) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Irfan Ghatala was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

It was observed that SCHAFENBERG (P. Mani) accidentally stumbled soon after the start.

Jockey A. Prakash, the rider of SILVER SWIFT reported that he accidentally lost his right rein in the final 100 Metres, which he regained within a few strides.

Routine Sample was taken for analysis from the winner dk b g AUGUSTO.
