RACING INCIDENTS
(123 - 129)

Going: Good

PENETROMETER READING: 3.3 Cms.

RAILING POSITION: Railing fixed at an average width of 7.5 meters from 1600 meters to the winning post from its original position.

1st Race: 123. The Sriharikota Plate - (About) 1600 metres. Horses rated 00 to 25 (8 Runners).

Jockey A.Ashhad Asbar, the rider of JOYFUL SPIRIT reported that his mount was hanging 'out' from 1000 meters. Trainer Mr. M. Rajendra Singh was informed to take appropriate corrective measures before accepting with it again.

Jockey Imran Chisty, the rider of DOUBLE SCOTCH reported that he lost his whip as Jockey Kiran Rai.P the rider of BURNING ARROW accidentally struck his whip approaching 300 meters. As the incident was accidental no action was taken beyond noting the incident.

Jockey A.Ashhad Asbar, the rider of JOYFUL SPIRIT was reprimanded for shifting out and inconveniencing SUPERHERO (Y. S. Srinath) on his outside approaching 250 Metres.

Jockey Y. S. Srinath, the rider of SUPERHERO was reprimanded for shifting 'in' and inconveniencing JOYFUL SPIRIT (A.Ashhad Asbar) on his inside approaching 150 Metres.

Jockey Kiran Rai P, the rider of BURNING ARROW was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

An enquiry is being held into the running and riding of SEA DIAMOND, trained by Mr. Umar Shariff.S and ridden by Jockey Vivek in the above race.

It was observed that Jockey Suhas. K, the rider of GOLDEN GALLERY lost his left rein momentarily, which he regained within a few strides passing the 300 Metres.

It was reported after the race that GOLDEN GALLERY (Suhas. K) returned bleeding from both nostrils. Trainer Mr. V. Lokanath was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner dk b g SUPERHERO.

2nd Race: 124. The Chunchanakatte Falls Plate - Div. II - (About) 1200 metres. Horses rated 20 to 45, 4 years old only (9 Runners).

WAKIZASHI (G. Praveen) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Vishesh M.P. was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

YANNICK (Aleemuddin) took a fly jump.

VALENCIA (A.Ashhad Asbar) jumped awkwardly inwards onto WAKIZASHI (G. Praveen) at the start.

Jockey G. Praveen, the rider of WAKIZASHI was fined Rs.5,000/- for not improving his position from 1100 Metres till about 500 Metres for no apparent reason.

Jockey Salman Khan, the rider of CARTER was fined Rs.1,000/- for shifting "in" and causing interference to LORVEN LUV (Anish Anamo Hangal) on his inside passing 1000 meters.

It was observed that LORVEN LUV (Anish Anamo Hangal) was squeezed between THUTMOSE (M. Mark) and GOLDEN GLORY (Tousif Khan) soon after the start, whereby jockey Anish Anamo Hangal, the rider of LORVEN LUV lost his right stirrup which he regained at about 700 meters.

At the request of Trainer Mr. S.Shoban Babu, Endoscopy was performed on THUTMOSE (M. Mark) and it was found to have burst its blood vessels (Grade - III). Trainer Mr. S. Shoban Babu was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

LORVEN LUV (Anish Anamo Hangal) was subjected to veterinary examination but no abnormality was reported.

Surprise sample was taken for analysis from b g THUTMOSE.

Routine Sample was taken for analysis from the winner b g YANNICK.

3rd Race: 125. The Arkavati Plate - (About) 1600 metres. Horses rated 20 to 45, 5 years old and over (11 Runners).

Permission was granted to Trainer Mr. Faraz Arshad to withdraw BRUCE ALMIGHTY (M. Mark) on veterinary grounds as it was found to have right capped elbow. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

PETTES LOVE (Vinod Shinde) reared up as the gates opened, lost many lengths at the start and ran detached thereafter. In view of its behaviour, Trainer Mr. Joseph B. Awale was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Akshay Kumar, the rider of MYSTICAL AIR was severely reprimanded for taking an unduly long lead during the above race.

MY VISION (Antony Raj S.) was subjected to veterinary examination but no abnormality was reported.

SACRED CREATOR (Rajesh Kumar M) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner ch m MYSTICAL AIR.

4th Race: 126. The K.N.Chennabasappa Memorial Trophy - (About) 1200 metres. Horses rated 40 to 65 (10 Runners).

DR ASH (Rajesh Kumar M) was slowly away, lost few lengths and did not raise a fluent gallop after the first 200 Metres of the start. In view of its behaviour, Trainer Mr. G. Y. Rajesh Babu was informed not to accept with it

again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Laxman Singh, the rider of HIGH SPEED DIVE reported that his mount was hanging out from 900 meters. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Sriram Komandur was informed to take appropriate corrective measures before accepting with it again.

Jockey Adarsh G., the rider of IL VOLO was reprimanded for riding an indifferent race.

Jockey Gaurav Singh, the rider of TRUE PUNCH was fined Rs.1,000/- for shifting out and inconveniencing DR ASH (Rajesh Kumar M) on his outside passing the 200 Metres.

An enquiry is being held into the running and riding of DEL AVIZ, trained by Mr. S.S. Attaollahi and ridden by Jockey Akshay Kumar in the above race.

It was reported after the race that TRUE PUNCH (Gaurav Singh) returned bleeding from both nostrils. Trainer Mr. M. Rajendra Singh was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

KNOTTY BLUSH (Y. S. Srinath) Sustained punctured wound on right fore fetlock.

Jockey A. Ramu, the rider of OXYTOCIN was questioned regarding his riding in presence of Trainer Mr. Warren Singh as to the reason why Jockey A. Ramu was riding in check for the first 300 Metres and thereafter he started riding his mount.

The Trainer stated that this was the way his charge had to be ridden but it used to grab the bit and was inclined to run out and therefore he would always in future also instruct the rider to ride this horse in a similar manner.

The Jockey stated that:-

- a) His mount was too keen and there were horses in front whereby he had to ride in check as instructed by the trainer;
- b) He gradually improved his position thereafter and in the straight he rode out but could only finish 3rd.

Their explanations were noted for future reference.

Blood sample was taken for analysis from the winner b c KNOTTY BLUSH.

5th Race: 127. The Narasimharaja Cup - (About) 1100 metres. Maiden Horses 3 years old only. (10 Runners).

As Jockey M. Prabhakaran was medically unfit to ride. Permission was granted to trainer Mr.S. Narredu to declare Jockey A.Ramu to ride ASHWA JIMBABE in place of the declared rider.

Jockey Akshay Kumar, the rider of FLAMING SWORD reported that the saddle shifted back passing the 900 Metres as such he could not offer much assistance thereafter. After due examination of the equipment, Trainer Mr.S.Dominic was fined Rs.3,000/- for faulty saddling of his charge.

Jockey Antony Raj S., the rider of KHAZANA was fined Rs.2,000/- for coming 'in' and causing interference to EL REY (David Allan) on his inside approaching 600 metres.

Jockey Imran Chisty, the rider of STEFFEN was reprimanded for shifting out and inconveniencing ASHWA JIMBABE (A.Ramu) on his outside passing the 600 Metres.

Jockey Rayan Ahmed R., the rider of MOON STAR was reprimanded for shifting out and inconveniencing ASHWA JIMBABE (A.Ramu) on his outside passing the 300 Metres.

Jockey David Allan, the rider of EL REY was reprimanded for shifting 'in' and inconveniencing THESSALIAN (Shamaz Shareef) on his inside passing the 300 Metres.

Jockey Imran Chisty, the rider of STEFFEN was fined Rs.1,000/- for shifting out and inconveniencing MOON STAR (Rayan Ahmed R.) on his outside passing the 200 Metres.

It was observed that THESSALIAN (Shamaz Shareef) was running erratically between the 150 Metres and 100 Metres.

ZIVA (Darshan R.N) sustained superficial injury on left hind fetlock.

Routine Sample was taken for analysis from the winner b c EL REY.

6th Race: 128. The Melkote Plate - (About) 1400 metres. Horses rated 40 to 65, 5 years old and over (9 Runners).

STAR ADMIRAL (Rayan Ahmed R.) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Aravind G. was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Kiran Rai P, the rider of INDIAN BLUES was fined Rs.2,000/- for dropping hands in the final 100 Metres for no apparent reason.

SASSY (Darshan R.N) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner gr m SEKHMET.

7th Race: 129. The Chunchanakatte Falls Plate - Div. I - (About) 1200 metres. Horses rated 20 to 45, 4 years old only (10 Runners).

Jockey A.R. Pradeep was unable to arrive on time to fulfill his riding engagement (missed the flight). Permission was granted to trainer Mr. Vishesh M.P. to declare Jockey Rayan Ahmed R to ride CARAT LOVE in place of the declared rider.

It was observed that PERICLES (Darshan R.N) was inclined to run out between the 900 Metres and 800 Metres.

Jockey Koshi Kumar, the rider of GROUSE MOUNTAIN was fined Rs.3,000/- for not making sufficient effort on his mount in the final 200 Metres.

An enquiry is being held into the running and riding of STAR HONOUR, trained by Mr. S. Narredu and ridden by Jockey Siddaraju.P in the above race.

An enquiry is being held into the running and riding of SUPERCHARGE, trained by Mr. Warren Singh and ridden by Jockey A.Ashhad Asbar in the above race.

Routine Sample was taken for analysis from the winner b f CARAT LOVE.

Permission was granted to trainers M/s. Purshotham. K, Neil B. Devaney and S. Narredu to deputize on behalf of trainers M/s. S. Padmanabhan, Prasanna Kumar and Rajesh Narredu who were unable to attend the races.
