# BANGALORE WINTER MEETING 2024-25 FIRST DAY , FRIDAY , 1<sup>ST</sup> NOVEMBER 2024 RACING INCIDENTS

# <u>(1-8)</u>

#### **GOING : Good**

#### **PENETROMETER READING: 4.0 Cms.**

**RAILING POSITION:** Railing fixed at average width of 3.0 Meters from 1600 Meters to winning post from its original position.

# <u>1<sup>st</sup> Race: 1. The Kentucky Plate - (About) 1200 metres. Maiden Horses 3 years old only. (11 Runners).</u>

Permission was granted to Trainer Mr. S. Padmanabhan to withdraw DESERT GODDESS (A. Sandesh) on veterinary grounds as it was found to be lame on left hind. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Imran Chisty, the rider of DAIKI reported that his mount was hanging 'in' from 600 Metres. The horse was subjected to veterinary examination. On examination it was found to have bit sore on right oral commissure. Trainer Mr. Pradeep Annaiah was informed to take remedial measures before accepting with it again.

GLOWING MOONLIGHTS (Ravi R.) ran detached from the field. Trainer Mr. Sriram Komandur was informed to ensure better performance of his charge in future.

Routine Sample was taken for analysis from the winner b f REGAL REALITY.

### 2<sup>nd</sup> Race: 2. The Kudremukh Plate - Div. II - (About) 1400 metres. Horses rated 20 to 45 (10 Runners).

Trainer Mr. Pradeep Annaiah was fined Rs.2,000/- for not obtaining prior permission to use red hood for his charge DARRION (Imran Chisty).

FEEL OF HOPE (A.Ramu) took a fly jump.

Jockey S.K.Paswan, the rider of LADY INVICTUS was fined Rs.2,000/- for not improving his position from the 1200 Metres till about 700 Metres.

Jockey Rayan Ahmed R., the rider of CAT WHISKERS was reprimanded for shifting out and inconveniencing ROYAL WHISPER (Shreyas Singh S) on his outside passing the 500 Metres.

Jockey Imran Chisty, the rider of DARRION reported that his mount stopped galloping in the final 150 Metres. The horse was subjected to veterinary examination but no abnormality was reported.

FEEL OF HOPE (A.Ramu) ran detached from the field. Trainer Mr. Pradeep Annaiah was informed to ensure better performance of his charge in future.

INSPIRE (Antony Raj S.) was subjected to veterinary examination but no abnormality was reported.

EMPRESS BELLA (Vinod Shinde) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b f NYX.

## <u>3<sup>rd</sup> Race: 3. The Dudhsagar Falls Plate - Div. II - (About) 1200 metres.</u> <u>Horses rated 20 to 45 (8 Runners).</u>

Trainer Mr. V. Lokanath was fined Rs.1,000/- for failing to produce the declared colors at the scales in respect of his charge (SLING SHOT). Subsequently, All Black emergency colors were permitted to be used.

Jockey S. Hussain, the rider of ELVEDEN was fined Rs.1,000/- for shifting 'in' and tightening SCARLETTE LADY (Akshay Kumar) on his inside passing the 850 Metres.

Jockey Tousif Khan, the rider of ANZAC PARADE was reprimanded for riding an indifferent race.

Jockey S. Hussain, the rider of ELVEDEN was reprimanded for riding an indifferent race.

Jockey Mohammed Aliyar, the rider of SCHAFENBERG was reprimanded for riding an indifferent race.

MAKOTO (Rajesh Kumar M) was subjected to veterinary examination but no abnormality was reported.

An enquiry is being held into the running and riding of LADYLION, trained by Mr. Sriram Komandur and ridden by Jockey Girish R. in the above race.

Routine Sample was taken for analysis from the winner b f SCARLETTE LADY.

# 4<sup>th</sup> Race: 4. The Belgaum Plate - (About) 1200 metres. Horses rated 60 to 85 (6 Runners).

NEVER GIVE IN (Antony Raj S.) reared up as the gates opened, whereby the rider was totally unbalanced immediately after the start, in the process the colour cap along with his goggles came off as such the rider had to ride without the goggles throughout the race. As the incident was accidental no action was taken beyond noting the incident.

Routine Sample was taken for analysis from the winner b c JERSEY KING.

### 5<sup>th</sup> Race: 5. The Jayant Shah Memorial Trophy - (About) 1400 metres. Horses rated 40 to 65 (12 Runners).

Jockey Akshay Kumar, the rider of DEL AVIZ was fined Rs.3,000/- for shifting 'in' and causing interference to ARMORY (Rajesh Kumar M), which in turn passed it onto the horses on his inside viz; THEWHISPERQUIETLY (S.K.Paswan) and REGAL ARISTOCRACY (A. Sandesh) soon after the start.

Jockey Rajesh Kumar M, the rider of ARMORY reported that he lost his right stirrup at the start, which he regained at about 900 Metres.

Jockey Suraj Narredu, the rider of DIVINE ART reported that he could not get a clear view between the 800 Metres till about 600 Metres due to the kick back of the earth.

Jockey Antony Raj S., the rider of DISCIPLE was fined Rs.1,000/- for coming 'in' and tightening STAR COMET (Rayan Ahmed R.) on his inside passing the 300 Metres.

Jockey Vinod Shinde, the rider of STELLAR GOLD was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

Jockey V.R.Jagadeesh, the rider of SEKHMET was reprimanded for dropping hands before passing the winning post.

An enquiry was held by the Stipendiary Steward for the above race with respect to the riding of Jockey S.K.Paswan, the rider of THEWHISPERQUIETLY "wherein from 1200 Metres he did not make any effort to improve his position till about 650 Metres for no apparent reason and thereafter, he did not infuse adequate vigour in riding out his mount in the final 400 Metres".

Jockey S.K.Paswan was interviewed by the Stipendiary Steward. The Stipendiary Steward after considering the submissions made by Jockey S.K.Paswan and after viewing the CCTV decided to charge Jockey S.K.Paswan for Unsatisfactory Riding.

The Stipendiary Steward thereafter suspended the Jockey's Licence granted to S.K.Paswan for **four (4) race days of Bangalore Winter Meeting 2024-25 i.e., 16-11-2024, 23-11-2024, 29-11-2024 & 30-11-2024** as he had pleaded guilty for Unsatisfactory Riding under Rule No. 161 (ii) of the BTC Rules of Racing on his mount THEWHISPERQUIETLY (he is permitted to ride work) and was informed of his right to appeal.

Routine Sample was taken for analysis from the winner b f DIVINE ART.

# 6<sup>th</sup> Race: 6. The Rajyotsava Trophy - (About) 1400 metres. 3 years old and over. (4 Runners).

Routine Sample was taken for analysis from the winner b g YUKAN.

## 7<sup>th</sup> Race: 7. The Dudhsagar Falls Plate - Div. I - (About) 1200 metres. Horses rated 20 to 45 (7 Runners).

LOCKHEED (P. Trevor) reared up, dislodged its rider on the way to the starting gates and galloped nearly one full round of the course. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr. Darius R. Byramji was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

COOL WATER (Asirvatham) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Azhar Ali was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Routine Sample was taken for analysis from the winner b g RUN FOR THE SUN.

# 8<sup>th</sup> Race: 8. The Kudremukh Plate - Div. I - (About) 1400 metres. Horses rated 20 to 45 (9 Runners).

BALMORAL (Akshay Kumar) walked out of the gates. In view of its behaviour, Trainer Mr. S.S. Attaollahi was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

BOWEN (Ikram Ahmed) planted, lost many lengths at the start and ran detached thereafter. In view of its behaviour, Trainer Mr.S. Dominic was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey A. Sandesh, the rider of JOON was reprimanded for shifting 'in' and inconveniencing YANNICK (Antony Raj S.) on his inside rounding the final bend.

Jockey Rajesh Kumar M, the rider of INVINCIBLE was fined Rs.5,000/- for not making sufficient effort on his mount during the race.

Routine Sample was taken for analysis from the winner b f BALMORAL.

An enquiry was held by the Stipendiary Stewards regarding the running and riding of CAPRI GIRL, trained by Mr. M. Rajendra Singh and ridden by Jockey K. Sai Kiran in the above race. After due enquiry, their explanations were noted for future reference.

### <u>SIXTH DAY, SATURDAY, 27<sup>th</sup> JULY 2024</u>

#### Race: 40. The Udhagamandalam Plate - Div. I - (About) 1200 metres. Maiden Horses 3 years old only (Horses who have run at least thrice but not placed second, third or fourth even once ineligible).

An enquiry was held by the Stipendiary Stewards with regard to withdrawal of PRICELESS PRINCE in the above race. After due enquiry, Trainer Mr. S. Narredu was fined a sum of Rs.10,000/- for his negligence in discharge of his duties as a trainer, thereby contravening Rule No. 114 (b) (i) of the B.T.C Rules of Racing. In that he accepted his charge PRICELESS PRINCE to run in the above said race when it was not eligible.
