

**BANGALORE WINTER MEETING 2024-25**  
**THIRD DAY , FRIDAY , 15<sup>th</sup> NOVEMBER 2024**  
**(Preponed from Saturday, 16<sup>th</sup> November, 2024)**  
**RACING INCIDENTS**  
**(17- 24)**

**GOING : Good**

**PENETROMETER READING: 4.0 Cms.**

**RAILING POSITION: Railing fixed at average width of 7.0 Meters from 1600 Meters to winning post from its original position.**

**1<sup>st</sup> Race: 17. The Black Caviar Plate - (About) 1600 metres. Maiden Horses 3 years old only. (9 Runners).**

IMPERIAL EMPEROR (Vinod Shinde) after jumping out swerved towards the left, did not raise a fluent gallop and took no practical part in the race. In view of its behaviour, Trainer Mr.Rajesh Narredu was informed not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least **one Mock Race** and **two jump outs** on a starting gate practice day.

Routine Sample was taken for analysis from the winner b f FINAL CALL.

**2<sup>nd</sup> Race: 18. The Shimsha Plate - (About) 1400 metres. Horses rated 00 to 25 (8 Runners).**

SUPER BOLD (Tousif Khan) walked out of the gates and lost few lengths at the start. In view of its behaviour, Trainer Mr. Pradeep Annaiah (deputising on behalf of Trainer Mr.S. Dominic) was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Vinod Shinde, the rider of BOURBON BAY was fined Rs.2,000/- for shifting out and causing interference to EMPRESS BELLA (Arvind Kumar. N) who had check his mount and shift out, causing interference to SUPERHERO (Rayan Ahmed R.) passing the 350 Metres.

Jockey A.R.Pradeep, the rider of EMERALDO was fined Rs.1,000/- for coming 'in' and causing interference to CROISSANTINO (P. Sai Kumar) on his inside passing the 350 Metres.

Jockey A.R.Pradeep, the rider of EMERALDO was fined Rs.1,000/- for coming 'in' and causing interference to SACRED CREATOR (Angad) on his inside passing the 300 Metres.

Jockey Arvind Kumar. N, the rider of EMPRESS BELLA was reprimanded for shifting out and inconveniencing CROISSANTINO (P. Sai Kumar) on his outside passing the 150 Metres.

Jockey A.R.Pradeep, the rider of EMERALDO was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

Jockey Ikram Ahmed, the rider of SEA JACK was fined Rs.5,000/- for not making sufficient effort on his mount during the race.

Jockey P. Sai Kumar, the rider of CROISSANTINO was fined Rs.2,000/- for dropping hands in the final 100 Metres for no apparent reason.

Routine Sample was taken for analysis from the winner b m SACRED CREATOR.

**3<sup>rd</sup> Race: 19. The Hogenakkal Falls Plate - (About) 1600 metres. Horses rated 20 to 45 (9 Runners).**

SEKHMET (Arvind Kumar. N) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr.Kishan Thomas. K was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Suraj Narredu, the rider of IMPERIAL STAR was fined Rs.1,000/- coming 'in' and causing interference to ANCIENT HISTORY (Siddaraju.P) on his inside passing the 1300 Metres.

Jockey P. Trevor, the rider of COUNT BASIE reported that he could not get a clear view between the 1100 Metres till about 800 Metres due to kick back of the earth.

Jockey P. Trevor, the rider of COUNT BASIE reported that his mount was hanging 'in' after entering the straight. The horse was impounded for veterinary examination. On examination it was found to have sustained clip injury on left fore cannon and superficial clip injury on right hind cannon.

Jockey M. Prabhakaran, the rider of QUEEN OF KINGS reported that he lost both his stirrups after he received interference near 1200 Metres. Subsequently, he regained his right stirrup approaching 800Metres and left stirrup approaching 600 Metres. He also added that he did not ride out his mount in the final 350 Metres as it had sustained injury during the race.

Jockey L. Alex Rozario, the rider of TOROBRAVO was reprimanded for riding an indifferent race.

QUEEN OF KINGS (M. Prabhakaran) was subjected to veterinary examination. On examination, it was found to have punctured wound on right fore cannon.

ANCIENT HISTORY (Siddaraju.P) punctured wound on right hind fetlock.

JOON (Vinod Shinde) was subjected to veterinary examination but no abnormality was reported.

Trainer Mr. Rajesh Narredu was questioned regarding the relative improved performance of his charge IMPERIAL STAR (Suraj Narredu) in the above race as compared to its previous run in Race No.8 i.e.,The Kudremukh Plate - Div. I - (About) 1400 metres. Horses rated 20 to 45 run on 01/11/2024 wherein it ran unplaced.

The trainer stated that:

- 1) His charge had finished 7<sup>th</sup> in its previous start though the rider had ridden out with the aid of whip;
- 2) As his charge had underperformed he decided to put on a pair of Blinkers;
- 3) His charge worked well with the blinkers on 12/11/2024 during the official gate practice;
- 4) This was a suitable 1600 Metres race available otherwise he had to wait for about three weeks; &
- 5) He added that though his charge won by 2 ½ he had not fancied it much due to its previous performance.

While noting his explanations he was cautioned to be more prudent in running his charges in future.

An enquiry was held by the Stipendiary Steward into the interference caused by Jockey Vinod Shinde, the rider of JOON in the above race. In that he shifted 'in' and caused severe interference to the horses on his inside viz AMUSING (Salman Khan) and QUEEN OF KINGS (M. Prabhakaran) approaching 1200 Metres, whereby COUNT BASIE (P. Trevor) and TOROBRAVO (L. Alex Rozario) which were travelling directly behind also had to be checked by its respective riders.

Jockey Vinod Shinde was interviewed by the Stipendiary Steward. The Stipendiary Steward after considering the submissions made by Jockey Vinod Shinde and after viewing the CCTV replay decided to charge Jockey Vinod Shinde for Careless Riding.

The Stipendiary Steward thereafter suspended the Jockey's Licence granted to Vinod Shinde for **four (4) race days of Bangalore Winter Meeting 2024-25 i.e., 29/11/2024, 30/11/2024, 6/12/2024 & 13/12/2024** as he had pleaded guilty to the charge under Rule No. 161 (i) of the BTC Rules of Racing for Careless Riding on his mount JOON (he was permitted to ride work) and was informed of his right to appeal.

Surprise sample was taken for analysis from b g COUNT BASIE.

Routine Sample was taken for analysis from the winner b g IMPERIAL STAR.

**4<sup>th</sup> Race: 20. The Vidurashwatha Plate - Div. II - (About) 1200 metres. Horses rated 20 to 45 (12 Runners).**

JULLY (B. L. Paswan) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Azhar Ali was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

THE STRIKINGLY (Ravi R.) jumped out awkwardly.

Jockey Ravi R., the rider of THE STRIKINGLY was fined Rs.1,000/- for shifting out and causing interference to PRINCESS GOLD (P. Sai Kumar) and GLAZE (Rajesh Kumar M) on his outside approaching 1100 Metres.

Jockey Tousif Khan, the rider of DOMINA reported that his mount was hanging out after entering the straight. Trainer Mr. M. Rajendra Singh was informed to take appropriate corrective measures before accepting with it again.

Jockey P. Trevor, the rider of REAL HAPPINESS reported that his mount was running green throughout the race.

Jockey P. Sai Kumar, the rider of PRINCESS GOLD reported that his mount was not galloping fluently in the last 400 Metres and ran detached thereafter. Trainer Mr. Umar Shariff. S was informed to ensure better performance of his charge in future.

Routine Sample was taken for analysis from the winner dk b f EMPHATIC.

**5<sup>th</sup> Race: 21. The Ardent Knight Trophy - (About) 1400 metres. Horses rated 40 to 65, 4 years old and over (8 Runners).**

AQUAMATIC (Akshay Kumar) was examined at the starting gate by the Club's Veterinary Officer and was found to be trotting lame on right fore. Under the circumstances, it was permitted to be withdrawn on veterinary grounds before coming under Starter's order. Trainer Mr. Azhar Ali was

informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey Angad, the rider of AUSPICIOUS QUEEN was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

LEX LUTHOR (Vinod Shinde) ran detached from the field. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Kishan Thomas. K was informed to ensure better performance of his charge in future.

Routine Sample was taken for analysis from the winner b f VICTORIA DORESAANI.

**6<sup>th</sup> Race: 22. The Royal Calcutta Turf Club Cup - (About) 1400 metres. Horses rated 80 and above (5 Runners).**

Jockey P. Trevor, the rider of GALAHAD reported that he did not get a clear view between 1200 Metres and 800 Metres due to the kick back of the earth.

Routine Sample was taken for analysis from the winner dk b g AFRICAN GOLD.

***It rained heavily after the sixth race and as the underfoot conditions of the track was not conducive for racing, the Stewards of the Bangalore Turf Club Ltd., decided to cancel the reminder of the races, Mock Race & the Auction Sale.***

**7<sup>th</sup> Race: 23. The Hebbe Falls Plate - (About) 1400 metres. Horses rated 20 to 45, 4 years old and over (12 Runners).**

**8<sup>th</sup> Race: 24. The Vidurashwatha Plate - Div. I - (About) 1200 metres. Horses rated 20 to 45 (12 Runners).**

**ADDITIONAL REPORTS**  
**BANGALORE SUMMER MEETING 2024**

**(A)**

**ELEVENTH DAY, WEDNESDAY, 14<sup>TH</sup> AUGUST 2024**

**Race: 74. The Mahalakshmi Plate - (About) 1600 metres. Horses rated 00 to 25.**

The Stipendiary Stewards reported Trainer Mr. M. Rajendra Singh to the Stewards for Contravention of B.T.C Calendar Notification under the heading "PUNISHMENT TO TRAINERS BY STIPENDIARY STEWARDS / STEWARDS (Under Clause -8)" read with of Rule No.202 (xvi) of the BTC Rules of Racing in respect of his charge TIGERKING.

"In that his charge TIGERKING ran in an inconsistent manner and exhibiting reversal of form wherein, it won in Race No. 74 of the BSM 2024 i.e., The Mahalakshmi Plate - (About) 1600 metres. Horses rated 00 to 25 run on 14/8/2024 as compared to its previous run in Race No. 14 i.e., The Manitou Stakes - Div. II, (about) 1200 Metres, Horses rated 20 to 45, run on Sunday, 14th July, 2024 trained by you and when ridden by Jockey S. Hussain it ran unplaced".

The Stewards held an enquiry on 15-11-2024 and examined Trainer Mr. M. Rajendra Singh.

**The Stewards considered the following:**

- The Minutes of the Preliminary enquiry conducted by the Stipendiary Stewards;
- Charge sheet issued to Trainer Mr. M. Rajendra Singh by the Stipendiary Stewards;
- The Submissions made by Trainer Mr. M. Rajendra Singh during the enquiry;
- The Stewards noted that Trainer Mr. M. Rajendra Singh had pleaded guilty to the alleged breach of Contravening Rule Nos. 114 (b) (i) & 202 (xvi) of the BTC Rules of Racing as charged by the Stipendiary Stewards.

**After due deliberations, the Stewards decided as under:-**

- (a) To Suspend the trainer's licence granted to trainer Mr. M. Rajendra Singh w.e.f **24/11/2024 to 01/12/2024** [Both days inclusive] and fine him a sum of **Rs. 25,000/-** for Contravention of Calendar Notification under the heading "PUNISHMENT TO TRAINERS BY STIPENDIARY STEWARDS / STEWARDS (Under Clause - 8)" in respect of his charge TIGERKING.
- (b) He was informed of his right to appeal to the Board of Appeal.

**TWELFTH DAY, SATURDAY, 24<sup>TH</sup> AUGUST 2024**

**Race: 79. The Chennai Cup - (About) 1200 metres. Horses rated 40 to 65.**

The Stipendiary Stewards reported Jockey Akshay Kumar to the Stewards for Contravention of Rule No. 159 (b) of the B.T.C Rules of Racing on his mount FINLEY. The Stipendiary Stewards also reported Trainer Mr. S.S. Attaollahi to the Stewards for Contravention of Rule No. 114 (b) (i) of the B.T.C Rules of Racing for his charge FINLEY in the above race.

The Stewards held an enquiry on 15/11/2024 and examined Trainer Mr. S.S. Attaollahi and Jockey Akshay Kumar.

**The Stewards considered the following:**

- The Minutes of the Preliminary enquiry conducted by the enquiry officers;
- Charge Sheet issued to Jockey Akshay Kumar and Trainer Mr. S.S. Attaollahi by the Stipendiary Steward;
- The Submissions made by Trainer Mr. S.S. Attaollahi and Jockey Akshay Kumar during the enquiry;
- Stewards viewed various angles of the race with specific reference to the riding by Jockey Akshay Kumar in the above race;

**After due deliberations, the Stewards decided as under:-**

- a) To severely caution Jockey Akshay Kumar as to the future riding in races and further warned him that the repetition of similar practice of riding on his mounts in future will be severely dealt with.
- b) To severely caution Trainer Mr. S.S. Attaollahi as to the imparting of riding instructions to his rides and further cautioned him to be very careful in future as to the running of his charges in races.
