**FOURTH DAY , SATURDAY , 23<sup>RD</sup> NOVEMBER 2024**

**RACING INCIDENTS**

**(25-32)**

**GOING: Good**

**PENETROMETER READING: 3.3 Cms.**

**RAILING POSITION: Railing fixed at average width of 8.0 Meters from 1600 Meters to winning post from its original position.**

**1<sup>st</sup> Race: 25. The Beginners Plate - (About) 1100 metres. Maiden Horses 2 years old only. (6 Runners).**

LIGHTNING BLITZ (M. Prabhakaran) jumped awkwardly outwards.

Routine Sample was taken for analysis from the winner b f SEE THE LIGHT.

**2<sup>nd</sup> Race: 26. The Shivanasamudra Falls Plate - Div. III - (About) 1400 metres. Horses rated 20 to 45 (12 Runners).**

STAR SYMPHONY (M. Prabhakaran) walked out of the gates, lost many lengths at the start and ran detached thereafter. In view of its behaviour, Trainer Mr. Rajesh Narredu was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Shreyas Singh S, the rider of STRIKING EYES reported that a lump of earth hit his face (left eye) passing the 1100 Metres as such he could not offer any assistance to his mount thereafter. Jockey Rajesh Kumar M, the rider of MAKOTO reported that he had to ride his mount in check between the 600 Metres till about 400 Metres due to the incident.

An enquiry was held by the Stipendiary Steward into the interference caused by Jockey D'nuSingh Deora, the rider of ROYAL WHISPER in the above race. In that he shifted out and caused severe interference to SEA DIAMOND (Surya P.) on his outside, thereby SEA DIAMOND (Surya.P) struck the hind of ROYAL WHISPER, whereby Jockey Surya.P, the rider of SEA DIAMOND was totally unbalanced and was dislodged from his mount approaching 900 Metres. JOYFUL SPIRIT (A. Ramu) which was travelling along side had to steady his mount and DOUBLE VISION(V.R. Jagadeesh) which was travelling directly behind had to be checked by its rider very severely to avoid striking the prostrated horse and rider. LORDS GRACE (Chethan Kalay.S) also had to steady his mount momentarily.

Jockey D'nuSingh Deora was interviewed by the Stipendiary Steward. The Stipendiary Steward after considering the submissions made by Jockey D'nuSingh Deora and after viewing the CCTV replay decided to charge Jockey D'nuSingh Deora for Careless Riding.

The Stipendiary Steward thereafter suspended the Jockey's Licence granted to D'nuSingh Deora **for four (4) race days of BWM 2024-25 i.e., 6/12/2024, 13/12/2024, 14/12/2024 & 21/12/2024** as he had pleaded guilty to the charge under Rule No. 161 (i) of the BTC Rules of Racing for Careless Riding on his mount ROYAL WHISPER (he was permitted to ride work) and was informed of his right to appeal.

DOUBLE VISION (V.R.Jagadeesh) was subjected to veterinary examination but no abnormality was reported.

STAR SYMPHONY (M. Prabhakaran) was subjected to veterinary examination but no abnormality was reported.

It was reported after the race that SEA DIAMOND (Surya P.) burst its blood vessels. Trainer Mr.Umar Shariff.S was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b g POWER OF BEAUTY.

**3<sup>rd</sup> Race: 27. The Phar Lap Plate - (About) 1100 metres. Maiden Horses 3 years old only. (9 Runners).**

THUTMOSE (Chethan Kalay S.) reared up as the gates opened and lost many lengths at the start. In view of its behaviour, Trainer Mr.S.Shoban Babu was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

ROCKING GIRL (Arshad Alam) sustained clip injury on right knee.

Routine Sample was taken for analysis from the winner b c SMALL DREAMS.

**4<sup>th</sup> Race: 28. The Shivanasamudra Falls Plate - Div. II - (About) 1400 metres. Horses rated 20 to 45 (11 Runners).**

Permission was granted to Trainer Mr.Warren Singh to withdraw GALLON OF MY LOVE (A.Ramu) on veterinary grounds as it was found to be lame on left fore due to tendinitis. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

MONTERIO (Shamaz Shareef) jumped awkwardly inwards onto PETTES LOVE (D'nuSingh Deora) at the start.

Jockey Kiran Rai P, the rider of INVINCIBLE was fined Rs.2,000/- for dropping hands before passing the winning post.

An enquiry is being held into the running and riding of MONTERIO, trained by Mr. Prasanna Kumar and Jockey Shamaz Shareef in the above race.

Routine Sample was taken for analysis from the winner b f QUEEN OF KYIV.

**5<sup>th</sup> Race: 29. The V Venugopal Naidu Memorial Trophy - (About) 1600 metres. Horses rated 40 to 65 (12 Runners).**

Jockey Rayan Ahmed R., the rider of STELLAR GOLD reported that his mount was hanging 'in' throughout the race. The horse was subjected to veterinary examination. On examination, it was found to have sustained bit injury on left oral commissure. Trainer Mr. S. Ganapathy was informed to take remedial measures before accepting with it again.

Jockey Siddaraju.P, the rider of ALL ATTRACTION was reprimanded for shifting 'in' and bumping ARMORY (Angad) on his inside approaching 1400 Metres.

Routine Sample was taken for analysis from the winner b g RANQUELINO.

**6<sup>th</sup> Race: 30. The Bangalore Turf Club Trophy - (About) 1200 metres. 3 years old and over (4 Runners).**

Routine Sample was taken for analysis from the winner b h ASCOVAL.

**7<sup>th</sup> Race: 31. The Smarty Jones Plate - (About) 1200 metres. Horses rated 60 to 85 (7 Runners).**

Jockey A.R.Pradeep, the rider of THE PERFECT CHOICE had to steady his mount soon after the start due to a closely packed field.

Routine Sample was taken for analysis from the winner b g NEVER GIVE IN.

**8<sup>th</sup> Race: 32. The Shivanasamudra Falls Plate - Div. I - (About) 1400 metres. Horses rated 20 to 45 (12 Runners).**

STEP TO DESTINY (Naveen M.) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.V. Lokanath was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey L. Alex Rozario, the rider of PROMISEOFTHEFUTURE was fined Rs.1,000/- for shifting out and causing interference to MAGICAL BAY (Akshay Kumar) on his outside approaching 800 Metres.

Jockey Shreyas Singh S, the rider of CONNECTING DOTS was fined Rs.3,000/- for not making sufficient effort during the race.

Jockey G. Praveen, the rider of SUPER KIND was reprimanded for riding an indifferent race.

Jockey A.R.Pradeep, the rider of LOCKHEED reported that his mount was hanging out throughout the race. The horse was subjected to veterinary examination. On examination, it was found to have sustained bit injury on left oral commissure. Trainer Mr. Neil B. Devaney (deputising on behalf of Trainer Mr. Darius R. Byramji) was informed to take remedial measures before accepting with it again.

Jockey Ikram Ahmed, the rider of THE STRIKINGLY was reprimanded for travelling wide rounding the final bend for no apparent reason.

FAST RESPONSE (Tousif Khan) ran detached from the field. The horse was subjected to veterinary examination. On examination, it was found to be lame on left fore. Trainer Mr. S. Dominic was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

PROMISEOFTHEFUTURE (L. Alex Rozario) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner dk b g MAYNE MAGIC.

**ADDITIONAL REPORT**

**FIRSTDAY, FRIDAY, 1<sup>ST</sup> NOVEMBER 2024**

**Race: 3.The Dudhsagar Falls Plate - Div.II-(About)1200 metres. Horses rated 20 to 45.**

The Stipendiary Stewards reported Jockey Girish .R to the Stewards for Contravention of Rule No. 159 (b) of the B.T.C Rules of Racing on his mount LADYLION & Trainer Mr. Sriram Komandur to the Stewards for Contravention of Rule No. 114 (b) (i) of the B.T.C Rules of Racing for his charge LADYLION in the above race.

The Stewards held an enquiry on 23/11/2024 and examined Trainer Mr. Sriram Komandur and Jockey Girish .R.

**The Stewards considered the following:**

- a) The Minutes of the Preliminary enquiry conducted by the enquiry officers;
- b) Charge sheet issued to Jockey Girish.R and Trainer Mr. Sriram Komandur by the Stipendiary Steward;
- c) The Submissions made by Trainer Mr. Sriram Komandur and Jockey Girish. R during the enquiry;
- d) Stewards viewed various angles of the race with specific reference to the riding by Jockey Girish. R in the above race;

***After deliberations, they decided to change the charges levied against Jockey Girish.R by the Stipendiary Stewards from Contravention of Rule No. 159 (b) of the B.T.C Rules of Racing to Unsatisfactory Riding Rule No.161 (ii) of the B.T.C. Rules of Racing and thereafter decided as under:-***

- (a) Suspend the Jockey's Licence granted to Girish.R **for four (4) race days of BWM 2024-25 i.e., 6/12/2024, 13/12/2024, 14/12/2024 & 21/12/2024** for Unsatisfactory Riding [Rule No. 161 (ii) of the BTC Rules of Racing] on his mount LADYLION (He is permitted to ride work) & he was informed of his right to appeal;
- (b) To severely caution Trainer Mr. Sriram Komandur as to the imparting of riding instructions to his riders and further cautioned him to be very careful in future as to the running of his charges.
