## **RACING INCIDENTS**

## <u>(39 – 45)</u>

#### **GOING: Good**

#### **PENETROMETER READING: 3.2Cms.**

#### **RAILING POSITION:** Railing fixed at its original position.

## 1<sup>st</sup> Race: (39) The Becket Plate - (About) 1100 meters, Maiden horses2 years old only (Terms). (8 Runners).

Trainer Mr. Rajesh Narredu was fined Rs. 5,000/- for not obtaining prior permission to race with Tongue Strap for his charge ASHWA KALI BHANI (Suraj Narredu). Subsequently, permission was granted to him torun with a Tongue Strap for his charge in the above race.

Trainer Mr. S.S. Attaollahi was fined Rs. 10,000/- for not declaring his charge MUTUAL TRUST to start after having accepted with it to run in the above race.

It was observed that MYSTIC CHARM (S. Hussain) accidentally stumbled passing the 1000 Metres.

Jockey Rajesh Kumar. M, the rider of HACKATHON reported that his mount was inclined to run out from 800 meters. The horse was subjected to veterinary examination. On examination, it was found to have bit sore on both oral commissure. TrainerMr. Narayana Gowda. V was informed to take remedial measures before accepting with it again.

Jockey S. Hussain, the rider of MYSTIC CHARM reported that his mount was inclined to run out from 600 meters. The horse was subjected to veterinary examination but no abnormality was reported.

Jockey Rayan Ahmed.R the rider of ETERNAL GLORY was fined Rs. 3,000/- for the excessive use of the whip on his mount during the race ( $1^{st}$  Infringement).

Routine sample was taken for analysis from the winner b f VIBRANT BLISS.

## <u>2<sup>nd</sup>Race : (40) The Nagarjuna Sagar Plate – Div II (About) 1400</u> meters. Horses rated 20 to 45, 4 years old and over(9 Runners).

GLOW IN THE DARK (Ravi.R) was slowly away and lost a few lengths at the start. In view of its behaviour, Trainer Mr. Warren Singh was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Shreyas Singh.S, the rider of INFINITE SPIRIT reported that his mount was hanging out from 900 meters despite his best efforts, in the process he shifted out and took out PROPHECY (A.Sandesh) between 550 meters and 450 meters. However, INFINITE SPIRIT was subjected to veterinary examination but no abnormality was reported. Trainer Mr. V. Lokanath was informed to take appropriate corrective measures before accepting with it again.

Jockey Shreyas Singh.S, the rider of INFINITE SPIRIT was fined Rs. 2,000/- for allowing his mount to shift out thereby causing interference to GLOW IN THE DARK (Ravi. R) approaching the 200 meters.

Jockey Suraj Narredu, the rider of ASAGIRI was fined Rs. 3,000/- for the excessive use of whip on his mount during the race ( $1^{st}$  Infringement).

It was reported after the race that GLOW IN THE DARK (Ravi.R) burst its blood vessels. Trainer Mr.Warren Singh was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

PROPHECY (A. Sandesh) was subjected to veterinary examination. On examination by the Club's Veterinary Officer, it was found to be lame on left hind and also sustained clip injury on left hind cannon. Trainer Mr. S. Padmanabhan was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine sample was taken for analysis from the winner dk b g CAT WHISKERS.

# <u>3<sup>rd</sup>Race : (41) The Muthyalamaduvu Plate – (About ) 1600 meters,</u> <u>Horses rated 20 to 45 (8 Runners).</u>

Permission was granted to Trainer Mr. Kishan Thomas to withdraw SOUTHERN ARISTOCRAT(Arvind Kumar. N) on veterinary grounds as it was found to be lame on left fore. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

DR ASH (L. Alex Rozario) was slowly away and lost a few lengths at the start. In view of its behaviour, Trainer Mr. Irfan Ghatala was informed not to accept with it again until its behavior improved to the satisfaction of the Stipendiary Steward in a jump out on a starting gate practice day.

RISE AND REIGN (Suraj Narredu)was slowly away and lost a few lengths at the start. In view of its behaviour, Trainer Mr. S. Narredu (deputizing on behalf of Trainer Mr. Rajesh Narredu) was informed not to accept with it again until its behavior improved to the satisfaction of the Stipendiary Steward in a jump out on a starting gate practice day.

Jockey L.Alex Rozario, the rider of DR ASH was reprimanded for shifting 'in' and tightening PETTES LOVE (Naveen.M) on his inside passing the 450 Meters.

Jockey A. Ramu, the rider of CONTINUES was reprimanded for shifting 'in' and inconveniencing QUEEN OF KINGS (M. Prabhakaran) on his inside passing the 250 Metres.

Jockey Antony Raj.S, the rider of EMPRESS BELLA was reprimanded for dropping hands in the final 200 Metres.

RISE AND REIGN (Suraj Narredu) sustained clip injury on right hock.

Routine sample was taken for analysis from the winner dk b f RISE AND REIGN.

# <u>4<sup>th</sup>Race : (42) The Kempegowda Trophy – (About) 1100 meters, Horses</u> rated 40 to 65 (11 Runners).

Jockey Shreyas Singh. S, the rider of IL VOLO reported that his mount raced fiercely between the 800 Metres till about 550 Metres. Thehorse was subjected to veterinary examination. On examination, it was found to have bit injury on right oral commissure. Trainer Mr. S.S. Attaollahi was informed to take remedial measures before accepting with it again.

Jockey L.Alex Rozario, the rider of REDOUBLE was fined Rs. 3,000/- for not improving his position from 800 Meters till about 550 Meters.

Jockey A. Ramu, the rider of DHANTERAS was fined Rs. 3,000/- for riding his mount in check between the 850 Meters till about 500 Meters.

Routine sample was taken for analysis from the winner b g FLIGHT ON.

## 5<sup>th</sup> Race: (43) The Bangalore 1000 Guineas (Grade II) – (About) 1600 meters,3 years old Indian Fillies only (Terms) (7 Runners).

ART OF ROMANCE (P.Trevor) stumbled soon after the start and did not raise a fluent gallop for the first 100 meters. In view of its behavior, Trainer Mr. Warren Singh was informed not to accept with it again until its behavior improved to the satisfaction of the Stipendiary Steward in at least one Mock Race.

It was reported after the race thatART OF ROMANCE (P.Trevor) burst its blood vessels. Trainer Mr. Warren Singh was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Compulsory urine and blood samples were taken for analysis from the following I,II& III placed horses viz:

## 6<sup>th</sup> Race: (44) The Chintamani Stakes - (About) 1200 meters. Horses rated 40 to 65, 5 years old and over (8 Runners).

Jockey Y.S. Srinath, the rider of MAPLE LEAF reported that his mount was hanging out from 600 Meters. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. S. Dominic was informed to take appropriate corrective measures before accepting with it again.

Routine sample was taken for analysis from the winner b g GOLDEN TIME.

## 7<sup>th</sup> Race: (45) The Nagarjuna Sagar Plate – Div .I (About) 1400 meters. Horses rated 20 to 45,4 years old and over (9 Runners).

THE GREY GERANIUM (Naveen. M) jumped awkwardly inwards.

JockeyTousif Khan, the rider of SMILE OF BEAUTY was fined Rs.1,000/- for shifting out and causing interference to SPRINGSTEEN (Antony Raj. S) on his outside approaching 300 Metres.

Jockey A. Ramu, the rider of THE GOLDEN DREAM was reprimanded for riding an indifferent race.

Jockey Akshay Kumar, the rider of BRAVE MAJESTY reported that he could not get a clear run between the 250 Meters and 200 Meters due to a closely packed field.

Routine sample was taken for analysis from the winner ch g PHARAZON.

Permission was granted to trainers M/s. S. Narredu and Neil B. Devaney to deputize on behalf of trainers M/s. Rajesh Narreduand Darius R. Byramjiwho were unable to attend the races.
