

**BANGALORE WINTER MEETING 2024 – 2025**

**RACING INCIDENTS**  
**(66 – 72)**

**GOING: Good**

**PENETROMETER READING: 3.4 Cms.**

**RAILING POSITION: Railing fixed at an average width of 6.0 meters from 1600 meters to the winning post from its original position.**

**1<sup>st</sup> Race: 66. The Seattle Slew Plate - (About) 1400 metres. Maiden Horses 2 years old only. (6 Runners).**

CIRCLE OF DREAMS (Akshay Kumar) was slightly slowly away.

ASHWA KALI BHANI (Suraj Narredu) jumped awkwardly inwards.

Jockey Suraj Narredu, the rider of ASHWA KALI BHANI reported that his mount shied away due to the presence of the birds passing 500 meters.

Jockey Shamaz Shareef, the rider of SASSY SARAH reported that his goggles came off in the final 100 meters. As the incident was accidental no action was taken beyond noting the incident.

It was reported after the race that MONEY BAGS (P. Trevor) had pulled up its left testicle.

Routine Sample was taken for analysis from the winner b c MONEY BAGS.

**2<sup>nd</sup> Race: 67. The Virajpet Plate - (About) 1200 metres. Maiden Horses 3 years old only. (12 Runners).**

As Jockey S. Antony Raj was certified medically unfit to ride. Permission was granted to trainer Mr. Arjun Mangalorkar to declare Jockey A. Sandesh to ride ROYAL DECCAN in place of the declared rider.

JULLY (Shariq Mohd) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Umar Shariff.S (deputising on behalf of Trainer Mr. Azhar Ali) was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

ABSOLUTE KATRINA (Darshan R.N) took a fly jump.

Jockey L. Alex Rozario, the rider of FELISA was fined Rs.1000/- for coming "in" and causing interference to GREY IMPACT (P. Trevor) on his inside soon after the start.

Jockey Arvind Kumar. N, the rider of MARTINO was fined Rs. 3,000/- for shifting out and causing interference to LIVE THE DREAM (Akshay Kumar), which in turn passed it onto the horses viz; AMUSING (Arshad Alam) and FELISA (L. Alex Rozario) on his outside passing the 1100 meters.

Jockey P. Trevor, the rider of GREY IMPACT was reprimanded for shifting out and inconveniencing the horses on his outside viz; DAIKI (Rajesh Kumar M) and N R I JETPOWER (Tauseef Ahmed) approaching 800 Metres.

Jockey Arshad Alam, the rider of AMUSING was reprimanded for shifting "in" and inconveniencing ABSOLUTE KATRINA (Darshan R.N) on his inside approaching 800 meters.

Jockey P. Trevor, the rider of GREY IMPACT reported that his mount was hanging out throughout the race. The horse was subjected to veterinary examination but no abnormality was detected. However, Trainer V. Lokanath was informed to take appropriate corrective measures before accepting with it again.

Routine Sample was taken for analysis from the winner dk b c DEFENCE COUNSEL.

**3<sup>rd</sup> Race: 68. The Krishna Plate - Div. II - (About) 1200 metres. Horses rated 20 to 45, 4 years old and over (Whips not allowed) (8 Runners).**

Permission was granted to Trainer Mr. S. Inayathulla to withdraw ALTAMONTE (V.R.Jagadeesh) on veterinary grounds as it was found to be lame on right fore. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

As Jockey S. Antony Raj was certified medically unfit to ride. Permission was granted to trainer Mr.Arjun Mangalorkar to declare Jockey P. Trevor to ride EBOTSE in place of the declared rider.

Routine Sample was taken for analysis from the winner dk b g EBOTSE.

**4<sup>th</sup> Race: 69. The Glass House Trophy - (About) 1400 metres. Horses rated 40 to 65 (12 Runners).**

As Jockey S. Antony Raj was certified medically unfit to ride. Permission was granted to trainer Mr.Arjun Mangalorkar to declare Jockey A. Sandesh to ride CROSSWATER in place of the declared rider.

Trainer Mr. Joseph B. Awale was fined Rs.1,000/- for failing to produce the declared colors at the scales in respect of his charge (HAND OF GOD). Subsequently, All Black emergency colors were permitted to be used.

Jockey A.Ramu, the rider of BESTIDENTIFICATION was reprimanded for shifting "in" and inconveniencing CLASSIC CHARM (Koshi Kumar) on his inside approaching 1200 meters.

Jockey Koshi Kumar, the rider of CLASSIC CHARM reported that his mount was hanging 'in' after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Aravind. G (deputizing on behalf of Trainer Mr. S. Ganapathy) was informed to take appropriate corrective measures before accepting with it again.

Jockey Akshay Kumar, the rider of HAND OF GOD reported that he could not get a clear run in the final 100 Metres.

Jockey A.Ramu, the rider of BESTIDENTIFICATION was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

STORM SHADOW (P. Trevor) sustained superficial injury on Left Hock.

CROSSWATER (A. Sandesh) sustained superficial clip injury on Left Achilles.

Routine Sample was taken for analysis from the winner b f VICTORIA DORESAANI.

**5<sup>th</sup> Race: 70. The Dr. M.A.M. Ramaswamy Memorial Trophy - (About) 1200 metres. Horses rated 80 and above (6 Runners).**

As Jockey S. Antony Raj was certified medically unfit to ride. Permission was granted to trainer Mr.Arjun Mangalorkar to declare Jockey P. Trevor to ride ALDGATE in place of the declared rider.

Trainer Mr. Joseph B. Awale was fined Rs.1,000/- for failing to produce the declared colors at the scales in respect of his charge (VIJAYA FALCON). Subsequently All Black emergency colors were permitted to be used.

Jockey P. Trevor, the rider of ALDGATE reported that his mount was not galloping fluently throughout the race. The horse was subjected to veterinary examination but no abnormality was reported.

Jockey Akshay Kumar, the rider of VIJAYA FALCON was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

Routine Sample was taken for analysis from the winner b m ISNT SHE BEAUTIFUL.

**6<sup>th</sup> Race: 71. The Sutlej Plate - (About) 1400 metres. Horses rated 00 to 25 (9 Runners).**

As Jockey S. Antony Raj was certified medically unfit to ride. Permission was granted to trainer Mr.Umar Shariff. S to declare Jockey P. Trevor to ride SEA JACK in place of the declared rider.

Jockey P. Trevor, the rider of SEA JACK reported that his mount slightly swerved towards the left soon after the start.

Jockey Aleemuddin, the rider of ESTEFANIA was reprimanded for shifting out and inconveniencing GISMO (S.K.Paswan) on his outside approaching 1000 meters.

Jockey Aleemuddin, the rider of ESTEFANIA was reprimanded for shifting out and inconveniencing SEA JACK (P. Trevor) on his outside approaching 500 meters.

TANKINIKA (Salman Khan) ran detached from the field. Trainer Mr. S. Inayathulla was informed to ensure better performance of his charge in future.

Jockey Darshan R.N, the rider of QUICK WITTED was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

Jockey Vinod Shinde, the rider of SUNLIT PATH was fined Rs.5,000/- for the excessive use of the whip on his mount during the race (2nd infringement).

It was reported after the race that SUNLIT PATH (Vinod Shinde) burst its blood vessels. Trainer Mr. Irfan Ghatala was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Surprise sample was taken for analysis from ch r GISMO.

Routine Sample was taken for analysis from the winner b g QUICK WITTED.

**7<sup>th</sup> Race: 72. The Krishna Plate - Div. I - (About) 1200 metres. Horses rated 20 to 45, 4 years old and over (Whips not allowed) (10 Runners).**

As Jockey S. Antony Raj was certified medically unfit to ride. Permission was granted to trainer Mr.Arjun Mangalorkar to declare Jockey P. Trevor to ride SPRINGSTEEN in place of the declared rider.

Jockey Tousif Khan, the rider of SMILE OF BEAUTY was fined Rs. 1,000/- for shifting out and causing interference to THE GALLERY TIME (Naveen M.) on his outside soon after the start.

Jockey R. Robert, the rider of VAYU was fined Rs.2,000/- for shifting 'in' and tightening the horses on his inside viz; STEP TO DESTINY (Suhas. K) and THE GALLERY TIME (Naveen M.) approaching 1000 Metres.

Jockey Tousif Khan, the rider of SMILE OF BEAUTY was reprimanded for shifting out and inconveniencing PROPHECY (A. Sandesh) on his outside in the final 100 meters.

An enquiry was held by the Stipendiary Steward into the interference caused by Jockey Suhas.K, the rider of STEP TO DESTINY in the above race. In that he did not exercise sufficient control on his mount thereby allowing his mount to shift 'in' causing severe interference to THE GALLERY TIME (Naveen M.) on his inside, who

had to check his mount & shift out and inconveniencing VAYU (R. Robert) approaching 1000 meters.

Jockey Suhas.K was interviewed by the Stipendiary Steward. The Stipendiary Steward after considering the submissions made by Jockey Suhas.K and after viewing the CCTV replay decided to charge Jockey Suhas.K for Careless Riding.

The Stipendiary Steward thereafter suspended the Jockey's Licence granted to Suhas.K **for two (2) race days of BWM 2024-25 i.e., 04/01/2025 and 10/01/2025** as he had pleaded guilty to the charge under Rule No. 161 (i) of the BTC Rules of Racing for Careless Riding on his mount STEP TO DESTINY (he was permitted to ride work) and was informed of his right to appeal.

Routine Sample was taken for analysis from the winner dk b g CAT WHISKERS.
