RACING INCIDENTS

(137 - 143)

Going: Good

PENETROMETER READING: 3.1 Cms.

RAILING POSITION: Railing fixed at an average width of 4.0 meters from 1600 meters to the winning post from its original position.

1st Race: 137. The Vani Vilasa Sagara Plate - (About) 1400 metres. Horses rated 00 to 25, 4 years old and over (8 Runners).

As Jockey Siddaraju. P was certified medically unfit to ride. Permission was granted to trainer Mr.Imtiaz Khan to declare Jockey Darshan R.N in place of the declared rider.

MULTISIDED (A.R.Pradeep) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Darius R. Byramji was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey A.R.Pradeep, the rider of MULTISIDED was reprimanded for shifting "in" and inconveniencing BOURBON BAY (Koshi Kumar) on his inside approaching 250 meters.

Jockey Darshan R.N, the rider of TURKOMAN reported that his mount was hanging 'in' in the final 150 meters. The horse was subjected to veterinary examination but no abnormality was reported. Trainer Mr. Imtiaz Khan was informed to take appropriate corrective measures before accepting with it again.

Jockey K.G. Likith Appu, the rider of RECREATOR was fined Rs 2,000/- for weighing "in" 400 grams less in relation to weighing out.

ROYAL WHISPER (S. Sachin) sustained superficial clip injury on left hind cannon.

Routine Sample was taken for analysis from the winner b g TURKOMAN.

2nd Race: 138. The Bhadra Plate - (About) 1400 metres. Horses rated 20 to 45, 6 years old and over (Whips not allowed) (9 Runners).

Jockey V.R.Jagadeesh, the rider of ALTAMONTE reported that his mount stopped galloping in the final 100 meters. The horse was subjected to veterinary examination but no abnormality was reported.

It was reported after the race that THE GREY GERANIUM (Naveen M.) returned bleeding from both nostrils. Trainer Mr.V. Lokanath was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

THE STRIKINGLY (Arvind Kumar. N) was impounded for veterinary examination. On examination, it was found to have burst its blood vessels (On Endoscopy Grade - IV). Trainer Mr. Joseph B. Awale was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Surprise sample was taken for analysis from b m THE STRIKINGLY.

Routine Sample was taken for analysis from the winner b g GLOW IN THE DARK.

3rd Race: 139. The Tokino Minoru Trophy - (About) 2000 metres. Horses rated 40 to 65 (4 Runners).

Routine Sample was taken for analysis from the winner b g ROCK BANK.

4th Race: 140. The Hoysala Salver - (About) 1400 metres. Horses rated 80 and above (5 Runners).

Routine Sample was taken for analysis from the winner b g VIVALDO.

5th Race: 141. The Century Valentine's Million - (About) 1400 metres. Maiden Horses 3 years old only. (10 Runners).

RAVISHING BEAUTY (David Allan) after jumping out swerved towards the left and lost considerable ground. In view of its behaviour, Trainer Mr.Prasanna Kumar was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

ASHWA KALI BHANI (Akshay Kumar) jumped awkwardly outwards.

OUT INTO SPOTLIGHT (Shamaz Shareef) was slightly slowly away and ran detached from the field. The horse was subjected to veterinary examination but no abnormality was reported. Trainer Mr. Prasanna Kumar was informed to ensure better performance of his charge in future.

OUT INTO SPOTLIGHT (Shamaz Shareef) accidentally brushed the running rails passing the 500 Metres.

RAVISHING BEAUTY (David Allan) was subjected to veterinary examination but no abnormality was detected.

Routine Sample was taken for analysis from the winner dk b f RAVISHING BEAUTY.

6th Race: 142. The Uttara Kannada Plate - (About) 1600 metres. Horses rated 20 to 45 (8 Runners).

N R I VICTORY (V.R.Jagadeesh) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Md Sajid Qureshi was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

QUICK WITTED (Koshi Kumar) jumped awkwardly inwards and inconvenienced SHE RULES (Vivek.G) soon after the start.

Jockey Tauseef Ahmed, the rider of CASCAIS reported that his mount totally stopped galloping in the final 200 meters. The horse was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner gr g KRYSTALLOS.

7th Race: 143. The Vindication Plate - (About) 1200 metres. Horses rated 40 to 65, 5 years old and over (9 Runners).

Jockey Aleemuddin, the rider of SPRINGSTEEN reported that he could not get a clear run in the final 100 Metres due to a closely packed field.

Jockey Aleemuddin, the rider of SPRINGSTEEN was fined Rs.2,000/- for weighing 'in' 800 grams excess in relation to weighing out.

At the behest of the Stipendiary Stewards, the Stewards held an enquiry immediately after the race and examined Jockeys A.Ramu (OXYTOCIN), P. Trevor (CLASSIC CHARM), David Allan (PRIME ABBESS), Akshay Kumar (SOUTHERN FORCE) and V.R.Jagadeesh (BREEZE BLUSTER). After deliberations, in terms of Rule No.160 of the BTC Rules of Racing they decided to disqualify OXYTOCIN (A. Ramu) from the above race and the revised order of placings are as under:-

An enquiry is being held into the interference caused by Jockey A.Ramu, the rider of OXYTOCIN to PRIME ABBESS (David Allan) which in turn passed it onto CLASSIC CHARM (P. Trevor) along the rails totally unbalancing Jockey P. Trevor, SOUTHERN FORCE (Akshay Kumar) and BREEZE BLUSTER (V.R.Jagadeesh) which were travelling directly behind also had to be checked by their respective riders and shift out to avoid striking the front runner approaching 800 Metres.

OXYTOCIN (A.Ramu) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner ch g LAUTERBRUNNEN.

Permission was granted to trainer M/s. S. Narredu and Shobhan Babu to deputize on behalf of trainer M/s. Rajesh Narredu and S. Inayathulla who were unable to attend the races.
