# **RAILING POSITION:** Railing fixed at an average width of 4.0 meters from 1600 meters to the winning post from its original position.

#### <u>1<sup>st</sup> Race: 144. The Dandeli Plate - Div. III - (About) 1100 metres.</u> <u>Horses rated 20 to 45 (9 Runners).</u>

DAIKI (Rajesh Kumar M) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Narayana Gowda V. was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Salman Khan, the rider of N R I JETPOWER was reprimanded for shifting "in" and inconveniencing TRIPPLE V (Suraj Narredu) on his inside approaching 1000 meters.

Jockey Suraj Narredu, the rider of TRIPPLE V reported that his mount was racing fiercely between the 900 Metres to 800 Metres.

Jockey Vishwa. V, the rider of GISMO was reprimanded for shifting out and inconveniencing TRIPPLE V (Suraj Narredu) on his outside passing the 800 meters.

Jockey Vishwa. V, the rider of GISMO was reprimanded for dropping hands in the final 50 meters for no apparent reason.

It was reported after the race that NAPOLEAN (Vivek.G) returned bleeding from both nostrils. Trainer Mr.Prasanna Kumar was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

BALTIMORE (M. Mark) Sustained clip injury on right hind inner bulb.

Routine Sample was taken for analysis from the winner b g GROUSE MOUNTAIN.

#### 2<sup>nd</sup> Race: 145. The Dandeli Plate - Div. II - (About) 1100 metres. Horses rated 20 to 45 (8 Runners).

Permission was granted to Trainer Mr.G. Y. Rajesh Babu to withdraw ADELANTO (Salman Khan) on veterinary grounds as it was found to have abscess on the neck. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

MULTIQUEEN (Mohammed Aliyar) after jumping out did not raise a fluent gallop till about 900 Metres and ran detached thereafter. In view of its behaviour, Trainer Mr. M. Rajendra Singh was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race. Jockey M. Mark, the rider of DIVO reported that his mount was hanging out after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr.S.Shoban Babu was informed to take appropriate corrective measures before accepting with it again.

Jockey Darshan R.N, the rider of MEHRA reported that his mount was wobbling in the final 100 Metres. The horse was subjected to veterinary examination but no abnormality was reported.

Jockey V.R.Jagadeesh, the rider of DOMINA was severely reprimanded for striking the right arm of Jockey L. Alex Rozario, the rider of FELISA during the race between 150 Metres and 100 Metres.

Jockey L. Alex Rozario, the rider of FELISA was fined Rs.5,000/- for not maintaining a straight course thereby causing interference to DOMINA (V.R.Jagadeesh) on his outside passing the 50 Metres.

Jockey L. Alex Rozario, the rider of FELISA was fined Rs.2,000/- for not wearing goggles during the race.

Jockey V.R.Jagadeesh, the rider of DOMINA placed 2nd by the judge objected against Jockey L. Alex Rozario, the rider of FELISA placed 1st "In the last 50 meters the winner came in sharply and clipped my horse. Whereby I had to stop riding and I totally got unbalanced, which cost me a certain race". The Stewards held an enquiry immediately after the race and interviewed the Jockeys concerned. After deliberations, they decided to overrule the objection.

Routine Sample was taken for analysis from the winner b f FELISA.

#### <u>3<sup>rd</sup> Race: 146. The Topmost Plate - (About) 1600 metres. Maiden</u> <u>Horses 3 years old only. (6 Runners).</u>

Permission was granted to Trainer Mr.S. Narredu to withdraw RESPLENDENCE on veterinary grounds as it was found to have deep laceration on buccal mucosa (left side). He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Trainer Mr. S. Narredu was fined Rs.10,000/- for not declaring his charge KISS OF GREY to start after having accepted with it to run in the above race.

EINAUDI (A. Sandesh) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. S.S. Attaollahi was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

AGAPE (Darshan R.N) after jumping out did not raise a fluent gallop approaching 1100 meters and ran detached thereafter. In view of its behaviour, Trainer Mr. S.S. Attaollahi was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Routine Sample was taken for analysis from the winner b c GLORIOUS STRIDES.

### 4<sup>th</sup> Race: 147. The H.B.Gundappa Gowda Memorial Trophy - (About) 1200 metres. Horses rated 40 to 65 (8 Runners).

Trainer Mr.Azhar Ali was fined Rs.1,000/- for failing to produce the declared colors at the scales in respect of his charge TESORINO (Vivek.G). Subsequently All Black emergency colors were permitted to be used.

PHOENOMENON (Suraj Narredu) was subjected to veterinary examination. On examination, it was found to have sustained superficial injury on left hind pastern.

It was reported after the race that XAILY (Rajesh Kumar M) returned bleeding from both nostrils. Trainer Mr. G. Y. Rajesh Babu was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

ADAMAS (Shamaz Shareef) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b f TESORINO.

# 5<sup>th</sup> Race: 148. The Garden City Trophy - (About) 1400 metres. Horses rated 60 to 85 (5 Runners).

As Jockey Arvind Kumar N. was certified medically unfit to ride. Permission was granted to trainer Mr.Azhar Ali to declare Jockey M. Mark to ride AQUAMATIC in place of the declared rider.

AQUAMATIC (M. Mark) ran detached from the field. Trainer Mr. Azhar Ali was informed to ensure better performance of his charge in future.

Routine Sample was taken for analysis from the winner dk b g MAYNE MAGIC.

#### <u>6<sup>th</sup> Race: 149. The Dandeli Plate - Div. I - (About) 1100 metres.</u> Horses rated 20 to 45 (8 Runners).

As Jockey Arvind Kumar N. was certified medically unfit to ride. Permission was granted to trainer Mr.Irfan Ghatala to declare Jockey Vinod Shinde to ride DAYS DATE in place of the declared rider.

Jockey S.Hinayathulla, the rider of MONTERIO was fined Rs. 1,000/- for shifting "in" and tightening VAYU (V.R.Jagadeesh) on his inside approaching 900 meters.

Jockey Anish Anamo Hangal, the rider of LG'S STAR reported that his mount was hanging out from 700 meters. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. V. Lokanath was informed to take appropriate corrective measures before accepting with it again.

Jockey S.Hinayathulla, the rider of MONTERIO was reprimanded for travelling wide rounding the final bend for no apparent reason.

Jockey V.R.Jagadeesh, the rider of VAYU reported that his mount was hanging 'in' after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr.Joseph B. Awale was informed to take appropriate corrective measures before accepting with it again. It was reported after the race that FAST RESPONSE (Rayan Ahmed R.) pulled up lame on left fore. Trainer Mr.S. Dominic was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

ECLIPSE PULSE (L. Alex Rozario) was subjected to veterinary examination but no abnormality was reported.

An enquiry is being held into the running and riding of ECLIPSE PULSE, Trained by Mr. Azhar Ali and ridden by Jockey L. Alex Rozario in the above race.

Routine Sample was taken for analysis from the winner ch g INVINCIBLE.

#### <u>7<sup>th</sup> Race: 150. The Bidar Plate - (About) 1400 metres. Horses rated</u> <u>40 to 65, 5 years old and over (7 Runners).</u>

It was reported by the Club's Veterinary Officer that PHARAZON (Pavan) lost its right fore shoe on the way to the starting gates. As it could not be reshod due to time constraint, it was permitted to be withdrawn from the above race.

FORTUNATUS (Mohammed Aliyar) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. S.Shoban Babu was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey V.R.Jagadeesh, the rider of KNOTTY PATTON reported that his mount stumbled at the start.

BLUE GOD (Aleemuddin) was subjected to veterinary examination. On examination, it was found to have sharp molars. Hence, Trainer Mr. Arjun Mangalorkar was fined Rs.3,000/- for his negligence (1st infringement).

Routine Sample was taken for analysis from the winner b g METZINGER.

The Stewards held an enquiry on 14/02/2025 and examined Trainer Mr. G.Y. Rajesh Babu and Mr. P. Trevor (Spokesperson) for Jockey Kiran Rai.P and Jockey Kiran Rai.P himself.

#### The Stewards considered the following:

- a) The Minutes of the Preliminary enquiry conducted by the enquiry officers;
- b)Charge sheet issued to Jockey Kiran Rai.P by the Stipendiary Stewards;

- c) The Submissions made by Trainer Mr. G.Y. Rajesh Babu and Spokesperson Mr. P. Trevor for Jockey Kiran Rai.P during the enquiry;
- d) Stewards viewed various angles of the race with specific reference to the riding by Jockey Kiran Rai.P in the above race;
- e) The Stewards noted that Jockey Kiran Rai.P had not pleaded guilty to the alleged breach of Contravening Rule No. 159 (b) of the BTC Rules of Racing as charged by the Stipendiary Stewards.

Thereafter, the Stewards unanimously decided that Jockey Kiran Rai.P was "Guilty" as charged in the matter.

#### In light of the above, the Stewards decided as under:

- (a) To treat Jockey Kiran Rai.P as a disqualified person with effect from 01/03/2025 to 31/08/2025 (Both days inclusive) and fined a sum of Rs.25,000/- for Contravening Rule No. 159 (b) of the BTC Rules of Racing on his mount DUFY (He is not permitted to ride work).
- (b) Noted the explanations tendered by Trainer Mr. G.Y. Rajesh Babu.
- (c) He was informed of his right to appeal to the Board of Appeal.

# Race: 108. The J. Tyrrell Memorial Trophy - Div. II - (About) 1400 metres. Horses rated 20 to 45.

The Stipendiary Stewards reported Trainer Mr. G.Y. Rajesh Babu for Contravening Rule Nos. 114 (b) (i) read with Rule No. 167 (b) of the B.T.C Rules of Racing in respect of his charge COUNT BASIE and Jockey N. Tauseef Ahmed to the Stewards for Unsatisfactory Riding thereby Contravening Rule No. 161 (ii) of the B.T.C Rules of Racing on his mount COUNT BASIE.

The Stewards held an enquiry on 14/02/2025 and examined Trainer Mr. G.Y. Rajesh Babu and Mr. Ahsan Qureshi (Spokesperson) for Jockey N. Tauseef Ahmed and Jockey N. Tauseef Ahmed himself.

#### The Stewards considered the following:

- a) The Minutes of the Preliminary enquiry conducted by the enquiry officers;
- b) Charge sheet issued to Trainer Mr. G.Y. Rajesh Babu and Jockey N. Tauseef Ahmed by the Stipendiary Stewards;
- c) The Submissions made by Trainer Mr. G.Y. Rajesh Babu and Spokesperson Mr. Ahsan Qureshi for Jockey N. Tauseef Ahmed during the enquiry;
- d) Stewards viewed various angles of the race with specific reference to the riding of Jockey N. Tauseef Ahmed in the above race;

- e) The Stewards noted that Trainer Mr. G.Y. Rajesh Babu had not pleaded guilty to the alleged breach of Contravening Rule No. 114 (b) (i) read with Rule No. 167 (b) of the BTC Rules of Racing as charged by the Stipendiary Steward.
- f) The Stewards noted that Jockey N. Tauseef Ahmed had not pleaded guilty to the alleged breach of Contravening Rule No. 161(ii) of the BTC Rules of Racing as charged by the Stipendiary Steward.

#### In light of the above, the Stewards unanimously decided as under:

- (a) To suspend the Jockey's Licence granted to N. Tauseef Ahmed with effect from 24/02/2025 to 15/03/2025 (Both days inclusive) for Unsatisfactory Riding thereby Contravening Rule No. 161 (ii) of the BTC Rules of Racing on his mount COUNT BASIE (He is permitted to ride work).
  - (b) To fine Trainer Mr. G.Y. Rajesh Babu a sum of **Rs.50,000/-** for his negligence in discharge of his duties as a licenced professional, thereby contravening Rule No. 114 (b)(i) read with Rule No. 167 (b) of the BTC Rules of Racing.
  - (c) They were informed of their right to appeal to the Board of Appeal.
