**RACING INCIDENTS**

**(130 - 136)**

**Going: Good**

**PENETROMETER READING: 3.5 Cms.**

**RAILING POSITION: Railing fixed at its original position.**

**1<sup>st</sup> Race: 130. The Kadambi Falls Plate - Div. II - (About) 1400 metres. Horses rated 20 to 45, 5 years old and over (8 Runners).**

ICE STORM (Rajesh Kumar M) jumped awkwardly outwards.

Jockey K.G. Likith Appu, the rider of STRIKING EYES was reprimanded for shifting out and inconveniencing THE GOLDEN DREAM (A.R.Pradeep) on his outside approaching 1300 meters.

An enquiry is being held into the running and riding of TREASURE CHEST on an oral complaint made by Trainer Mr. S. Dominic against Jockey Koshi Kumar who rode TREASURE CHEST in the above race.

BAASHHA (M. Prabhakaran) sustained clip injury on left hind tendon.

TREASURE CHEST (Koshi Kumar) sustained superficial injury on right fore cannon.

Routine Sample was taken for analysis from the winner dk b g BAASHHA.

**2<sup>nd</sup> Race: 131. The Sans Craintes Million - (About) 1200 metres. Maiden Horses 3 years old only. (6 Runners).**

RANSOMWARE (Rajesh Kumar M) accidentally stumbled approaching 1000 meters.

Jockey P. Mani, the rider of SILVER QUEST reported that his mount was running erratically throughout the race and was hanging 'in' after entering the straight as such he could not offer much assistance to his mount during the race. The horse was impounded for veterinary examination. On examination, it was found to have sharp molars and bit injury on right oral commissure. Hence, Trainer Mr. M. Rajendra Singh was fined Rs. 3,000/- for his negligence (1st infringement) and he was informed to take appropriate corrective measures before accepting with it again.

Surprise sample was taken for analysis from gr f SILVER QUEST.

Routine Sample was taken for analysis from the winner b f ETERNAL GLORY.

**3<sup>rd</sup> Race: 132. The Suresh Shanmugam Memorial Sprinters' Trial Stakes - (About) 1200 metres. 4 years old and over at the time of starting. (6 Runners).**

As Jockey Akshay Kumar could not arrive to fulfil his riding engagement due to the reasons beyond control. Permission was granted to trainer Mr. Prasanna Kumar to declare Jockey A. Sandesh to ride MASATO in place of the declared rider.

YUKAN (Y. S. Srinath) jumped awkwardly outwards.

ISNT SHE BEAUTIFUL (Vivek.G) jumped awkwardly outwards.

Jockey Suraj Narredu, the rider of STAR GLORY was fined Rs. 1000/- for shifting out and causing interference to the horses on his outside viz. BERRETTINI (P. Sai Kumar) and MASATO (A. Sandesh) at the start.

Jockey Y. S. Srinath, the rider of YUKAN reported that his mount was hanging out after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. S.S. Attaollahi was informed to take appropriate corrective measures before accepting with it again.

It was reported after the race that ISNT SHE BEAUTIFUL (Vivek.G) returned bleeding from both nostrils. Trainer Mr. S. Padmanabhan was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b m ISNT SHE BEAUTIFUL.

**4<sup>th</sup> Race: 133. The Dr. T. Thimmaiah Memorial Trophy - (About) 1400 metres. Horses rated 40 to 65 (8 Runners).**

As Jockey Akshay Kumar could not arrive to fulfil his riding engagement due to the reasons beyond control. Permission was granted to trainer Mr. Prasanna Kumar to declare Jockey Vivek.G to ride SCARLETTE LADY in place of the declared rider.

LUX AETERNA (Shreyas Singh S) accidentally stumbled at the start.

Jockey Rajesh Kumar M, the rider of ARMORY reported that he had to ride in check between 850 meters to 800 meters due to a closely packed field.

Jockey Arvind Kumar. N, the rider of POWER OF BEAUTY was reprimanded for shifting "in" and inconveniencing METZINGER (Antony Raj S.) on his inside approaching 200 meters.

Jockey Arvind Kumar. N, the rider of POWER OF BEAUTY reported that his mount was lugging "in" under pressure in the final 150 meters.

Jockey Siddaraju.P, the rider of DIVINE ART reported that his mount was lugging "in" under pressure in the final 100 meters.

Jockey V.R.Jagadeesh, the rider of CHOTIPARI reported that he accidentally lost his whip passing 100 meters.

Jockey Shreyas Singh S, the rider of LUX AETERNA was reprimanded for riding in an indifferent race.

Routine Sample was taken for analysis from the winner b g POWER OF BEAUTY.

**5<sup>th</sup> Race: 134. The Stayers' Trial Stakes - (About) 2400 metres. 4 years old and over at the time of starting. (4 Runners).**

As Jockey Akshay Kumar could not arrive to fulfil his riding engagement due to the reasons beyond control. Permission was granted to trainer Mr. S.S. Attaollahi to declare Jockey Y. S. Srinath to ride SASSY in place of the declared rider.

Jockey Suraj Narredu, the rider of TOUCH OF GREY was fined Rs. 1000/- for shifting out and causing interference to SASSY (Y. S. Srinath) on his outside approaching 1700 meters.

Jockey Suraj Narredu, the rider of TOUCH OF GREY was fined Rs.5,000/- for the excessive use of whip on his mount during the race (2nd infringement).

TOUCH OF GREY (Suraj Narredu) was impounded for veterinary examination but no abnormality was reported.

Surprise sample was taken for analysis from gr h TOUCH OF GREY.

Routine Sample was taken for analysis from the winner b f QUEEN OF KINGS.

**6<sup>th</sup> Race: 135. The Vidhana Soudha Trophy - (About) 1200 metres. Horses rated 60 to 85 (5 Runners).**

Permission was granted to Trainer Mr.S.Shoban Babu to withdraw ICICLE (Ravi R.) on veterinary grounds as it was found to have laceration on right gum. He was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

An enquiry is being held into the relative performance of ENGLISH BAY (A.R.Pradeep), trained by Mr.Warren Singh as compared to its previous run in Race No. 119. i.e. The A.R.Trophy - (About) 1400 metres. Horses rated 60 to 85 run on 26<sup>th</sup> January, 2025 wherein it ran unplaced.

Routine Sample was taken for analysis from the winner b g ENGLISH BAY.

**7<sup>th</sup> Race: 136. The Kadambi Falls Plate - Div. I - (About) 1400 metres. Horses rated 20 to 45, 5 years old and over (9 Runners).**

Jockey A.R.Pradeep, the rider of GLOW IN THE DARK was fined Rs. 1000/- for shifting out and causing interference to INVINCIBLE (Rajesh Kumar M), which in turn passed it onto MEGA SUCCESS (V.R.Jagadeesh) soon after the start.

Jockey D'nuSingh Deora, the rider of HONOURABLE LADY reported that he was tightened for room at the start due to the crowding of the field.

Jockey Tauseef Ahmed, the rider of N R I TOUCH reported that his mount was not striding out well during the race. The horse was subjected to veterinary examination. On examination it was found to be lame on left fore. Trainer Mr. Md Sajid Qureshi was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Jockey V.R.Jagadeesh, the rider of MEGA SUCCESS was fined Rs.5,000/- for the excessive use of the whip on his mount during the race (2nd infringement).

INVINCIBLE (Rajesh Kumar M) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g GLOW IN THE DARK.
