UNFORGETTABLE STAR (M. Prabhakaran) walked out of the gates, lost few lengths at the start and ran detached thereafter. In view of its behaviour, Trainer Mr. S. Narredu (deputizing on behalf of Trainer Mr.Rajesh Narredu) was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Akshay Kumar, the rider of CHARISMATIC was reprimanded for shifting out and inconveniencing CELESTIAL FLAME (Darshan R.N) on his outside approaching 1300 meters.

Routine Sample was taken for analysis from the winner ch c CHARISMATIC.

#### 2<sup>nd</sup> Race: 167. The Manikyadhara Falls Plate - (About) 1600 metres. Horses rated 20 to 45 (8 Runners).

Jockey L. Alex Rozario, the rider of THEWHISPERQUIETLY was reprimanded for shifting out and inconveniencing STENTORIAN (Yash Narredu) on his outside passing the 800 meters.

Jockey Neeraj Rawal, the rider of IMPERIAL STAR was reprimanded for travelling wide rounding the final bend for no apparent reason.

Jockey Antony Raj S., the rider of BRUCE ALMIGHTY was reprimanded for shifting 'in" and inconveniencing EQUALIZER (Salman Khan) on his inside passing the 300 meters.

EQUALIZER (Salman Khan) ran detached from the field. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. G. Y. Rajesh Babu was informed to ensure better performance of his charge in future.

Routine Sample was taken for analysis from the winner b g STENTORIAN.

AATHERV (Akshay Kumar) was subjected to veterinary examination but no abnormality was reported.

Jockey G. Praveen, the rider of MEHRA was reprimanded for travelling wide between 750 meters and 650 meters for no apparent reason.
