<u>1st Race: 158. The Koyna Plate - (About) 1200 metres. Horses rated</u> <u>60 to 85 (5 Runners).</u>

Routine Sample was taken for analysis from the winner b g METZINGER.

2nd Race: 159. The Raichur Plate - (About) 1600 metres. Horses rated 00 to 25 (11 Runners).

QUEVEGA (Harish B.) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Narayana Gowda V. was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

MY VISIONARY (V.R.Jagadeesh) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. S. Inayathulla was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

LORVEN'S GLORY (Hemant Chandragiri) ran detached from the field. Trainer Mr. G. Y. Rajesh Babu was informed to ensure better performance of his charge in future.

Jockey Adarsh G., the rider of CHANNAGIDE was fined Rs.3,000/- for the excessive use of the whip on his mount during the race (1st infringement).

It was reported after the race that SOUTHERN WARRIOR (Afsar) pulled up lame on left fore. Trainer Mr.Faraz Arshad was informed that he must produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

SOUTHERNARISTOCRAT (Antony Raj S.) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner dk b g SUPERHERO.

<u>3rd Race: 160. The Mahadayi Plate - Div. II - (About) 1200 metres.</u> <u>Horses rated 20 to 45, 5 years old and over (9 Runners).</u>

STEP TO DESTINY (A.R.Pradeep) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.V. Lokanath was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Akshay Kumar, the rider of FIREFINCH reported that his mount was not galloping fluently after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported. Jockey Asirvatham, the rider of BALTIMORE had to steady his mount momentarily passing the 800 Metres.

Routine Sample was taken for analysis from the winner dk b m DOMINA.

4th Race: 161. The Adichunchanagiri Plate - (About) 1200 metres. Horses rated 40 to 65, 5 years old and over (9 Runners).

STAR ADMIRAL (Koshi Kumar) planted and lost many lengths at the start. In view of its repeated behaviour, Trainer Mr. Aravind G. was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in two Mock Races.

FORTUNATUS (V.R.Jagadeesh) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. S.Shoban Babu was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

POSITIVITY (Siddaraju.P) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. S. Narredu was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey Siddaraju.P, the rider of POSITIVITY was fined Rs. 2,000/- for shifting out and causing interference to SOUTHERN FORCE (L. Alex Rozario), which in turn passed it onto FORTUNATUS (V.R.Jagadeesh) on his outside passing the 350 meters.

Jockey Suraj Narredu, the rider of LAUTERBRUNNEN was fined Rs. 1,000/for coming "in" and tightening SUPER MARVELLA (Darshan R.N) on his inside approaching 300 meters.

Jockey Suraj Narredu, the rider of LAUTERBRUNNEN reported that his mount was coughing during the race. The horse was subjected to veterinary examination. On examination, it was found to have burst its blood vessels (On endoscopy Grade - IV). Trainer Mr. Narayana Gowda V. was informed to produce a Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

SOUTHERN FORCE (L. Alex Rozario) was subjected to veterinary examination but no abnormality was reported.

Jockey Koshi Kumar, the rider of STAR ADMIRAL was fined Rs.2,000/- for his negligence in weighing "in" 700 gms excess in relation to weighing out.

An enquiry is being held into the running and riding of POSITIVITY, trained by Mr. S. Narredu and ridden by jockey Siddaraju.P in the above race.

Routine Sample was taken for analysis from the winner b g KNOTTY PATTON.

5th Race: 162. The Maj. C. Newton-Davis Memorial Trophy - (About) 1200 metres. Horses 3 years old only. (10 Runners).

Jockey Salman Khan, the rider of SILVER QUEST was fined Rs.1,000/- for shifting "in" and causing interference to DARRINGTON (L. Alex Rozario) on his inside at the start.

Jockey Rajesh Kumar M, the rider of RANSOMWARE was fined Rs.2,000/- for shifting 'in' and tightening the horses on his inside viz; ROSALINE (Antony Raj S.) and MOON STAR (Akshay Kumar) passing the 1000 Metres.

Jockey Salman Khan, the rider of SILVER QUEST was reprimanded for shifting 'in' and inconveniencing KISS OF GREY (Suraj Narredu) on his inside approaching 1000 Metres.

Jockey Akshay Kumar, the rider of MOON STAR reported that his saddle shifted back in the straight. After due examination of the equipment, Trainer Mr. S. Ganapathy was fined Rs.3,000/- for faulty saddling of his charge.

Jockey Shamaz Shareef, the rider of OUT INTO SPOTLIGHT reported that his mount was hanging 'in' after entering the straight. The horse was subjected to veterinary examination but no abnormality was reported. However, Trainer Mr. Neil B Devaney (deputizing on behalf of Trainer Mr. Prasanna Kumar) was informed to take appropriate corrective measures before accepting with it again.

Jockey Shamaz Shareef, the rider of OUT INTO SPOTLIGHT was fined Rs. 1,000/- for shifting out and causing interference to SILVER QUEST on his outside passing 250 meters.

Jockey Akshay Kumar, the rider of MOON STAR was fined Rs. 2,000/- for shifting out and causing interference to HYPERDRIVE (Arvind Kumar. N) on his outside approaching 150 meters.

Routine Sample was taken for analysis from the winner b g SICYON.

6th Race: 163. The P.V.Shetty Memorial Trophy - (About) 1400 metres. Horses rated 40 to 65 (8 Runners).

DISRUPTOR (Darshan R.N) was extremely fractious and refused to remain in the stalls. Under the circumstances, it was permitted to be withdrawn before coming under starter's orders.

SUNDANCE KID (A.R.Pradeep) after jumping out, did not raise a fluent gallop for the first 100 meters and ran detached thereafter. In view of its behaviour, Trainer Mr. K. Purshotham was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in at least one Mock Race.

Jockey Salman Khan, the rider of IL VOLO reported that he accidently lost his whip passing the 300 Meters.

CORINTHIAN (P. Trevor) was subjected to veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b f FINLEY.

<u>7th Race: 164. The Mahadayi Plate - Div. I - (About) 1200 metres.</u> <u>Horses rated 20 to 45, 5 years old and over (10 Runners).</u>

RIGHTLY NOBLE (Suhas. K) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. V. Lokanath was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

ABLE ONE (Asirvatham) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Azhar Ali was informed not to accept

with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

It was observed that VAYU (Prashant P.Dhebe) slipped from its hind legs at the start and the jockey was momentarily unbalanced.

Jockey P. Trevor, the rider of SMILE OF BEAUTY reported that his mount was hanging out throughout the race. The horse was subjected to veterinary examination. On examination, it was found to have sustained clip injury on right fore cannon.

It was observed that VAYU (Prashant P.Dhebe) could not get a clear run between 250 Metres and 150 Metres due to a closely packed field.

Routine Sample was taken for analysis from the winner ch m DOUBLE VISION.

8th Race: 165. The Red Fort Plate - (About) 1400 metres. Horses rated 20 to 45 (12 Runners).

TURKOMAN (Salman Khan) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr.Imtiaz Khan was informed not to accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in a jump out on a starting gate practice day.

Jockey V.R.Jagadeesh, the rider of THRILL OF BRAZIL was fined Rs.3,000/for not making sufficient effort to improve his position from the start till about 700 Metres.

Jockey Vishwa. V, the rider of GISMO was fined Rs.1,000/- for shifting out and causing interference to LORVEN LUV (Koshi Kumar) on his outside passing the 1000 Metres.

THRILL OF BRAZIL (V.R.Jagadeesh) was subjected to veterinary examination but no abnormality was reported.

LORVEN LUV (Koshi Kumar) was subjected to veterinary examination but no abnormality was reported.

Trainer Mr. Md Sajid Qureshi was fined Rs.10,000/- for the improved performance of his charge CARTER (Rayan Ahmed R.) in the above race as compared to its previous run in Race No. 153 i.e. The Shivaganga Falls Plate - Div. II - (About) 1200 metres. Horses rated 20 to 45 run on 22/02/2025 wherein it ran unplaced.

Routine Sample was taken for analysis from the winner b g CARTER.

Permission was granted to trainer Mr. Neil B. Devaney to deputize on behalf of trainer Mr. Prasanna Kumar who was unable to attend the races.

ADDITIONAL REPORT

BANGALORE WINTER MEETING 2024-2025 TWENTYFIRSTDAY, SATURDAY, 22ND FEBRUARY 2025

Race: 153. The Shivaganga Falls Plate - Div. II - (About) 1200 metres. Horses rated 20 to 45.

An enquiry was held by the Stipendiary Steward into the running and riding of MISTER BROWN, trained by Mr. Pradeep Annaiah and ridden by Jockey Tousif Khan in the above race. In that "He did not use adequate vigour in riding out his mount in the final 200 Meres".

Jockey Tousif Khan was interviewed by the Stipendiary Steward. The Stipendiary Steward after considering the submissions made by Jockey Tousif Khan and after viewing the CCTV decided to charge Jockey Tousif Khan for Incompetent Riding.

The Stipendiary Stewards thereafter decided as under:

"Should he apply for a grant of "A" Jockeys Licence under BTC Rules of Racing for the year 2025-26, the same shall remain suspended **for the first four (4) race days of Bangalore Summer Meeting 2025** as he had pleaded guilty to the charge for Contravention of Rule No. 161 (ii) [Incompetent Riding] of the BTC Rules of Racing on his mount MISTER BROWN (He is permitted to ride work)".
