REG: OUTSTATION HORSES FOR THE BANGALORE SUMMER MEETING 2012.

In supersession to notice dated 8th April 2012, please note the following:

- I. As regards visiting horses for Bangalore Summer Meeting 2012 the following category of horses alone are eligible for allotment of stables **in order of priority Subject to the availability of Stables: -**
 - a) All 3 and 4 years old that are entered for Bangalore Summer Classic/s 2012 and not struck out till the date of stable allotment (as in notice dated 12th April 2012)
 - b) 3 years old that are entered for atleast Five Sweepstakes races to be run during Bangalore Summer Meeting 2012.
 - c) 3 years old which have won atleast one race.
 - d) Horses aged 4 years rated 60 and above and 5, 6 & 7 years rated 80 and above.
- II. **Outstation Horses will not be permitted to race in 00 to 25 races.**
- III. Horses will be permitted into Bangalore Turf Club premises from 1st May 2012, subject to notice enclosed.
- IV. Horses on arrival should be produced before the Club's Veterinary Officer and a certificate of soundness Obtained.
- V. Allotment of stables is at the sole discretion of the Stewards of the Club.
- VI. Two year olds and horses not covered under clause I above will not be entitled for allotment of stables.

NOTICE

In partial modification of our circular dated 8th April 2012 Outstation Horses arriving at Bangalore for Participating in B.S.M. 2012 should possess the following:-

1. A valid Coggins test certificate negative for EIA.
2. A Health certificate from the Sr. Veterinary Officer of the respective club stating that the horse does not show any clinical signs of E.I.A., Glanders, AHS, Strangles or Equine Influenza at the time of its departure.
3. An endorsement in the Passport to the effect that they have been administered with approved vaccination against Equine Influenza. The details of the Vaccination such as, Date and Name of the Vaccine, Batch No. and Expiry date (Vignette) should be endorsed in the Passport and must be duly signed by the Sr. Veterinary Officer of the respective club.
4. In respect of horses arriving from Mumbai/Pune, the following conditions will apply in addition to the above,
 - (a) These horses should have received Procaine Penicillin (20-40 lakh units for 5 days), another single Procaine Penicillin injection should be given just prior to being transported out of RWITC, Mumbai/Pune. The details including the date, penicillin product name, dose and batch numbers must be recorded in the health certificate issued by the Sr. Veterinary officer of RWITC, Mumbai. Only horses, which have received above doses of Procaine Penicillin will be allowed into BTC stables.
 - (b) After their arrival at Bangalore Turf Club Ltd, Bangalore a temperature record of each horse should be presented to the Chief Veterinary Officer, BTC. daily for next 15 days.
