ORDER OF THE BOARD OF APPEAL

BANGALORE SUMMER MEETING 2013

SIXTEENTH DAY, SUNDAY, 7TH JULY 2013 Race No.131, The Young Rajput Plate (About) 1200 Metres. Horses rated 20 to 45

- 1. The Board of Appeal at its Meeting held on Monday, 5th August 2013 considered the Appeal dated 20th July 2013 filed by Trainer Mr. Amit Caddy against following decision of the Stewards of the of the Bangalore Turf Club Ltd., in connection with the running of his charge PACIFIC BLUE in the above said race to the following effect:
 - (a) To fine Trainer Mr. Amit Caddy a total sum of Rs.50,000/- for (i) unsatisfactory running of his charge PACIFIC BLUE in the above said race; (ii) for tendering unsatisfactory explanation, false and misleading evidence during the enquiries; (iii) negligence in the discharge of his duties as a trainer in not reporting to the authorities on his own as to the manner of riding of his charge PACIFIC BLUE by Jockey A Ramu in the above race; and
 - (b) further to punish him by suspending his Trainer's licence for a period of 6 months for the unsatisfactory running of his charge. However, under the circumstances of the case the enforcement of the punishment by way of suspension of Trainer's licence shall stand suspended for a period between 19-7-2013 and 31-3-2015(both days inclusive) during which period if similar breach of unsatisfactory running of his charge occurs, the Stewards shall enforce the punishment of suspension of Trainer's licence for 6 months with immediate effect at the time of occurrence of the said breach.

The Board of Appeal at the above said meeting also considered the appeal dated $20^{\rm th}$ July 2013 field by Jockey A. Ramu against the decision of the Stewards of Bangalore Turf Club Ltd., to the following effect.

Declare Jockey A. Ramu as a disqualified person under BTC Rules of Racing with effect from 7-8-2013 to 6-8-2014 (both days inclusive) for not permitting his mount PACIFIC BLUE to run on its merits in the above race thereby contravening Rule No. 159 (a) & (b) of the BTC Rules of Racing.

2. The Board of Appeal considered the following:

(a) The Minutes of the Meeting of the Stewards of the Bangalore Turf Club Ltd. dated 18th July 2013
 (b) The written Grounds of Appeal dated 2.0 2017

(b) The written Grounds of Appeal dated 3-8-2013 submitted by Trainer Mr. Amit Caddy;

- (c) The written ground of Appeal dated 3-8-2013 filed by Jockey A. Ramu.
- 3. The Board examined Trainer Mr. Amit Caddy and Jockey A. Ramu.
- 4. After consideration of all the above, the oral submission made by Trainer Mr. Amit Caddy and Jockey A. Ramu during the hearing the the appeal and after repeatedly viewing the CCTV replay of the race in question, the Board of Appeal unanimously decided as follows:



- (a) To partially allow the appeal filed by trainer Mr. Amit Caddy.
- (b) To partially modify the punishment imposed on Trainer Mr. Amit Caddy as follows:
 - (i) To uphold the decision of the Stewards in fining Trainer Mr. Amit Caddy Rs..50,000/- for (i) unsatisfactory running of his charge PACIFIC BLUE in the above said race; (ii) for tendering unsatisfactory explanation, false and misleading evidence during the enquiries; (iii) negligence in the discharge of his duties as a trainer in not reporting to the authorities on his own as to the manner of riding of his charge PACIFIC BLUE by Jockey A Ramu in the above race;
 - To revoke the following suspended sentence (ii) imposed on Trainer Mr. Amit Caddy by the Stewards of the B.T.C. to the effect of punishing him by "suspending his Trainer's licence for a period of 6 months for the unsatisfactory running of his charge. However, under the circumstances of the case the enforcement of the punishment by way of suspension of Trainer's licence shall stand suspended for a period between 19-7-2013 and 31-3-2015 (both days inclusive) during which period if similar breach of unsatisfactory running of his charge occurs, the Stewards shall enforce the punishment of suspension of Trainer's licence for 6 months with immediate effect at the time of occurrence of the said breach".
 - (iii) To forfeit the deposit of Rs.2,500/- paid by Trainer Mr. Amit Caddy towards the appeal fee;
- (c) (i) To reject the appeal filed by Jockey A. Ramu;
 - (ii) However, to modify the period of disqualification imposed on Jockey A.Ramu in that he shall be a disqualified person under BTC Rules of Racing with effect from 7-8-2013 to 31-3-2014 (both days inclusive) for not permitting his mount PACIFIC BLUE to run on its merit in the above race thereby contravening Rule No.159(a) & (b) of the BTC Rules of Racing.
 - (iii) forfeit the deposit of Rs.2,500/- paid by Jockey A. Ramu towards the appeal fee;

MOCK RACE HELD ON 19-2-2013

The Board of Appeal at its Meeting held on Monday, 5th August 2013 considered the Appeal dated 20th July 2013 filed by Jockey V.R,. Jagadeesh against decision of the Stewards of the of the Bangalore Turf Club Ltd., in suspending his Jockey's Licence from 7-8-2013 to 6-11-2013 (both days inclusive) and not permitting him to ride work during the period of suspension of Jockey's Licence for his misconduct while riding in the Mock Race held on 19th February 2013 at Mysore on his mount BORN TO PERFORMthereby contravening Rule No.101(i) of the BTC Rules of Racing

The Board of Appeal considered the following:

- (a) The Minutes of the Meeting of the Stewards of the Mysore Race Club Ltd., held on 22-5-2013;
- (b) The Minutes of the Meeting of the Stewards of the Bangalore Turf Club Ltd , held on 18-7-2013;
- (c) The written Grounds of Appeal dated 3-8-2013 submitted by Jockey V.R. Jagadeesh;

The Board examined Jockey V.R. Jagadeesh

After consideration of all the above, the oral submission made by Jockey V.R. Jagdeesh during the hearing of appeal and after repeatedly viewing the CCTV replay of the Mock Race in question, the Board of Appeal unanimously decided as follows:

- (i) To reject the appeal filed by Jockey V.R. Jagadeesh;
- (ii) forfeit the deposit of Rs.2,500/- paid by Jockey V.R. Jagadeesh.
